A word from the commander

For the better part of the past six months, I have been struggling with pain and limited movement in my right shoulder. For several months, I chose to ignore it and then after visiting with my doctor, he prescribed physical therapy for two months. When the pain and immobility increased, I requested an MRI which indicated a torn rotator cuff.

On 3 November, I had outpatient surgery where the rotator was repaired, some calcium deposits removed, some bone removed, and when they found a piece of tissue that they didn't wish to remove, they screwed it onto my clavicle. I have only recently returned to driving on my own and I can once again dress myself...something that would make my mother proud and makes my wife happy because she doesn't have to do it anymore. ☺ My surgeon just prescribed two additional months of physical therapy 3x a week.

This has been quite a setback and although I hesitate to use it as an excuse, it altered my schedule dramatically. It has been the reason we did not meet this past Fall and why a newsletter wasn't sent earlier.

A complete update on the work of the Historic Fort Wayne Coalition was shared by guest Tom Berlucchi. Given that the Commandery used to help support the Plymouth Historical Museum with an annual contribution of \$150, it was moved by Companion Harrison to give \$150 annually to the HFW, 2nd by Companion Davis and passed unanimously.

The Coalition and the Commandery have pledged support for each other and will look for future opportunities to work together to further the history of the Civil War and the Fort. Guest David Jamroz shared insight into the book, *Images of America – Detroit’s Historic Fort Wayne*, written by he and Bill Conway. Several copies were sold and signed.
