National Council of Administration Meeting Minutes Saturday, April 13, 2013 Springfield, Illinois

The Council of Administration meeting was opened by Commander-in-Chief Perley Mellor at 7:50 PM. Chaplain Kowolski was absent due to sickness therefore substitute Chaplain Alan Russ provided a moment of prayer followed by the Pledge of Allegiance. CinC Mellor thanked everyone for attending and gave general opening comments.

Jerome Orton, PDC NY

Brother Orton (PDC NY) presented to the CinC an original certificate concerning a Past Commander-in-Chief which his wife purchased at a flea market and worded: "State of Ohio, City of Columbus, Supreme Court of Ohio, January Term AD 1909. William M. Coffin was duly examined and regularly admitted to practice as an Attorney and Counselor at Law in any courts of record in the State of Ohio." The Commander-in-Chief thanked Brother Orton.

Action: Given to Executive Director for disposition.

SVCinC Ken Freshley spoke to the CofA about his life changes, including his hospitalization and health issues that resulted in other set-backs and time spent helping family members experiencing difficulties. He acknowledged that his ability to keep up with SUVCW responsibilities has been affected. He has asked for help from others, and is sure that his responsibilities will be completed. He is still working on Proceedings and is about 98 percent complete. He stated that

he expected the project will be completed in the new few weeks. The CinC asked him if he has been using his assistants and he said he was and that things are also settling out for him.

JVCinC Tad Campbell indicated that he had nothing addition to his written report previously submitted. From his report, he wished to highlight that he has had 148 membership applications since our Encampment last August.

National Quartermaster Danny Wheeler reported that his assistant has been helping him well.

National Treasurer Richard Orr gave a presentation on where the Order was on our application for IRS 501c3 status. We are moving right along and the paperwork is finished and being signed by himself and the Commander-in-Chief. Most require notarized signatures. We must register with thirty-nine (39) states and Camps/Departments in order to cover the Camps and Departments who will be under us. He reminded us that an SUVCW organization asking for donations through a website, that is considered by tax courts to be a solicitation "worldwide." There is a possibility that by the Encampment, we could announce that we are IRS approved for 501c3. The normal delay is 1.5 years, however, because of our backing, and the fact we are already 501c4, we may be approved much earlier. Two States require a resolution allowing the organization's Treasurer and Commander-in-Chief to sign the State 501c3 application.

A MOTION by Brother Orr, seconded by Brother Palmer, to adopt a resolution authorizing our Treasurer and Commander-in-Chief to apply for Certificates of Charitable Organization for those two States. PASSED unanimously.

He then provided the members on our current budget status and passed out copies of the Consolidated Balance Sheet for the period ending March 31, 2013 and the FY 2012 final audit and management letter. He also provided a report concerning the successful, audit completed by Abraham & Gaffney, P. C. Though successful, the Treasurer is not happy with how long it took (7 months), or the many mistakes requiring correction or attention by the auditor's employees. He is looking into finding a new Auditing firm that can complete the audit in a more timely and professional, manner. A copy of the audit was presented.

He acknowledged confusion that resulted in Department EIN Reports. It is his desire that Camps and Departments NOT send him their IRS 990Ns. He does not need or want them. The report he requires is the Department's Report containing the Camp EINs, and contact information for the members responsible for filing reports to the IRS (normally the treasurer). A discussion on this issue included the possibility of making a "Department EIN Reporting Form" (referred to Plans and Programs) and resulted in asking the Banner to publish a story in the next edition highlighting this report, explaining what is needed and when to submit it to the National Treasurer

ACTION: Treasurer to write an article on EIN reporting requirements for the Spring edition of The Banner.

An SUVCW proposed investment plan, including brochures and prospectuses was presented. He is proposing we invest our available monies into four (4) different "low risk" bond funds by Lord Abbett:

Lord Abbett Core Fixed Income Fund
 Lord Abbett Total Return Fund

- Lord Abbett Income Fund - Lord Abbett Short Duration Income Fund These will give us a 5 Percent (all things as predicted). Discussion followed, indicating the members preferred a more diversified plan, even if the risk was moderately higher, including individual stocks (such as Disney) that historically provide a handsome return.

A MOTION by Brother Petrovic, seconded by Brother Wheeler, authorizing the National Treasurer to investigate other opportunities, and if found – authorize him to take advantage of the opportunity. PASSED Unanimously.

It was reported in previous minutes that the IRS original 1941 letter authorizing our 501c4 status could not be found. However, our Treasurer, while preparing for our 501c3 status application did run into it and we now have it.

PCinC Jim Pahl volunteered to take on the project of digitizing ALL issues of National Encampment Proceedings into one digital library. He is probably the only individual in the organization hold all of them.

National Secretary Eugene Mortorff had nothing in addition to what was already published in his written report.

National Quartermaster Danny Wheeler discussed the Junior Associate Certificate and indicated there have been requests for a Junior Member Certificate. Discussion ensued in the lines of there is no need for a Junior Member certificate because they can be issued a regular member certificate instead.

He then discussed the JROTC certificates, specifically should the certificates have pre-printed CinC Signatures? Discussion ensued revolving around the merits of this and alternate means of getting signatures on the form.

A MOTION by Brother Petrovic, seconded by Brother Campbell, to not pre-print the signatures, but to send out the blank ones and provide information on persons who can do calligraphy for them. PASSED Unanimously.

Specific changes to the ROTC Certificate Request form were recommended by the National Quartermaster. Discussion followed.

ACTION: Referred to Programs and Policy Committee.

Brother Wheeler also discussed SUVCW Grave Markers being available soon for sale. The mold is being made for coated aluminum markers which will sell for \$18. These should be available through the Quartermaster within 30 days.

Break at 9:35 Reconvened at 9:40 PM

Brother Ed Kreiser discussed the progress of finishing the transcription of the 2012 Proceedings. He is still working on them, but has been delayed due to health concerns. He has been having a difficult time reading due to sight problems caused by fluctuating blood pressure. He is asking for help in finishing them (especially the computer work). Possibly Keith Harrison could help?

ACTION: Brother Jim Pahl will ask Brother Keith Harrison if he could lend a hand on this task.

The Commander-in-Chief made an announcement concerning the committee chairperson of the Vision & Planning Committee resigning due to a difference in agreement with a Sesquicentennial Event decision made by the SES Sub-committee and the Council of Administration. Brother Brian Pierson accepted the Chairperson position. The committee will now move forward.
