COUNCIL OF ADMINISTRATION MEETING

A meeting of the Council of Administration of the Sons of Union Veterans of the Civil War was held on Sunday, August 15, 1976 in the Headquarters Suite of the Neil House Motor Hotel, Columbus, Ohio.

Commander-in-Chief Clarence J. Riddell called the meeting to order

at 1:50 p.m. with the following present:

- 1. The minutes of the Council of Administration meeting of August 13, 1975 held at Rochester, New York were read by National Secretary-Treasurer Fred H. Combs, Jr. A motion for acceptance was made by Brother William C. Rule, seconded by Brother Harold T. Beilby and unanimously adopted.
- 2. A printed resume of the financial and membership reports for the year ending June 30, 1976 was read by National Secretary-Treasurer Combs and copies were distributed to the members of the Council. Copies of the C.P.A. Report were also received.
- 3. The report of the Organization's publication The BANNER was submitted by Brother Fred H. Combs, Jr., Editor. A refund check in the amount of \$148.03 was turned over to the Organization as the surplus amount after expenditures for the four publications during the fiscal year ending June 30, 1976. A motion was made by Brother Rippey, seconded by Brother Beilby, commending Brother Combs for his work as Editor of The BANNER. The motion was uanimously approved.
- 4. On a motion by Brother Rippey, seconded by Brother Beilby, The BANNER appropriation for 1976-1977 was established at \$2,800.00. Motion carried
- 5. On a motion by Brother Rippey, seconded by Brother Beilby, the subscription rate for The BANNER for 1976-1977 was retained at \$2.00.
- 6. On a motion by Brother Rippey, seconded by Brother Beilby, Albert W. Lambert was appointed Editor of The BANNER with his appointment to become effective following the publication of the October 1976 issue of The BANNER.
- 7. On a motion by Brother Rippey, seconded by Brother Beilby, the following voucher system governing the issuance of annual interest checks for Life Memberships was adopted as follows:

a. Prior to the payment of the life membership interest, a voucher be sent from National Headquarters to the appropriate officer of the Camp.

b. Request that the voucher be properly verified by affixing the appropriate signature (Camp Secretary or Secretary-Treasurer) and

returned to the National Secretary-Treasurer.

c. Request that if the member has died a note to that effect containing the date of death be written on the voucher before its return to the National Secretary-Treasurer.

d. A check for payment of the interest on the life membership be sent only upon return of the completed voucher to the National

Secretary-Treasurer.

e. By use of a rubber stamp, indicate on the check that the check will become void after ninety days.

The Officers and Delegates of the Sons of Union Veterans of the Civil War and the Auxiliary to the Sons of Union Veterans of the Civil War assembled in the Presidential Ballroom West of the Neil House for their traditional Joint Opening at 9:30 a.m. under the direction of Mrs. Claire Monahan and John C. Yocum, National Chiefs of

Staff of the Auxiliary and Sons, respectively.

For the first time in the history of our Organizations, the presiding officers were husband and wife. Commander-in-Chief Clarence J. Riddell escorted National President Caroline E. Riddell down an aisle which was formed by National Aides of the Auxiliary dressed in long white gowns and holding small American Flags which were later placed on an altar in front of the presiding officers' table. The table also contained an open floral Bible and lamps in the shape of praying hands. The National President's theme for the year was "Pray for Peace".

The Past National Presidents and Past Commanders-in-Chief were then received, and Past Department Commander John Junge of New Jersey sang "Let There Be Peace", accompanied by Past National President Anne O. Clayton at the piano. Chief of Staff Claire Monahan asked a blessing encompassing the theme for the year and presented the gavel to the National President. Commander-in-Chief Riddell pinned a corsage of yellow roses on National President Riddell, and the Sons then retired to their meeting room.

REPORT OF THE COMMANDER-IN-CHIEF

To the Officers and Members of the 95th Annual Encampment Sons of Union Veterans of the Civil War

Greetings:

It is an honor and privilege to submit to you this report of my ac-

tivities for the year 1975-76.

August 13, in the City of Rochester, New York, you elected me to the highest office in the Sons of Union Veterans of the Civil War to be your Commander-in-Chief. I am grateful for the confidence you placed in me, and I sincerely trust I have fulfilled my duties to your satisfaction.

September 7 - My first official duty was to attend the viewing for Past Commander-in-Chief Albert C. Lambert who passed away on September 3. Our ranks of Past Commanders-in-Chief and our entire Order will greatly miss such a leader. Our sympathy is extended to the New Jersey Department and Brother Lambert's family on the loss of such a loyal and devoted Brother.

September 22 — Attended the reception for the Pennsylvania Department Commander and President, Bill and Mary Jane Simpson in

Reading.

September 27 — Attended the Anniversary Luncheon of Camp #149 Media.

September 28 — Accompanied the National President to Syracuse, New York, to deliver a plaque to Past National President Ida Rokes Klein for her 50 years as Past National President. She was delighted to see us. Sorry to say Sister Klein passed away on March 25.

October 11 — Attended the 86th Anniversary Dinner of Anna M.

Ross, Auxiliary #1, Philadelphia.

November 8 — Was greatly honored by a reception to the National President and myself, given by Anna M. Ross Auxiliary #1 and Philadelphia Camp #200. It was a night we will long remember. Our thanks

to all who came to help make this such a happy occasion.

November 22 — Remembrance Day at Gettysburg. A parade of more than 500 participants in the uniforms of the Union Blue and the Confederate Gray was a sight the National President and I will never forget as we stood at attention while the line of march passed us in review. The placing of the wreaths at the Woolson Monument was quite an honor. In the evening, at the dinner, I had the extreme privilege of presenting our scholarship to Carl E. Alexis of Bethesda, Maryland, a senior in history at Gettysburg College.

February 12 - I represented our Organization at the Lincoln Memorial in Washington, D. C. I was escorted by Major Elton P. Koch of the Pennsylvania Brigade, Sons of Veterans Reserves, when presenting the wreath from the Sons. President Ford was present and made a fine speech after which he placed the Presidential wreath. A luncheon was then held at the Army and Navy Club. This entire event was sponsored by the Military Order of the Loyal Legion. Incidentally,

the Sons and Auxiliary were the second ones to present their wreaths. April 15 — Springfield, Illinois, at the ceremony commemorating the 111th anniversary of President Lincoln's death. These exercises were conducted by the Sons of Union Veterans of the Civil War assisted by the Military Order of the Loyal Legion. Past Commander-in-Chief George Cashman was chairman and Past Department Commander Thomas L. W. Johnson co-chairman. Brother Johnson presided at the Tomb. I had the privilege of reading "Lincoln's Farewell to Springfield" after which there was the placing of the wreaths. This was then followed by a luncheon.

April 25 — Attended the services at General Grant's Tomb in New York. Brother Cecil Baer was in charge. After the exercises at the tomb, which were very impressive, we had a dinner at Stouffer's Restaurant.

May 31 — Was very privileged to attend the Memorial Day exercises in Gettysburg and to review the parade before proceeding to the cemetery where a most impressive service was held. Flags were on all the graves, and school children strew flowers on them all. I had the pleasure of placing a wreath in the name of the National Organization Sons of Union Veterans of the Civil War.

Sorry I could not attend the Cathedral of the Pines at this time, but would like to thank National Chaplain Richard E. Wyman for representing me and presenting our check.

VISITATIONS

February 13 — Started a five-week trip to the West Coast. Our first called meeting was at Fresno, California with Department Commander Kenneth Greely and a large number of the Sons attending. Due to a notice in the newspaper that we would be making our visit to this section, a member of Auxilary #200 who had moved to Fresno about 30 years ago joined the Auxillary so she could be present when we made our visit. It pays to advertise.

February 27 — A called meeting in Portland, Oregon. This was a fine meeting and as well attended as some of the regular Encampments. The banquet in the evening had over 70 men and women present, and I had the pleasure of initiating six new members into the Oregon Camp. Department Commander Lawrence Allison and his wife Eva took the National President, her Personal Aide and me on a tour of Oregon-Washington. Our many thanks to them.

After leaving Oregon we ran into a real snowstorm going over the mountains and were snow-bound in Cheyenne, Wyoming for 2½ days.

March 7 — In Colorado Springs, my next called meeting, the temperature was in the 70's. It was a small group but most interested. After the meeting I was taken on a tour of the Air Force Academy and some of the city. It was just beautiful.

March 12 — DesMoines, Iowa was the next called meeting. After we arrived, there was a bad sleet storm and some of the members could not make the trip; however, we did have a nice group and the meeting was really interesting. Sister Ethel Jones said to be sure to say she drove through it twice in one day to make our visit a pleasant one

We then started for home and were fortunate in missing a tornado in South Bend, Indiana only because several members asked us to meet them for breakfast. If we had left as early as originally planned we would have arrived in South Bend in the midst of the storm.

March 27 — Attended a luncheon at the Maryland-Delaware Department and made my official visit. It was a good affair and well attended.

April 2 — Massachusetts Encampment. This was a very well attended Encampment, and the degree team initiated six new members. They were expecting a few more to join shortly. Hope they can continue such a gain.

April 9 - Rhode Island Encampment. While this is a small Depart. ment they are still doing a good job of keeping the Organization before the public in civic work and at the Veterans Home.

April 30 - Attended the New Hampshire Encampment.

May 2 - Was able to be at the Connecticut Encampment.

May 5 - Had a called meeting in Maine which was very well attended. We had a splendid meeting. Department Commander Butler and Department President Sister Hamm took us on a tour which was very much enjoyed.

May 9 — Attended the Vermont Encampment.

May 16 — Had a called meeting in Alliance, Ohio which was very interesting. Stopped in Columbus on May 17 to discuss some of the plans for the Encampment with Sister Margaret Orr.

June 5 - Attended the Wisconsin Encampment which proved to be

very interesting and enjoyable.

June 10 — Attended the Illinois Encampment where there was also a fairly good attendance.

June 13 - Michigan Encampment, while small was a very active group.

June 18 - New Jersey Encampment. A very active and well attended Encampment. This was a difficult Encampment for most of its members due to its being the first one without the help of Brother Lambert - the gap was felt by all. They are a strong and well organized group and I am sure will continue to grow.

June 27 - New York Encampment. A very good turnout and much

activity.

Bury, II, Department Commander, Sons of Union Veterans of the Civil War; Esther Greer, Department President, Auxiliary to Sons of Union Veterans of the Civil War; and Frances Capuaro, President, Circle #9, Columbus, Ohio, Ladies of the Grand Army of the Republic. Brother Bury presented a basket of flowers and expressed the hope that the Encampment would be enjoyable for all.

Commander-in-Chief Riddell: Thank you for the lovely flowers. Please

present them to my station.

The above-named Sisters extended their best wishes and commented that this was the first time that either of them had visited a Sons of Union Veterans of the Civil War National Encampment and that they were pleased to have the opportunity.

Past Commander-In-Chief C. LeRoy Stoudt: As Chairman of the Encampment Site Committee, I am proud of you for having us here. It becomes more difficult each year to secure a place for the Encampment; therefore, we are sincerely grateful to you folks from Ohio for inviting us to come to Columbus.

Commander-in-Chief Riddell: We will now continue with the reading of reports. Will the officers please submit their reports as called.

REPORT OF THE SENIOR VICE COMMANDER-IN-CHIEF

To Commander-in-Chief Clarence Riddell Officers and Brothers of this 95th National Encampment,

Greetings:

One year has passed since last we met and you honored me by reelection to the office of Senior Vice Commander-in-Chief. This year has been far too short for me.

The office of vice president of any organization has limited activities, but it does allow for continuity of programs and projects if properly used. It also allows for the study of the organization and a platform to offer suggestions for the good of the Order. I would like to make five recommendations:

Recommendation #1: That we broaden our membership. In 1972, I authored an amendment to lower the age of eligibilty to 14, and it has helped in some areas. This year I author a proposed amendment that will broaden our membership base. In 1951 the Massachusetts Department asked that blood nephews be given full membership and they were ruled out of order. In 1954 our Federal Charter stated that members of the corporation (SUVCW) shall be blood relatives of Union Veterans. In 1969, 1971, and 1972, I suggested these changes to allow collateral descendants full membership. I am proud that Ohio now submits this change in proper form.

Recommendation #2: Scholarship, Education and Awards. The scholarship program is good, but is in fact a grant in aid. We live in inflationary times, and this should be increased by \$50.00 this year. The Americanism and Education Committee badly needs to be revitalized. Education is one of our major purposes, yet we do little in this field. This committee should be developing programs for use in our schools. Many patriotic societies have an awards program — either a certificate and/or a medal for scholarship or an ROTC cadet. We need the public recognition such a program can provide. The Council of Administration should develop such a program.

Recommendation #3: Photocopies of Department and Camp Charters. The basic idea of this regulation passed last year is sound, but impractical. The order was established to provide future historical information, but here in Ohio it costs about \$20.00 to make such photocopies and some camps are refusing on grounds of the condition of their charters and do not want to remove them from the frames. Therefore. I would recommend that we have an offset printed form containing Department name, Camp name, Charter members, National Commander and Secretary, Department Commander and Secretary, and the date of issue.

issue. This form, at most, would cost 15¢, plus postage.

Recommendation No. 4: Accelerate growth. We are rapidly approaching our 100th Anniversary and need many more members. Years ago we had a standing National Organization committee for the purpose of promoting our Order. They had great success taking in 1,000 members a year and felt they failed. We must commit some money toward advertising and do it now. Fred Combs has proved the value of advertising by the large number of National Members at Large, but our efforts have

been small compared with what we should be doing. New promotional material for use by our membership needs to be developed to bring credit to our Order.

Recommendation #5: Life Memberships. This is one of my favorite projects. I was proud to recommend changes in the fees and payment system in 1972, and we took in more life members than in the previous fifteen years. Brother Chester Shriver and I recognized last year that we had a problem of inflation and Brother Shriver's fee structure was adopted. I would recommend that the fee structure be changed to the following: \$150.00 to age 55; \$100.00 for ages 56 through 65; and \$75.00 over age 65. This fee is a fair price and one that I believe the member would feel that he would live to see his camp receive the amount he paid. I would further recommend that this amount be paid over a three-year period with one-third down and a minimum of one-third per year — the life membership to go into effect after the full amount is paid.

The Council of Administration assigned the Senior Vice Commanderin-Chief the task of collecting funds to celebrate our 100th Anniversary. This is low keyed, and I ask that you contribute first to the National Patriotic Instructor's G.A.R. Fund and then make a donation to the Senior Vice Commander-in-Chief for the 100th Anniversary Fund.

It has been my sincere privilege to work with you, Brother Commander-in-Chief, and I thank you and the members for the honors given to me.

REPORT OF THE JUNIOR VICE COMMANDER-IN-CHIEF

To Commander-in-Chief Clarence J. Riddell and Assembled Members of the Sons of Union Veterans of the Civil War

Greetings:

First, I want to express my sincere thanks to the members of our Order who elected me Junior Vice Commander-in-Chief at last year's Encampment held in Rochester, New York. Also, my deepest thanks to all Brothers who recruited new members this past year.

I wrote every Junior Vice Department Commander approximately January 1, 1976 urging all of them to obtain as many new members as possible. Again in May I wrote to each Junior Vice Department Commander and enclosed a self-addressed, stamped envelope so they could send me a report on their membership activities for the year. I received a response from half of them.

Some Departments showed an increase in membership, some a loss; although they had obtained new members, unfortunately they had lost more. Some had remained at the same level. I am happy to report that my own Camp initiated two new members. Also, the New York Department obtained fourteen new members, and the Pennsylvania Department showed a net gain of sixteen members.

All the reports I received showed an active desire on the part of all members to obtain more members. I feel that all have done their best

I am sorry that I can't report any new Camps, although the Secretary-Treasurer in his report may have some to report. We are working on one in the New York Department at the present time.

I had the pleasure of initiating five new members in Smith Camp #193 at Halsey Valley, New York in April. This Camp was reactivated about two years ago.

REPORT OF THE NATIONAL COUNSELOR

To the Officers and Members of the 95th National Encampment Sons of Union Veterans of the Civil War

Greetings:

Herewith submitted is my report as National Counselor.

Shortly after returning from the 1975 National Encampment, the Commander-in-Chief requested information from me as to the numerical make-up of the several National Committees and upon the information available, though some of it contradictory, concluded that each committee should consist of five (5) members except for the Fraternal Relations and Legislation Committees as determined in Chapter III, Article VII.

Unfortunately, this ruling became quite a controversial matter, and upon further investigation into the existing Constitution and Regulations and the report as submitted at the 1975 National Encampment by the Committee on Constitution, it was discovered that matters thought to have been adopted as amendments to the Constitution and Regulations had never been adopted, and I can only presume the Committee on Constitution will be in the position to have these matters submitted for proper disposition thereof.

As the result of this and what appear to be other minor errors, I immediately wrote to the Commander-in-Chief and the National Secretary-Treasurer, suggesting the printing of new Constitutions as au-

thorized, be withheld, pending the outcome of the above.

Early in July, I received a letter from the Department Commander of Ohio asking for an opinion in a matter that had been referred to the Department Counselor who declined to rule due to a conflict of interest. I replied, quoting Chapter III, Article V, Section 8 (page 32, 1956 ediFOR GP =

tion, Constitution and Regulations) — "The National Counselor shall act as the legal adviser of the Commander-in-Chief and the National Organization" and suggested that he (Department Commander) direct the matter to the Commander-in-Chief.

Later in July, I received a similar letter from the Department Counselor of Ohio and I replied to him exactly as I did to the Department

Commander.

On August 3rd, I received a request from the Commander-in-Chief for a ruling on the Ohio matter which had been directed to him and replied, advising that due to the timing of the matter, same was out of order, forwarding copies to all parties involved.

Although this has been a year somewhat of a controversial nature,

it has been most experiencing and educational.

I would recommend when the new Constitution and Regulations are printed that prior approval be secured to include therein, the full and complete text of The Act of Incorporation (P. L. 83-605).

To you Commander-in-Chief, my sincere thanks for the privilege to have served on your staff, and I trust your Encampment will be har-

monious and constructive.

REPORT OF THE NATIONAL SECRETARY-TREASURER

To: Clarence J. Riddell, Commander-in-Chief 95th Annual National Encampment Sons of Union Veterans of the Civil War

Dear Commander-in-Chief and Brothers:

It is my great privilege and pleasure to submit to you this annual report on the fiscal transactions and the administrative activity of the office of National Secretary-Treasurer as well as the annual membership report. It is my hope that you will find the information contained herein informative and enlightening and indicative of progress of our Organization, or lack of progress as the case may be, during the past year. Although the year ended on the bleak note of a net loss in membership of \$3, it has been a year during which general operational expense has been kept under control, despite still rising costs and far from ideal economic conditions, and our financial reserves have increased.

1. ADMINISTRATION — The financial books, records, assets, etc. have been audited by James Harttraft, C.P.A., of Hamilton Township, New Jersey for the fiscal year ending June 30, 1976 as required by our Congressional Charter. His certified audit has been reviewed by the Council of Administration and, subject to the approval of this Encampment, a copy will be sent to the Congress of the United States. A summarization of the financial report, as well as the annual membership report, will be distributed to every delegate attending this Encampment.

Quarterly per capita and membership report blanks have been furnished each Quarter to each Department and each Camp-at-Large. I wish to commend Department and Camp-at-Large Secretaries or Secretary-Treasurers as the case may be for their willing and helpful assistance and cooperation in completing and returning these reports promptly, and I urge each one of them to continue to keep in mind the importance of doing so in the future. Efficient transaction of the business of the National Organization is greatly dependent on prompt, thorough and accurate reporting from the respective Departments.

The volume of correspondence sent to National Headquarters continues to be very extensive and appears to be increasing rapidly. Such correspondence relates to supply requisitions, membership inquiries, requests regarding search of military records of Civil War veterans, and numerous matters of a miscellaneous nature. Correspondence, as nearly as possible, has been answered daily or as rapidly as conditions existing at the time will permit.

Proceedings of the 94th Annual National Encampment held in Rochester, New York, August 10-14, 1975 were prepared by Past National Secretary-Treasurer Chester S. Shriver, and edited and published; actions of the Council of Administration and minutes of its meetings were reported in the Proceedings; the investments of the Permanent Fund were transferred in January 1976 from the broker in Gettysburg, Papreviously engaged by Brother Shriver to the Lawrenceville, New Jersey office of Merrill, Lynch, Pierce, Fenner & Smith, Inc.; an inventory of supplies has been set up and is being perpetually maintained for the purpose of having complete and accurate records of supply and demand matters close at hand at all times; requisitions for supplies are filled as expeditiously as possible; copies of The BANNER were mailed to Department Secretaries, members-at-large and subscribers within a few days after the first day of the months of October, January, April and July.

At this point, I should like to commend those Secretary-Treasurers who mail the BANNERS to the members in their Departments within a short time after they are received from National Headquarters, and express the hope that in next year's report I can commend all Department Secretaries on doing so.

- 2. MEMBERSHIP The net loss of 83 members this year is regrettable, but it should not discourage us. Our total membership has decreased from 2,551 members to 2,468. While five Departments, one Camp-at-Large and the national membership-at-large showed gains in membership, the opposite was true in thirteen Departments and one Camp-at-Large largely because of deaths and the necessity for dropping members. Actually, a total of 262 new members were recorded, but the total loss of 345 heavily exceeded the gain. Sons of Veterans Reserve activities and national advertising promotion were responsible for the acquisition of many new members. The fact that there is much genuine interest in our Organization throughout the Country is clear and evident. Many inquiries about membership are received at National Headquarters with regularity, and many of those who inquire are referred to Department Secretaries for follow-up. I feel confident that if members of all Camps and Departments put their shoulders to the wheel and push hard on membership with diligence, imagination and initiative, we can quickly offset the net loss that has occurred this year. It is important that we not be discouraged by this loss but instead be encouraged by the wide-spread interest in the Sons of Union Veterans of the Civil War that exists. It is equally important that a concerted effort be made to seek new members out to increase our ranks and to revitalize our Organization as a tribute and memorial to those gallant stalwarts who wore the Union Blue in 1861-1865 and fought to preserve our precious Country as one entity.
- 3. FINANCES The costs of postage, printing, supplies and services continue to rise, thus creating more of a financial burden on our Or-

ac-

counts.

ganization. This problem, in addition to the loss of per capita tar income brought about by decrease in membership, must be considered fully by the Budget Committee and this Encampment. Contributions to the National Patriotic Instructor's Fund during the past year have again been very commendable and outstanding. As in the case of past Na. tional Patriotic Instructors, much credit is due Patriotic Instructor Frank L. Clark for the diligence and excellence of effort with which he has striven for attainment of his goal and fulfillment of his responsibility. During 1975-76 the receipts from Life Memberships totalled \$2,215,00 and contributions to the Honor Roll Fund amounted to \$577.00 \$1.624.25 was realized in dividends from 2,225 shares of Wellington Fund. Continued placement of certain amounts from the G.A.R. Memorial Fund, Permanent Fund and 100th Anniversary Fund in special savings accounts where guaranteed interest can be earned on the amounts instead of having them accumulate in the general checking account has proved to be a beneficial financial asset. At the time of the transition of duties from Past National Secretary-Treasurer Chester S. Shriver to the current National Secretary-Treasurer in January 1976, the following amounts were placed in special savings accounts:

4. SUPPLIES — The establishment of a manufacturing source for our medals has been accomplished as a result of the diligent effort of Past National Secretary-Treasurer Shriver before he relinquished the position. It is difficult, however, to keep up with supply demands, especially the membership badges and some of the other badges, because of the number of new members that are added to the membership rolls each year.

The length of time required for receipt of badges and medals from our suppliers because of other obligations the suppliers have makes it essential that all requisitions by Departments, Camps and individuals be submitted to National Headquarters well in advance of anticipated needs. During the past year heavy demands on suppliers for Bicentennial paraphernalia caused some delays in meeting our needs. An overall total of \$1,386.20 was realized from sales during the past fiscal year. Every attempt will be made to keep sufficient quantities of the respective items on hand to make possible the filling of requisitions in as timely a manner as possible.

5. PHOTO COPIES OF DEPARTMENT AND CAMP CHARTERS—Action taken at the 94th Annual National Encampment held in Rochester, New York August 10-14, 1975 required each Camp to forward by June 30, 1976 two (2) photo copies of its Camp Charter to the Department Secretary—one (1) copy to be forwarded to National Headquarters as a permanent record and one (1) copy to be retained at the Department Headquarters. It was further required that each Department forward by June 30, 1976 to National Headquarters one (1) photo copy of the Department Charter for filing as a permanent record.

The reason for this action was indeed a sound one. It was to provide for the permanent filing and safe-keeping of the Charter copies in the Department and National Headquarters so that the copies will

be available to provide essential information in the future in case Camp property is misplaced, destroyed by fire, or some other cause, or filed or stored in places that subsequently become generally unknown.

To date, copies of 10* of a total of 19 Department Charters, 58 of a total of 169 Camp Charters* and 2 of a total of 3 National Camps-at-Large have been forwarded to National Headquarters. The cooperation of those Departments and Camps that have complied is greatly appreciated. The cooperation of those Camps and Departments which have not as yet complied is urgent and essential. Since in my judgment the purpose underlying last year's action remains sound and is in the best general interest of our Organization, I include recommendations pertinent thereto in a subsequent portion of this report.

6. RECOMMENDATIONS — In the interest of the good and general welfare of our Organization, I offer the following recommendations:

Recommendation #2: That each Department that has not already done so retain the original copy of the Department Charter in the Department files and forward no later than December 31, 1976 one (1) photo copy of the Department Charter to the National Secretary-Treasurer for the National Organization's files.

Recommendation #3: That as in the past two years authorization be granted for purchase of an "Ad" in an early issue of the Civil War Times for the purpose of continuing the advertising of our Organization and its purposes and encouraging eligible persons to apply for membership.

REPORT OF THE NATIONAL HISTORIAN

It has been a pleasure to serve as National Historian.

A young man at Oxford, Iowa, Patrick Loan, started to bring up a history of his forefathers, and he discovered his great grandfather was a Civil War veteran but could not locate where he was buried. He did find that his great grandmother was buried in a one-acre family plot in the center of a farm field near Hills, Iowa. When he went down there, he discovered the tombstone - his great grandfather's name on one side and his great grandmother's name on the other side. The condition of the cemetery was terrible. It was covered with weeds and underbrush and a farmer was using it as a hog pasture. He went to the County Supervisors and they refused to do anything about it. Someone advised him to contact the Department of Iowa, Sons of Union Veterans, which he did. Our Secretary, Jacob Kirchner, presented the problem to our Encampment at Des Moines. After discussion, I volunteered to see what could be done. I went down to inspect the cemetery with Mr. Loan. There were so many weeds and underbrush it was hard to get around, but we did find several monuments. Most of them were broken or lying on the ground. After discussing what would have to be done, we decided to arrange to meet with the Board of Supervisors of Johnson County to see about cleaning up and straightening up the monuments. In March of this year we met with them, and they agreed to do what we asked them to do. In April, I heard about an old cemetery near Bristow, Iowa, that had all but been forgotten. A group of veterans, headed by Karen Thorson, Auxiliary President of the Legion at Bristow, got busy as a Bicentennial project. They went in and cleaned out the underbrush and weeds and straightened up the monuments and head markers. The County was going to erect a new fence. I stopped by Bristow on my way to Osage to attend a funeral to see what had been done, but it was raining at the time and the lane down to the cemetery was about a quarter of a mile from the highway. I received a letter from Karen on June 8th which read as follows:

"Out at Woodland Cemetery all we really did was clean it up; that was a job in itself. It hadn't been cleaned for over 20 years. It

looked real nice Memorial Day. This was the first year for many years that services were held out there. Flags were put on graves of the veterans. We still have work to do. The County has to fix the road yet; they have gotten fence but it has to be put up yet."

On March 15th several from Iowa attended the 20th consecutive Memorial Service at Lincoln's Tomb. It was well attended.

I have been very active in Bicentennial parades, having taken part in six with one more yet to go.

REPORT OF THE NATIONAL GRAVES REGISTRATION OFFICER

(Read by National Secretary Combs) Mr. Clarence Riddell, Commander-in-Chief, and Delegates to the 95th National Encampment

Greetings:

I regret my inability to be with you at this Encampment. This in view of the fact that I have been, and still am, engaged in cleaning up and refurbishing the French-Richards Cemetery.

This work has been accomplished by Michael Reily of the Sons of the American Revolution and a member of this Organization, with the assistance of the members of Boy Scouts of America Troop #14 of Elizabeth, New Jersey. To date, 260 hours have been devoted to this project. Headstones were turned over and broken. New granite markers have been ordered for three Revolutionary veterans' graves, as well as three Civil War Veterans' graves.

Eighteen new granite markers were set on June 15th, replacing a like number in St. Mary's Cemetery, Elizabeth, New Jersey. All were Civil War Veterans.

All letters received to date have been answered and requested action taken. Attached hereto are reports covering two projects that I mentioned in my report of last year which have been completed.

I would like to point out that the Encampment of 50 years ago initiated our Program of Graves Registration Work by this Organization.

In 1946, when discharged from World War II, I became interested in this endeavor and became County Supervisor of Veterans' Interments, as per a Civil Service Examination in 1954, and have been President of the State Association of Supervisors since 1956; hence, I am interested and qualified. I have served as your National Graves Registration Officer for five terms and will be happy to serve again, if so designated.

RECOMMENDATION: That each Department advise the National Graves Registration Officer of the name and address of their designated officer and in that way and manner, we can cooperate more closely.

BE IT FURTHER RESOLVED that a copy of this Resolution honoring him be placed with pride in the Proceedings of this Encampment; and BE IT FURTHER RESOLVED that a copy of this Resolution be forwarded to Brother Lambert's widow, Past National President of the Auxiliary to Sons of Union Veterans of the Civil War, Edna S. Lambert.

THEREFORE BE IT RESOLVED, that Section 2 of Chapter IV -Sons of Veterans Reserve, be changed to read as follows:

"Effective 1 January 1977, to be eligible for membership in the Sons of Veterans Reserve, a Brother must be in good standing in the Sons of Union Veterans of the Civil War. Members of the Auxiliary to the Sons of Union Veterans of the Civil War may affiliate with subordinate units and be Identified as members of the Sons of Veterans Reserve Nurse Corps with uniform, dress and duty to that of the period of the Civil War. Members of the SVR Nurse Corps would not pay dues, administer forms or have rank structure."

BE IT FURTHER RESOLVED, that this Resolution as submitted by the undersigned, be presented for adoption at the 95th Annual National Encampment of the Sons of Union Veterans of the Civil War, August 15-18, 1976 at Columbus, Ohio.

BE IT FURTHER RESOLVED, a copy of this Resolution be forwarded to the National Organization for presentation and consideration at the forthcoming National Encampment, urging the establishment of a Special Committee for the implementation of the above and to be empowered to work in behalf of our Organization for the purpose expressed and to remain in effect as a committee until Memorial Day is returned to May 30th.

RESOLUTION NO. 7

WHEREAS, we realize that detente with the Soviet Union is of the utmost importance, we also realize that the Soviet Union has never, in any instance, lived up to an agreement, either oral or written, we must assume they have no intention of doing so in the future;

THEREFORE BE IT RESOLVED THAT WE SUPPORT:

- 1. The strengthening of our armed forces, both of land and sea, so that they may be second to none, thereby acting as a deterrent to war.
- 2. Objection to the resumption of political and trade ties with the government of Cuba, who is our avowed enemy and is actively engaged in sending mercenary armies to fight in foreign wars of Communist aggression.
- 3. Objection to the revelation of our secret agents of the C.I.A. to the world press, thereby making their job hazardous and the effect of that body almost nonexistent.

WHEREAS, we also realize that busing of school children to attain racial desegregation has not worked and has taken away the rights of the majority of the people to control the education of their children;

THEREFORE BE IT RESOLVED THAT WE SUPPORT:

- 1. The right of each community to govern its own schools, the right of each parent in that community to have a say in his child's education.
- 2. The establishment of good schools in the communities that have none. We believe that no citizen of this country should be deprived of the best possible education.
- 3. A halt to the lowering of our standards of education, and the building of more trade schools, so that those who do not meet academic requirements may have a chance for a meaningful occupation through trade schools.
- 4. The re-establishment of discipline in our schools by giving the right of disciplinary action to proper school authorities.

WHEREAS, we have in the past taken a firm stand against a change in the 1903 treaty with the Government of Panama, concerning the Panama Canal, we realize that the changing times and the lessening of importance of the Canal to world commerce and the importance of

keeping a good relationship with the governments of South and Central America has made the 1903 treaty obsolete;

THEREFORE BE IT RESOLVED THAT WE SUPPORT:

- 1. The negotiating of a new Panama Canal Treaty on a fair partnership basis with the Government of Panama.
- 2. The United States Government must maintain the right to regulate the traffic of ships through the Canal.
 - 3. The United States must be allowed to maintain the required per-

sonnel to operate, maintain and defend the Canal.

BE IT ALSO RESOLVED, in this Bicentennial Year, that we urge all Americans to stop this continual self-persecution of themselves and their Country, and let them adhere to the principles on which this Country was founded.

WHEREAS, there presently exists in the City of Waterloo, Iowa, a beautiful Grand Army of the Republic of the Civil War building which

has a beautiful site overlooking the Cedar River; and

WHEREAS, said building presently houses many relics and items pertaining to the Grand Army of the Republic of the Civil War, and which is believed to be the only Memorial Building presently existing in the United States which was built and dedicated to the memory of the Armed Forces of the Civil War;

NOW, THEREFORE, BE IT RESOLVED that the Sons of Union Veterans of the Civil War respectfully petition that the present Memorial Hall constructed by and built for the Grand Army of the Republic of the Civil War be declared a National Shrine to the memory of the Soldiers of the North in the conflict known as the Civil War.

DISTRICT OF COLUMBIA REPRESENTATIVE SONS OF UNION VETERANS OF THE CIVIL WAR

RESOLUTION NO. 9

WHEREAS, continued pressure of legal and illegal immigration into the United States, continuing to erode our living standards; and WHEREAS there is the standards illegal

WHEREAS, there is no plausible estimate of the number of illegal aliens in the United States and no official records are kept of the number of emigrants from the United States: and

WHEREAS, there are serious proposals to give "amnesty" to substantial numbers of such immigrants and there are at this time no criminal penalties against known employment of illegal aliens and it appears many temporary entrants to the United States simply remain and become permanent illegal immigrants; and

WHEREAS, there are various ways in which the process of issuing of Social Security Cards needs to be made more secure to prevent issuance to illegal aliens;

THEREFORE BE IT RESOLVED that we go on record as being unalterably opposed to the concept of "amnesty" to illegal immigrants and in favor of Legislation imposing sanctions on employers of illegal aliens, such as House Resolution 982 and House Resolution 257, which should be sufficient.

WHEREAS, Legislation should be passed which will permit more careful scrutiny of applicants for temporary visas;

THEREFORE BE IT RESOLVED that we are in favor of the provisions of House Resolution 3737 that requires specific alien and citizenship information be provided prior to the issuance of a Social Security Card, that tamperproof Social Security Cards be so marked, that cards issued to aliens who are not permitted to work be so marked also, that cards be presented by prospective employees to employers before obtaining employment, and that criminal penalties be provided for employers who violate its provisions.

WHEREAS, the Battle of Fort Stevens was the only battle of the Civil War that was fought within the District of Columbia and the only battle at which a President was present; and

WHEREAS, part of the Fort is preserved in the memory of President Lincoln and the soldiers who defended the Capital, forty-two of whom lost their lives in that battle; and

WHEREAS, the rest of the Fort is fastly deteriorating because of

its use by children as an unofficial playground;

BE IT RESOLVED that the National Capital Regional Park Service be requested to protect the area around the Fort in general as it was when restored twenty-five years ago; and

BE IT FURTHER RESOLVED that this area also be given the same care that would be given to any great monument to preserve the dignity and respect: and

BE IT FURTHER RESOLVED that a suitable enclosure be erected that will encourage respect from visitors who come to observe the Fort that defended the Capital against General Early's attack; and

BE IT FURTHER RESOLVED that the National Capital Regional Park Service be requested to place markers or signs designating that the Fort is under their protection and that these markers or signs be protected from theft or vandalism such as was the fate of markers and signs placed there in the past.

WHEREAS, the National Archives and the Library of Congress have both been vandalized and had records stolen from them, some of which pertained to the Civil War; and

WHEREAS, pages have been torn from some books and documents;

and

WHEREAS, most of these crimes have never been solved and the

criminals apprehended;

BE IT RESOLVED that closer security be maintained at these and other public buildings which house the records and historical data of our great Country and that positive action be taken to preserve the historical records and artifacts of the United States and its citizens.

simultaneously defined.

New Section 3 - The National Committees shall consist of five (5) members of the Sons of Union Veterans of the Civil War, except the Membership Committee which shall consist of the Senior Vice Commander-in-Chief as Chairman and a member from each Department and Camp-at-Large. All shall be in good standing in their respective Camps.

New Section 4 - (Insert herein, old Section 3 as appears on Pages

33 & 34).

Chapter II — Page 29 — Article IV — Officers:

Immediately following the comma (,) in the second (2nd) line, insert: "all National Committees", causing the entire section to read: On assuming office, the Commander-in-Chief shall appoint all other officers, all National Committees and may appoint such aides as he may deem necessary, for such services as he may designate.

As a leader in a nationally respected organization, you may be interested in the enclosed copy of legislation I recently introduced in the United States House of Representatives. (H. R. 13215)

This legislation would authorize the Secretary of Defense to inter the remains of an Unknown American Revolutionary War Serviceman near the Amphitheater at Arlington National Cemetery. As you know, there are presently entombed near the Amphitheater the remains of three Unknown Americans representing those who served in World War I, World War II, and the Korean Conflict. Additionally, Congress has authorized the entombment of an Unknown American from the Vietnam Fra.

In this 200th Anniversary of our nation's birth, no unknown representative of the American Continental Army, Navy or Marine Corps is interred at Arlington, yet without the sacrifice of those who served the American cause 200 years ago, there would be no Bicentennial Year. This seems to me to be most appropriate legislation for this Bicentennial Year.

I hope that I can count on the support of you and your members in seeing this proposal come to fruition by whatever expressions of interest you and they can direct to the Committee and to their own Representatives.

Commander-In-Chief Riddell: Thank you, Brother Combs, for reading the Resolutions and Communications. We will now continue with the Report of the National Military Affairs Committee.

Past Commander-In-Chief Norman R. Furman: Thank you, Commander-in-Chief.

REPORT OF THE NATIONAL MILITARY AFFAIRS COMMITTEE

The following Regulation was APPROVED by the National Encampment of the Sons of Union Veterans of the Civil War at Palm Springs, California, August 5-9, 1973. (Page 53, Ninety-second Annual National Encampment Proceedings.)

CHAPTER IV SONS OF VETERANS RESERVE

SECTION 1. The Sons of Veterans Reserve shall constitute the authorized military feature of the Order. It shall include all military bodies of the Order with the exception that Camps may maintain an independent military organization as a Camp Guard or unit for parade and service under the auspices of the Camp with which such unit is associated.

SECTION 2. Effective 1 January 1975, to be eligible for membership in the Sons of Veterans Reserve a person shall be a member of the Sons of Union Veterans of the Civil War, the Auxiliary to the Sons of Union Veterans, the Daughters of Union Veterans of the Civil War 1861-1865, the Ladies of the Grand Army of the Republic, or the Woman's Relief Corps.

SECTION 3. The Sons of Veterans Reserve as it now exists or may hereafter be organized shall be governed solely, except as herein stated, by the rules and regulations adopted or subsequently modified or amended by the National Military Affairs Committee upon approval by the National Organization, Sons of Union Veterans of the Civil War. Such rules and regulations shall not be inconsistent with National or State laws or the Constitution, Regulations or general welfare of the Order.

SECTION 4. The combined units of the Reserve shall be known as the National Military Department, Sons of Veterans Reserve. The National Military Department shall be divided into Districts geographically for administrative and command purposes. There shall be no military rank in the SVR higher than a Brigadier General.

SECTION 5. The uniform and regulations shall conform as nearly as practicable to the less advanced U. S. Army regulations, preferably nearer to those of the Union Army during the period of the Civil War.

RECOMMENDATION NO. 1: I recommend the addition of the following, to clarify this Regulation:

SECTION 6. The NATIONAL MILITARY AFFAIRS COMMITTEE shall be composed of seven (7) members in good standing in the Sons of Veterans Reserve, the Chairman to be appointed by the Commander-in-Chief, and the additional six (6) members to be appointed by the Chairman, National Military Affairs Committee, with recommendations by the Commander-in-Chief, Sons of Union Veterans of the Civil War.

(This was a recommendation of Colonel O. G. McPherson when he was Chairman of the National Military Affairs Committee. It was APPROVED by the National Encampment of the Sons of Union Veterans of the Civil War, and was made a part of the SVR Regulations. However, it was NOT made a part of SUVCW Regulations, which explains the present problem.)

Your National Military Affairs Committee has completely revised the Regulations of the Sons of Veterans Reserve to conform to SUVCW Regulations. They will be reviewed annually, and amended if necessary, to keep them up to date.

RECOMMENDATION NO. 2: Due to the rise in Postal Rates, I recommend the amount given to the National Military Department to partly cover operating costs be increased to One Hundred Fifty (\$150.00) Dollars.

A further report on the operation of the National Military Department will be rendered by the Commanding Officer, National Military Department, Sons of Veterans Reserve.

Norman R. Furman, Chairman National Military Affairs Committee

After comments by Past Commander-in-Chief LeRoy Stoudt as to the correctness of the Report of the National Military Affairs Committee to a certain degree, the substance of the Committee's Recommendation No. 1, and the varied interpretations that have been made regarding numbers of members on Committees; and after a review of the past by the Chairman of the Military Affairs Committee, Brother Furman withdrew Recommendation No. 1 of his Report.

Past Commander-in-Chief Frank M. Heacock, Sr.: I move you that the report of the Military Affairs Committee, as presented, less the portion that has been withdrawn, be accepted; and that the matter referring to the Committee's increased request for expenditures (\$150.00 instead of \$100.00) be referred to the Budget Committee of the Council of Administration for consideration.

The motion was seconded by many and passed.

Past Commander-in-Chief Heacock: Commander-in-Chief, I would like to ask through you to the Chairman of the Committee on Military Affairs: Is there anything additional in your report about removal of an officer?

Past Commander-in-Chief Furman: No, there isn't.

Past Commander-in-Chief Heacock: Is there nothing about a court martial or the removal from office of an officer for conduct unbecoming an officer?

Past Commander-in-Chief C. LeRoy Stoudt then rose on a point of order about discussing in this Encampment a matter about an officer of the Sons of Veterans Reserve, since the matter was, in his judgment, one for the SVR to handle and should be handled by that body. Brother Stoudt was sustained by the Commander-in-Chief.

Commander-in-Chief Riddell: May we have the Report of the Commanding Officer of the National Military Department, SVR, at this time?

Brig. Gen. Chester S. Shriver then read the following formal report and also the financial report of Adjutant General Charles H. Lilienthal, 1 Lt., SVR.

REPORT OF THE COMMANDING OFFICER NATIONAL MILITARY DEPARTMENT SONS OF VETERANS RESERVE

Brother Clarence J. Riddell, Commander-in-Chief Brother Norman R. Furman, Chairman, NMAC Officers and Delegates Assembled 95th Annual National Encampment

Sons of Union Veterans of the Civil War

It is my honor and pleasure to submit this formal report as your Commanding Officer of the Sons of Veterans Reserve of the National Military Department of our Order to this, the 95th annual Encampment of our Order and the year of the 200th Anniversary of our Nation.

Within the scope of this report, you will note a review of the past year's service of the Sons of Veterans Reserve that has credited our Organization with attracting membership and to provide activity for our Brothers who choose to wear the uniform in the representation of the only male Organization recognized by the Grand Army of the Republic. This report also notes the general programs of events during the past fiscal year and proposes the future guidelines for its continued successes in a capacity where they can best (sic) our parent Organization. To provide this information to you, may I note the following categories:

HISTORY

The foundation of the Sons of Veterans Reserve is based in the Pennsylvania Brigade where enlistments and leadership were first recognized and from which many Departments of the Sons of Union Veterans of the Civil War were represented with SVR Units attached. Formed in 1881, we must never forget that during the years prior to 1960, this Brigade — known today as The First Brigade, provided assistance to the Comrades of the Grand Army of the Republic. Their training in the field and participation in ceremonies on Memorial Day provided the bulwark of the National Military Department of today. Times change, and your uniformed representation, through the National Organization of the Sons of Union Veterans' understanding and approval, has accepted it with your maintaining of our historic image.

PURPOSE

To assist our Parent Order; encourage memberships individually and dual Camp/Unit affiliation; observe Memorial Day, Flag Day, Veterans Day, Remembrance Day; as well as assisting Departments at area programs.

PROGRAMS AND PARTICIPATION

During the past fiscal year ending 30 June 1976, the Sons of Veterans Reserve was issued a Charter of Affiliation and Bicentennial Flag upon being approved as a Bicentennial Organization from their Headquarters in Washington, D. C. The 6th SVR National Encampment was held in Ravenna, Ohio with over 800 registered participants. The New England Regional observed a special Civil War observance program in August 1975, with the SVR as Host. Other outstanding observances were the 19th annual GAR Remembrance Day Parade and Services in Gettysburg on November 16, 1975 with 400 uniformed participants, observances of Memorial Day over the United States where the Sons of Union Veterans and Sons of Veterans Reserve were located. Although a few days beyond the close of the fiscal year, mention must be made of the observance of the 113th Anniversary of the Battle of Gettysburg in connection with the 200th Anniversary of the United States of America at the Gettysburg Battlefield where 1850 registered uniformed "troops" participated in the "Battle of Pickett's Charge" and "Farnsworth's Charge". The SVR was selected as the Host for the two-year planning and execution Army. Here an estimated 40,000 witnessed the weekend events plus millions seeing the action live on CBS-TV News coverage. The result was appreciated when individuals have approached Officers and Unit Commanders requesting SUV/SVR membership.

STRUCTURE OF OPERATIONS

Governed by the National Military Affairs Committee of our Parent Order, in uniformity and training as near as practicable to that of the Civil War 1861-1865. Commander-in-Chief Riddell expressed his confidence and approval in Gettysburg on the occasions of the GAR Remembrance Day activities and Memorial Day 1976, that he was pleased with the programs of the SVR Operations. Col. Furman and the National Military Affairs Committee aided in seeking updated provisions to be added or changed in the SVR Standard Operations Procedures. As in the past years of the SVR, the past year provided a high standard of credit to our Order. Unit problems and individual problems are few and have been acted upon this past year and are experienced each year concerning lack of communication, following chain of commands or disrespect for the Orders that govern.

LEADERSHIP

Members of the National Staff, District Staffs and Brigade Staffs devote much effort and time in the assignments they are appointed or elected to serve. These men are of varied professions but the Commanding Officer is confident that each man is of the highest degree of being dedicated to his ancestry that qualifies him for membership. These men have no desires for personal gains but rather to assist and help others. The enlisted men are trained to respect their heritage and they seek planned activity to retain their interest. The Adjutant General's Report, which accompanies this Report, shows 532 SVR members in good standing. 27 Officers are in Assigned Command or Staff Appointments which leaves a ratio of one officer to eleven enlisted men. Each man serving on the National Staff deserves the highest of credit for his untiring concern to serve a certain assignment.

REGULATIONS

Governed by the National Military Affairs Committee under the approval of the Commander-in-Chief and/or the National Organization, SUVCW, to establish guidelines for the qualifications, formation and operation of the Military — in respect for chain of command, discipline, and service to the Parent Order.

FUTURE

That only a Son of a Union Veteran may be a member of the Sons of Veterans Reserve

Service to our Parent Order from which authorized

To work together - we stregthen our membership

To choose independency we weaken our links

To retain our image on the highest standards

To observe Memorial Day as the most sacred day to honor our Nation's Dead

To train and discipline lineal descendants that portrayal of a phase of Civil War History is an honor to those Grand Army Veterans who served them.

In closing this formal report, I am sure some of you here assembled may say it was a lengthy report. But remember that these men who choose to sacrifice their time in their respective Camp areas have accepted the proud duty and obligation of serving our membership in the Military Department. To you, Commander-in-Chief, may I convey their thanks and appreciation for having served under your leadership. Also, my personal congratulations for having a most successful year. To your successor — we pledge our support.

Both reports were well-received.

Past Commander-in-Chief Heacock: Commander-in-Chief, may I ask the Commanding General: What is the difference between a sponsoring group and a host group?

Brig. Gen. Shriver: A sponsor is an Organization, such as the Lion's Club, an American Legion Post, a Travel Agency, etc. who provide for the financial support for any event, no matter how large or how small. A host is usually a local unit which does the planning and execution of the event. The sponsor always provides the liability insurance for that event, normally this covers a three-day period.

Past Commander-in-Chief Heacock: I move that the Commanding General's Report be adopted with commendation and made a part of the Proceedings of this Encampment

The motion was seconded by many and approved.

The Commander-in-Chief declared a recess until 9:00 a.m. Tuesday, August 17th.

The Bible was closed by the National Chaplain, Richard E. Wyman-

TUESDAY MORNING SESSION

August 17, 1976 9:10 a.m.

National Chaplain Wyman opened the Bible.

Commander-In-Chlef Riddell: We will begin this morning's Session with the reading of the Reports of the various Committees. Brother Rippey, are you ready with the report of the Committee on Constitution and Regulations?

Past Commander-in-Chief Rippey: I wish at this time to thank all of you for your contributions. Regarding the Constitution, no changes were submitted; regarding the Regulations, there are several:

1. With reference to the Resolution presented by three of our Past Commanders-in-Chief, Brothers Shriver, Stark and Heacock, that a Sons of Veterans Reserve member must be a member of the Sons of Union Veterans of the Civil War and that females may affiliate as nurses attached to a unit as that unit's responsibility. Your Committee approves this Resolution.

(Committee Report concurred with)

Past Commander-in-Chief Heacock: I move you that where there are no objections the report of the Committee be concurred with. Seconded by many and carried.

2. The Resolution of the Wisconsin Department requesting deletion of the qualification that requires a member to have served as a Camp Commander in order to be eligible for election to the office of Department Commander is not approved by your Committee.

(Committee Report concurred with)

3. No action was taken by your Committee on the Resolution of the Ohio Department regarding eligibility to membership, since this Resolution was not published forty days in advance in The BANNER. It should be printed in the October 1976 issue of The BANNER and brought up in 1977 by the Committee on Constitution and Regulations.

(Committee Report concurred with)

4. Your Committee has approved the request from the Pennsylvania Department for a change in the Constitution and Regulations as they pertain to Standing Committees.

(Committee Report concurred with)

Past Commander-in-Chief Stoudt: I question that all Committees have five members. I refer to the National Encampment Site Committee where three have served for sixteen years and only one, the chairman, does all the work since he is directly responsible for the Hotel and the Host Committees. In most cases the chairman does the work.

Past Commander-in-Chief Rippey: The Committee on Constitution and Regulations concurs with the request that the Department Commanders consider the matter of Department Encampment coordination

so two or more will not be held on the same dates.

(Committee Report concurred with)

Following a discussion regarding instances where our Constitution and Regulations do not agree with our Congressional Charter, several delegates asked if we would have a Constitutional Convention in 1977, and Past Commander-in-Chief Rippey explained that the Constitution

and Regulations MUST conform to the Congressional Charter and if any Department wishes to submit an Amendment for consideration at the National Encampment the Department may call a meeting of the Department Council to draw up and submit Amendments, or handle any other business.

Past Commander-in-Chief Heacock: There has been no disposition of the Committee on Constitution and Regulations and this Report as a whole. I was going to make a motion that their report be accepted; however, in view of the fact that there is still hanging fire the provision for the Encampment Site Coordinator which should be included under Chapter III, Article IV, Section 1, on page 29 of the 1956 edition of the Constitution and Regulations, I would move you that this matter be referred to the Committee on Constitution and Regulations that they may submit a supplementary report at their convenience to this Encampment. I make that as a motion. Seconded by National Patriotic Instructor Frank Clark. Motion carried.

Past Commander-in-Chlef Heacock: I move also that the incoming Committee on Constitution and Regulations be authorized to prepare in its entirety a coordinated, properly written revision of the Constitution and Regulations with all the little step-children hanging fire so that it will coordinate with the Act of Congress, that it be submitted at next year's Encampment, and that the Committee be authorized to have this, when it is completed, prepared in mimeographed form so that each member of the Encampment shall have a copy of it for their consideration, the expense of which shall be borne by this National Organization. I make that as a motion. Seconded by Past Commander-in-Chief Allen Howland. Motion carried.

REPORT OF THE COMMITTEE ON LEGISLATION

(In the absence of the Chairman of this Committee, the Report was read by National Secretary Combs.)

TO: Clarence J. Riddell, Commander-in-Chief

Greetings. Your committee, appointed to study legislation of interest to our Order, begs leave to submit the following Report to you and thru you to the officers and delegates attending the 95th Annual Encampment. Your chairman would like to take this opportunity to acknowledge the unstinting and continued cooperation he has received from Brother Fred H. Combs, Jr., in printing the interim reports each quarter in The Banner.

REVISION OF U. S. FLAG CODE — As our Nation celebrates its Bicentennial, we can report that the 94th Congress recently enacted a new Flag Code thru a series of far-reaching amendments to existing law. Senate Jt. Resolution 49 passed the Senate on May 10, 1976, on a voice vote, and passed the House of Representatives with amendments on June 21 on a roll-call vote of 352 to 0. The following day, June 22, the Senate agreed with the provisions in the revised bill and sent the measure to President Ford for signature.

The specific provisions of Senate Jt. Resolution 49 were enumerated in detail in our Annual Report for 1974-75 as found on pages 50-53 of the Proceedings of the 1975 National Encampment and will not be repeated here. For the most part, the amendments to Senate Jt. Resolution 49 sought by the House were technical in nature and simply clarified ambiguous language in the measure. The one amendment of sub-

stance deleted from the Resolution a provision that would have created a National Flag Commission that would have been empowered to make further revisions in the Flag Code. In a letter to your chairman, Rep. Don Edwards of California, chairman of the subcommittee that considered the legislation, said, "I believe it is Congress' obligation to make the changes when needed, and organizations such as yours will keep us advised as these modifications become necessary." In debate on the House floor, Rep. Edwards observed that he saw no need to enlarge the federal establishment with another agency when the Congress itself was better able to do the work required.

In brief, the newly revised Flag Code modernizes existing law by recognizing acceptable changes in flag etiquette, clarifles previously ambiguous passages, deletes obsolete provisions, and permits the Congress

to retain its authority over future revisions.

It is important to remember that the Flag Code serves as a guide for all of us and should be so considered when we display our flag. Regardless of the law on the subject, there can be no substitute for the virtues of respect and common sense.

STATUS OF MONDAY HOLIDAY LEGISLATION — As reported in the January 1976 issue of The Banner, the Congress passed and President Ford signed Public Law 94-97 which returns the federal observance of Veterans Day to November 11 beginning in 1978. In that column we reported on the debate which accompanied passage of the measure in the House of Representatives. The floor manager of the bill, Rcp. Patricia Schroeder of Colorado, pointedly said that her subcommittee was in no mood to recommend further changes in the Monday Holiday Act and admitted that Congress simply felt obliged to follow the lead of some 46 States which had previously returned Veterans Day to its original date within their jurisdictions. Rep. David Henderson of North Carolina, chairman of the Post Office and Civil Service Committee of which Rep. Schroeder's subcommittee is a part, echoed her remarks and cited Memorial Day as a holiday that should be observed on a Monday as the law now provides.

To date your chairman can detect no evidence that Congress is willing to consider the return of Memorial Day to May 30 despite the number of bills and resolutions that have been introduced to accomplish that objective. The House bills are buried in Rep. Schroeder's subcommittee and the lone Senate bill resides in the Judiciary Committee of the Upper Chamber. For the record, there have been eleven bills and four joint resolutions introduced in the House and one bill in the Senate. For your reference, the numbers on the House bills are H. R. 119, 235, 1728, 1972, 2248, 2606, 3331, 4533, 4793, 7749, and 11104. The House Jt. Resolutions are H. J. R. 262, 330, 825, and 852; the Senate

bill is S. 429.

At the State level, your chairman is aware of activity on the part of some States to seek the return of Memorial Day to May 30 within their borders. In the States of Delaware, New Jersey, and Wisconsin, legislation to accomplish this end passed one of the houses of each State's legislature but was not reported or failed of passage in the other house.

In States that do observe May 30 as Memorial Day, Illinois and New Hampshire for example, efforts to bring their laws into conformity with the federal Monday Holiday Act have been half-hearted at best this year. Perhaps this is because according to the calendar, Memorial Day was uniformly observed this year on Monday, May 31 (May 30th hav-

ing fallen on a Sunday) and in 1977 the Nation will again unite this time on May 30, as Memorial Day. Regardless of the quirks in the calendar, however, proponents of the May 30 date must not relax their efforts or assume that the issue is dormant.

DESIGNATION OF SPECIAL DATES OF OBSERVANCE — On April 13, 1976, President Ford signed Public Law 94-263 which designates that date as "Thomas Jefferson Day" in honor of our 3rd President's birth and his part in framing the Declaration of Independence.

On April 19, 1976, President Ford signed Public Law 94-270 which designates "National Family Week" to include Thanksgiving Day.

Other bills would recognize Flag Day, June 14, and Constitution Day, September 17, as legal public holidays and give special recognition to the birthdays of Susan B. Anthony and Martin Luther King, Jr. These measures have not been acted upon in either house of Congress.

OTHER ITEMS OF LEGISLATION OF INTEREST — On July 4, 1976, President Ford signed into law the provisions of H. R. 5621 which provide for the transfer of Valley Forge State Park to the federal government to be known as Valley Forge National Historic Site and for the modest enlargement of that site. The success of that measure this year can be traced to the Bicentennial and crowned the long-term efforts of Sen. Hugh Scott and Rep. Richard T. Schulze, both of Pennsylvania. In the Senate, an effort by Sen. James McClure of Idaho to add an 869 acre area known as the Chesterbrook section to the park site was defeated on the basis that its cost was excessive — estimated at \$24 million — and that adding that costly amendment to the legislation could endanger the success of the original measure. With the passage of the bill, the National Park Service assumed responsibility for the day-to-day management and interpretation of the existing park.

Rep. Schulze has also introduced H. R. 12962 which would provide for the burial of an unknown soldier from the Revolutionary War at Arlington National Cemetery. That bill has been referred to the Committee on Veterans Affairs and reportedly has received the preliminary endorsement of at least 208 House members. In another action related to the celebration of the Bicentennial, Sen. William Scott of Virginia has introduced S. 431 that would establish the boyhood home of George Washington located at Ferry Farm near Fredericksburg, Virginia, as a National Historic Site.

The memory of our 16th President, Abraham Lincoln, has also been the subject of legislation in the 94th Congress. By terms of Public Law 94-208 approved by the President on February 4, 1976, the United States will present a statue of the Emancipator to Israel with funds donated by Leon and Ruth Gildesgame of Mount Kisco, New York. Senate Bil 64 would add the names of the States of Alaska and Hawaii to the Lincoln National Memorial. This measure passed the Senate on April 6, 1976, and is presently in the House Interior and Insular Affairs Committee.

Of particular interest to our Order is S.91 that would authorize the expansion of the Antietam National Battlefield Site from about 1,100 acres to a total of 3,260 acres. The enlargement would include not only the actual battlefield site but also an environmental protection zone as a means of preserving the largely rural scenery around the battlefield and along lower Antietam Creek. Introduced by Maryland's Senators, Charles Mathias and J. Glenn Beall, S.91 has been referred to the Senate Interior and Insular Affairs Committee. The measure is similar

to bills introduced in the previous two Congresses but takes into consideration the rights of owners of residential and agricultural properties in the area. As Sen. Mathias observed when the bill was introduced in January of 1975, "It is becoming increasingly clear that the survival of the Antietam Battlefield in the face of encroaching development can no longer be entrusted purely to chance or private action." He also reminded his colleagues that a number of points of interest associated with the battle are presently outside the bounds of the federally controlled site.

RECOMMENDATIONS FOR 1976-77 — In recognition of some of the issues discussed but unresolved in this Report, the following recommendations are made on behalf of the Committee on Legislation:

Recommendation #1: That our Order petition Congress to give favorable consideration to proposals before it to return the observance of Memorial Day to May 30 and to recognize that date as a federal holiday.

Recommendation #2: That our National Organization urge its Departments to work within the States in which they are located to seek legislation to obtain State recognition of May 30 as Memorial Day and to observe it as a legal public holiday.

Recommendation #3: That Congress be urged to give full and favorable consideration to the enlargement and enhancement of the Antietam National Battlefield Site according to the provisions of S.91.

It is a pleasure for your chairman to acknowledge the support and encouragement given him by his colleagues on the committee: C. Leroy Stoudt, Cleon E. Heald, Richard Greenwalt, and the Rev. Alvin Lee Baker. He also wishes to acknowledge with grateful thanks the cooperation furnished by Brother Frank M. Heacock. It has been an honor and a personal privilege to serve our Commander-inChief in this capacity.

FOR THE COMMITTEE

Past Commander-in-Chief Heacock: I move you that the Report of the National Legislative Committee be received and that the recommendations be taken up seriatim.

Motion seconded by Brother Rule and passed unanimously.

Motion by Past Commander-in-Chief Heacock, seconded by Past Department Commander Rule, that where there be no objections, the Recommendations be accepted by the sound of the gavel. Motion carried, There were no objections to Recommendations No. 1, No. 2, or No. 3.

REPORT OF THE COMMITTEE ON MEMBERSHIP

Past Department Commander Harold T. Beilby, Chairman, stated that he had no report to read at this Encampment.

REPORT OF THE COMMITTEE ON AMERICANISM AND EDUCATION

To the Officers and Members of the Ninety-Fifth Annual Encampment of the Sons of Union Veterans of the Civil War

As chairman of the Committee on Americanism and Education, I submit the following report. First, let me tell you I wrote to all the members of the committee to get their report on what they had been

doing to promote Americanism and Education in their area. As mem. bers of the committee I feel they should have a chance to voice their views. As I start this report, the only one I have heard from is Past Department Commander Thomas A. Monahan of Philadelphia, Penn. sylvania. Thank you, Tom.

In the State of New Hampshire, the first act of our newly elected governor, Meldrim Thomson, was to put Memorial Day back to May 30th as it should be. Our Governor is always preaching Americanism. and goes into the schools regularly to tell the students about our heritage and discuss the Constitution of New Hampshire with them. He has been to many of the schools in New Hampshire. Our Governor has been to three out of four of our Department Encampments held since he was elected four years ago. This shows you that he does have an interest in our kind of people.

As a member of the school budget committee for the last two years, I have had a chance to work for better education in our schools. This is a good training ground for knowing what the schools are doing to promote Americanism and to get an insight into the kinds of courses being offered in our schools. There is much work to be done in this area as our schools are not turning out well-rounded students. There are too many courses being offered that have nothing to do with basic education, such as English, math and science. They teach, I prefer to call it "indoctrinate", too many courses on the social aspect of life which is better done in our churches and homes. Too many of these courses have no text books so it is nothing but a "bull" session on unamerican ways of life.

The administrators of our schools, in my opinion, accept too many of these government sponsored programs which in most instances add nothing to education. It is simply another way of getting control of our schools. A good example of this is the busing situation in the Boston area of Massachusetts. It is so bad that most of the teacher's time is spent on other things than teaching. This has been going on for two years. Finally the courts have taken over the running of the schools. This means government control. So many times I have heard educators say, "Oh, the government will never take over control of our schools." When the government puts money into anything, they are going to keep their fingers in the pie.

There is very little Civil War history taught at the high school level. In this area Civil War history is taught in the fifth grade. How much of it that is taught depends a great deal upon the teacher teaching it. The ones, such as my wife, that have a great interest in the Civil War teach a thorough course; and those that don't, skim over it. This also applies to Americanism. The flag salute is given in most schools in area. However, other than that, the teachers that are real Americans, the ones that feel America is great, do a good job of teaching America. canism while the others stress everything that is wrong with America.

John W. Spaulding Camp #38 tries to have programs that stress the Civil War and Americanism. We have programs on flag etiquette. There are a great many people that do not know how to display the flag. I have seen flags displayed wrong in veteran's halls. One man insists he is right seen flags displayed wrong in veteran's halls. insists he is right so the flag is still displayed wrong. Our last meeting we had a man give we had a man give us a talk on the men from Milford and the part they played in the Civil War, also the responsibility of the town in taking care of danned and the country of the town in taking care of dependents.

We have attended several Bicentennial parades and you see very few people stand and salute the flag as it is carried by. I have talked on this at gatherings I have attended.

The following is a report on what is being done in the area of Philadelphia, Pennsylvania as reported by Thomas A. Monahan, Past

Department Commander.

"Philadelphia Camp #200 has been very active in restoring the burial site of General Winfield S. Hancock. About a year ago it was discovered that the tomb of this Civil War General was being vandalized and Camp #200 set out to have it restored. Since General Hancock was the first Commander-in-Chief of the Loyal Legion, we contacted them and they kindly donated. Our Memorial Day services were held this year at General Hancock's resting place with a large turnout. The final dedication is being planned for sometime in October.

"Pennsylvania is still striving to have Memorial Day returned to May 30th. We have urged all members to contact their Senators and

Congressmen.

"Pennsylvania is also responsible for the Remembrance Day in Gettysburg and we feel the committee should be complimented on the large attendance it is creating for this occasion. Every year it becomes a bigger and better affair than the year before. At this dinner in recent years our Scholarship has been given to a student of Gettysburg College (Pennsylvania) by the Commander-in-Chief.

"Pennsylvania was very busy and entertained many, many visitors at Independence Hall in Philadelphia, where everyone goes to touch the Liberty Bell. This year the bell rang out on the 4th of July with President Ford and Queen Elizabeth of England each visiting the Bell.

"Our Pennsylvania schools are teaching patriotism and salute the flag and sing the Star Spangled Banner each day. This year especially, each school — elementary, junior high and high — had a Bicentennial month where they prepared all year special assemblies and fairs."

To my commander in chief, I wish for you a most successful and

harmonious convention.

He represented our Order with dignity, and his presence symbolized the importance our Order attaches to the memory of our 16th President. Bro. Riddell was joined by Col. Joseph B. - 3. This year's ceremony was unique in that all sitting National Presidents of the organizations allied with the Grand Army of the Re public were present. They were as follows: Caroline E. - 4. Under the able command of Capt. Robert M. Graham, a co-chairman of the ceremony, the 114th Regt., Ill. Vol. Inf. (Reactivated) and official honor guard for the ceremony, provided escorts for the wreathbearers.

But thru careful and prudent management, we will endeavor to keep within the limits of our basic allocation.

Also, the Pennsylvania Department Commander and four Department Presidents in attendance along with many other past and present out-of-state National and Department Officers. Brig. Gen. Wilfred A. Morgan, Ret. USAR of Altoona, Pa. was the speaker of the day.

However, the list of expenses given to me by National Secretary-Treasurer Combs did list one other item of \$13.00 for the Gettysburg College representative and the College Student who received the Scholarship Award at the annual November dinner. This expense is not directly related costwise to the afternoon G.A.R. Remembrance Day Program or

the committee. However, since the two affairs are held on the same day, if the \$13.00 item is included, the total expenditures would come to \$134.85.

As most of you men know, this program is held in the Gettysburg National Military Park Visitors Center and at the Woolson Monument nearby. Over the years with changes of personnel on the Park Service Staff, some of the rules have changed along with the conditions for holding this program. With the gathering together of parade participants and other people in attendance, we are now somewhat cramped for space. Also, the Park Service now definitely frowns upon the carrying of unloaded firearms, as carried by the uniformed personnel. We are granted the use of the auditorium for the program, between the showing of a film by the Park Service.

Having been an appointed member of six of the last seven committees, and having worked on all seven programs. I would like to offer some suggestions. The front of the printed program states, "Sponsored by the National Organization Sons of Union Veterans of the Civil War and Gettysburg Camp No. 112, Sons of Union Veterans of the Civil War, for the Nation, etc."

The Gettysburg Camp now has over thirty (30) members who live in the town and/or within a few miles radius. Through some means, eight to ten of these members should be brought together and given the facts and a full picture of this program and activities associated with it. Authority should be delegated and then have the team of members handle this annual program. Secondly, two or three of the Camp members should be appointed by the Commander-in-Chief, with the understanding that other Camp members will function on the committee. Thirdly, the appointments should be made at the National Encampment before it closes. This way, the committee can get started immediately. Waiting for the appointments to be announced in the October issue of The BANNER, is six or more weeks lost after the National Encampment.

It has been my sorry experience to learn of my appointment to the Remembrance Day Committee from the October issue of The BANNER, during the last few years. In fact, following the National Encampment the Commander-in-Chief should write follow-up letters to the appointed committee members.

The Remembrance Day Program in November is a "must attend" affair by many of our members and the Allied Organizations. I'm sure that the Gettysburg Camp can come through and handle the details for these annual programs. With a "team concept" in operation, I see success.

Recommendation: That the Council of Administration allocate an amount not less than \$175.00 for the 1976 G.A.R. Remembrance Day Committee.

If any Department returns home - Sons or Ladies - and can interest the Department in hosting a National Encampment, please submit in writing to me at your earliest possible convenience a statement of your interest.

Past Commander-in-Chief Heacock: I move that this Report be ac-

cepted. Seconded by many. Motion carried.

A motion was then made by Brother Heacock, seconded by Brother Rule, and carried, that a telegram be sent to the Woman's Relief Corps in Convention assembled at Cedar City, Iowa expressing our best wishes for the success of their Encampment.

Sr. Vice Commander-In-Chief Wolz: The Audit Committee of the Council of Administration has checked the report of the Certified Public Accountant and the Statistical Reports of the National Secretary-Treasurer and has accepted them as being true and correct. On a motion by Brother Heacock, seconded by many, the report of the Audit Committee was accepted.

Commander-in-Chief Riddell: I will declare a recess at this time

and ask all Brothers to return promptly at 1:30 p.m.

Rule, all of Massachusetts; and Brother Charles Bournstein of the Department of Illinois, who is a direct son of a Union Veteran, was recognized for his sixty-six years as a member of the Sons.

Commander-in-Chief Riddell: Is there any new business to come

before the Encampment at this time?

Brother Heacock presented the matter of the Hancock Tomb restoration for discussion and made a motion that, from the G.A.R. Memorial Fund, a contingent appropriation be made available to the Hancock Committee for their work or for their continued maintenance thereof in the sum of \$500.00. The motion was seconded by Brother Herman Poehler and carried.

Commander-in-Chief Riddell: Since it is now time for us to pay our annual visit to our Auxiliary, I will declare a recess until 3:00 nm (The session re-convened at 3:00 p.m.)

Commander-in-Chief Riddell: At this time we have the pleasure of receiving the Greetings Committee from the Ladies of the Grand Army of the Republic.

(The committee consisted of Edra Gene Tighe, National President: Harriet Eaton, Winona Kahl, Marion Leach, Edna McCready, Alice Harwood, Della Richard, and Mary Noonan. Each expressed good wishes; all except National President Tighe are Past National Presidents.)

National President Tighe: This is a moment I have looked forward to for a long time. I bring you greetings and wish you much success. I have one request - remember the Ladies of the Grand Army of the Republic will always be indebted for the kindnesses you have shown us this year.

Past Department Commander Elton Koch: Commander-in-Chief Riddell has asked me to respond to your delegation in his behalf and I am most happy to do so. We are glad that you have come to visit us and we know that you have always worked with us. It is a pleasure to have you meet annually with us at our National Encampment.

(The delegation then retired.)

Sr. Vice Commander-in-Chief Robert J. Wolz: Commander-in-Chief, I have the pleasure to present to you and the members here assembled, Mr. Eugene C. McGuire, Past President General of the Society of Sons

of the American Revolution.

Past President General McGuire: I am most happy to be here to bring the greetings of the Society of Sons of the American Revolution. In this Bicentennial year there is an effort towards united efforts. Our Country has not always been united, and it is Organizations like yours that are needed. I am a lineal descendant of a Union Veteran and can recall the men of the GAR, as they were the people to know. Organizations such as yours need membership and this is the bulwark of our Orders' needs today.

National Secretary-Treasurer Fred H. Combs, Jr.: Brother McGuire, we are deeply indebted to you for taking of your time to be here. We know you are proud of any inknow you are proud of your heritage and you have expressed your in-National Order. Your membership would be most welcomed.

Baer: Commander-in-Chief Riddell, I would like to make a motion that we send a letter of congratulations from this Encampment to the delegation of the Veterans of Foreign Wars, now holding their National Encampment in New York. I will be glad to hand-deliver the letter upon my return home to New York.

Motion seconded by Past Department Commander Frank L. Clark of New Jersey and carried.

Past Department Commander Baer: I would like to bring before the Brothers at this time the question of re-application for membership of Bert Sack, who was rejected by his New York Department Camp and by the New York Department. Mr. Sack has recently made application for membership at Reading, Pennsylvania and on his application shows that he was never rejected. We in New York believe he was rejected.

Past Commander-in-Chief Heacock: I move that this matter pertaining to Brother Sack be referred to the Council of Administration for proper disposition thereof. Seconded by Brother Frank Clark. Motion carried.

Commander-in-Chief Riddell: We will now have Brother Shriver read the Report of the Committee on Officers' Reports.

REPORT OF THE COMMITTEE ON OFFICERS' REPORTS

Your Committee on Officers' Reports has read the Reports submitted at this Encampment for their past year of activity and have considered them most seriously.

We wish to commend each for his untiring efforts given to our Order. Each has accepted his responsibility and given of his time to perform the responsibilities required. Our Organization can be proud of each of these men as they served as a team.

Commander-in-Chief Riddell is to be commended for his year of Administration. His report shows that he made official visits from Maine to California and has represented our Order most honorably. Listed in his Report are four recommendations:

- 1. Referred to Budget Committee
- 2. Referred to Budget Committee
- 3. Our Commander-in-Chief has recommended that we continue to participate in the observance at the Lincoln Memorial in Washington, D. C. on February 12 as has been done for some years now. The Committee does not concur with this recommendation for the following reasons. Each year our Organization receives an invitation from the Loyal Legion to participate in this Service but each year it arrives closer and closer to the date of the event. This past year we were not allowed to carry rifles because the President of the United States was expected to be in attendance. This is understandable, but last year our Color Guard which escorted our Commander-in-Chief was not allowed to carry our American Flag and our Organization's Banner.

During the ensuing discussion, several members of our Organization were opposed to continuing participation in the Service at the Lincoln Memorial in Washington because the members of our Organization have in past years been given very little or no recognition and are not extended comparable courtesies by the members of the Loyal Legion which we extend to Legion members at the Springfield Tomb Ceremony. Many members felt that this traditional observance of the birth date of

Abraham Lincoln should be continued as an expression of tribute to our martyred President and that personal feelings should be cast aside

in deference to this long-standing tribute to him.

Past Commander-in-Chief Fred H. Combs, Jr.: I feel, as the Committe does, that we should discontinue participation in this event since our members are not extended the same courtesies in Washington that we extend to the Loyal Legion in Springfield. Therefore, I move that we go along with what has been recommended by the Committee on Officers' Reports, that participation in the Lincoln Memorial Ceremony on February 12th in Washington, D. C. at the Lincoln Memorial be discontinued as of this Encampment.

The motion was seconded by several. Motion defeated.

Past Commander-in-Chief Shriver: Regarding Recommendation No. 4 of the Commander-in-Chief, your Committee concurs.

Past Commander-in-Chief Heacock: I move you that where there

be no objections, the Committee be sustained by a sound of the gavel. Motion seconded by several and carried.

Brother Shriver continued: The Report of the Senior Vice Commander-in-Chief contains a wide scope of thinking and presents his interest in the future of our Order. He has listed five recommendations:

- 1. No definite action referred to Committee on Constitution and Regulations for consideration
- 2. Referred to Budget Committee
- 3. Non-concurrence
- 4. Concurred in principle
- 5. Do not concur

The Report of the Junior Vice Commander-in-Chief displays his sincere interest in our Order. He, too, worked hard through letters to the Departments regarding membership and is to be commended on his efforts. His report contains one recommendation which was referred to the Council of Administration.

The Report of our National Secretary-Treasurer shows the outstanding work done by Brother Combs. His report contains a complete condition of our finances, records, membership, and administrative duties. Our Order must appreciate his work, as it is the most important office of the Sons of Union Veterans of the Civil War. Brother Combs made three recommendations:

- 1. Concurrence

Past Commander-in-Chief Allen B. Howland: Brothers, your Committee has met and considered the many Resolutions presented to it and our Chairman, Brother Haskell, has asked me to submit our report to you.

REPORT OF THE COMMITTEE ON RESOLUTIONS

The Resolutions from the Pennsylvania and New Jersey Departments indicate a large undertaking, but we believe it can be done and therefore we approve the following:

- 1. That a Committee of five be appointed by the incoming Commander-in-Chief one for five years, one for four years, one for three years, one for two years, and one for one year. Each succeeding Commander-in-Chief will appoint one member annually for a term of five years and/or until the matter has been accomplished. All future matters of coordination and implementation are herewith referred to the Council of Administration for the proper disposition thereof.
- 2. The Resolution from the Iowa Department in regards to the Memorial Building in Waterloo, Iowa, which has been supported by several letters from various Organizations in Waterloo, we approve and suggest that the National Secretary send a letter to the Iowa Department endorsing the project.
- 3. The Resolutions from Arthur Glenum, our District of Columbia Representative, are a duplicate of the Resolutions that he submitted last year. We recommend that we continue what we voted last year.

We submit the following actions for your consideration: Resolution regarding Past Commander-in-Chief Albert C. Lambert of

New Jersey. We concur.

Past Commander-in-Chief Heacock: Commander-in-Chief, I would move you as the recommendations are read, where there be no objections, they shall be approved by a sound of the gavel. Motion seconded by Brother Rule and carried.

Resolutions from the Departments of Pennsylvania and New Jersey

re: Memorial Day. We concur.

Resolution from the Department of New Jersey (General). We concur.

Resolution from Waterloo, Iowa. We concur. Resolution from Arthur Glenum. We concur in spirit; most acted on in 1975.

Communication from Richard T. Schulze, Member of Congress (General). We concur.

Resolution Committee's statement of belief:

TO ALL IN WHOSE PRESENCE SHALL COME THIS RESOLUTION by the SONS OF UNION VETERANS OF THE CIVIL WAR

in Encampment assembled at Columbus, Ohio on August 17, 1976:

Thinking the duty of the Resolutions Committee to be one of composing as well as disposing, and that this Encampment should make a clear, concise statement of belief, we do hereby submit the following for your approval:

- That the United States of America shall maintain superior military strength worldwide;
- That the United States shall retain complete sovereignty over the Panama Canal Zone;
- That the Rights and Privileges of the law-abiding citizenry must not be abridged in the dispensation of justice;

4. That taxation must be fairly applied;

- 5. That all citizens are entitled to a basic, unadorned and disciplined education which will ensure the literacy of our population;
- 6. That May 30 is the only true and meaningful Memorial Day;
- That the "Star Spangled Banner" must not be replaced as the National Anthem of the United States of America;
- 8. That the membership of this Organization shall do their utmost, by all means, to support the principles set forth herein.

REPORT OF THE NATIONAL PATRIOTIC INSTRUCTOR

To the Officers and Members of the 95th Annual National Encampment, Sons of Union Veterans of the Civil War Clarence J. Riddell, Commander-in-Chief

Brothers:

One year ago, in Rochester, N. Y., I assumed the duties of the office of National Patriotic Instructor of our Organization. I must admit I had great misgivings about taking on this responsibility but at the urging of several of our members I accepted. The activities of the

year and the results of my efforts have been a revelation to me and while I would not want to assume such a responsibility again it has been an education for me to have had this experience.

On Saturday, November 8, 1975 it was my pleasure, along with many members of my Department, to journey to King of Prussia, Pa to attend the joint testimonial dinner for Commander-in-Chief Clarence Riddell and National President Caroline Riddell. Saturday, November 22nd I attended the Remembrance Day Observances at the Woolson Statue on the Gettysburg Battlefield. This was not my first time for this observance but each time I attend I find it equally inspiring. To Commander-in-Chief Riddell my sincere thanks for your confidence in placing me in this office this year. May you have a most enjoyable and constructive Encampment. To the incoming administration I pledge my continued support.

CHAPTER III

Article VII

Committees

Section 1. The regular committees of the National Organization shall a Standing Committees of the National Organization be a Standing Committee on Constitution and Regulations, Legislation, Military Affairs, Marian Mar Military Affairs, Membership, Americanization and Education, Lincoln Tomb Observance, Inc. Tomb Observance, Remembrance Day. Fraternal Relations, and Encampment Site. campment Site.

Section 2. Special committees may be created by action of a National Encampment and shall be for the period of time designated in the creation thereof. Their duties and responsibilities shall be simultaneously defined taneously defined.

Section 3. The regular national committees shall consist of five members of the Sons of Union Veterans of the Civil War, except the Membership Committee Thio Veterans of the Civil War, except the Membership Committee which shall consist of the Junior Vice Commander-in-Chief as challenged of all mander-in-Chief as chairman and the junior vice commanders of all Departments and Campacity Departments and Camps-at-Large, and except the Encampment Site Committee which shall consist of three members. All shall be in good standing in their respective. standing in their respective Departments and Camps.

Section 4. It shall be the duty of the Committee on Legislation watch matters of property of the Committee on Legislation to watch matters of proposed legislation affecting the welfare of the Order or the Constitution and legislation affecting the welfare Order or the Constitution or welfare of the United States of America, proposed either in the Congress of the United States or elsewhere; to oppose such as are inimical to the same and to make a written report to the Commander-in-Chief at the session following its appointment.

CHAPTER III ARTICLE IV Officers

Section 3. On assuming office, the Commander-in-Chief shall appoint all other officers and national committees, and may appoint such aides as he may deem necessary, for such services as he may designate.

CHAPTER IV

Section 2

Sons of Veterans Reserve

Effective 1 January 1977, to be eligible for membership in the Sons of Veterans Reserve, a brother shall be a member in good standing in the Sons of Union Veterans of the Civil War.

Members of the ladies organizations of the Allied Orders of the Grand Army of the Republic may affiliate with subordinate units, and be identified as members of the SONS OF VETERANS RESERVE NURSE CORPS, with uniform, dress and duty conforming to that of the period of the Civil War. Members of the SONS OF VETERANS RESERVE NURSE CORPS shall not pay dues, file forms or have rank structure.

The revised amendments were approved as read.

Past Commander-in-Chief Stoudt: Am I correct in saying that all changes made since 1956 are to be updated by the 1977 Encampment ready for printing?

A discussion followed during which it was emphasized that a motion had been made and passed providing for the updating of the Constitution and Regulations prior to the 1977 Encampment, at which time mimeographed copies would be distributed to all delegates in attendance.

- 2. On a motion by Brother Rippey, seconded by Brother Rule, it was determined that the Department Treasurer's Receipt Book, the Ledger (Form E), the Cash Book (Form F), and the Descriptive Book (Form A) will no longer be available from the National Organization and will be removed from the Requisition for Supplies (Form 1). The motion was carried unanimously.
- 3. On a motion by Brother Rippey, seconded by Brother Beilby, the screw-type Bronze Lapel Recognition Buttons will be offered to the membership at a cost of seventy-five cents each. Motion carried unanimously.
- 4. It was moved by Brother Rippey and seconded by Brother Riddell that the dividends earned on the Wellington Fund and the interest earned on the special savings accounts be placed in the General Fund for 1976-1977. The motion was carried unanimously.
- 5. On a motion by Brother Rippey, seconded by Brother Rule, the National Secretary-Treasurer was authorized to renew for three years and National Secretary-Treasurer prior to the expiration of the present bonds on August 1, 1977. Motion carried unanimously.
- 6. On a motion by Brother Rippey, seconded by several, the matter of the acceptance into membership of Bert Sack, formerly a member of Camp which was brought to the attention of the Encampment by ther Cecil Baer of the Department of New York was tabled for furinvestigation.

- 7. Brother Joseph Rippey moved and several seconded the motion that we retain the same amount of \$6.00 per member as the payment to Camps of Life Members in January 1977. Motion carried unanimously
- 8. The motion was made by Brother Wolz and seconded by Brother Rule that the Memorial Day Restoration Committee, chaired by Protection Commander-in-Chief Frank M. Heacock, Sr., be authorized to spend a sum of up to \$500.00, to be drawn from the National G.A.R. Fund in the fiscal year 1976-1977 on vouchers to be submitted to the National Secretary-Treasurer for printing and mailing of letters and for carrying out the function of the Committee. - 11. The National Secretary-Treasurer was given authority to adjust the prices listed on the Price List of Supplies, as needed, to allow for any increases in the cost of postage and supply items.
- 12. The matter of the status of Camp-at-Large No. 21, Beaufort, South Carolina, was discussed. Commander-in-Chief Kenneth T. Wheeler offered to visit the Beaufort Camp during his term of office in order to encourage the Camp to meet its obligation of payment of per capita tax on its members to the National Organization.
