## FIREFIGHTER FROM OCEAN STATE IS NEW CINC

Leo Kennedy of Greenville, Rhode Island, is the son of Marlene and the late Leo Kennedy. He was born in Providence, RI, in 1959. His father died in the line of duty as a Greenville firefighter in 1979. Br. Leo is the third Rhode Islander to be elected Commander-in-Chief. The last CinC from Rhode Island was elected in the year Br. Leo was born.

Br. Leo is the descendent of Stephen Kettle of the 2nd RI Inf. and George Kettle of the 1st RI Cav. George was captured along with a majority of the 1st RI Cavalry in Middleburg, VA, in June 1863. He was released after nine months in a Confederate prison, reenlisted and served to the end of the war.

Br. Leo graduated Smithfield High School and then, Providence College, where he holds a Bachelors Degree and is a member of the honor society. He currently attends the National Fire Academy, working on a degree as an Executive Fire Officer.

Br. Leo is an SUVCW life member and received the Meritorious Service with Gold Star in 2001. He is a proud member of Col. Zenas R. Bliss Camp 12, Dept. of Rhode Island. He also was made an honorary Kentucky Colonel at the 2003 Nat. Encampment. He served on the Nat. Graves Registration Committee, chairing it for seven years. He is a member of the SVR Headquarters Company.

Br. Leo has been a firefighter with the City of Cranston since 1981 and has risen to the rank of Deputy Chief. He is currently in charge of the emergency medical and rescue division. Br. Leo has also worked with FEMA and was deployed to the World Trade Center collapse for two weeks in Sept 2001. The Governor appointed him to the RI Ambulance Service Advisory Board, where he was elected Chair in 2008.

Br. Leo is the Deputy Director with the Smithfield Emergency Management Agency. He is a member of the International Association of Fire Fighters, the International Assoc. of Fire Chiefs, Rhode Island Fire Chiefs Assoc., RI Critical Incident Stress Management

Br. Leo is happily married to Sandra and they both enjoy camping and travel from Alaska to Ireland.


#### OHIOAN LEADS AUXILIARY

# COMMEMORATING

## **NEW SALEM...THE TESTING GROUND**



In the summer of 1831, there came to the infant pioneer village of New Salem, a tall, raw-boned, awkward an uneducated young man, a young man

who was destined to write his name upon the pages of history among the world's great. To his youth of 22 years, New Salem was his first contact with community life.

Before him lay the uncharted trail, an association of challenge in a climate of mutual aid, critical and tough in aspect, where opportunity demanded the best of a man, and an outward expression of the best. Abraham Lincoln met the challenge; he used the trail to good advantage. He discovered the importance of goals of achievement...he would not be deterred. He learned that with sound body, a stout heart and determination; there is no power on earth that he need fear.

Abraham Lincoln's six years at New Salem were decidedly the turning point in his life. Here he struggled to eke out an existence by doing all sorts of things. His activities were many and varied. He clerked in a store, was a mill-hand, a woodchopper, laborer, storekeeper, village postmaster, deputy surveyor and a politician, and with all he studied and read to improve his lot. After a day of labor, Lincoln might be found at the coopershop before the fireplace, studying by the light from the burning shavings, not only a few law books, but many of the classics as well. Whenever he absorbed a new point of law, he would put it into practice by drawing up legal papers for his neighbors.



At New Salem, Lincoln gained the friendship and the confidence of the people and assumed a position of leadership, not only in the community, but in the surrounding country as well. After a hard and bitter struggle against adversity, he won local renown as a lawyer and as a Whig member of the Legislature.

New Salem was for Abraham Lincoln the testing ground. When he arrived there, the village was a thriving infant, and after he left for the greener fields of Springfield, the village fell into decline and rapidly deteriorated into oblivion.

From New Salem, Lincoln emerged as a thoughtful leader, inspiring confidence and the admiration of the people. Do you recall his words, when at the age of 23, the townspeople made him their candidate for the Legislature? He said, "My greatest ambition is to be truly esteemed by fellow men by rendering myself worthy of their esteem." No one may doubt that he fulfilled that ambition.

# **TEXAS REFLECTIONS**



#### **GENERAL ORDER NO. 13**

- 1. It is with great honor that I write this General Order in recognition of the faithful and dedicated service of Past Commander-in-Chief, Richard Partington. PCinC Partington is celebrating his 75th anniversary as a member of the Sons of Union Veterans of the Civil War, beginning his membership in 1934.
- 2. In 1939, he attended his first National Encampment in Pittsburgh, PA. He has attended the National Encampments of the Grand Army of the Republic and has since written a book on his recollections of the GAR.
- 3. PCinC Partington served as Commander of the Dept. of PA from 1962 to 1963 and was elected Commander-in-Chief in 1987.
- 4. On behalf of the Sons of Union Veterans of the Civil War, I thank PCinC Partington for his many contributions to the Order and his good counsel to many of our members.
  - 5. Thank you, PCinC Partington. Ordered this 29th day of June, 2009.

#### GENERAL ORDER NO. 14

1. Effective this date, the National Quartermaster has been approved by the Council of Administration to produce and sell Dept. and Camp Flags for the Order. All requests for Department and Camp flags are to be made through the Nat. Quartermaster.

So ordered this 26th day of July 2009.

#### **GENERAL ORDER NO. 15**

- 1. A resolution was introduced and adopted by the Department of Pennsylvania in 2008, to amend the Constitution of our Order.
- 2. This Resolution was provided to the Commander-in-Chief at least forty (40) days preceding the 127th National Encampment.
- 3. On August 16, 2008, this Resolution to Amend the Constitution was presented at the 127th National Encampment of our Order in Peabody, Massachusetts and this resolution was approved and adopted by well over 2/3's of the voting delegates present.

- 4. All 28 Departments of the Order have held their 2008 Encampments.
- 5. 19 of these Departments have ratified this resolution.
- 6. WHEREFORE, pursuant to National Constitution, Article IX, I hereby declare our Constitution amended, by changing Article V Organization to read as follows:

ARTICLE V

Organization

Section 2.

- (a) The supreme power and authority.....
- If the Commander-in-Chief is of the opinion that (b) an action of the last proceeding National Encampment is in violation of or in conflict with our Congressional Charter, and/or the Constitution, and/or Nat. Regulations, and/or U.S. Law, he may propose such General Order(s) to delay implementation of such action or suspend such action if previously implemented, until such time as the violation or conflict can be corrected. A two-thirds majority vote of the Council of Administration is required to support the proposed General Order authorizing the Commander-in-Chief to proceed, the Commander-in-Chief abstaining from participating in such vote and the Senior Vice Commander-in-Chief may only vote to break a tie. Such presentation and vote may be taken by electronic means of communication. The Commander-in-Chief must propose a resolution to the conflict by the next Nat. Encampment.

Ordered this 8th day of August 2009.

#### **GENERAL ORDER NO. 16**

This General Order is to inform the Order that effective 13 August 2009, the Headquarters for the Sons of Union Veterans of the Civil War will transfer from: 72 Limestone Blvd., Chillicothe, OH 45601 to: The Crowne Plaza Hotel, 830 Phillips Lane, Louisville, KY 40209 (502) 367-2251 and will remain through 16 August 2009. #### **GENERAL ORDER NO. 17**

1. While in session at the 128th Nat. Encampment of the Sons of Union Veterans of the Civil War in Louisville, Kentucky, it is hereby ordered that the Dept. of Missouri has expanded to include the state of Arkansas. The Department name shall remain the "Department of Missouri".

## NEW NATIONAL OFFICERS ELECTED

#### PDC SCHALL CHOSEN TO COMMAND



PDC D. Brad Schall was elected Junior Vice Commander-in-Chief at this year's Nat. Encampment. Br. Brad has served five years on the Nat. Council of Administration.

In 2002, Br. Schall sold his business, DBS Specialty Foods, a meat brokerage

company, and moved to Lincoln, CA. Since then, he reorganized and commanded Gen. Alfred Pleasonton Camp 24 and served on the staff of two other Camps. He's commander of Co. B, 8th CA Vol. Inf., SVR. After serving as Dept. Commander, Br. Schall served as chairman of the Fraternal Relations Committee, on the Nat. C&R Committee, and as a Nat. Aide to the Memorials Committee. He is also co-chair of the SUVCW Foundation. He serves as his Camp's Secretary and Civil War Memorials Officer.

#### PDC VIEIRA FILLS VACANCY

**PDC Bill Vieira**, of Rhode Island's Col. Zenas R. Bliss Camp 12 was elected to fill the remaining year of PDC Schall's unexpired term on the CofA. He concurrently is serving as National Chief of Staff.



Br. Vieira served as RI DC from 2006-09 and is now Dept. Counselor, Council chair and Chief of Staff. Last year, he served as the New England Regional Association's Commander.

He's a private in Batt. B, 1st RI Lt. Art. a living history organization and part of the RI

State Militia, holding the Order of Saint Barbara and the RI State Militia Long-Service Award. He's also a Private in Co. B, 2nd RI Inf.

Br. Vieira graduated Magna Cum Laude from the URI and received a Teacher's Certificate from RI College He belongs to the Golden Key Honor Soc. of the URI and the Nat. History Honor Soc. Phi Alpha Theta. He teaches history at William E. Tolman H.S. and has researched and published a book on the Brotherhood of Railroad Trainmen.

#### **GENERAL ORDER NO. 3**

- 1. The National Council of Administration met in session on August 13 and voted that in order to have a more complete record for the Order it is necessary to have copies of all Department Bylaws on file at the National Headquarters.
- 2. Thus, it is ordered that all Dept. Commanders send a copy of their Dept. Bylaws to the Executive Director by September 30, 2009. The copy shall be signed by the Dept. Commander, either the sitting DC when the Bylaws were written or the current DC. Your cooperation is appreciated.
- A. This will be a one-time deal. From this date forward as Bylaws are sent in for approval of changes, the CinC

will forward an approved copy to the Department and to the Nat. Headquarters.

3. Also approved by the CoA, Dept. Secretaries are expected to mail the Form 35 to the Nat. Headquarters on or before May 31 each year. They should have in their possession the Form 27 from the Camps before April 30 each year. As of May 2010 Dept. #### NATIONAL COUNCIL OF ADMINISTRATION MEETING MINUTES 13 AUGUST 2009 - LOUISVILLE, KY

The meeting was opened by CinC David V. Medert at 8:30 pm. Nat. Chaplain Jerome Kowalski offered the opening prayer, followed by the Pledge of Allegiance, led by CinC Medert. The roll of officers was called, with the following recorded as present:

PCinC Andrew Johnson, Banner Editor PCinC Stephen A. Michaels, and Exec. Dir. David Demmy.

Additional PCinCs present included Charles Corfman, Richard L. Greenwalt, Bud Atkinson, Alan R. Loomis, Richard D. Orr, Richard D. Orr, Edward Krieser, Donald E. Darby, and James B. Pahl.

Guests included Nat. Chaplain Jerome Kowalski, Nat. Webmaster Ken Freshley, DC John McNulty (PA), PDC Bill Vieira (RI) and PDC Ron Gill (IN).

#### Old Business

**Nat. QM Printer Update**. Nat QM Wheeler reported that he has received the printer, printed 300 Eagle Scout certificates and the print quality is very good.

#### **New Business**

Monument Funds for Past Projects. Inquiries were made, regarding the potential for receiving funds from National for projects that have already been completed in an attempt to reimburse Camp/Dept. treasuries. PCinC Orr noted that the policy does not allow this. Nat. Treas. Newman noted that there is over \$11,000 in the Civil War Monuments account and the committee can distribute the funds to those Camps/Departments that apply this year.

QM Selling Camp & Dept. flags. CinC Medert tasked the Nat. QM with placing an ad in the BANNER along with pricing information. PCinC Corfman offered to sell the 22 remaining SUVCW emblems Given Camp 51 had made for flags to the Nat. QM to help in flag production. The Council recommended that the chosen supplier's flags' quality be evaluated before a decision is made to purchase the 22 remaining emblems. Nat. QM Wheeler moved, Br. Schmincke seconded, to allow PCinC Corfman to sell the remaining emblems if the Nat. QM elects not to purchase them. *Motion passed*.

Maintaining Originals of Forms, including Dept. By-Laws. Options discussed included the Exec. Dir. and the Nat. Sec. The Council's concensus was that the Exec. Dir. was the better option due to his proximity to Nat. Headquarters. Nat. Sec. Palmer had only a few copies of Dept. By-Laws in his files, which was also the case with the Exec. Director's files. Nat. Sec. Palmer also noted that he received several Department inquiries, seeking copies of their By-Laws. Hence, there's a desire to have copies of the latest versions of all Dept. By-Laws on file at National. PCinC Orr recommended that the CinC issue a Gen. Order, requiring Departments submit copies of By-Laws to National by a certain date. CinC Medert will task all Departments with sending their By-Laws to the incoming CinC.

Requests for Replacement Headstones. The Veterans Administration is now requiring copies of the veteran's records. Nat. QM Wheeler confirmed that requests for a new headstone require original documentation. PCinC Pahl recommended that he invite a speaker to give a presentation on the new process and acceptable documentation at the November Council meeting. The CinC requested that PCinC Kuhn investigate the possibility of having a Gettysburg VA representative attend as well.

**Temporary Nat. Treasurer.** PCinC Orr expressed interest in stepping in for the next year under the

condition that the SUVCW hire a bookkeeper or accountant to handle the day-to-day work. Bookkeeper cost would range from \$12,000 to \$15,000/year. The SUVCW would still need to pay an auditor. PCinC Darby inquired about the use of reserve funds for one year to see if the arrangement works. Nat. QM Wheeler moved, PCinC Kuhn seconded, that if no other Brother expresses interest in serving as Nat. Treas: (1) funds from the reserve be obligated for one year to secure a bookkeeper and (2) the Council conduct a search with a goal of establishing a contractual relationship with a bookkeeper. *Motion passed*.

Minors in SUVCW Programs. The potential need to amend the Constitution referencing minors, protecting the SUVCW from lawsuits, was discussed. The difficulty coming up with a blanket policy because states have different laws was noted. PCinC Pahl mentioned that the simplest approach would be to require all Camps and Departments to comply with their state laws. PCinC Orr responded that there is an amendment to the Regulations proposed by the C&R Committee.

Sons of Confederate Veterans Support Request. The SCV wants the city of Jonesboro, TN to reverse their decision relative to their memorial to US veterans and include those that served in the Confederate forces during the Civil War. Both PCinC Kuhn and Br. Schall recommended that the SUVCW avoid involvement due to the fact that this is a city of Jonesboro issue. The Council voiced concurrence.

#### Sons of Confederate Veterans Member's Petition.

The petition to restore funds originally allocated to the Nat. Park Service to renovate Petersburg Nat. Cemetery is to be presented to Virginia legislators. Apparently, the NPS funds have been re-allocated on more than one occasion. Nat. QM Wheeler was tasked with raising the issue on the Encampment floor under New Business.

Reimbursement Request. PDC Al Peterson (Dept. of CA&Pac) requested that the Nat. organization reimburse his travel expenses to Washington, DC to continue efforts to recognize the traditional date for Memorial Day. The Council recommended that Wash. DC Rep . PCinC Johnson, be tasked with this action.

Review of the Exec. Director's Report. Br. Demmy noted that Form 35 annual reports are required to be postmarked by 31 May, but timely submittal of Form 49 officer election and installation reports is a problem. The Regulations require this form to be submitted within 30 days after the Dept. Encampment. PCinC Orr recommended that the CinC's ruling be issued in a Gen. Order, clarifying the submittal date to National. Br. Demmy also recommended that copies of Form 27s be submitted with the Form 35.

Update on Program & Policy Committee activities. SVCinC Kennedy highlighted the committee action

relative to mandatory Camp meetings, noting that the committee recommended that Camps hold at least two meetings per year. He also noted that this recommendation has not yet made it to the C&R Committee for their review and action.

**Award Recipients.** The CinC mentioned that he has a listing, which will be published in a Gen. Order with Saturday's date. He did not want this information released prior to presenting the awards to those on the list.

**2009-2010 Proposed Budget.** Nat. Treas. Newman presented the budget for the administrative year. SVCinC Kennedy moved, Nat. QM Wheeler seconded, to accept budget as proposed by the Nat. Treasurer. Motion passed.

**Ebay Sale.** PCinC Pahl noted that a SV Grand Division Commanders badge was available.

Letter of Support Request. JVCinC Hanby reported that Lynchburg, VA's, Taylor-Wilson Camp is requesting support from the Nat. organization for the establishment of a memorial to Union soldiers that died at a Lynchburg POW camp. CinC Medert requested that a draft resolution be presented at the Encampment.

New Camps. Nat. Sec. Palmer reported on those established during 2008-2009. He received Form 49s that should have gone to the Exec. Dir. Although Br. Palmer developed and distributed a form submittal matrix, which references submittal to the Exec. Dir., the fact that Form 49 still references submittal to the Nat. Sec. prompts some Dept. Secretaries to continue sending it to the Nat. Sec.

PCinC Corfman asked the Council members to check and make sure that they have his correct e-mail address....bgcorfman@aol.com.

New Nat. Museum of Civil War Chaplains. Nat. Chaplain Kowalski reported that he has been in contact with the new facility, located at Liberty University in Lynchburg, VA.

**Commemorative Badge.** PCinC Orr distributed a badge to Council members, honoring PCinC Richard Partington's 75 years of SUVCW membership.

**Pennsylvania luncheon.** PA DC McNulty reported that the luncheon will be held at noon on Saturday in the hotel restaurant.

**SUVCW website.** Nat. Webmaster Freshley reported that there were over 11 million hits the during the 2008-2009 administrative year...a major increase over previous years.

With no further business to come before the Council, CinC Medert asked Nat. Chap. Kowalski to provide a closing prayer and subsequently adjourned the meeting at 11:25 pm.

#### NATIONAL COUNCIL OF ADMINISTRATION MEETING MINUTES 16 AUGUST 2009 - LOUISVILLE, KY

The meeting was opened by CinC Leo F. Kennedy at 8:10 am. Nat. Chaplain Jerome Kowalski offered the opening prayer, followed by the Pledge of Allegiance, led by CinC Kennedy. The roll of officers was called, with the following recorded as present:

PCinC Andrew Johnson, Banner Editor PCinC Stephen A. Michaels, and Exec. Dir. David Demmy. Additional PCinCs present included PCinC Charles Corfman PCinC Bud Atkinson PCinC Donald E. Darby and PCinC James B. Pahl. Guests included Nat. Chaplain Jerome Kowalski and Asst. Nat. Treas. Max Newman

Use of Trademarks. The previous discussion surrounded the costs of filing for registered trademarks; however, Nat. Treas. Orr noted that there is no cost to use "TM", which reflects a "common law" trademark. The TM symbol indicates to the world that the person who makes or sells the product bearing the name or mark is using that as a trademark. A trademark application does not need to be filed in order to use this mark. It does provide an additional level of safeguarding, although not to the extent of a registered trademark. PCinC Medert moved, SVCinC Hanby seconded to use "TM" on SUVCW symbols. *Motion passed*.

Nat. Treasurer Budget & Staffing. A MI Brother, who has helped address the recent tax issues, is interested in running for Nat. Treas. at next year's Nat. Encampment, as long as we pay a bookkeeper. PCinC Medert moved, Nat. QM Wheeler seconded, to allocate \$20,000 from the reserve to purchase the services of a bookkeeper. *Motion passed.* 

Nat. Treas. Orr recommended that Br. Newman be appointed as Asst. Nat. Treas., supporting the transition and helping out when needed. CinC Kennedy made the appointment. Also noted that Philip Caines (Dept. of CA & Pac) was interested in serving as Asst. Nat. Treas.

Rescinding Nat. Policies. Nat. Counselor Grim noted that a number policies have been incorporated into the Regulations. Those incorporated at the 127th Nat. Encampment in Peabody, MA (2008) include: (1) use of Veteran Charters, (2) sale of extra Nat. Encampment badges, and (3) unused GAR and SUVCW graves. Those incorporated at the 128th Nat. Encampment in Louisville, KY (2009) include: (1) execution of contracts, (2) Memorials and Monuments grants funds, (3) Nat. Officer

and Committee expense reimbursement, and (4) use of badges, emblems, seals and symbols. PCinC Medert moved, SVCinC Hanby seconded, to rescind the policies as recommended by the Nat. Counselor. *Motion passed*.

# **COLLECTING THE SONS**

## AUXILIARY TO THE SONS OF UNION VETERANS (PART 1 OF 2)

While a separate organization, the Sons Auxiliary has been a tremendous help to the Sons both in manpower and fundraising. We respectfully include their membership badges to our collections.

In 1883, largely through the efforts of Maj. A.P. Davis, the mothers, wives, sisters and daughters of Sons of Veterans, USA were recruited to form the Ladies Aid Societies to assist the Sons of Veterans, USA, and the GAR in their patriotic work. The Eastern and Western Pennsylvania Divisions and the Ohio Division were among the first to organize.

Badges of the Ladies Aid Society, Auxiliary to the Sons of Veterans

Type I: Bronze design patented by Maj. Davis in 1887 for the Ladies Aid Societies to the Sons of Veterans, USA. Obverse is medallion with American eagle, rays radiating from the center, behind eagle. Between two concentric circles of medallion is inscription "veneramus et succurrimus • MDCCCLXXXIII", the inner circle enclosing the eagle & rays. Surrounding medallion is a laurel wreath, the ends of two cannon, which appear to cross behind wreath & medallion, and projecting ends of a Greek cross upon the ends are "L.A.S. SV." On reverse is raised medallion. Surrounding "USA" monogram and radiating rays are two concentric circles with inscription, "Auxiliares Femineae Societates• Filii Veteranorum". Pat. Mar 8, 1887. Hidden brass pin at top of ribbon reads "Major AP Davis, Pittsburgh, Pa." Manufactured by Bailey, Banks & Biddle. Members wore red, white & blue vertical striped ribbon. Auxiliary officers wore SV blue ribbon. State officers wore SV red Division ribbon. Nat. officers wore gold ribbon used by SV's Commandery-in-Chief.

**Type II-** same design but pale gold plated for recruiting 9 new members in 1888.

**Type III-** same design but silver plated for recruiting 5 new members in 1888

**Type IV-** a 14 kt rose gold badge was issued for recruiting 25 new members in 1888. Actual design of this badge is unknown. The Sons badge had a very different design from the regular membership badge

**Type Va-** Reflects 1904 name change to Sons of Veterans Auxiliary. Design very similar to Type I except on the ends of the Greek cross are letters "SV" at the bottom. The top pin bar reads" S of V Auxiliary. Previous ribbon used. No maker's hallmark.

**Type Vb** – same, but reddish copper finish

**Type VI**- The design is very similar to Type II except on the ends of the Greek cross there is only the letters "SV" at the bottom. The top pin bar reads" S of V Auxiliary. Manufactured by Joseph Davison, Philadelphia, Pa.
