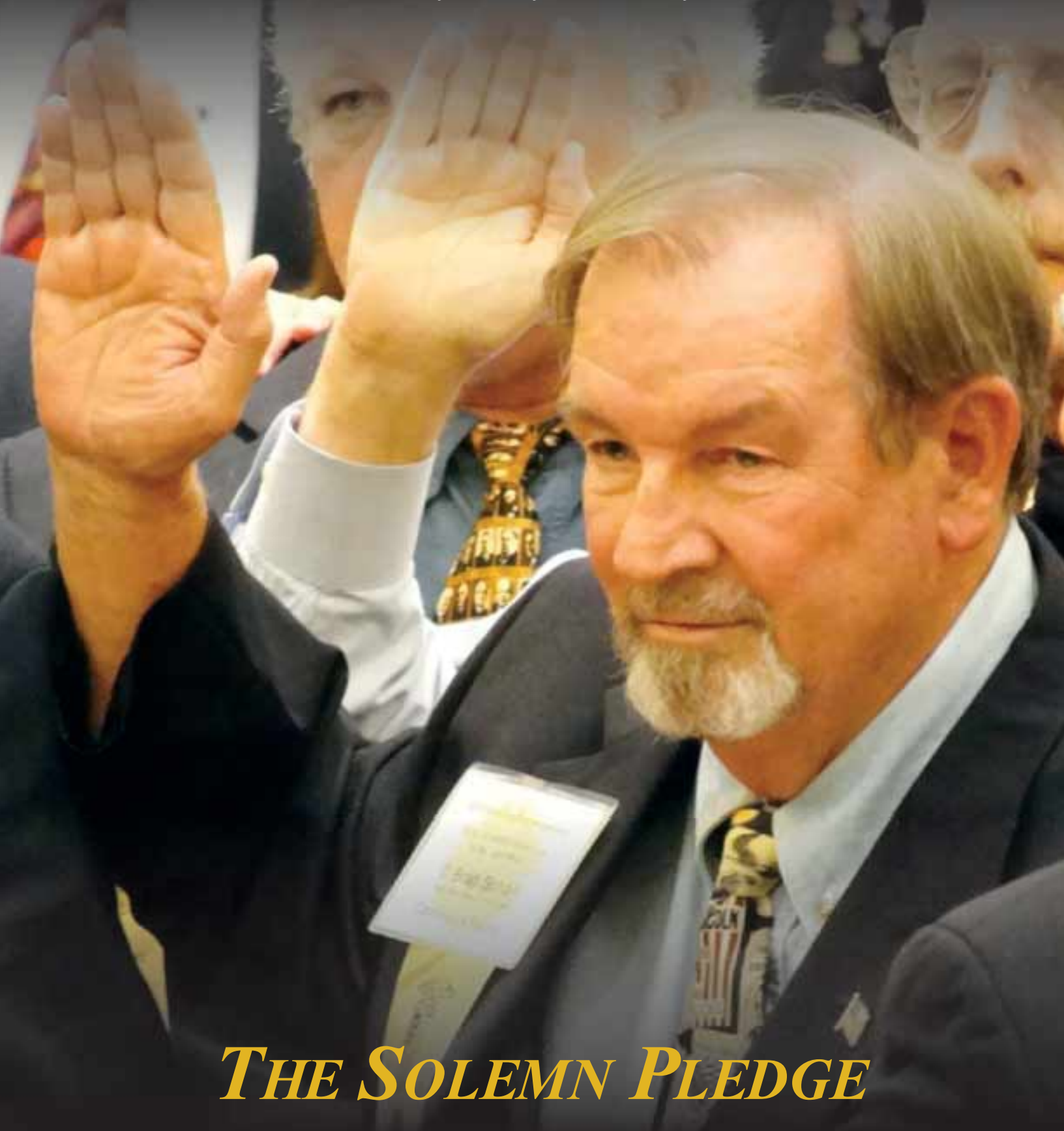

## KUDOS IN ORDER

Yarmouth, Maine's Haskell-Marston Camp 56's Br. Steve Bunker was awarded the 2010 Warren Randall Award by outgoing Chamberlain Civil War Roundtable president Jay Stencil. The award is given annually to a person who has made significant contributions to the preservation, promotion or documentation of Maine's Civil War heritage.



In 2010, the SUVCW has 6,349 Brothers in Good Standing. This total represents 5,316 Members, 12 Real Sons, 337 Life Members, 3 Honorary Members, and 560 Associates. The total reflects an increase of 152 from 2009 for a .96% gain. Additionally, there are 120 Juniors and 4 Junior Associates. There are 265 Camps in 28 Departments, 4 Camps-at-Large (NMAL). (The NMAL is composed of Brothers, who live in a state that's not currently administered by a Department.)

## BR. SCHALL ELECTED COMMANDER-IN-CHIEF

Brad Schall of Lincoln, CA, was elected Commander-in-Chief at the 129th SUVCW Nat. Encampment in Overland Park, KS. He is the fourth Californian to be elected CinC, the last being elected 44 years ago.

CinC Schall's membership honors two great grandfathers: Sgt. Wm. Braden Schall, 11th IL Vol. Cav., and Pvt. Willis Reed, 107th IL Vol. Inf., later a Sgt. in the 1st IL LA. Three great uncles, Capt. Absalom Schall, 11th PA, Cpl. Thos. Jackson Schall, killed at the battle of Fair Oaks and Pvt. Geo. G. Schall, 67th PA Inf., all served in the Union Army. Wm. Braden Schall and Absalom Schall were members of the GAR. Twenty-two other ancestors fought for the Union.

Brad Schall is the oldest son of Donald Braden Sr. and Anna Mae Schall. He has one brother and five sisters. He was born in Hutchinson, KS, where his Nana Schall introduced him to his family's Civil War history and the Joseph Hooker GAR Post. Among his prize possessions are his great grandparents' GAR and WRC Encampment ribbons and badges. Both his Nana and great grandmother were members of the WRC. His brother William, son Braden and grandson Christopher are SUVCW members.

During his childhood, he lived one block from Hutchinson's Lincoln Civil War Memorial. He and his family participated in Memorial Day services with descendants of Joseph Hooker GAR Post 17, of which his great-grandfather had been a member. Brad's family decorated the graves of Civil War soldiers at Hutchinson's East Side Cemetery with flags and flowers.

Brad joined Phil Sheridan Camp 4 in San Jose, CA, and during the next 15 years, held almost every Camp and Dept. position. He organized Gen. Alfred Pleasonton Camp 24 in 1999. He served on the Nat. Memorials, E-Bay, Constitution and Regulations, and Sesquicentennial Committees, as Chairman of the Nat. Memorials Grant, Life Membership and Fraternal Relations Committees, as Nat. Patriotic Instructor, for two terms on the Council of Admin., and advanced to become CinC. He was Co-Chairman of the SUVCW Charitable Foundation. He participates with Sacramento's Gen. Geo. Wright Camp 22 and with San Francisco's Camp 24.

He retired in 2002, selling his meat brokerage business and moving to Lincoln, CA. He started his food industry career at Safeway while in school, and spent 17 years at the Quaker Oats Co. in sales, sales management and promotion. He then spent ten years in the export/import business and then, as general manager of a Con Agra Distribution Co. in California. He went into the meat industry after that, owning his own business for eight years.

Br. Brad belongs to the California Hist. Soc., Kansas State Hist. Soc., Derry, Pennsylvania Hist. Soc., Pennsylvania Genealogy Soc., Ft. Larnard Old Guard, Friends of Gettysburg Battlefield, Gettysburg Battlefield Assoc., Lincoln Forum, California Military Museum, Sacramento and San Francisco Civil War Roundtables, Co-Chairman of the Friends of Civil War Alcatraz, Volunteer NPS Docent at Alcatraz Island in San Francisco, Nat. Eagle Scout Assoc., Fellowship of Christian Athletic and is manager of the Sun Eagles senior softball team, and is a U.S. Army veteran.

However he is most proud of his family heritage, his wife Patti, five children, 12 grandchildren and one great grandchild.

## U. S. GRANT REMEMBERED

It's been 125 years since General Grant died just days after completing his memoirs at a cottage atop New York's Mount McGregor.

On July 24th, as 100 people watched, the Sons and Auxiliary participated in a Gen. U.S. Grant Remembrance Day at the Grant Cottage. The green and yellow Adirondack cottage's porch was filled with spectators watching the recreation of the private funeral service held there on Aug. 4, 1885. Prayers, hymns and readings from the original funeral were included.

PCC Ray LeMay, (Representing MOLLUS), PDC Jerry Orton and Br. Capstraw raised the Flag over Grant's Cottage to half staff. They then folded the flag for presentation. Br. Steve Trim, who is an impressionist and interpreter at the Cottage, spoke to the public as Frederick Dent Grant.

DC Jeffrey Albanese and Sr. Lorraine Orton both laid wreaths on the Sons Monument in the middle of the grove at Grant's Cottage.

Bro. LeMay presented the flag to Mrs. Grant in mourning. Br. Orton with Sister Lorraine set up a GAR Display.

***A Resolution Honoring the 100th Anniversary of the  
Founding of the Boy Scouts of America***

Whereas Lieutenant General Robert S. S. Lord Baden-Powell established the World Scouting Movement at Brownsea Island in the United Kingdom on 1 August 1907,

And, Whereas William D. Boyce, Ernest Thompson Seaton, and Daniel Carter Beard, recognizing the potential value of Scouting ideals, values, methods, and practices to American young men, established the Boy Scouts of America on 8 February 1910,

### 12 AUGUST 2010 - OVERLAND PARK, KS

Rep PCinC Andrew Johnson and Exec. Dir. David Demmy. Immediate PCinC David V. Medert and SVCinC James Hanby were recorded as absent.

Additional PCinC's present included Richard Greenwalt, Bud Atkinson, Keith Harrison, Ed Krieser, George Powell, Don Darby, James B. Pahl and Charles Kuhn.

Guests included Nat. Chaplain Jerome Kowalski, PDC Alan Russ (Acting Program & Policy Chairman), Asst. Nat. Treas. Max Newman, Nat. GRO Bruce Frail, PDC Tim Downey (KY), PDC Steve Hammond (MD), DC Gene Mortorff (MD), Br. Mark Day MD), PDC Blair Rudy (TX).

**Civil War Sesquicentennial Committee.** PDC Blair Rudy presented recommendations. CinC Kennedy ruled that the recommendations should be brought to the floor of the Nat. Encampment. He also noted that a medal must be made available for review by the Council of Admin. before approval could be granted.

**Honorary Membership Recommendation.** PDC Tim Downey recommended Ms. Gaye Clark for Honorary Membership. Br. Petrovic moved, Nat. QM Wheeler seconded, to delay action on this recommendation until the Post-Encampment Council of Admin. meeting. Motion passed.

**Ex. Dir. Report.** Br. Demmy highlighted his recommendation to drop Camp requirement to submit Form 22. Nat. Treas. Orr moved, Br. Mellor seconded, to send this recommendation to the Constitution & Regulations Comm. for review. Motion passed.

**Program & Policy Comm Report.** PDC Russ, acting Chairman, presented revisions to Forms 50 and 53; the committee recommended that the modified version of Form 50 be adopted and Form 53 be eliminated due to redundancy. Br. Vieira moved, Br. Campbell seconded. Motion passed. On the subject of revisions to Form 55, the committee recommended the modified version of Form 55 be adopted. Nat. Treas. Orr moved, Br. Petrovic seconded, to approve the recommendations, but requests

that an additional page be developed to include information on dual members. Motion passed. The results of the review of Awards and Recognition Policy were presented. Nat. Treas. Orr moved, Nat. QM Wheeler seconded, to change the award period dates as recommended, plus change "National Executive Officer" to "National Executive Director". Motion passed. Nat. Treas. Orr moved, Nat. QM Wheeler seconded, to accept the Awards & Recognition Policy recommendations with the specified amendments. Motion passed. A discussion was held regarding the intent of the term "member" relative to the B.F. Stephenson, Davis-Linder and Under 40 Awards. Nat. Treas. Orr offered his opinion that "member" means "member" and not "brother". Motion by Br. Vieira, second by JVCinC Schall, that the Council of Admin. stipulate that "member" means "Brother". CinC Kennedy nullified this motion and ruled that this question should be brought before the Nat. Encampment.

**Graves Registration Comm Report.** Nat. GRO Frail presented recommendations. On the request to permit Archives.com to place a link on their website to allow their users to access the SUVCW Graves Registration website, motion by Nat. Treas. Orr moved, Nat. QM Wheeler seconded, to deny the request. Motion passed. The comm. requested that a line-item account be established for development and maintenance of a new database and GR Comm. expenses. Br. Vieira moved, Council Member Mellor seconded, to approve and set a cap at \$5000 for start up. Br. Freshley moved, Nat. Treas. Orr seconded, to amend the original motion to allow up to \$10,000. Motion passed. Nat. Treas. Orr moved, Br. Vieira seconded, to amend the original motion to require the committee to include maintenance costs, which would continue over time. Motion passed. Original motion as amended passed. The comm. requested that it be allowed to make changes to the Graves Registration Handbook without Council of Admin. or Program & Policy Comm. review/approval. Nat. QM Wheeler moved, Nat. Treas. Orr seconded, to approve the recommendation for appendices only. Motion passed.

**Civil War Memorials Grant Fund.** Br. Petrovic recommended putting a limit on funds allocated at \$500. The CinC tasked Br. Petrovic to propose revisions and submit to the Program & Policy Comm. for review.

**2011 National Encampment.** DC Mortorff requested time during one of the National Encampment business sessions to give a short presentation. The Commander-in-Chief granted five minutes.

**Dept. of MD Appreciation.** Br. Day noted that Taylor-Wilson Camp received \$2000 from the Nat. organization to support their projects and expressed thanks. He also noted that letters will be sent requesting support for the Chaplain's Museum in Lynchburg, VA.

**THE AMERICAN'S CREED**

The American's Creed is the result of a 1918 nationwide contest to create a brief summary of the American political faith. Over 3000 entries were received and William Tyler Page was declared the winner. Page was a descendant of John Page, who had come to America in 1650 and had settled in Williamsburg, Virginia. Another ancestor, Carter Braxton, had signed the Declaration of Independence. Still another ancestor, John Tyler, was the 10th president of the United States. Page used his \$1000 prize money to buy Liberty Bonds and gave them to his Church.

*"I believe in the United States of America as a Government of the people by the people, for the people, whose just powers are derived from the consent of the governed; a democracy in a Republic; a sovereign Nation of many sovereign States; a perfect Union, one and inseparable; established upon those principles of freedom, equality, justice, and humanity for which American patriots sacrificed their lives and fortunes.*

### 10TH ANNUAL "STUDENT" CIVIL WAR RE-ENACTMENT IN KING CITY, CA

Over 450 students participated in the Battle of Bull Run I at San Lorenzo Regional Park on May 21st. During the school year, they made their own uniforms in preparation for this event hosted by Chalone Peaks Middle School. The day started off at 8:30 a.m. with a parade to the King City Cemetery for a memorial ceremony, in which students participated in the floral presentation and honor guard. A 3-man firing detail consisted of PCC Frank Avila (Phil Sheridan Camp 4), DJVC Tim Reese (Lincoln Camp 10), and a Confederate member of the ACWA. Dept. Honor Guard Coord. Paul Laverishef, Camp 10 SVC Don Fusilier, and Camp 10 Council Member Tom Brown also participated in the ceremony. There was a large public turnout at the event.

During the battle reenactment, DJVC Reese took command of the 114th PA Zouaves students, PCC Avila commanded the 20th ME Inf., and Br. Laverishef commanded the 24th MI Inf. "General" Tom and "Colonel" Don commanded the field with Gen. Grant; and they stood with President Lincoln and the regimental commanding officers during the review. After the battle, Br. Station Banners: Discussion ensued. Our Nat. Treasurer believes things required by ritual should be provided only through the QM.

(2) A motion to approve the request to allow the requesting Camp to produce station banners was seconded and unanimously failed. (Motion Failed)

License Plates: The clarity of the graphics was discussed. It was agreed that the Camp name should be listed on the license plate.

(3) A motion to return the license requests explaining the deficiencies in the product and urging them to correct and resubmit was seconded and unanimously passed (Motion Passed)

**SUVCW Grave Flags:** The QM could make these available, similar to those used by other organizations. Discussion ensued. (4) A motion for the QM to procure and make available SUVCW Grave Flags was seconded and unanimously approved.

**SUVCW Guidon flags:** The Treas. proposed. (Colors would indicate level – National, Department or Camp.). Each would be custom made. The QM agreed to produce and present a sample at the Gettysburg Council of Administration meeting.

**Long Range Financial Plan (10 years).** The Encampment directed the Council to form a committee to construct a plan to be presented at the next Nat. Encampment. This committee will make recommendations on how to improve the Order's financial planning. Membership will be Brs. Mellor, Vieira and Freshley.

**Investment Comm.** PCinC Grim was appointed chair. Br. Darby will serve with invitations to Brs. Glen Knight and Bruce Gosling. A volunteer from the Nat. Encampment will be contacted. This committee should be open to look at any and myriad funding opportunities or programs.

**Civil War Memorials Committee.** Brs. Petrovic, Freshley and Campbell will serve.

**Photography Protocol.** Rudeness to our photographer (pushed, blocked, etc.) was discussed. Br. Newman suggested that at Encampments, an announcement be made that we have an official Photographer, identify them, and state that the official photographer is not to be interfered with in the conduct of their many duties.

**Members with Disabilities.** Chap. Kowalski explained that at the Encampment, during a “non-voting” period, one of our disabled members was barred from leaving the room when attempting to use the rest room. Discussion revealed that it is against the rules at any time to prevent a member from leaving the room. The room is only sealed in regards to re-entry during those times. The rules on this must be well instructed to the Encampment Guards. This should also be incorporated in the

guidebook managed by the Nat. Encampment Selection Comm.

**Adding Official Photographs to Encampment Proceedings.** Chap. Kowalski suggested and discussion ensued. Adding them would substantially slow downloading time. There is a “Gallery” section on the website with photos from each Encampment.

**Membership Fees.** In order to be in line with the Per Capita increase, the Life Membership reimbursement needs to be re-set.

(5) A motion to set the reimbursement at \$4 was seconded and unanimously passed. (Motion Passed)

(6) A motion to excuse members serving in active combat zones from their dues was seconded and unanimously passed. (Motion Passed) Recognizing our membership serving in active combat zones was discussed.

(7) A motion by PCinC Wheeler to have the Secretary send a card to all known members serving in active combat zones yearly was seconded and unanimously passed. (Motion Passed)

**Honorary Membership.** A previous request from the Dept. of MD to recognize renowned Civil War historian and veteran NPS member Ed Bearrs was reconsidered. Expenses for this membership (certificate and badge) would be borne by the Nat. Order. After discussion on the merits:

(8) A motion to approve an Honorary Membership for Ed Bearrs was seconded and unanimously approved. (Motion Passed)

A previous request from the Dept. of KY to grant an Honorary Membership to Gaye Clark (previously discussed on Thursday) was considered. The recommendation lacked of evidence of service to the Nation, which is an award requirement.

(9) A motion to approve an Honorary Membership for Gaye Clark was seconded and unanimously failed. (Motion Failed)

The Council added that this decision does not in any way limit the Dept. or Camp from considering an award for Ms. Clark.

**National Budget.** The Treasurer indicated it needed to be approved by the Council. Discussion followed.

(10) A motion to approve the final budget was seconded and approved unanimously. (Motion Passed)

**Increasing Charter Fees.** This method of raising funds for the Order was discussed. (11) A motion by SVCinC Palmer to raise Charter Fees to \$50 was seconded, but ruled out of order and referred to the C & R Comm.

**MARYLAND****Buckhannon Camp 49 Restores Monument**

Pvt. Jesse Taylor must have been a popular young man in his hometown of Jollytown, PA. He was the first member of the 7th WV and the first resident of Jollytown to be killed in action during the Civil War. A rebel bullet at a battle just west of Romney, WV, struck him down. In an unusual gesture, his unit and the village of Jollytown erected a monument to his memory in 1892.

**Patriotic Numbers:** With 24 of 28 Departments reporting, only 35% of our Camps participate in events to educate the public like speakers programs, living histories, parades and displays.



Monuments of such quality were typically reserved for high-ranking officers. To make Jesse's memorial even more atypical, it is flanked by a pair of Civil War mortars on one side and a cannon on the other.



The wood and metal of these large guns were in desperate need of paint and the area around the monument was becoming covered with weeds. Four members of Buckhannon Camp 49 painted the guns with high quality paint they received at a 50% discount and trimmed the weeds.

After Pvt. Jesse Taylor's death, the main road through Jollytown was renamed Hero Road and the area where he had lived was named Hero as well. For a private, Jesse Taylor has an unusually large memorial and with the help of the SUVCW and other groups, Jesse's memory and the memories of the other 620,000 heroes who died in the Civil War will not fade.

## MICHIGAN

On June 19th, DeWitt's George W. Anderson Camp 58 gave Pvt. Benjamin Park his final rites in a rededication ceremony at Alma's Bailey Cemetery.

Pvt. Park was mustered into Co. E, 10th MN Inf. on August 15, 1862 for three years. He was honorably discharged on May 29, 1865. It's unknown why his grave had been unmarked for so many years. His descendant, Greg Park, of Seattle, WA, had found the omission while researching at Michigan State University.

On November 20, 2008, six Union descendents met at a bed and breakfast in Sainte Genevieve in response to a local newspaper article about organizing a new Camp. Two were already members of a nearby Camp, but the other four were new to the organization.

This first gathering grew to a chartered membership of seven. On January 13, 2009, Nat. Sec. Donald Palmer installed officers of the newly formed Lt. Col. J. Felix St. James Camp 326. Then, on February 27th, CinC Medert approved the charter. The following June, at the Dept. Encampment, the Camp's charter was presented. Thus, **"we came."**

From March 2009 through May 2010, Camp 326 became known for preserving the memory of our Union ancestors. Numerous activities and projects were planned: grave registrations (highest in the state); Civil War Community book of Ste. Genevieve Cty. Veterans project; two-day Civil War living history; monthly Camp newsletter; online Camp website; SVR unit formed (Co. F, 78th E.M.M.); chartered Auxiliary; grants for Lt. St. James Memorial Plaque; Camp and SVR participation with other area Camps/SVR units, American Legion, and VFW posts on Memorial Day and Veterans Day; and numerous graveside dedications throughout southeastern MO. Thus, **"we saw."**

On June 5, 2010 in Kansas City, MO, the Dept. presented Camp 326 with the James B. Eads Award for the Dept.'s Most Outstanding Camp. Thus, **"we conquered!"**

## EAGLE PROJECT IN PACIFIC

Garfield Camp 4 is the great grand nephew of Pvt. Stultz and was told by his grandmother that she never knew what happened to the private. After years of research, Br. Murphy was able to tell his ancestor's story, but he wanted to do more. He contacted the VA through his local Congressman and a memorial headstone was delivered at the church and placed by Br. Murphy's cousin. It rests only a few feet from the private's brother and Br. Murphy's great grandfather, Conrad Winfield Scott Stultz, Co. B, 21st PA Cav.

## OHIO

Cadot-Blessing Camp 126, in cooperation with the South Gallia High School FFA chapter, helped preserve a piece of Civil War history in Gallia County. The Sons asked the FFA to build a sign to mark John Leaper GAR Post 397's former meeting site. The Post's meetinghouse no longer exists and Camp 126 of Gallipolis now owns the property. The CinC shared the new password for the Electronic Boardroom.

With no further business to come before the Council, CinC Schall asked Nat. Chaplain Kowalski to provide a closing prayer and subsequently adjourned the meeting at 11:20 AM.

Jacob enlisted in Summer 1862 at Nashville's Camp Spears. His son, Samuel, enlisted on December 26th of the same year. After spending two months in the hospital "on account of old age and infirmity," Jacob was discharged on July 28, 1863. A little more than two months later, while still wearing his federal uniform, he was accosted by Confederate bushwhackers, who falsely accused him of shooting at them. They hanged Jacob from a tree near his house, leaving his body for his daughters to cut down.

His son, Samuel was mustered out of service in June 1865. He lived to the age of 91 and died of natural causes in 1936.

Fort Donelson Camp 62 and 10th Tennessee SVR Bns. Timothy and Wayne Moulder, who are direct descendents of Jacob and Samuel, participated in the ceremony, assisted by DC Sam Gant. Moulder descendents from 10 different states also attended the June 12th event.

## Remembering His Sacrifice

On July 24th, four California Camps and two Auxiliaries corrected an historical error. Last November, DGRO Joe Marti was investigating a cannon theft at Vallejo's Sunrise Mem. Cemetery when a worker told him of a Confederate's grave at the cemetery.

However, after some research, it was clear that Pvt. Samuel Brown served in Co. K, 137th USCT. Br. Marti, past-DGRO Donald Hotchkiss of Wm. B. Keith Camp 12 and Dept. Mem. Comm. Chair Kirby Morgan of Geo. Wright Camp 22 found that Brown was a former slave, freed by the Emancipation Proclamation. He joined the Union Army in Macon, GA, one day before Lee's surrender. A new VA headstone was obtained and the cemetery waived their fee because of the unique story.

Phil Sheridan Camp 4 helped conduct the gravesite ceremony. JVCinC Brad Schall MC'd the ceremony, while DGRO Marti presided. Geo. Wright Camp 22, Elmer Ellsworth Camp 23, and Alfred Pleasonton Camp 24 attended. DP Rachele Campbell led the sisters of Mary Walker Aux. 52 and Ivy Stiers Aux. 23. The American Civil War Assoc. provided a firing detail and bugler.

Br. Marti located and contacted Mary Johnson, Brown's granddaughter. She and over 120 descendants attended. During his remarks, Vallejo Mayor Osby Davis declared July 24th, 2010 "Samuel Brown Sr. Day." 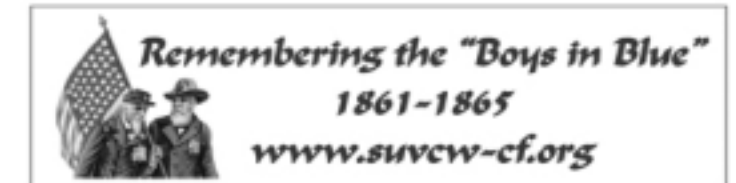
