



**On the Cover:** Last Soldier George H. Pounder was a candidate for GAR Nat. Commander-in-Chief when this Summer 1935 color photo appeared in *The Milwaukee Journal*. Pounder was born near Milwaukee in 1844 and attended school until the 5th grade. He was a 19-year old blacksmith when he enlisted in Co. K, 2nd WI Cav. in 1863. The company saw service as Gen. Custer's headquarters guard.

Pounder was mustered out at the end of the war. In 1868, he moved to Fort Atkinson, Wisconsin, and worked as a blacksmith, repairing and improving plows and harrows, receiving several patents for his designs. He then built a foundry, manufacturing implements of his own design.

In 1872, he lost his 25-year old wife in childbirth and their baby shortly afterwards. He was married twice more, outliving his second wife.

He served on the city council, as an early firefighter on the city's "bucket brigade," and was a patron of the Methodist Church. His hobby was poetry and his work was featured in local and state publications. His charcoal drawing of Niagara Falls also survives.

He was active in Fort Atkinson GAR Post 159, was elected WI GAR DSVC in 1927 and DC in 1928. He served as Asst. AG and Asst. QMG in 1933. As part of an initiative to prolong the life of the state's remaining posts, his wife served as John E. Holmes Post 26 secretary in 1932-35. Comrade Pounder was elected JVCinC in 1934.

When he died on December 10, 1936, at the age of 92, he was the last living Union veteran in Jefferson County.

#### **GENERAL ORDER NO. 10**

In accordance with Nat. Constitution and Regulations, annotated, Chapter III, Article V, Section 1, Duties of Officers:

The Commander-in-Chief is in concurrence with Nat. Counselor PCinC Donald Darby's opinion number 3, whether or not a Camp Commander can hold the office of Camp Commander and Sec/Treas. at the same time. The ruling is: A Camp commander can not hold the positions of Camp Commander and Sec/Treas. at the same time.

Opinion: The Constitution and Regulations of the SUVCW, annotated with the Decisions and Opinions of the Commanders-in-Chief and the Judge Advocate General/Nat. Counselor's and Policy Decisions of Nat. encampments is in fact mute on this question. It is the opinion of this Nat. Counselor that a Camp/Dept. Commander can NOT hold the office of Commander and Treasurer (Secretary-Treasurer) simultaneously. The C&R permits the position of Secretary and Treasurer to be held by one Brother (Secretary-Treasurer) it does not extend that ability to any other elected office/officer. Given that the Camp/Dept. Commander must approve all expenditures by the Treas. (Chapter 1, Article VI Section 1 and Chapter 2, Article 5, Section 4), it would create a conflict of interest for him to hold both (Commander, Treas.) or all three offices (Commander, Sec.-Treas.).

#### **GENERAL ORDER NO. 11**

It is with great sadness that I must report the last World War I doughboy, Corporal Frank Buckles, passed away Sunday, 27 February 2011, in his home in Charles Town, WV. Cpl. Buckles was 110 years old at the time of his death. He was the last known American veteran of that war.

Frank Buckles' cattle farm in West Virginia was not far from several Civil War battlefields.

The Sons of Union Veterans of the Civil War and its 6600 members honor the almost five million Americans who answered their country's call during World War I.

We express our condolences to Cpl. Buckles' daughter Susannah Buckles Flanagan and her husband.

The family asks that donations be made to the National World War One Legacy Project to honor Buckles and the 4,734,991 Americans who served during WWI.

The first time the Sons gathered in Virginia, the Civil War Centennial was winding down and the GAR Centennial was looming on the horizon. Richmond had been selected for the 84th National Encampment. In those days, our convention ran four days, Sunday through Thursday. As we look forward to returning to Virginia for our 129th National Encampment this year, we thought it might be interesting to also look back at...

## **RICHMOND – 100 YEARS LATER – THE 1965 NATIONAL ENCAMPMENT**

Starting Sunday, August 15th, the SUVCW, our Auxiliary and LGAR arrived in Richmond by auto, bus, plane and railroad. Following morning church services, each organization conducted registration. The SUVCW's registration was 116—Auxiliary, 224 – LGAR, 109. On Sunday afternoon, Nat. Chaplains John C. Yocum and Eileen Coombs conducted a beautiful and impressive Memorial Service in the Marshall Room of the John Marshall Hotel.



New York's Br. Joseph Rippey concluded his second term as Commander-in-Chief, presiding over the 1965 Nat. Encampment.

On Sunday evening, Mayor Morrill M. Crown, in a dramatic moment at the Campfire, welcomed the Northerners. Other distinguished guests included SCV Commander Col. John A. May, Virginia Civil War Commission executive director Hon. James J. Geary, DOLLUS NP Mrs. Sara Binder Moore, and UDC NPG Mrs. Quentin Gregory. Prior to and during the Campfire, the U.S. Continental Army Band from Fort Monroe, VA, played "The Battle Hymn of the Republic" and "Marching Through Georgia" among other favorites. Rev. PDC Richard O. Partington presided at the Campfire where PDC Frank M. Heacock, Sr., gave the principal address. Nat. Chap. Yocum gave the invocation and benediction. Lt. Col. Howard Dissinger directed an impressive "Advance to the Colors".

Monday saw business sessions preceded by a Joint Opening of the Sons and Auxiliary under the direction of Chiefs of Staff Miss Viola L. Bremme and C. Leroy Stoudt. On Monday evening, the annual dinner of the Past Commanders-in-Chief and Past National Presidents was held, followed by Auxiliary exemplification of the ritual

and Auxiliary Courtesy Hour. Later the same evening, the Convention Committee presented a Cabaret Dance and entertainment.

Tuesday was devoted to business sessions, followed in the evening by the annual Banquet and

Reception honoring Nat. Officers of the Sons and Auxiliary. LGAR NP Alma Blixt and representatives of the other Allied Orders were guests. At the dinner, NP Emma Wheeler presented a check in the amount of \$500 to CinC Rippey as a gift to the SUVCW. Both Col. May and Mrs Gregory extended greetings from our Southern counterparts.

Wednesday was a free day, including a courtesy bus trip and a tour of the Virginia Civil War Centennial Center and the Berkley Plantation. Walking into the Virginia Room on Wednesday evening at the Military Ball was like entering a time machine. The five crystal chandeliers reflected from gold and white walls and down on authentically costumed SUVCW and their ladies. The men wore Union uniforms. Many wore officer's insignia. The ladies wore silks and satins. The majority of which were in bright reds, yellows and a dozen or more shades of blue. Many of the women were wrapped in long shawls. Some ladies in hoop skirts, curtsied graciously on the arms of their escorts.

An occasional Confederate uniform gliding in tight circles to a waltz enhanced the aura of authenticity. Blue and Gray were grouped together as Virginians and Rhode Islanders chatted about details of "the late war." A group singing southern songs of the Civil War period represented the South, in addition to the uniformed Confederate uniformed good will emissaries.

Thursday saw concluding business sessions, election and installation of officers and closing council meetings.

The National Encampment returned to Virginia and Richmond for the last time in 1980.

## **RICHMOND RESOLUTIONS ADOPTED**



National Encampment Memorial Service

• Opposed limitation of the State's jurisdiction over "right to work" laws and similar matters of largely local interest reserved to the States by the Constitution.

• Opposed the Federal Government's contributions to the cost of education and similar financial aid to the States, which inevitably extend Federal control over matters heretofore responsibilities of the States. Bills that authorized new classrooms and increased teachers' salaries were defeated in Congress in 1961 and 1962 for fear of federal control, exclusion of church-affiliated and independent schools, and desegregation compliance. However, the \$1.3 billion Education Act of 1965 was passed, basing aid on numbers of children from low-income families in each public school district.

The 1965 National Encampment in Richmond was deeply concerned with national events of that time. The Encampment adopted several resolutions, addressing legislation that seemed inconsistent with the intent of our U.S. Constitution. The SUVCW:

 Opposed any modification or weakening of the Connally Reservation, reserving the right of the U.S. to decide what matters are domestic and those in the jurisdiction of the World Court. The Connally Reservation prevented the International Court of Justice from having jurisdiction over domestic matters as determined by the U.S.

• Opposed any yielding of the U.S. sovereignty and control of the Panama Canal or Guantanamo Naval Base.

• Opposed liberalization of the McCarran-Walter Act and

welcomed the support of other patriotic organizations and individuals to work for its retention. The McCarran-Walter Act of 1952 removed racial barriers to immigration and empowered the Dept. of Justice to deport immigrants or nationalized citizens engaging in subversive activities. Parts of the act remain in place, but much of it was overturned by the Immigration & Naturalization Act of 1965.

• Urged the effective enforcement of the Monroe Doctrine and appropriate protection of the U.S. Flag and property abroad.

• Urged Congress to define more precisely the jurisdiction and limitations of Federal Courts.

• Urged the Post Office Dept. to stop free distribution of Communist propaganda and the establishment of appropriate penalties for malicious injuries to public property and deliberate violations of the Flag Code at home.

• Urged that foreign aid be terminated as soon as practicable and accounts audited and settled.

• Urged our members to communicate personally these recommendations to their Senators and Representatives in Congress and ask their active assistance in making them effective a every possible opportunity.

## PATRIOTISM, STRENGTH & COURAGE

At the 1905 WI GAR Dept. Encampment, a resolution was offered, asking that the position of "patriotic instructor" be created at both the National and Department levels. The GAR had experienced success during recent history textbook, U.S. Flag and military drill campaigns, but this might be short-lived. Both the Dept. and National Encampments approved the action. The position's duties were not new, but the focus of the effort was intensified by the change. The Sons' Nat. Patriotic Instructor office was created in 1906, following the GAR's example. Camps, Posts, and Departments slowly, if somewhat reluctantly, followed suit.

Today, the Patriotic Instructor is commonplace. He occupies a red bannered station in front of an assembly of Brothers. Nat. PI Don Martin asked our Patriotic Instructors to comment about the position and their activities.

**DPI Mark Day** (MD) observed, "Many good camps are well organized and administered, but to be a great Camp there must be a greater sense of purpose. Patriotic Instructors can be the source of that sense of purpose. They can keep a camp focused on its duty to perpetuate the memory of our forefathers".

**Br. Steve Williams,** Champion Hill 17 (IN), identified some of the PI's key duties:

"Create dialogue. Patriotism is drawn from the simple, yet complex, principles drawn from our founding documents – both the Declaration of Independence and the Constitution".

"Teach something much deeper than partisanship. Patriotism requires, even when

uncomfortable, allowing others to express views (and methods) which we consider noxious".

"Show that Patriotism must not be transitory; it needs sustained commitment through all conditions. We must not be what Thomas Paine calls "sunshine patriots".

"Examine the concept that Patriotism can, and sometimes should, involve using democratic means to change the policies and programs of the state".

"Provide patriotic enhancing exercises that make people think, and then act upon their reasoned conclusions".

"Present brief situations or scenarios that stimulate questions and discussion. The objective is to enhance or reinforce a mindset that is conducive to patriotic action".

Simply stated, Patriotic Education permeates most of our activities. Most agree, though, that there are two distinct programs.

**CPI Brian E. Watkins**, Gen. J.J. Byrne Camp 1 (TX), replied, "The job of Camp Patriotic Instructor is to bring my Camp information about our ancestors, history of battles of the War, local history, and State History. I educate others outside our Order about facts concerning the War. Mainly, the job is being an educator, both inside, and outside the SUVCW."

**DPI Lyman Baker**, (NY) provides a monthly talk & stays connected to each Camp. He tries to inspire others to remember and perhaps tell others about historical accounts.

**CPI Charles W. Sprague,** E.E. Ellsworth Camp 18 (TX), says, "I see our job as keeping alive the feeling of patriotism, or love of country, by reminding our brothers at every meeting of the sacrifices our ancestors made in order to preserve the Union. I do this by presenting brief historical accounts of the people and events of the Civil War that illustrate those sacrifices and how those people and events impacted the country."

**DPI Mark Day** (MD) summarized, "A Patriotic Instructor has two jobs...to ensure that the sacrifices of those men who gave us our freedom are not forgotten, and to mentor the citizens of our country, young and old, in order that they may see their shared obligation with the patriots of our past. 'Lest we forget' should be the motto and oath sworn by every Patriotic Instructor."

The Internal Program, aimed at our Brothers, includes presentations on Civil War topics during meetings, encampments and other events. This program also includes occasional trips to historical sites and museums.

**CPI George Andrew Huttick**, Fort Donelson Camp 62 (TN), suggests, "It is a useful position to keep key activities and opportunities in front of the Camp, and to encourage spirit within the Camp. This can be done by inspirational messages, etc. A monthly patriotic message is either given at the Camp meeting and/or emailed and posted on the Camp's Face Book page. Additionally, other programs are encouraged (e.g. Memorial University).

**DPI Brian Pierson,** (GA&SC) theorized, "Ideally, every Brother should be a 'patriotic instructor' to his fellow citizens. But the PI must be more than just a cheerleader. Because American patriotism is based on the principles expressed in the Declaration of Independence and the Constitution, it demands more than just mere flag-waving. It requires a citizenry educated in these principles. So, the PI is a teacher or a coach who gives his Brothers the tools they need to be able to engage the public..."

**DPI John M Bowyer** (IN) summarized, "Patriotic Education is a very important part of our Order and my role is to support and encourage all of our Brothers to be Patriotic Instructors in their daily lives."

The External Program demonstrates not just patriotic outreach, but the Sons' role in the local community. Aimed at the general public, this program includes talks to schools and community groups, special programs like Presidents' Day luncheons and U.S. Flag retirements, and displays at Civil War events and other venues.

## WHY A PATRIOTIC INSTRUCTOR?

#### By Hosea W. Rood

Once a chosen Patriotic Instructor at one of our Grand Army Posts wrote to me to say that he did not believe in any such officer, and would have nothing to do with it; that people **ought** to be patriotic without it. This comrade told the truth. People surely **ought** to love their country, to be true and loyal to their flag and all it signifies. So, also, ought people to be honest and upright; to observe the Golden Rule in all their relations with one another, and be reverent toward God. There is, nonetheless, a tendency with many of us not to be so good as we **ought** to be. Therefore, we need teachers—bible teachers and preachers—to lead us into the path of duty. And so we need also to be taught the importance of being true and loyal to our country. Especially do our children need such teaching in the duties, obligations and privileges of American citizenship. It was indeed wise in the Grand Army to create the office of patriotic instructor. Though many persons honored with appointments to the position have proved



indifferent and negligent, thinking every man should be patriotic without special instruction, it is a fact that the active interest of hundreds, yes thousands, of Grand Army patriotic instructors in our country has had a greater influence for good than we can understand. Our urging such teaching at all times has led teachers to give patriotic instruction in nearly every school. I know that more and more attention is being given to this matter. This is indeed encouraging. If ever wholesome instruction in Americanism has been needed, it is now.

Hosea Rood was born in 1845 in Persia, NY, not far from where his grandfather deserted the British Army during the War of 1812. After moving to Wisconsin, Hosea enlisted in Co. E, 12th WI Inf. at age 16. After three years, he re-enlisted and was promoted to corporal. He was wounded at Atlanta, survived, and was mustered out in July 1865. After the war, he graduated from Milton College, receiving his State Teacher certification. He served as principal of five different schools and was active in Milton's A.D. Hamilton GAR Post 60. At the time of the above writing, he had been Dept. PI for over 15 years, starting in 1906. He made as many as 100 school appearances a year. With the exception of a one year retirement, he remained an influential PI until his death in 1933.

**DPI Mark Day** (MD) said, "Patriotic Instructors can make contact with other fraternal organizations, schools, and churches. They can promote programs such as presenting flags, organizing speaker's bureaus, or ensuring youth recognition programs such as Eagle Scout and JROTC are in place. "

**DPI PCC Richard Hardesty** (FL)\, replied, "I'm actively coordinating with Graves Registration to get the message out about all the Union veterans buried in Florida. I also coordinate a program to have high school children visit a cemetery, photograph a Union Veterans' headstone and then research his family, unit, et al. The next step is to follow up with the Wreaths Across America program and honor these veterans by placing a wreath on their gravesite at Christmas time."

**CPI Robert Meyer** Custer Camp 17 (NJ), volunteered, "I help raise money for wounded veterans like Brendan Marrocco who lost both arms and legs. I challenge other Camps to help us with this cause."

**DPI Brian Pierson** (GA&SC) uses help from others, "I have found it useful to supplement the excellent Nat. Patriotic Instructions with Dept. Patriotic Instructions that address current events in light of our history, American exceptionalism, and the founding principles of our Republic and that reinforce the understanding that our country was founded to uphold democracy and liberty, with the opportunity for prosperity to all."

**Br. Steve Williams** concluded that we need to..."Forge our own concept of patriotism that we can champion during the sesquicentennial – making it our "brand". There is much discussion among professional historians, authors and state authorities – none of whom is listening to the other- about how to "manage" the sesquicentennial activities. This involves different views (infused, in many instances, with substantial "political correctness") concerning African slavery and its role in the conflict, the Lost Cause mythology, etc. I am hopeful that we can somehow rise above this confusion.



Comrade Hosea Rood observed, "A commander has influence within the Order, but a patriotic instructor reaches out in every direction, especially into the schools, where our boys and girls are receiving their first ideas of, and training for, good citizenship; and this field is all but limitless." **CPI** Brian E. Watkins, Gen. J.J. Byrne Camp 1 (TX), says, "I have my Camp lead and participate in formal U.S. Flag and Texas Flag Retirement Ceremonies. Both were well received, and we educated the public on the proper ways to retire flags, and whom to give the flags to be retired."

**DPI PDC Mike Rusk,** Indian Nations Camp 3 (OK), added, "I feel the best thing I do is coordinate the Memorial Day and Remembrance Day observances. The entire camp and members of the community attend these gatherings and the reverent atmosphere and patriotic speeches are, to me at least, what our Order is all about. Lest We Forget."

**PDPI John Lazzeri** (CT) agreed. "The Patriotic Instructor's main role is Memorial Day...not only the "Day" but any flag decoration or cemetery services. From this, he builds his lessons during the next 11 months..."

### THE GAR 'S "ARMED BATTALION"

It was a cool overcast autumn morning when E.K. Wilcox GAR Post 16 assembled at their hall in downtown Springfield, MA. It was 9:30 AM, Sunday, September 25, 1887, and 66 post members were preparing to march to the train station a few blocks away. The Boston & Albany train would take them to the GAR Nat. Encampment in St. Louis, MO. The post was not just attending this encampment; most of these men were serving as the "Escort to the Commander-in-Chief" of the GAR. Collectively, they were the "Armed Battalion, which had marched in many parades and were known throughout the GAR for their precision and execution." Today, we'd call them a close-order drill team. That morning, after a breakfast served by the local WRC, the boys boarded two special cars on the 11:25 AM express train, taking them from Springfield to Cleveland to St. Louis. The train arrived in St. Louis, early Monday morning. Upon arriving, the post marched to Washington Park where the rest of its Dept. was preparing to camp for the duration of the encampment. The day also included receptions throughout the city.

The men awoke Tuesday morning to a torrent of rain. Encampment leaders postponed the parade until Wednesday, but the rain persisted. Unwilling to postpone or cancel again, despite the bad weather, the leaders set the parade for Wednesday morning. At exactly 11 AM, mounted police started down Franklin Ave. and turned onto 12th St. Grand Marshal Grier, his staff and St. Louis' Logan Post, all mounted, followed. The "Armed Battalion" marched behind their horses, performing various maneuvers. CinC Lucius Fairchild marched directly behind his "escort" wearing a raincoat. He and his mounted staff of 100 men preceded 20 carriages, three abreast, which contained War Governors and

other honored guests, like Gen. Sherman, who received loud applause.

What followed resembled a scene from Disney's Fantasia. Marching mushrooms were, in fact, thousands of GAR members, their umbrellas lifted against the rain. Only the MA Dept. refused to use umbrellas. The departments marched in order of seniority, except for the host (MO), which brought up the rear.

As the procession wound its way down 12th St., it passed under an arch, memorializing Lincoln and Grant in life size glass mosaic pictures. When the boys passed under the arch, they doffed their hats in respect to their departed leaders. The

triumphal arch, further ahead, depicted battle scenes and the GAR membership badge. The reviewing stand was located soon after the second arch. When reaching the reviewing stand, the parade paused as CinC Fairchild, the War Governors, Gen. Sherman, Ex-VP Hannibal Hamlin, and others took their seats. Grand Marshal Grier and his staff sat in their saddles across the street, facing them. For the next hour and a half, thousands of GAR members marched past while the rain continued to fall. The MO contingent was so large, it took 25 minutes to pass. Generals Fairchild and Sherman bowed, continually acknowledging the rousing cheers that went up from each post as they filed by. A squad carrying tattered battle-flags received enthusiastic applause all along the parade route.

As the soldiers reached the end, they broke ranks and hurried back to the reviewing stand to catch a glimpse of their former leaders. At one point, they blocked the street, stalling the rest of the column. The IL Dept.'s mounted staff forced a path through the crowd. As the parade ended, so many surrounded the reviewing stand that "Uncle Billy" Sherman had to be rescued from well-wishers and autograph seekers.

The "Armed Battalion" left St. Louis Thursday night, arriving at the Springfield Railroad Station on Sunday morning. The post's remaining members met them there and escorted them back to the post building where the WRC provided hot coffee and sandwiches.

**Editor's Note:** The story of the Battalion's trip was gleamed from newspaper articles in the **Springfield Daily News** from September 24 to October 2, 1887.

## **TEXAS SESQUICENTENNIAL EVENT**

#### By CC David LaBrot, Lt. Cmdr. Edward Lea, USN, Camp 2

On February 12th, Sons and reenactors from all over Texas, participated in the dramatic reenactment of the Federal Army's surrender in Texas. This event, recognized the 150th anniversary of the Civil War and was the first in a series of "Signature Events" recognized by the SUVCW. The setting was the Alamo in San Antonio, the location of the original surrender.

During this historic event on February 16, 1861, predating the bombardment of Fort Sumter, about 1,000 Texas militiamen and other secessionist militia companies suddenly surrounded the 200 garrisoned Federal troops, commanded by U.S. Army Brevet MG David E. Twiggs. The secessionists demanded an immediate surrender of federal arms, munitions, stores, and public property.

The narrated 2011 event included: the escorted arrival of Gen. Twiggs by horse and buggy; an assembly of Federal troops and numerous Texan militia units; the reading of the surrender ultimatum; the offer of loyalty cross-over given by Texan Col. Ben McCulloch; the lively depiction of the lone cross-over, a Virginia-born federal officer, who was forcefully stripped of his sword by outraged Federals; the tension and near armed conflict between the Texas Militia and the Federal troops; the reading of Order No. 5 (the surrender); and fine depictions of Sam Houston, Robert E. Lee, Gen. Twiggs, and Col. McCulloch.

The entire reenactment was performed twice to a large and very appreciative audience. The Dept. recruited several new members and received favorable television coverage in San Antonio.



Encampment (1) supported the observance, (2) recommended it be called "Union Defender's Day," and (3) prescribed that the CinC issue orders providing for its observance by our Order.


#### LINCOLN VISITS THE OHIO STATE HOUSE

Lincoln (Fritz Klein) was introduced in the House Chamber by Gov. Dennison (PDC Bob Davis) at the same podium with the same speaker's chair in the background. 





#### New Jersey Camp Rededicates Monument

Last Veterans Day, Hiram W. Pursell Camp 104 rededicated a 140-year old Civil War monument at South Hunterdon Regional High School in Mount Airy. The 25ft. high monument was erected in 1870, in Lambertville's Mount Hope Cemetery. It was assembled in three pieces; on its pinnacle stood a bronze eagle with a 5-ft. wingspan.

The eagle remained there until 1898, when the iron bolts that held it rusted and failed, sending it some 25 feet to the ground. The eagle was replaced with a life-sized statue of a Civil War soldier and the entire monument was moved to Mary Sheridan Park in the center of town, where it stands today. In 1900, the local GAR decided the eagle should be saved for posterity and Lambertville's high school became its caretaker. The eagle was reattached to its 6-foot base with the inscription "G.A.R. Post 20 1900" carved into it. It stood in front of the

school until moved in the 1950s to a new high school in West Amwell.

The original meaning of the monument faded. When Camp 104's Br. Les Salsbury was attending a school function for one of his children, he noticed the monument and its inscription. Students and teachers knew nothing about the monument, so Camp 104 began a re-education program. Present at the rededication service along with members of Camp 104, were local veterans and high school students. The original GAR Memorial Dedication Ceremony was used, accompanied by fife and drum, plus Taps, played by a school band member.

In an ironic twist of fate, the descendent of the model for the Civil War soldier statue that replaced the eagle, (Miss Maryann Ransom) was also present.

A 15-month fundraising and community partnership project had culminated with the reassembly of the "Sherman" cannon. The 1861 Parrott Field Rifle tube had been cleaned, refurbished, and placed on a new cast aluminum carriage.

Early 20th century newspapers say that the cannon was sent to Ben Butterfield GAR Post 77 after the group sent a request to then General of the Army Wm. T. Sherman. The post wanted to use a proper cannon in parades and observances.

Lost to history for much of the 20th century, the gun tube was resurrected from a ditch behind Lancaster's Sherman House Museum in the mid-1960s and restored at that time by local residents and the Fairfield Heritage Assoc. The gun was last fired for a Veterans Day ceremony in 1969. Carriage repairs were completed in 1985. Since then, the assembly sat on Lancaster's Veterans Square, slowly deteriorating from the effects of weather and neglect.

Camp 21 will feature the cannon in parades and observances just as in days gone by. The gun will be the main attraction at Veteran's Square, starting Memorial Day 2011. It will appear in the 4th of July parade and a blank charge will be fired to kick off the fireworks display. Learn more at www.savethecannon.com.

Gen. Benjamin D. Fearing Camp 2 has completed the restoration of a GAR monument in Marietta's Oak Grove Cemetery. The monument commemorates Buell GAR Post 178 and the dead buried elsewhere in unknown graves. While the exact age of the memorial is unknown, it has been a prominent fixture in the "Soldiers' Plot" for many years. Ongoing maintenance and repair work by Camp 2 have kept the monument in good condition, but

metal portions of the arch had deteriorated so that the entire metal framework had to be replaced and the concrete base resealed. The original arch bearing the words "IN MEMORIAM - UNKNOWN DEAD" was exactly reproduced using "at cost" donations and material from area citizens and businesses. The letters were watercut, drilled, and all metal parts were powder-coated (including the original eagle atop the arch) before being hand-drilled, riveted and reassembled. All work and reassembly was accomplished by Camp 2. The newly refurbished Buell Post G.A.R. memorial stands within the more conspicuous of two Civil War burial sections in Oak Grove and is highly visible from Eighth Street fronting the cemetery. Camp 2 is planning a rededication of the monument and interpretive tour of historic Oak Grove Cemetery near Memorial Day 2011.

At the annual Military Order of the Loyal Legion of the United States (MOLLUS) annual Abraham Lincoln Birthday commemoration in Washington DC, MOLLUS CinC (and SUVCW PCinC and SVR Past Commanding Officer) Keith G. Harrison met the Secretary of Education (Luis Maldonado Venegas) and his delegation from the Mexican State of Puebla. They were guests to the MOLLUS banquet and Sec. Maldonado was slated to lay the wreath of the Diplomatic Corps at the MOLLUS Lincoln Memorial program the following day. During the banquet, the Mexican government awarded CinC Harrison a medal with neck ribbon, acknowledging his and the MOLLUS role in preserving Lincoln's memory and his activities with the Civil War Sesquicentennial.

Also at the banquet, Sec. Maldonado (on behalf of Mexican State of Puebla Gov. The battle of Cinco de Mayo was a Mexican-French Battle in which the French lost terribly and ultimately lost their foothold in Mexico. The battle also effectively stopped the French from providing support and supplies to the Confederate States of America. MOLLUS CinC Harrison has since extended this invitation to the SVR. He also has initiated discussions with the Mexican Ambassador to the U.S. about the arrangements that would be needed for this to occur.
