GENERAL ORDER NO. 11

Cornelius F. Whitehouse Award (est. 1994)—presented to the CinC's choice for the most outstanding brother during the last year.


B.F. Stephenson Award (est. 1996)—presented to the brother, who is the top recruiter during the last year.

CIVIL WAR SESQUICENTENNIAL EVENT

THREE DAYS OF THE MONITOR

On January 30, 1862, the USS Monitor was launched from the Continental Works in Greenpoint, Brooklyn, New York. 150 years later, a National Sesquicentennial Signature Event commemorated the event. The event, held January 28th, 29th and 30th, recognized inventor John Ericsson, builder Thomas F. Roland, the crew and the Continental Works workers, who built the ship.

The New York Dept., Oliver Tilden Camp 26, Co. I, 83rd New York Vol. (SVR), the Greenpoint Monitor Museum and the John Ericsson Society sponsored the event. Camp 26 and the museum took the lead in organizing the observance.

On Saturday, a history fair was held at Capital One Bank (formerly Greenpoint Savings Bank). Monitor builder Thomas Fitch Rowland was an early trustee of the Greenpoint Savings Bank. That evening, a Civil War concert was held at the Church of the Ascension. Rowland donated funds from the Monitor's construction to build this Church.

On Sunday, a Memorial Service at the Church was followed by a parade from the Church to the site of the launch and the future museum for a ceremony. Later, an anniversary reception was held at Grand Prospect Hall.

On Monday, wreathes were laid at the USS Monitor statue in McGolrick Park. 350 students from PS 110 carryied their flags of tribute from their school to the statue led by Camp 26, the museum and USS Lehigh. The bus tour stopped at the launch site, the Brooklyn Navy Yard, the Grand Army Arch, Greenwood Cemetery (graves of the crewmen), and finally, the wreath laying ceremony at the John Ericsson statue in Battery Park, NYC.

The Sons of Union Veterans and Greenpoint Monitor Museum lead the parade from the Church of the Ascension to the USS Monitor's launch site at Quay St. and the East River.



At the reception, a grand entrance was made at the Grand Prospect Hall. Co. 1, 83rd NY Vol., SVR and USS Lehigh sailors served as the Color Guard. The Old Bethpage 11piece Civil War Brass Band played the National Anthem. The evening was filled with Civil War Music to everyone's delight.



OUR UNION DEFENDER'S DAY TRADITION

Pres. Lincoln's birthday was first recognized in 1866, less than a year after his death. A ceremony was held at the Capitol building with Pres. Johnson, his cabinet and other dignitaries present.

The Sons of Veterans, USA, held the first nationwide observance in 1889. In General Order 17, CinC George B. Abbott requested that all Camps hold appropriate services, celebrating Lincoln's birthday on February 12th. Based upon the celebration's success, CinC Abbott recommended that the observance be made a feature of our Order and be provided for in the Constitution. The 1890 Nat. Encampment (1) supported the observance, (2) recommended it be called "Union Defender's Day," and (3) prescribed that the CinC issue orders providing for its observance by our Order.

CHESAPEAKE

On February 11th, Irish Brigade Camp 4's Annual Lincoln Birthday Dinner was held in Fredericksburg, Virginia, as was Taylor-Wilson Camp 10's 4th Annual Lincoln Birthday Dinner at Lynchburg College.

On February 12th, Luray-Carlisle Camp 1881 CC Mike Bell represented our Order at the Lincoln Birthday event at the Lincoln Family Homestead, Rockingham County, Virginia.

IOWA

Co. A, 49th Reg., Iowa Vet. Vol. Inf. partnered with the Historical Society, the City planners and the local police department. A photo from a grave marking ceremony last summer was printed on Des Moines' downtown February monthly parking passes. In honor of our 16th President's birthday, the pass featured the unit with Pres. Lincoln (Stan De Haan).



NEBRASKA



Over 140 people, the most in the event's 5-year history, attended the Gettysburg Address Ceremony at State Capitol. Creighton University's ROTC Color Guard posted the colors. A Cub Scout from Lincoln's Pack 48 delivered the Pledge of Allegiance. Pres. Lincoln (Stan De Haan of Orange City, IA) gave the Address.. Also present was State Senator and SUVCW member LeRoy Louden.

After the ceremony, programs and displays were held at the Nebraska State Historical Society Museum.

OHIO

On Feb 11-12th, Lincoln Dinners were held by Manfield's McLaughlin Camp 12, Columbus' Gov. Wm. Dennison Camp 1, Chillicothe's Sgt. Richard Enderlin Camp 73.

WISCONSIN

Rev. Robert Miller spoke to nearly 100 people, representing over 35 different patriotic and hereditary organizations at Milwaukee's 42nd annual Patriotic Luncheon, held February 4th. C.K. Pier Badger Camp 1 and Auxiliary 4 have hosted an observance since 1890. Brothers from Henry Harnden Camp 2, MG John Gibbon Camp 4, Lt. Alonzo Cushing Camp 5, Old Abe Camp 8, and sisters from Ammi Hawks Aux. 5 also attended.

A raffle and silent auction were held, with proceeds benefiting veterans' relief, patriotic education and historic preservation.



Lincoln's birthday is legally recognized in ten states (CT, DE, IL, MN, NJ, NY, ND, PA, WA, WY). It last failed to make Federal Holiday status in 1968, when Washington's birthday observance was moved to the 3rd Monday in February. In 1971, the day was renamed Presidents' Day.



A SOLDIER'S DIARY LIKE NO OTHER

Family history became a lot more important to me after my father's death. Picking through pieces of my family tree puzzle, I made many new discoveries. I found two ancestors in the Civil War, and three in the Revolutionary War.

My attention focused on photographs of my G-G-Grandfather, George E. Dixon. One had names written on the back, which I entered into a genealogy web site. One tree matched mine and I made a phone call. My new cousin agreed to send me our G-G-Grandfather Dixon's diary.

Dixon was born in Pound Ridge in 1834 and married in 1859. After the war broke out, he enlisted in the 172nd NY Inf. He was transferred to Co. M, 6th Reg. NY Heavy Artillery that December. He fought at Manassas Gap, Wilderness, Spotsylvania, Cold Harbor, and Bethesda Church. He was wounded in this last battle, and later, at Petersburg, was shot in the right arm. Transferred to Co, C, 14th Reg. Veterans Reserve Corps, he was appointed sergeant of the guard at the Washington, D.C., penitentiary, where he was in charge of the guards at the execution of Mary Surratt, Lewis Payne, George Atzerodt, and David Herold.



Thumbing through the diary, one page got my attention...a page listing the names of the conspirators to be hanged on July 7, 1865, along with the names of guards and cell numbers. These cells were where the conspirators were kept.


I was in the court room during the day while the

I was in the court room during the day while the witness's were being examined. I saw the bullet that killed the President, also the pistol and two carbines. Booth's photograph and the boot that was cut open to take it from his broken leg by Dr. Mudd.

The day of the execution, he wrote,

July 7, 1865: On guard at the penitentiary. The execution of Mrs.Surratt, Payne, Atzerodt + Herold.

The last four names on the page were the "prop knockers", the men assigned to knocking the wooden post out from under the doors the conspirators were standing on.



The diary is the first known document found to list the names of the guards and their charges. It's a firsthand account in the handwriting of the man who was actually there and participated in this historic event. Furthermore, it proves conclusively that the condemned were moved to cells on the first floor, where two guards each were stationed for duty. Prisoners spared from the gallows were assigned one guard each.



After his discharge on July 31, 1865, Dixon returned to Pound Ridge, where he carried mail for 22 years. When rural routes were instituted, he continued carrying freight and passengers until 1916. On March 16, 1925, 90-year old George E. Dixon died, just 19 days shy of his 66th wedding anniversary (April 4, 1925). He was one of the oldest members of Stamford's Charles A. Hobbie GAR Post 23. He was survived by his wife, Sarah E, four children, 14 grandchildren and 15 great grandchildren.

California Provides Four GAR National Leaders - Two are Los Angeles Comrades -

Early in 1867, Maj. Thomas J. Blakeney (1st CA Vol. Cav.), of Sacramento, who had been on a visit East, returned with authority to organize the GAR on the Pacific coast. On May 7, 1867, Blakeney named John F. Miller the Dept. of California's Provisional Commander. Gen. Miller assumed command on May 8th. The Dept. of California's 1st Annual Convention met at San Francisco's Eureka Hall on February, 21, 1868, and effected a permanent organization.

Sacramento's Elbridge Lafayette Hawk was the first Californian elected CinC during the Encampment on Sept. 15, 1927 at Grand Rapids, MI. At age 94, "Colonel" John S. Dumser of Oakland, CA, became the 76th GAR Commander at the Nat. Encampment in Indianapolis on Sept. 17, 1942 when he ran unopposed for CinC.

Two National Commanders from Los Angeles were elected over the history of the GAR:

Russell C. Martin was born November 24, 1848 at Randolph, VT. He served in Co. I, 1st VT Cav., enlisting on December 17, 1863 at the age of 15 years. He served in the Army of the Potomac under Generals Custer and Sheridan.

Comrade Martin came to California in 1881. He was Past Commander of Los Angeles' Bartlett-Logan Post 6, served as Dept. Commander (1919-1920), and was commandant of the California State Veterans' Home at Yountville (1921-1926). It was with that position that he received the title of "Colonel." Martin was the Dept. Judge Advocate General and Nat. SVCinC when he succeeded CinC Wm. P. Wright upon Wright's passing on June 15, 1933.

Comrade Martin died on Dec. 29, 1945, and is buried at Forest Lawn Cemetery, Glendale, CA.

Dr. Overton H. Mennet, M.D. was elected CinC on Sept. 7, 1937 at Madison, WI. He had served as Nat. JVCinC during 1935-1936. Mennet was Dept. Commander of California-Nevada in 1933-1934, and had served as Commander of the Southern California Veterans Association in 1926-1927. He was past commander of Los Angeles' Stanton Post 55. Mennet led the GAR veteran ranks at the 1938 Gettysburg reunion.

Dr. Mennet came to Los Angeles in 1910, after having practiced medicine in Columbus, OH, for nearly 40 years. He was born on an Indiana farm in 1830, and enlisted in Co. E, 146th IN Inf. on Feb. 15, 1865. His service saw him guarding trains at Harpers Ferry. He was discharged on Aug. 31, 1865.

Dr. Overton answered the Last Muster on Jan. 25, 1941and was buried at Rosedale Cemetery.

THE LOS ANGELES LAST MAN CLUB

Los Angeles' Stanton GAR Post 55 held its last full ritual meeting on Dec. 17, 1937, in the Lincoln Room of Patriotic Hall. During the meeting, the 19 comrades present offered a toast to the Post's departed members and to the Last Man Club, organized in 1935 with 44 members. On Nov. 30, 1942, the Club's nine remaining members met again at Patriotic Hall.

Only 102-year old **Charles L. Chappel** could attend the meeting of Post 55 and The Last Man Club on April 8, 1949. The other two members, Douglas T. Story and William A. Magee, were confined to their homes. Despite his mobility, Chappel was the first of the three to answer the Final Roll Call.

Charles L. Chappel was 102 on July 7, 1949, and was the last California-Nevada GAR Dept. Commander. At the Dept.'s 82nd Encampment at San Diego, only five members were reported living in California and Nevada. At 17, Chappel enlisted in Co. B, 10th NY Inf., and as a private, he stood picket duty at Appomattox Courthouse when Gen. Lee surrendered. On



Sept. 2, 1949, he flew back from the GAR's last Encampment in Indianapolis. There, Vice Cmdr. Chappel's hope to be Nat. Commander was shattered when the six delegates voted against it. He asked CinC Theodore Penland, 100, of Portland, OR, to let him hold the gavel a minute and thus, symbolically closed his career as the delegate who always flew back to the Encampments. Chappel refused to go to a hospital when he had a heart attack at his Long Beach home. After a second attack several hours later, he was taken to the Naval Hospital where he died on Sept. 20, 1949. He was buried in Westminster Memorial Park in Westminster, CA, and was the last known Civil War veteran of Orange County. (Los Angeles Times, Sept. 21, 1949)

Douglas T. Story was born November 24, 1844. Mr. Story ran away from home twice in the early days of the conflict, only to be brought back home by his father. He finally succeeded in enlisting at the age of 18 and saw action with Co. I, 136th IL Vol. Inf. He fought through the war without being wounded and was honorably discharged. Upon returning home, he took up carpentry. He died April 22, 1952 at the age of 107 at the VA Center Hospital in West Los Angeles; and is buried at Los Angeles Nat. Cemetery. A son, Louis Story, served as SUVCW California & Pacific Dept. Commander in 1956. (Los Angeles Times, April 23, 1952)

William Allen Magee served as a private in Co. M, 12th Vol. OH Cav., enlisting October 20, 1863. He ran away from home as a 13-year old to be a bugler with Gen. Sherman on his historic march to the sea. He was a veteran of five of the nation's wars and retired from the U.S. Army as a Master Sergeant in 1898. He served under Lincoln, in the Indian Wars, the Spanish-American War, and skirmishes on the Mexican border. "Remember one thing, young man," he said in his last interview, "You can't beat the American ... always remember that. We are free men." "Our beloved United States," Magee said on his last birthday, "has never been licked in war and we never shall be licked. They just can't lick her, because we have the power. We have real power — and we have real men." Sgt. Magee also had some advice on alcoholic beverages. "Haven't had a drink of liquor myself for the past 50 years," he said. "And when I did drink, it was pure corn whiskey that the mountaineers made. It was good for a man. Today the young men mix their drinks. That's what shortens their lives." He had been in excellent health until Jan. 2, 1953 when he suffered a stroke. At age 106, one of America's last three Union veterans answered his final muster on January 23, 1953, at Wadsworth General Hospital at the Sawtelle VA Center. He was laid to rest in the Los Angeles Nat. Cemetery. The bugler's favorite music, the "Battle Hymn of the Republic" and "Tenting Tonight on the Old Camp Ground," were played during the burial ceremonies. Sgt. Magee's passing thinned the nation's ranks of Union veterans to two, one of whom was younger than Magee. The two were James A. Hard, 111, of Rochester, NY; and Albert Woolson, 105, of Duluth, MN. (Los Angeles Times, Jan. 24, 1953)

KNOWN ONLY TO GOD...AND A COUPLE OF OTHERS

From a report by Br. Mark Tennant, Buckhannon Camp 49 (Chesapeake)



I've been doing research on Civil War soldiers at West Virginia's Grafton Nat. Cemetery for the past seven years. I've identified 15 previously unknown Union soldiers buried there. In addition, I found mistakes in the names of two others. Br. Michael Phillips has identified one previously unknown soldier.

In May 2006, I submitted identifying research on the first five soldiers to the cemetery director. She forwarded it to historians at the National Cemetery Administration (NCA) in Washington, DC. After a year, they notified me they agreed with my research on four of the five. I then submitted another soldier and they agreed with that research also. I was told the U.S. Army is next of kin on all unknowns and the NCA can't provide headstones until Army either says the research is good enough to identify them or it needs more information like DNA. I recently submitted research on nine more soldiers. Br. Phillips, also of Camp 49, contacted the U.S. Army which said that Civil War soldiers were low priority, their focus was on WWII soldiers. DNA would have to be used for the final proof, so we would need these soldiers' descendants to give DNA samples.

Grafton Nat. Cemetery was established in 1867. From mid-1867 to late 1868, 1,251 Union soldiers were disinterred from battlefields and roadsides in West Virginia. Of these, 583 are known, 668 are unknown. The cemetery burial register gives the grave location, name, rank, regiment, company and date of death if known, the date interred, where the body was removed from and sometimes some brief remarks about the soldier. By using adjutant general records, history books and soldier records, I was able to learn the identity of 15 previously unknowns.

Pvt. Jesse W. Gardner, 20, Co. I, 32nd O.V.I., died April 14, 1862, at Huttonsville, (West) Virginia. The burial register correctly listed his last name, rank and unit. He was removed from a Randolph County farm. However, his stone was marked "unknown."

Pvt. Riley G. Davis, Co. A, 14th (West) Virginia Inf., died at the Battle of Greenland Gap near Moorefield, WV, on April 25, 1863. The burial register has this information, but his gravestone also says "unknown."

The West Virginia Adjutant General's report showed only one Union Soldier from the 14th WV killed in battle- Riley Davis. The others I have identified are: Pvt. Albert Aldrich, Co. C, 152nd IN Inf.; Pvt. James M. Cottrill, Co. E, 8th WV; Sgt. Right Bird Curry, Co. A, 10th WV, Pvt. Andrew Estep, Co. I, 8th WV; Pvt. John Friese, Co. G, 146th OH; Sgt. Jacob Frintz, Co. F, 28th OH. Also, Pvt. Johann Ingold, Co. A, 37th OH; Pvt. Michael Joyce, Co. G, 23rd IL; Pvt. Joseph Kedar, Co. A, 23rd IL; Pvt. Charles Pleffer, Co. C, 23rd OH; Sgt. Henry Reichelderfer, Co. C, 14th OH; Pvt. Emil Rosencranz, Co. A, 37th OH; Pvt. Andrew J. Fulkaneer, Co. E, 3rd WV Cav.

Br. Phillips identified Pvt. Patrick Keeshan, Co. A, 10th O.V.I.

In addition, I found mistakes on two gravestones; Pvt. Samuel Miller, 32nd O.V.I., should be Samuel Mills, 14th O.V.I. and Pvt. James Illiff should be Pvt. Pvt. James Joliff, 23rd O.V.I.

I am looking for information on several unknowns. One record says: "Supposed to be from St. Lawrence Co. NY. His white dog has remained in the vicinity and lay on his grave every night since." The only regiment from upstate NY that was in New Creek, WV was the 106th NY Inf. I have narrowed it to approximately 10 soldiers who died at New Creek in the fall of 1862.

An unknown hospital nurse, reinterred Nov. 8, 1868, from the hospital graveyard in Clarksburg, WV, was buried at Grafton.

Since this was written, I believe I've identified three more unknowns and found an error in another's identity. They are Pvt. Andrew Baily, Co. I, 8th WV Inf.- later 7th WV cavalry.; Pvt. A.T.J. Baily, Co. I, 8th (West) Virginia Inf.- later 7th WV Cav.; and Sgt. John Joyce, Co. E, 2nd KY Inf. The misidentified grave lists Pvt. William H. Matlick, Co. C, 3rd WV Inf.- (he was killed at the Battle of Droop Mtn., Nov. 6, 1863). I believe he is Cpl. William H. Mattack, Co. I, 13th O.V.I., wounded at the Battle of Carnifex Ferry on September 10, 1861. Grafton's burial register shows this soldier's body was removed from a farm adjacent to Carnifex Ferry battleground, not the summit of Droop Mtn.

I'm frustrated with the VA's and the NCA's double standard. In 2009, Br. Thomas Grund also used historical records to identify four previously unknowns at the Yorktown VA Nat. Cemetery, which is part of the Colonial Nat. Historic Park, administrated by the National Park System (NPS) and run by the Dept. of the Interior. (July 2009 Civil War News article) The NPS and Dept. of the Interior asked the NCA historian how Mr. Grund could get his previously unidentified soldier headstones by using historical records when I couldn't. She said the NPS and Dept. of the Interior had different rules than the VA and NCA. How can different government agencies have different rules on the same issue?

Br. Mark Tennant hopes descendants will learn of his findings and that readers have information about the others he mentions.

Cemetery. The research was based on a 1930s WPA list, preserved by the Broward County Hist. Society. The final resting place of Medal of Honor recipient 1Sgt. Edgar A. Bras, Co. K, 8th IA Vet. Inf. was "re-discovered." The Bras family was one of Ft. Lauderdale's founders.

The information was forwarded to the Broward County Centennial Commission for use in upcoming observances.

KANSAS Union Veteran Laid to Rest

Last July, the Missing in America Project and the Sons buried the ashes of Pvt. Geo. McCarthy, 2nd MO Reg. Artillery. McCarthy was born in 1844 in Canada and became a sailor. He came to America and joined the Union Army in St. Louis at age 20, serving as a clerk. He died on March 10, 1946 at age 102, was cremated, but his ashes were never claimed.

Missouri's Project contacted the VA and the Kansas Dept. The VA arranged to have McCarthy and 12 others, whose ashes were still in Missouri funeral homes, buried in the Ft. Leavenworth Cemetery.

The Kansas Dept. then organized Brothers and reenactors for the funeral service. The corps was led by Br. Marc Witkovski of Omaha's Victor Vifquain Camp 1. Bob Wandel of Lawrence's Sgt. Samuel J. Churchill Camp 4 carried the ashes. Also included: Westport Camp 64 (MO) Brs. Michael Lundeen and Perry Marks, Camp 4 Brs. Dennis Lawrence and John McCoin, Camp 1's Steve Bauermeister, and Old Abe Camp 16 (Topeka) Br. Conrad Fisher.

PCINC ALAN R. LOOMIS PASSES


PCinC Alan R. Loomis passed away on March 19th at age 77. He was a great friend to all and will be dearly missed.

In 1979, Br. Loomis joined David D. Porter Camp 116 in Valparaiso, IN. He based his membership on the service of two great grandfathers and two great uncles, who served in IL regiments.

He served as Camp Sec/Treas., Dept. Sec/Treas., two terms as Camp Commander, three terms as Dept. Commander (1988-90), Nat. GAR Hwy. Officer, and as a member of the Nat. Program & Policy Committee.

In 1988, with the assistance of legislators and the Indiana DOT, GAR Memorial Highway signs were placed at each intersection of US 6 and intersecting federal and state highways.

In 1990, he served as the site chairman of the Central Region Conference held in Chesterton, IN.



He was elected JVCinC in 1994. Br. Loomis worked with the Indiana legislature to name US 12 the "Iron Brigade Highway." He then raised \$1,260 for an Indiana State Historical Marker, commemorating "The Iron Brigade," dedicated July 1, 1995.

Between Fall 1994 and Spring 1996, PCinC Loomis organized Fort Wayne's Col. William Hardy Link Camp 12.

He served as Dept. GAR Hwy. Officer, and was elected Central Region Assoc. Commander in 1995. He was elected our Order's SVCinC in 1995 and CinC in 1996.

In 2003, he was appointed to the Lincoln Tomb Ceremony Committee. Appointed chairman in 2005, he served until 2008. For his work, he received the Cornelius F. Whitehouse Award in 2009.

PCinC Loomis graduated from Ottawa High School in 1952 and received a BS degree (1956) from Millikin University, Decatur, IL. Additionally, he received a Master's in Geography from Northern Illinois University (1966) and a Master's in Earth Science from the University of Notre Dame (1971).

Br. Loomis served in the U.S. Army from 1957 to 1959. He married Gretchen Miller of Valparaiso on June 16, 1963. He taught Junior High School for 35 years, retiring in 1994. He served as assistant Curator of Valparaiso's "Old Jail Museum." He also served as Secretary of the Board of Directors and as Treasurer of the Historical Society of Porter County which operates the museum. In addition, he organized and chaired the first committee that attempted to raise funds for restoring Valparaiso's GAR "Memorial Opera House." He later served on the Foundation's board of directors that eventually funded the restoration. Br. Loomis was a member of the Masonic Occidental Lodge 40 in Ottawa, IL. Surviving is his wife Gretchen, son Dale, nieces and nephews.





INDIANA

On December 16th, two SVR units (Co. D, 27th IN Inf and Co. A, 1st Reg. KY Capitol Guards) gathered in Louisville's Cave Hill Nat. Cemetery to dedicate a new monument. The VA replaced the original Bloedner, or 32nd IN Vol. Inf. (1st IN German) monument with a reproduction and asked the SVR to fire a salute. The Under Secretary for Memorial Affairs was one of seven speakers.

The new monument, carved from Indiana Bedford Limestone in Newport, RI, replicated Bloedner's 1862 work. The dedication took place one day short of the 150th anniversary of the battle of Rowlette's Station, where 13 of the regiment died. In 1867, both graves and monument were moved from Munfordville to Cave Hill. The original was placed in Louisville's Frazier Museum.

FORT DONELSON 150TH ANNIVERSARY

On February 18th, the 10th TN U.S. Vol. Inf., SVR, the 49th IA Inf., SVR, of Des Moines, and re-enactors of Co. B, 9th KY U.S. Vol. and Schoolfield's Battery of Tennessee joined together with the Nat. Park Service and Superintendent Steve McCoy, to honor the 670 Union fallen who rest in the Nat. Cemetery at Ft. Donelson. A memorial wreath was presented and a GAR marker placed. Following the ceremony, visitors' questions were answered about the Battle for Fort Donelson, the Sons and the SVR.

The 10th TN USVI was the first Federal unit to be invited to the Annual Overton County parade on December 10th. The unit served as Co-Grand Marshalls with members of the SCV's. Myers-Zollicoffer Camp and was well received The two and a half mile parade is one of the largest events in Northeastern Middle Tennessee and provided positive exposure for the SUVCW and the SVR.

PATRIOTIC POSTCARDS

As our thoughts and minds turn to Memorial Day, we remember decorating the graves of comrades, parades and patriotic orations of years past. One long forgotten tradition was sending Memorial Day cards to friends and relatives, especially veterans and members of the Sons.

This popular Victorian pastime of sending penny postcards was so called because it cost one cent to mail them in the US, Canada and Mexico. These colorful cards displayed the latest in lithographic art and were both flat and three dimensional with embossed designs. They were created for the major holidays like Easter and Christmas, but also for all the lesser holidays like the 4th of July, Thanksgiving and Memorial Day. Most were manufactured in England and Germany. Raphael Tuck is one of the most famous designers. Cards for the Grand Army, Sons of Veterans, Woman's Relief Corps, Ladies of the GAR and Abe Lincoln can be found. The Daughters of Veterans and our Auxiliary were both small in numbers and may not have had cards created for them.

The custom lasted until the advent of World War I when German imports were stopped. To locate them today, you might check post card shows, antique dealers and of course, the internet. Be sure to look under these topics: Holiday, Fourth of July, Memorial Day, Military, Lincoln, and Civil War. The cost can range from a few dollars to as much as \$50 for a mint, rare design. As they are a hundred years old, expect some wear for less costly specimens.






