Description:	A mustached Union infantryman dressed in a Civil War uniform that consists of a long overcoat, cape, trousers, and boots. He stands at parade rest with his proper left foot forward and holds the barrel of a rifle with both hands. The butt of the rifle rests near the figure's feet. The figure wears a belt around his waist with a bayonet at his proper left side and two pouches at his proper right side. The figure is placed atop a tall base that consists of tall polished column surmounted by a composite capital. The column stands atop a stepped lower section with a crenelated top and bartizan corners. A granite curb surrounds the monument and contains shrubs and flowers.

Provenance:	Formerly located Town Hall, Highland Street, Ashland, New Hampshire before 1900.
Remarks:	At its annual meeting in 1898 the Town of Ashland voted to appropriate \$1,500 for a Civil War soldiers monument provided that the local post of the Grand Army of the Republic and the Women's Relief Corps supplied the remainder of the money. The Grand Army of the Republic Post donated \$200 and the Women's Relief Corps raised \$300. The town contracted with John Swenson, a Concord quarryman, who produced the elaborate base. When the site of the monument was announced it aroused strong opposition from a group of townspeople who felt that the monument should be placed at a more prominent place on Main Street where strangers passing through the town would see it. A petition signed by 182 voters asking for the Main Street location did not dissuade the committee. The monument was installed as planned.
·	In March 1900, at the next annual meeting, the town voted to move the monument and appropriated \$450.00 for its relocation. By May, a new site had been chosen and the monument dismantled. The new site, a small triangle at the intersection of Main, Highland, and River Streets, was itself ruled out as the owner of the land refused to have the monument installed there. The committee was forced to use its second choice, a small square at the intersection of Main and Thompson Streets, soon renamed Monument Square. IAS files contain related articles from The Ashland Item, June 10, 1899; the Concord Monitor, May 31, 1899; and The Manchester Union, May 29, 1899; June 7, 1899, pg. 2; and June 16, 1899, pg. 1, 3. IAS files contain related excerpts from Doris Tatham and John Smith's "Ashland Centennial Book," Ashland, New Hampshire, 1968, pg. 68, 69; and David Ruell's typescript, "The Public Sculpture of New Hampshire," Concord, New Hampshire: New Hampshire Historical Society, 1980, pg. 44-47. IAS files contain transcription of names of Civil War dead from Ashland that appear on the plaque. The monument is now the main element of the town seal.
