








### - OBITUARY -KEITH G. HARRISON, PCINC

**JANUARY 10, 1950 - JANUARY 12, 2023** 



A resident of Holt, Michigan, Keith Graham Harrison passed away on Thursday, January 12, 2023 in Holt, Michigan. He held a 1972 Bachelor of Science degree in Fisheries and Wildlife Biology from Michigan State University and a 1974 Master of Arts degree in Ecology from Western Michigan University. He retired from the state of Michigan in February 2005 after serving for 25 years. In addition to his numerous state Civil Service environmental executive positions culminating as Director of the Office of Special Environmental Projects within the Michigan Department of Environmental Quality, he also held two gubernatorial appointed positions by then Michigan Governor John Engler (Executive Director of the Michigan Environmental Science Board and Acting Director of the state's Office of Great Lakes). In addition to state service, he also served as a Special Federal Employee, where he participated in several National Academy of Sciences and U.S. Environmental Protection Agency Science Advisory Board committees as an invited Ecology Expert. His professional research and work resulted in more than 100 publications addressing a wide range of environmental and natural history issues.

Keith belonged to the Military Order of the Loyal Legion of the United States, in which he served as the National Commander-in-Chief from 2009 to 2011, the Sons of Union Veterans of the Civil War in which he served as the National Commander-in-Chief in 1994/1995, and Commanding Officer of the Sons of Veterans Reserve in 1996/97. He traces his ancestry back to 47 Union Civil War soldiers.

Keith served as the Board President of Michigan's Grand Army of the Republic Memorial Hall and Museum (Eaton Rapids, Michigan) since its inception in 2013.

## BUILDING FOR THE FUTURE: MARCHING BEYOND RECRUITMENT AND RETENTION

Of the many challenges facing heritage organizations in the twenty-first century, attracting new members and retaining them in the ranks can be a daunting prospect. As Sons of Union Veterans of the Civil War, we are not immune from this dilemma and camps throughout the Order are working to address the issue. Many different strategies have been employed with varying levels of success and it is becoming apparent that a combination of approaches is essential to substantially increase our rolls and keep new Brothers onboard.

So, what happens when our recruitment efforts bear fruit and new Brothers enthusiastically renew their membership? What steps are we taking to encourage and prepare them for leadership roles at the camp level?

To address this, Baltimore's James A. Garfield Camp 1 completed a multi-phase workshop designed and directed by Camp Commander Brian Horgan to invest in and nurture leadership potential in its junior officer corps. Billed as the 'Garfield Staff Ride,' the first segment of the program instructed the camp's Junior Vice Commander, Patriotic Instructor, Chaplain, and Aide to select a particular field commander of their choice who was engaged in the Gettysburg campaign. Once their selection was made, the Brothers were given several weeks to do biographical research along with a summary of the field commander's action on the field and what leadership lessons could be learned. Of particular importance, they were also instructed to relate those leadership lessons to specific management challenges at the Camp and Department level within our Order.

The second segment of the workshop was a July 6, 2019 visit to the battlefield itself where Brothers initially gathered together at the Maryland monument and then the Woolson / GAR monument where PDC Faron Taylor presented an overview of the history of the Grand Army of the Republic and SUVCW. This introductory session concluded with a camp connection to the Woolson / GAR monument, as Commander Horgan recounted the memorial service for PDC Kenneth Hershberger, which was held at the Woolson, on Remembrance Day, 2017.

Brothers redeployed to the Buford monument where PDC Taylor delivered a sample leadership study focusing on the cavalry commander's vision, adaptability, creativity, and utilization of technology, and more significantly, how those leadership qualities could be applied to service and management within the Order. Following this model, the group proceeded to visit each of the attendee's selected sites and with facilitation by CC Horgan and PDC Taylor, the leadership of several famous and infamous field commanders were examined and analyzed. Not surprisingly, the scrutiny of Major General Daniel Sickles generated a slightly livelier discussion in comparison to generals Hancock, Hunt and Sedgewick.

While in Gettysburg, the day's program also capitalized on the extensive connection of the area to WWII. As the 75th anniversary of D-Day was fresh and with the convenience of The Gettysburg Museum of History's "Band of Brothers" exhibit, Commander Horgan facilitated a discussion of the leadership qualities of Major Richard "Dick" Winters. Once again, these aspects of leadership were applied to Camp and Departmental opportunities. The discussion was coordinated with a visit to the museum that includes the Maj. Winters and Lt. Ronald Speirs exhibits. Realizing the great value of fraternity in building relationships in our Order, attendees lunched together and shared a social gathering at the end of the day.

The third segment of the workshop was gathering feedback and assessing its initial impact. Attendees reported an enjoyable and positive learning experience. Participants reflected a greater perspective and understanding of the history of the Order and the Camp's and Department's role within the Order. In addition, the workshop facilitated a greater understanding of Camp history. The program shared common leadership attributes using lessons learned at Gettysburg, on the field at Gettysburg. This combination of ideas and discussion, offered within the context of the historic and sacred space of the battlefield, served as a powerful educational tool, which was greatly valued by all. The exercise facilitated discussion regarding leadership based on historical examples, as well as professional experience and the experiences of senior officers within the Order.

Overall, "The Garfield Staff Ride" was a successful, creative effort to invest in the future leadership of the Camp and further develop the interpersonal relationships of the Camp officer corps. As with any program, the camp is committed to reviewing the initiative further with the goal of making improvements that will enhance camp leadership and actively engage both newer Brothers as well as seasoned camp 'veterans.'

While not every camp or department has the luxury of having Gettysburg or other storied battlefields in their "backyard" as Garfield Camp does, there is no shortage of historical sites around the country where leadership decisions were made that helped shape America. Therefore, this staff ride model can be adapted to a variety of venues and may be an effective tool for other camps and departments in their efforts to identify facilitate and nurture future leaders of the Order.



## THE SOURCE FOR CIVIL WAR CLOTHING AND GEAR





#### OHIO

Judge Michael T. Daugherty, a member of Henry Casey Camp 92, died unexpectedly on Sept. 8, 2022 at the age of 53. A plaque bearing his image now adorns the entrance to his courtroom. In a Feb. 1, 2023 ceremonyhis Clinton County Municipal Courtroom in Wilmington,

Ohio was named the Honorable Michael T. Daugherty Memorial Courtroom in his honor.



An estimated 150 people attended the ceremony. In 2013, before he became an SUVCW member, and while he was still a practicing attorney, he agreed to represent (pro bono) the Ohio Department in a law suit to prevent the Wilmington Sugar Grove Cemetery from selling two Civil War cannons that are part of a GAR memorial.

In July, 2015 following an agreement between the SUVCW and the City of Wilmington, Ohio the court issued a permanent injunction preventing the cannons from being sold or moved without the approval of the Ohio Dept. SUVCW. A few days later he was appointed to fill an unexpired term as judge of the Clinton County Municipal Court by Ohio Gov. John Kasich. In 2016 he emerged as the winner in a six-person race for a six-year term as judge of the Clinton County Municipal Court.

In 2014 while representing the SUVCW in the law suit Daugherty along with his father Joe Daugherty joined both the Henry Casey Camp 92 and Company C, 20th Ohio Vol. Inf. Sons of Veterans Reserve. At the 2015 SUVCW National Encampment Commander-in-Chief Tad Campbell gave him the SUVCW Meritorious Service Award for his work in saving the Sugar Grove Cemetery Civil War cannons. Michael Daugherty's father Joe is now a past camp commander and is currently serving as the camp patriotic instructor.

The efforts of the members of the Ohio Department SUVCW, prompted by the Wilmington cannon situation, resulted in Ohio Gov. Mike DeWine signing into law in December, 2021 the Ohio Veterans Heritage Protection Act which protects war memorials from all American Wars from being moved, sold or destroyed.

### **PENNSYLVANIA**

The Brothers of Isaac Eaton Camp No 504 were proud to receive their new Camp flag at their February meeting. The Camp was Chartered over ten years ago and has 30 members on its roster.


## HISTORY OF THE SONS

### FORGOTTEN HISTORY: THE UNIQUE ROLE OF KEY WEST DURING THE WAR OF REBELLION

Recently, we celebrated the sesquicentennial of the Civil War from 2011 to 2015. Many scholars took the opportunity to contribute new research and provided members of the Sons the opportunity to fulfill our mission to teach the true history of the Civil War.

Known today as a tourist mecca, Key West, Florida was a strategic naval station that controlled the shipping lanes known as the Straits of Florida. In 1846, Fort Zachary Taylor and Fort Jefferson were erected as part of the coastal defenses of America. Key West became one of the largest and wealthiest cities in Florida...the seat of Federal Courts and government offices.



Captain John Brannon commanded the army garrison requested instructions from Washington. Receiving no response he secured Fort Taylor for the Union in January 1861.. Additional troops arrived and reinforced the forts. Any opportunity of the Confederates to capture them was now lost. Key West became command headquarters for the 3,500 mile naval blockade of the South.

While some white citizens went north to join the confederacy, others avoided the war by seeking refugee in the Bahamas. A thriving black community of both freed and enslaved black families prospered in Key West. In February 1863, Colonel James Montgomery of Kansas arrived in Key West with authorization to organize a black regiment.

One hundred and twenty black men between the age of 15 and 50 were enlisted to fight for the Union. Some were reluctant to join as the army pay of \$7.00 a month was far less then they were earning as free black merchants. Definitely many felt it was their duty to fight for the Union and for freedom. Their regiment was the Second South Carolina Volunteer Infantry (Union). Their units were mustered into Federal service on 22 May 1863. They participated in the raids on rice plantations on the Combahee Ferry which freed 800 slaves. They burned the town of Darien, Georgia. Other engagements included James Island, Grimball's Landing, Fort Wagoner and Fort Greg. Finally serving in Jacksonville, Florida.

They were discharged In the Spring, 1866. Most returned to Key West after the war. Of the 120 enlistees, 18 died in service. Others raised families and became active in the community.

Major Benjamin Curtis Lincoln Post # 3 was one of the first Florida. GAR integrated Posts and a Woman's Relief Corps was founded prior to the 1884 creation of the Florida Department.

In the 1880s and 1890s, with the end of Reconstruction, a totally different story emerged. Former Confederate soldiers and white Democrats "rewrote" history. Key West was always in rebellion against the northern occupiers. There were no black soldiers. Stephen Mallory was their favorite son who reflected southern valor. The "Lost Cause" mythology existed in Key West as it did though out the South.
