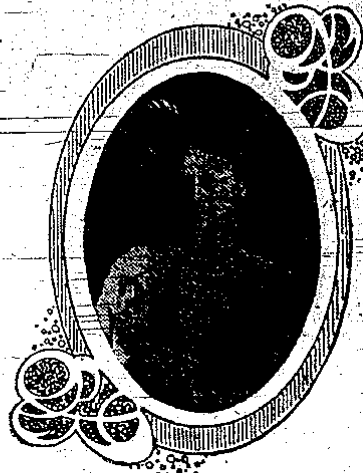
As a lasting and fitting memorial to the lives of those veterans of the Civil war, members of Halleck Post, No. 19, G. A. R., who lie buried in the Grand Army plot in Chico cemetery, the local G. A. R. and W. R. C. posts have started a movement to secure the erection of an imposing bronze statue and pedestal in the veterans' plot in the local cemetery.

The trustees of Halleck Post who have taken preliminary steps in the matter estimate that the total cost of the statue would be \$1100. To launch the campaign for funds to secure the memorial, Adjutant Wm. Bundy has called a joint meeting of the G. A. R. and W. R. C. for Friday night of this week.

The sketch of the proposed memorial, as prepared by William Robbie, provides for an imposing shaft or pedestal surmounted by the figure of a soldier, of a total height of fifteen feet. It is planned to have the figure of the soldier garbed in the uniform of the Union side and standing with hands holding a rifle at rest, done in bronze. This would stand six feet six inches in height.

The shaft or pedestal supporting the figure is to be of granite and will bear the following inscription:

ERECTED BY
HALLECK POST, NO. 19.
G. A. R.
IN MEMORY OF
OUR DEAD COMRADES
1861-1865.

BRONZE STATUE FOR CRUEL TEAMSTER TO VAN LIEW PRO MONUMENT HAS BE ARRESTED FOR WILL FIGHT ARRIVED BRUTALITY LAST DITE

Halleck Post's Memorial Shaft to Be Erected Immediately

Costly Tribute to Soldier Dead an Ornament As Well

The bronze statue of a soldier at parade rest, which is to be the main part of the monument to be erected in the Chico cemetery by Halleck Post, No. 19, G. A. R., and the W. R. C., arrived yesterday and is now at the marble works of William Robble, First and Main streets. The statue, valued at \$4000, is a beautiful specimen of the sculptor's art and when installed upon the pedestal, now being built at the Chico Marble Works, will be an ornament to the cemetery.

The soldier stands six feet high. His hands are clasped over his rifle and his head is erect with "eyes front." Beneath the statue, carved in the marble, will be the following inscription:

"Erected by Halleck Post, No. 19, G. A. R., and W. R. C. "MCMX."

Beneath that inscription and on the lower pedestal will be carved:

"In Memory of Our Comrades, 1860-1865"

The monument will stand fifteen feet high and will be placed at the entrance of the old soldiers' plot.

Some of the residents of Chico vicinity were subjected yesterday afternoon to a sickening scene of vicious brutality which will doubtless be the subject of court inquiry in the near future, and may have the very excellent effect of awakening the community to the need of a humane officer, whose duty it shall be to enforce the law against cruelty to animals.

The flagrant violation of the law yesterday was committed by a teamster commonly known as "Off Wheeler," but whose correct name, if he was ever deemed by his parents worthy of one, is not generally known. He was in charge of a six-horse lumber team, and one of the horses, which weighs but about 300 pounds and should not be expected to do service where such strength is required as in hauling lumber, quit pulling.

"Off Wheeler" set about the task of reforming the animal. He used a black snake for several minutes, waiting the body of the frightened animal until the hide was hardly normal at any spot. He then used a large rope, and finally resorted to the use of a chain with most cruel effect. The animal was crazed by the torture and threw itself to the ground, and the fiendish driver then continued to beat it unmercifully. He placed a chain around its neck and then about its nose to add to the torture, and attached the chain to the leaders. Women in the neighborhood sickened at the sight, and a call was sent to town for a constable. Constable Miller was finally secured but the brute on his way. A warrant was leveled against the man un-

Battle Will Not Be Normal Trust

There were no new developments yesterday in Governor Gillett's school at Chico other than the announcement that Dr. Van Liew would be driven from his position of the school president of the school.

The conference between Governor Gillett and the trustees Friday morning was a fairly informal one for the governor has no authority to call a meeting of the board, he is an ex-officio member of that body.

The meeting of the board will undoubtedly be held at Chico, under the law, in a meeting place.

Whether Governor Gillett will go to Chico on that occasion, is not announced. It is probable that he will not, as he never has attended a meeting of the Normal school upon this occasion, there is no necessity for his presence.

The carrying out of his plan will be the carrying out of his plan to represent him, O'Brien having stood against Liew, and Trustee Smith appointed for that purpose.

If the plan adopted by Dr. Gillett is officially decapitated, Dr. Gillett will declare the position vacant and another investigation it is believed will be instituted to the extent that he will be hearing before an impartial board of trustees. The majority of the trustees openly declared their opinion that the case should be taken to court, where witnesses would be called to appear. It is not known whether Governor Gillett will be a witness.

SAN FRANCISCO, Sept. 30.—Dr. Robert Thompson, alias Grant, was indicted early today for the death of Eva C. Swan, the young school teacher and stenographer who succumbed, following a criminal operation, and whose body was buried by Thompson in the basement of an old house. Murder is the charge of the grand jury.

Thompson was taken before the inquisitorial body and questioned, but upon the advice of his attorneys he refused to testify.

The principal witness was the nurse, Maey Messerschmidt, who testified that she was in the room when the Swan girl was given an anesthetic and had prepared the instruments for the operation. She reiterated her former statement that she was not present during the operation.

In addition to the count returned early today, charging him with murder in the first degree, the grand jury has indicted Dr. Thompson, alias Grant, for having mutilated a human body.

District Attorney Flickert said today that he had instructed the jury to bring an indictment against Willie Saack as an accessory to the murder of Eva Swan. Saack is the missing witness in the case.

VETERANS' MONUMENT WILL PRESERVE NAMES OF BUILDERS FOR POSTERITY

Memorial Will Be Unveiled Upon Return of Mrs. Bidwell

Costly Work Is Rapidly Nearing Completion

The G. A. R. and W. R. C. monument is rapidly nearing completion and will soon be erected in the Chico cemetery at the entrance to the old soldiers' plot. The State law is found in Section 862 of the Political Codes, and it applies not only to the governor, but the attorney-general and to the justices of the Supreme Court as well. The law says in no uncertain terms that the following officers must reside at and keep their offices in the city of Sacramento:

"The governor, the secretary of state, the controller, the attorney-general, the surveyor-general, the state printer, the superintendent of public instruction, the justices of the Supreme Court and the reporters of the Supreme Court."

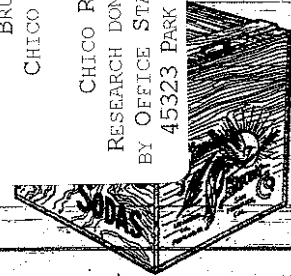

Locals Receive Eleventh Hour Notice of No Contest

The Chico High School football team did not go to Auburn yesterday. The Rugby players were scheduled to leave here at noon and were all ready to start, when a telegram was received from the manager of the Auburn High school aggregation informing them that the grounds were wet and that the game would have to be postponed.

This did not suit the fancy of the locals and a telegram was sent back to Auburn imparting the news that the game was scheduled by the league managers to be played in Auburn today and that the Auburn school carried out its part of the agreement the game would have to be declared forfeited. At a late hour last night no word was received from Auburn. It is likely that no game will be played in Auburn today. The local football colony is "some mad" as the result.

Back of the eleventh hour refusal of Auburn to play ball is a clever ruse, according to Chico sportsmen, who claim that Auburn has, since Chico defeated Sacramento 18 to 0, formed a decidedly good opinion of the prowess of Captain Clarence Henry's athletes, and the proposal to postpone the game one week is made in order that the Placer boys might attend the Stanford-California game today and thus pick up pointers that might be of value in checking the winning streak of the predicted league champions.

Certain newspapers several days ago contained the announcement that the scheduled game would not be played Saturday as the Auburn boys wanted to see the annual game between the universities. The locals therefore look with asstance upon the excuse that the grounds are wet in Auburn. The feel that they are being made the victims of a little athletic short-changing and refuse to allow the scheme to be worked.

This sort of a game does not meet with the approval of the locals, who contend they will be put at a great disadvantage if the game be postponed, as there will be no school all next week because of institute, and many of the players will be out of town and unable to practice.

Insane Act of Mrs. W. J. Bulin Near Hamil- ton City

HAMILTON CITY, Nov. 12. Mrs. W. J. Bulin, wife of W. J. Bulin, a dairyman residing on the McIntosh grant, five miles north of this city, committed suicide at her home this morning by plunging head first into a barrel of water. The body was found by her oldest daughter.

The Bulin family came to this section from Lincoln, Neb., in October, 1909, purchased a tract of land in the McIntosh grant and engaged in the dairy business. Mrs. Bulin, who was forty years old, had been ill for a number of months and despondency because of this illness is believed to be responsible for her act. 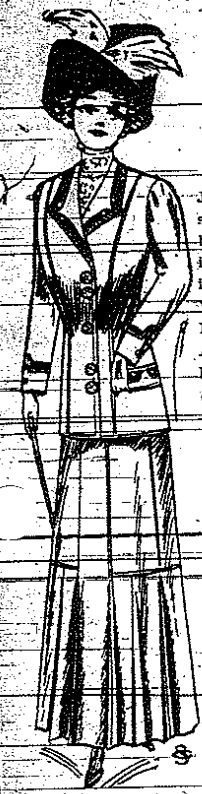

GRAND ARMY MONUMENT FORMALLY DEDICATED WITH SPEECHES AND MUSIC

Veterans Make an Impressive Spectacle on Great Occasion

Ghostly Memorial Erected After Much Labor by Halleck Post

At the entrance to the Old Soldiers' plot in the Chico cemetery stands a bronze soldier at parade rest. The metal figure is six feet in height and is supported on a pedestal of granite and marble. It stands as a memorial to the heroes who fought during the Civil War that the Union might exist, and it is to the work of the members of Halleck Post, G. A. R. and the Women's Relief Corps that is due the pretty memorial.

The monument was dedicated Sunday afternoon with the ritual of the Grand Army. Crowds stood with bared heads in the cheery November afternoon while the words of dedication were said, and the throng listened with deep interest while those who had been selected to speak said their words of praise, patriotism and cheer. It was a gala occasion in the annals of the Grand Army and those aged veterans who marched so proudly in step with the stirring music of the Second Infantry band may never feel again the same emotions that coursed through their breasts Sunday afternoon when the youth and age of Chico marched to see the monument unveiled.

There were old men and women, stern-faced guardsmen, young women and rollicking boys and girls in the procession that formed on Broadway and marched to the cemetery. The band was first in line, then Company A of the National Guard; following were Halleck Post, G. A. R., the visiting veterans, members of Halleck Post, W. R. 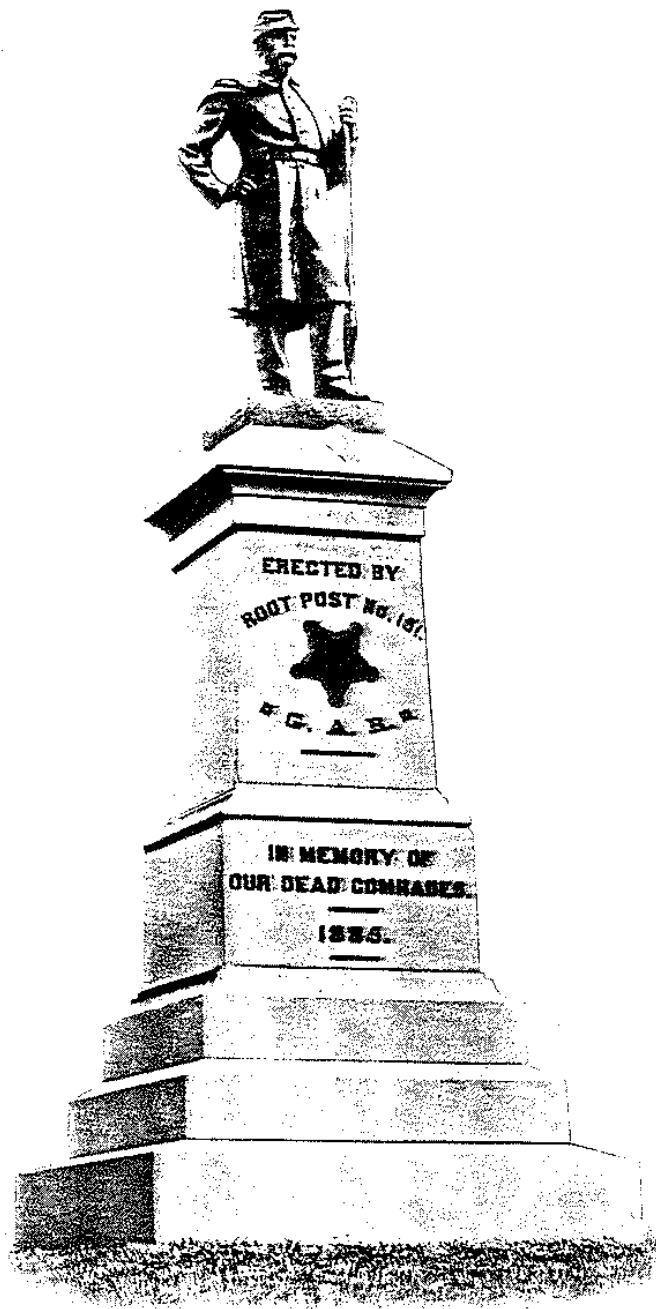
