Cedar Hill Cemetery Frankford & Cheltenham Aves. Philadelphia, PA

The Sons of the Union Veterans of the Civil War and the Frankford Memorial Project is seeking funds to aid in the restoration of the monument. The graves of 33 veterans are spread in a circle around the monument. Through efforts of the committee and many donors, the gravestones were recently replaced. This was phase 1 of the project. Phase 2 entails restoring the monument itself. Time and weather has taken its toll on the monument. The cost of the restoration is just over \$14,000. To date, we have raised all but \$3000. We are hoping to finish raising the funds by years end so that we can have a date in the spring for the restoration.

Dear Tony,

Kreilick Conservation, LLC is pleased to submit this proposal to conserve the Frankford Civil War Monument, located in Cedar Hill Cemetery, Philadelphia, PA.

Kreilick Conservation, LLC will:

- erect scaffolding to access the entire Monument,
- wash the Monument with non-ionic detergent, clean water, and non-metallic bristle brushes,
- apply a biocide to the stone to remove organic growth and the staining caused by it,
- consolidate the stone to improve granular cohesion and to increase the strength of the stone,
- fill cracks with micro-injection of grout up to 1/4" from the surface,
- fill top 1/4" of cracks with color-matched restoration mortar,
- stabilize top stone w/ eagle to prevent rotation, and
- provide a report documenting each step of the treatment. The report will include our recommendations for subsequent maintenance of the Monument.

The price for this Scope of Services is \$14,400. This price is inclusive of all labor, supplies, travel, and liability insurance. A breakdown of this price is provided below.

This proposal is subject to the attached General Terms of Agreement, which are incorporated into this proposal by reference and made a part hereof. If you are in agreement with the Scope of Services, Terms, and Conditions of this proposal as presented herein, please sign and date one copy where indicated and return to our office. When executed, the proposal, together with the General Terms of Agreement, will constitute our Professional Services Agreement.

Upon receipt of the signed Agreement, and the initial payment, it is anticipated that the project will take 8-10 weeks to complete.

The Conservator will receive payment as follows: one-half (1/2) with signed Agreement, and one-half (1/2) when the treatment has been completed. These payments are not subject to payments by third parties, nor are they subject to retainage.

This proposal is valid for sixty (60) days.


