This bust of Lincoln is viewed as one of the best of Lincoln. Adolph Weinman was a student of St. Gaudens (sculpted the Lincoln in Lincoln Park, Chicago) and a fellow student to Daniel Chester French (sculpted Lincoln at Lincoln Memorial, Washington, DC). Museum Carpenters Install New Column for Calkins Law Office

Historic Building Has New Supports

The city's oldest building, the Calkins law office, got a face lift Wednesday when four new Doric columns were installed.

Restoration of the 137-year-old structure started in December, 1971 when the neglected classical Greek-style building was moved from 1114 Ionia Ave. NW to the small Lincoln Place park near the Public Museum.

The 1836 building originally was located at the northeast corner of Crescent St. and Bond Ave. NW and was owned by Charles P. Calkins, one of the city's first lawyers.

It was one of only 13 frame buildings here at that time. The structure was moved to its Ionia Ave. location about 1890 to be used as a private residence until the 1950s, after falling into disrepair.

Local builder John R. (Jack) Stiles bought the building in 1970 and gave it to the city. Contributions from various groups, including the Grand Rapids Bar Association and Kent County Council for

Historic Preservation, paid for the move to Lincoln Place.

But funds are running low. Museum Director Frankforter said \$3,000 has been raised, but it'll take an additional \$3,000 to \$4,000 to complete the renovation work.

Latest job was erecting the four nine-foot columns. The original pillars were replaced by smaller, square supports years ago.

Frankforter said the columns cost \$300 and had to be ordered from a Chicago firm which specializes in such reproductions. Luckily, an 1890 etching of the structure is in the book, "Baxter's History of Grand Rapids" and the Chicago factory used that drawing to build the new columns to scale.

Previous work included laying a new foundation, adding siding to part of the building, extending the back roof line to conform with the architecture, replacing the deck which was rotted and installing specially-made windows.

Future work will include covering the concrete foundation with native river

limestone which the museum got following street excavation work recently on Front St. NW. Two new doors have yet to be installed and new steps will be built.

In addition, Frankforter noted that the bust of President Abraham Lincoln in front of the building has to be moved. It sits too close to the structure with its back to the entrance.

Frankforter said interior restoration will begin in the spring. Work will center on replastering and adding new window moldings. Helmholdt's Home Decorating Center will donate all the paint and wallpaper.

Furnishings will be a problem. Frankforter said the museum has a desk and a few other pieces of furniture, but needs more items to create the look of an 1850 law office.

He hopes the work will be finished next fall. "It's taking us a long time, but we're trying to do an authentic job of restoration and we've had to hold off because we don't have all the funds necessary," Frankforter said.



The bust, made of statuary bronze (97% copper), will be cleaned using the Secretary of the Interior Standards for Historic Preservation.

Because of the depth of the corrosion, the applied method would be "fire and brush" that must literally soften the surface of the sculpture to remove the accumulation of soil. The granite base (column) will need to be cleaned with non-abrasive chemicals so as to not harm the surface. These products include quaternary disinfectants.







Museum Carpenters Install New Column for Calkins Law Office

Historic Building Has New Supports

The city's oldest building, the Calkins law office, got a face lift Wednesday when four new Doric columns were installed.

Restoration of the 137-year-old structure started in December, 1971 when the neglected classical Greek-style building was moved from 1114 Ionia Ave. NW to the small Lincoln Place park near the Public Museum.

The 1836 building originally was located at the northeast corner of Crescent St. and Bond Ave. NW and was owned by Charles P. Calkins, one of the city's first lawyers.

It was one of only 13 frame buildings here at that time. The structure was moved to its Ionia Ave. location about 1890 to be used as a private residence until the 1950s, after falling into disrepair.

Local builder John R. (Jack) Stiles bought the building in 1970 and gave it to the city. Contributions from various groups, including the Grand Rapids Bar Association and Kent County Council for

Historic Preservation, paid for the move to Lincoln Place.

But funds are running low. Museum Director Frankforter said \$3,000 has been raised, but it'll take an additional \$3,000 to \$4,000 to complete the renovation work.

Latest job was erecting the four nine-foot columns. The original pillars were replaced by smaller, square supports years ago.

Frankforter said the columns cost \$300 and had to be ordered from a Chicago firm which specializes in such reproductions. Luckily, an 1890 etching of the structure is in the book, "Baxter's History of Grand Rapids" and the Chicago factory used that drawing to build the new columns to scale.

Previous work included laying a new foundation, adding siding to part of the building, extending the back roof line to conform with the architecture, replacing the deck which was rotted and installing specially-made windows.

Future work will include covering the concrete foundation with native river



limestone which the museum got following street excavation work recently on Front St. NW. Two new doors have yet to be installed and new steps will be built.

In addition, Frankforter noted that the bust of President Abraham Lincoln in front of the building has to be moved. It sits too close to the structure with its back to the entrance.

Frankforter said interior restoration will begin in the spring. Work will center on replastering and adding new window moldings. Helmhold's Home Decorating Center will donate all the paint and wallpaper.

Furnishings will be a problem. Frankforter said the museum has a desk and a few other pieces of furniture, but needs more items to create the look of an 1850 law office.


He hopes the work will be finished next fall. "It's taking us a long time, but we're trying to do an authentic job of restoration and we've had to hold off because we don't have all the funds necessary," Frankforter said.
