## VICKSBURG NATIONAL CEMETERY DISINTERMENT CEREMONY

On Saturday, 25 March, Brothers of the Sons of Union Veterans of the Civil War and Sisters of TN Auxiliary #62 led a Memorial Service at Vicksburg National Cemetery.

After forty months since a catastrophic landslide and the conclusion of more than seven months of consultation with the National Park Service, the resumption of recovery and disinterment of endangered United States Colored Troops veteran burials is beginning. The ceremony marked the resumption of the National Park Service's recovery and disinterment of endangered veteran graves and stabilization of the cemetery terraces and roads.

In January and February 2020, several days of torrential storms and above-average monthly rainfall totals crumbled a 180foot section of the cemetery jeopardizing more than eighty known and unknown Civil War-era graves, mostly United States Colored veterans. As legal heirs to the Grand Army of the Republic, the National Encampment and the Department of Tennessee with Mississippi were consulted regarding the unprecedented recovery and stabilization project.

Vicksburg National Cemetery is the largest Union cemetery in the nation with more than 17,000 troops buried here. The cemetery is the final resting of the largest number of black soldiers buried anywhere in the United States. After three years, one-third of the park remains closed to visitors, deemed unsafe and inaccessible. The first phase of the project is expected to last more than eighteen months. We plan to be a part of the ongoing work and participate in the reinterment of these veterans.



## JOHN DAVIS CAMP NO. 10 - LONDON, ENGLAND



On the 30th May at 2pm, brothers of Ensign John Davis Camp No. 10, London, England, assembled at the statue of Abraham Lincoln in Parliament Square, Westminster, London to observe Memorial Day. Following the opening address and prayers, Captain John Jeffcock, a poet and a former soldier in the Coldstream Guards, made a keynote speech. To our delight, tourists and passers-by respectfully attended the ceremony, during which Officers of the Camp laid tributes and a wreath at the foot of the Memorial.

Representatives of the Camp were also invited to attend the Centennial Memorial Day ceremony at the American Military Cemetery in Brookwood, Surrey on May 28th. The Camp's Commander, Matthew O'Neill, laid a wreath on behalf of the Camp and the SUVCW.

Our Camp, chartered in London in 2016 with the Commander-in-Chief present, continues to pursue its remit to locate the graves of Union veterans in the United Kingdom and obtain stones from the US Veterans Administration for those which are unmarked. We so far know of some 1,100 Union veterans probably buried here (including, in some cases, the widows of those who did not return – for example, we have the widows of sixteen men who died in Andersonville prison), and have so far found 468, or 42%, of their graves. These include seven recipients of the Congressional Medal of Honor, eight men who served in US Colored Troops units, four generals, and four women who served as nurses, two of whom were awarded Federal pensions.

We have already had dedications for four new gravestones – in one, the veteran's great-grandson travelled from California for the ceremony! - and plan at least two more during 2023, for James S. White of the 113th Ohio Volunteers, and Stephen Adams of the Mississippi Marine Brigade, both buried in London.


We also aim to produce a book on the group of veterans of whom we consider ourselves the successors, the London Branch of American Civil War Veterans, founded in 1910; its last veteran died in 1933. Our camp is named after its founder, Ensign John Davis USN, for whom we dedicated a grave stone in 2016.

However, our search for their graves depends to no small extent on being able to access the veterans' pension files in the US National Archives. While we have managed to obtain a number of these, we would be indebted to Brothers in America who could visit the National Archives for us and obtain copies of pension files. (Note from the National Secretary) This is a synopsis of the minutes as edited by the Banner Editor. The full minutes will be posted on the Order's website and is the official version)

Meeting called to order at 8:03 PM by CinC Bruce Frail.

The Council then went into executive session for a period of time, then terminated the executive session and went back on the record.

Brother Chris Workman notified the CinC he is temporarily unable to discharge the duties of his office as a member of the Council of Administration. Per National Regulations, Chapter 3 Article 6 Section 4D, the CofA appointed brother Michael Paquette, PCinC as a temporary member of the CofA until brother Workman notifies the CinC he is able to resume his duties.

The National Organization now belongs to tech soup, where we can get hardware and software at a fraction of the cost. Two copies of Adobe were obtained and the Treasurer will purchase 10 licenses for Microsoft 360 @ \$10.00/month per license. QuickBooks was also authorized for the Treasurer.

The National Committee on Encampment Credentials is concerned about submission of forms and reports. Ex Dir Brother Demmy will work on this report back to the Cof A at the pre-Encampment meeting.

The committee assigned to look at pricing for the new life membership program will refer it to the C&R committee.

Commander Frail reported on his communication with


The Fundraising Committee requested that \$2000 be added to this fiscal year's budget for the committee's project, polo shirts for 1881 club members. Motion carried.

# MERITING MERCY IN TIMES OF WAR: GEN. GRANT'S LESSON FOR ALL GENERATIONS

Can one's enemy earn mercy? If one man is forced to struggle and fight and bleed and suffer for years at the hands of another, and the former suddenly finds himself in a position to take revenge on the latter, is there anything the latter can do to merit mercy from the former? I recently read Virgil's epic masterpiece, The Aeneid, and spent the better part of two months contemplating this very question. For those unfamiliar with this classic, the protagonist Aeneas is a defeated Trojan forced from his homeland by the invasion of the Greeks, who travels for years at the urging of the gods in order to find and establish a new Troy in Italy. On one of his many stops he finds himself face to face with a Greek who was on his way to invade Troy, but who was deserted by his comrades in the land of the Cyclops. As the Greek warns Aeneas of the horrors of the Cyclops, a Cyclops approaches and Aeneas and his Trojans flee to their ships, taking the lonely and terrified Greek with them, this Greek who at the very least part represented the very cause for all of their strife and hardships.

The fact that Virgil has Aeneas saving the Greek as they flee the Cyclops is interesting in and of itself. However, what makes this part of the tale even more interesting is the reason Virgil has the Trojans saving the Greek: in Robert Fagles' translation the Trojans, "...take aboard the fugitive – he had earned his way...", and in C. Day Lewis' translation they take, "...on board that Greek who so merited mercy..." Why did he earn or merit mercy? After rushing towards Aeneas and his Trojans, the Greek did explain to them the cause of his terror and warn them that Cyclops wandered the land: was this warning enough to merit mercy? While this type of quid prop quo, information that may save your life in exchange for my own, might be the most pragmatic answer, it could not be that simple. Before the terrified Greek explains his plight and the dangers lurking in the mountains, as he rushes upon the Trojans, Aeneas' own father is seen giving "...the man his hand and the friendly gesture lifts the stranger's spirits." There must be something more than a sort of quid pro quo that makes enemies merit mercy.

To better understand how enemies can merit mercy, one really needs to look no further than to Gen. Ulysses S. Grant and his treatment of Gen. Robert E. Lee and the men of the Army of Northern Virginia during and after the surrender at Appomattox Court House. In April of 1865, Gen. Grant's Army of the Potomac crushed the exhausted and ill-equipped Army of Northern Virginia under Gen. Robert E. Lee. After years of being outmaneuvered, outsmarted, and outfought, the Army of the Potomac now had a major victory: a victory of victories that would end the war. It would be natural to expect the victorious army, and victorious general leading that army, to become proud, to gloat over the fallen enemy, to punish him for all of the death and destruction that occurred throughout the war, and to teach him a lesson about the consequences of a failed rebellion.

Yet this was not the way of the man who had earned the sobriquet "Unconditional Surrender" Grant. Indeed, Gen. Grant's only condition for the surrender of the Army of Northern Virginia was that they, "…lay down their arms, not to take them up again during the continuance of the war unless duly and properly exchanged." He further agreed to "…let every man of the Confederate army who claimed to own a horse or mule take the animal to his home…" as these men were mostly farmers who would need their horses to help raise enough crops to see their families through the coming winter. When Gen. Lee informed Gen. Grant that his men were starving, Gen. Grant "…authorized him to send his own commissary and quartermaster to Appomattox Station, two or three miles away, where he could have, out of the trains we had stopped, all the provisions wanted."

It is no small thing to see to the physical needs of those whom you have just conquered, and Gen. Grant certainly displayed great mercy in feeding the men of the Army of Northern Virginia and allowing them to keep their horses and mules. Yet it was in another act, one that I remember my father telling me when I was young, that Gen. Grant demonstrated perhaps an even deeper type of mercy, one that helps us understand how an enemy can merit or earn mercy, as Virgil's Greek did in The Aeneid. Expectedly, as news of the surrender reached the Union rank and file, they were exuberant: "...our men commenced firing a salute of a hundred guns in honor of the victory." This did not sit well with Gen. Grant, for he wrote, "I at once sent word, however, to have it stopped. The Confederates were now our prisoners, and we did not want to exult over their downfall." In this simple act we see two humane traits that can lead us to the answer of how enemies can merit or earn mercy. Although victorious, Gen. Grant was humble, and through this humility he realized that like him, his prisoners were human too. Even though the men of the opposing armies fought for different ideas and ideals, there was a common thread running through them all. They had all experienced hunger and privation. They had all seen bloodshed and felt the pang of sorrow and loss as their friends and comrades died. They had all experienced a longing desire to go home. They were all human, and in that, they all had something in common. Now was not the time to gloat, boast, punish, chastise, or abuse. Now was the time to heal and ease all

suffering. In the terrified Greek, Aeneas came face to face with someone who was more than just an enemy. He came to face to face with another human who like him had experienced fear, privation, and loneliness; a human who needed mercy. Like Aeneas, Grant too came face to face with his enemy, and in his humanity found his enemy to be a man who merited mercy because of his own humanity. *Images courtesy of the Library of Congress*.



# HISTORY OF THE SONS GRAND ARMY WOMEN

Seventy-four years ago, the Allied Orders of the GAR held their last national encampment. We were a family: the Sons were the male member and our mothers, wives, sisters and daughters belonged to one or more of the female Orders.

The GAR realized early on the benefit of enrolling these women to fulfill their mission to care for the disabled, the widows and orphans, to educate children in the public schools, protect the rights won for previously enslaved citizens and newly arrived immigrants.

During this absence of the last 74 years we have lost the connection with these women. In the 1880s Massachusetts women formed an Auxiliary based upon membership available to any patriotic woman believing more members would result in greater money for the cause. At the same time, New Jersey woman formed a GAR Auxiliarybased upon blood kinship to a Union veteran. The Massachusetts auxiliary was the basis of the National Woman's Relief Corps. The New Jersey Auxiliary became the Ladies of the GAR. Each raised millions of dollars building or supporting soldier's homes, widow's homes and orphanages and supporting the needs of local veterans. They distributed American flags and provided patriotic literature. All supported the Red Cross especially during World War I and World War II

In 1935, the Woman's Relief Corps was the largest woman's organization in the United States. Major AP Davis saw the tremendous benefit an auxiliary provided to the GAR and organized the Son's Auxiliary in 1883...just two years after he organized the Sons. In 1956, the Son's Auxiliary erected the Albert Woolson Monument in Gettysburg. In the 1970s, a cash love gift from the Sons Auxiliary kept our bills paid.

The Daughters of Union Veterans observed their Brothers participating in Memorial Day observances and desired to be an active member of the family. They were organized in1885, but not formally recognized until 1900. President William McKinley aided in their incorporation.


