The Battle of Big River Bridge — At dawn on October 15, 1861 the Iron Mountain Railroad Bridge over Big River was attacked here by 400 rebel calvary [sic] (2nd & 3rd dragoons) of the Missouri State Guard led by Brigadier General M. Jeff Thompson. The bridge was defended by 40 men of Company E, 33rd Illinois Volunteer Infantry (The Normal Regiment) led by Captain Isaac Elliott. After a brief but bitter fight the Union troops were overwhelmed and the bridge was burned. This was the only Civil War battle fought in Jefferson County. ——— The Battle of Blackwell Station – Later that morning the rebels were attacked 2 miles south at the town of Blackwell by 50 men of Company K, 33rd Illinois led by Captain Charles Lippincott. After routing this force, Thompson withdrew to Fredericktown. Total losses on both sides for the day's fighting were 7 killed and 22 wounded. These 2 engagements are known together as the Battle of Blackwell and mark the northernmost point of Thompson's advance toward St. Louis. ——— Erected on the 146th Anniversary of the Battle by a grateful nation to preserve the memory of the brave men who fought here. Oct 15 2007 -"All quiet along the Potomac tonight. No sound save the rush of the River. And soft falls the dew on the face of the dead. picket's off duty forever!"

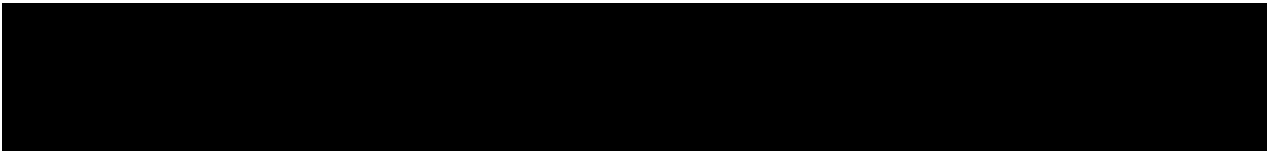

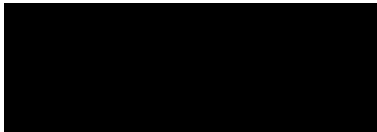

AT DAWN ON OCTOBER 16th 1861 THE IRON MOUNTAIN

THE BATTLE OF BLACKWELL STATION

LATER IN THE YEAR THE TROOPS WERE ATTACKED 2 MILES SOUTH AT
BLACKWELL STATION BY COMPANY K, 33RD ILLINOIS
VOLUNTEER INFANTRY. AFTER ROUTING THIS FORCE
THEY SUFFERED TOTAL LOSSES OF 20 MEN
KILLED AND 20 WOUNDED. THE REBELS
WERE ASSESSED AS 100 MEN
KILLED AND 100 WOUNDED.

AT DAWN ON OCTOBER 15, 1861 THE IRON MOUNTAIN

THE BATTLE OF BLACKWELL STATION

LATER THAT MORNING THE REBELS WERE ATTACKED 2 MILES SOUTH AT
THE TOWN OF BLACKWELL BY 50 MEN OF COMPANY K, 33RD ILLINOIS
VOLUNTEER INFANTRY, LED BY CAPTAIN CHARLES LIPPINCOTT. AFTER ROUTING THIS FORCE,
THOMPSON WITHDREW TO FREDERICKTOWN. TOTAL LOSSES ON BOTH
SIDES FOR THE DAY'S FIGHTING WERE 7 KILLED AND 22 WOUNDED.
THESE 2 ENGAGEMENTS ARE KNOWN TOGETHER AS THE BATTLE OF
BLACKWELL AND MARK THE NORTHERNMOST POINT OF THOMPSON'S
ADVANCE TOWARD ST. LOUIS.
