

PRE-ENCAMPMENT ACTIVITIES

Council of Administration Meeting, August 14, 1966

The Council of Administration met at 1:40 p.m., Sunday, August 14, 1966 in the Headquarters Suite of the Pantlind Hotel, Grand Rapids, Michigan. Those present were as follows:

Commander-in-Chief W. Earl Corbin
Jr. Vice Commander-in-Chief John H. Stark
Council Members
Harold M. Drown, Joseph S. Rippey, Albert W. Lambert
Secretary-Treasurer Chester S. Shriver
National Counselor U. S. Grant, III
Past Commander-in-Chief Albert C. Lambert

Commander-in-Chief Corbin presided at the meeting with the following items noted:

- 1. General Grant presented facts pertaining to the proposed erection of the Washington Cathedral in Washington. D. C. The importance and significance of the National Sons of Union Veterans of the Civil War to contribute in some way, whether by the purchase of a brick or some other item and the feasibility of sharing the presentation with the Auxiliary. Following some discussion on this matter, a motion by Brother Harold Drown, seconded by Brother John H. Stark, directed General Grant to meet with the Auxiliary with the same request in that they might join in this effort equally. Motion carried.
- 2. General Grant then spoke on the Resolution from the Pennsylvania Department regarding the flying of the Confederate flag on poles higher than the U.S. Flag. General Grant stated that the National Flag code regulates this but would be included in the Committee on Resolutions report.
- 3. The matter of the suspension of the Minnesota Department during the last fiscal year due to non-payment of per-capita tax was presented by National Secretary-Treasurer Shriver. This action was accepted by the Council of Administration and the Commander-in-Chief. However, following the suspension as of April 1, 1966, one Camp with 10 members has been reinstated in good standing and requested re-instatement officially. By a motion of Brother Joseph S. Rippey, seconded by Brother Albert W. Lambert, approval of re-instatement be accepted. Motion carried.
- 4. Discussion was made pertaining to THE BANNER and the renewal of the contract for 1966-1967. Many questions were discussed as to the cost of issuance, mailing and subscriptions with the unanimous feeling that every member of our Order should receive the BANNER. Before a decision could be made relative to the renewal of the contract, it was felt that Brother Charles A. Brady, Jr., Editor, should be called into the meeting and discuss any problems that he might have regarding his duties, etc. This was then tabled until a meeting could be held later in the evening with Brother Brady.
- 5. Secretary-Treasurer Shriver presented copies of the C.P.A. Audit for members of Council to review and answer any questions.

6. Commander-in-Chief Corbin then named the following Council of Administration Committees:

Audit Committee Harold M. Drown, Joseph S. Rippey Budget Committee Albert W. Lambert, Harold M. Drown

- 7. The revival of the Student Scholarship fund presentation was discussed and upon motion by Albert W. Lambert, seconded by John H. Stark, the fund was established at \$250.00 and to be given to Gettysburg College. Motion carried.
- 8. Commander-in-Chief Corbin stated that it was his hope that all five Allied Orders of the Grand Army of the Republic might meet in the same city and the same time in the near future. It was stated by General Grant and Albert C. Lambert, that this offer was directed to those Organizations and they must now submit their reply.

Meeting was recessed at this time of $3:00~\rm{p.m.}$ for Memorial Service and to reconvene at $10:00~\rm{p.m.}$

10. Brother Charles A. Brady, Jr. was present and presented facts concerning the publication of the BANNER. These included his time schedule to his primary employment and that the BANNER must be worked in on his off time. Printing, mailing and postage problems were discussed and after deliberations, a motion by Brother Shriver, seconded by Brother Drown, to renew the BANNER for the year 1966-1967 to Charles A. Brady, Jr. for \$1,800.00 and that by the next National Encampment, brother Brady to submit cost items and see if any adjustment might be made for the BANNER. Motion carried.

Meeting adjourned at 10:45 p.m.

Monday, August 15, 1966 — 10:00 a.m.



REPORT OF THE COMMANDER-IN-CHIEF

Akron, Ohio August 15, 1966

To the Commander-in-Chief, Officers and Members Sons of Union Veterans of the Civil War In session for the 85th National Encampment Officers and Brothers:

It is indeed a privilege and an honor to submit to you this formal but short report as your Commander-in-Chief.

At the close of the 84th Annual Encampment at Richmond, Virginia just one year ago, August 19, 1965, I was elected by you to the highest office you can bestow upon a Brother and I want to thank you.

I want to thank all National Officers for their response when I called on them—it sure was wonderful. I want to thank Past Commander-in-Chief Brother William N. Coffin of Ohio and Brother Harold M. Drown of Massachusetts for representing me in the New England States and every one who did a wonderful job for me.

There is one other Past Commander-in-Chief I want to thank for keeping me informed about what was going on in our organization and my wonderful wife Anna who kept the home fires burning while I was in the hospital. She answered letters and long telephone calls and did everything she could for me—thanks Anna.

REPORT OF THE NATIONAL SECRETARY-TREASURER

P. O. Box 24 Gettysburg, Penna. August 10, 1966

To W. Earl Corbin, Commander-in-Chief 85th Annual National Encampment Sons of Union Veterans of the Civil War Officers and Delegates Assembled Greetings:

1. It is with pleasure and pride, that I submit to you, this formal report of the activity and progress, as well as the current financial standing of the National Organization, Sons of Union Veterans of the Civil War, that is credited to the Administration under the leadership of Commander-

in-Chief, W. Earl Corbin, his Staff of Officers and all brothers of our organization.

- 2. The books, records, supplies and financial standing have been verified and audited by Clay W. Garrett, Certified Public Accountant, Hanover, Pennsylvania for the fiscal year of July 1, 1965 to June 30, 1966, copies of which have been examined and approved by the Council of Administration at this Encampment and a copy of which forwarded to the Congress of the United States along with a printed copy of the proceedings of this Encampment. This to conform to the Act of the Congressional Charter. A summarized statistical report of the Audit is attached to this report and copies distributed to the Officers and delegates present for this Encampment.
- 3. The analysis of our current membership standing continues to be our major problem, since there were 11 Camps and 294 less members on June 30, 1966 than one year ago, despite 135 new members added last year. Receipts from per-capita last year did exceed the budget. Yet two badge items in the supplies had to be replenished and the BANNER subscriptions received fell \$169.50 less than the estimated budget called for. Printing of forms for National Headquarters and supply use has increased. Naturally, conservation of our financial resources are of great necessity and despite the few variations during the past year, our total assets increased by \$1,512.92 to a total of \$34,078.57 on June 30th 1966. The understanding by the Officers and Committees of the value of our resources in future appropriations and expenditures, must be taken into consideration.
- 4. Our main source of financial reserve continues to be the Permanent Fund, which consist of increases from the accumulated Dividends, Life Membership Fees and donations to the Honor Roll Fund. The following is the breakdown of income and expense of the Permanent Fund for the fiscal year—June 30, 1965 to June 30, 1966:

- 6. A Life Membership of \$100.00 was transferred from the General Fund to the Permanent Fund, upon approval by the Council of Administration, to Joseph S. Rippey, as a testimonial for serving two years as Commander-in-Chief.
- 7. Investments for the Permanent Fund continued with the purchase of 100 shares of Wellington Fund on January 24, 1966 at a cost of \$16.24

per share and brings the total of investments to 1,800 shares with a June 30, 1966 market value of \$24,678.00 plus a cash balance of \$939.60.

- 8. Under the provisions of the U. S. Treasury Department, Internal Revenue Service, Section 501 (C) 4—Patriotic and Fraternal, dated January 31, 1958 and Identification Number 36-6108375, Form 990, Exemption Report for the National Organization was filed with the I. R. S. in compliance with the I. R. S. Law.
- 9. Following many months of letter writing and telephoning, efforts to former Officers in the Minnesota Department, were to no avail and with eight quarters in arrears with the payment of per-capita, action was taken by the Council of Administration and upon order of Commander-in-Chief Corbin dated April 1, 1966, the Minnesota Department was dropped with two Camps and 18 members. Through learning of this action, Brother George E. Bailey of Minneapolis, Minnesota immediately contacted National Headquarters and upon payment of the arrears of his Camp of percapita and without any further knowledge of the other Camp members, the Department was re-instated with one (1) Camp and 10 members.
- 10. Many outstanding events were represented by your National Secretary during the last fiscal year. Three of the most significant were the representation of Commander-in-Chief Corbin and the National Organization in the placing of the wreath at the Dedication of the Memorial to the Soldiers and Sailors of the Confederacy on the Gettysburg Battlefield on August 25, 1965, sponsored by the Sons of Confederate Veterans and the Daughters of the Confederacy, the placing of the wreath at the Lincoln Memorial in Washington, D. C. on February 12, 1966 and at the 99th Annual Memorial Day services at Gettysburg on May 30, 1966.
- 11. Reports, supply requisitions and correspondence arrive daily at National Headquarters and number into hundreds annually. Current reports were submitted to the Commander-in-Chief and Council of Administration. Minutes of all meetings of the Council of Administration are recorded. A copy of the 1965 National Encampment proceedings and C. P. A. Audit have been forwarded to the Congress of the United States. A supply of forms, badges, etc., are maintained at National Headquarters. The Headquarters is always available for any assistance that any National Department or Camp Officer or member may need.
- 12. The democratic principles of our Nation today, formed by our fathers and grandfathers over 100 years ago, are put to one of the hardest tests known to mankind. Our enemy of the Communistic world consist of well trained men who are taught to overthrow our way of life by the process of deterioration of our Allied Nations, the eruption of certain facets of our National, State, and local governments through strikes and other turmoil, have caused our patriotism to sink to a new low. Only when the Nation suffers directly here on our own land, do we turn to God and Flag to secure faith in ourselves. Let us here at this Encampment pledge as Sons of Union Veterans of the Civil War, that this Nation under God shall have a new birth of Freedom, and that Government of the People, by the People, shall not perish from the earth.
- 13. To you Commander-in-Chief Corbin, may I convey my deepest appreciation for serving on your administration. Your cooperation and un-

derstanding was sincere and despite the ill timed illness that you suffered, you continued like a good soldier. Your Staff was indeed a credit to your success.

To all brothers in our organization, my deepest and sincere thanks for your cooperation and support.

May we all strive to maintain our standards . . . to actively and promote the objects and interest . . . always and everywhere . . . so help you God.

REPORT OF NATIONAL HISTORIAN

To: W. Earl Corbin, Commander-in-Chief Sons of Union Veterans of the Civil War and Members of the 85th Annual Encampment

Commander-in-Chief and Brothers:

It is with pride and pleasure that I make my annual report to you as your National Historian.

One year ago a most unique National Encampment was held in the John Marshall Hotel, Richmond, Virginia, unique in the fact that it was held below the Mason-Dixon Line and more unique in that it was held in the Capitol City of the Confederate States (1861–1865). As in the past, several 109 registered Members of the Ladies of the G. A. R. and 224 registered Members of our Auxiliary met with the 116 registered Members of our own Organization.

Those of us who were privileged to take a "walking tour" about Richmond that included such buildings as the St. Paul's Episcopal Church where General Lee and Jefferson Davis worshipped—The Capitol of Virginia—The Governor's Mansion—The White House of the Confederacy 1861-1865—The Valentine Museum—the Sheltering Arms Hospital, the country's only free general hospital and the home of the nation's first Chief Justice John Marshall to mention a few, were most amply repaid. Here we relived for a brief hour the home, the center and the heart of

the Confederate States government, a side of the Civil War era not frequently seen by members of the Sons of Union Veterans of the Civil War.

Most impressive Joint Memorial Services were held with our Auxiliary

on Sunday afternoon at 3:00 o'clock after earlier registration.

Mayor Morrill M. Crowe welcomes the Northerners at the Camp Fire Sunday evening. Other distinguished guests present included Col. John A. May. Commander-in-Chief of the Sons of Confederate Veterans; Hon. James J. Geary, Executive Director Virginia Civil War Commission; Mrs. Sara Binder Moore, National President, Dames of the Loyal Legion and Mrs. Quentine Gregory. National President General of the United Daughters of the Confederacy. Prior to and during the Camp Fire the United States Continental Army Band from Fort Monroe, Virginia, played "The Battle Hymn of the Republic" and "Marching Through Georgia" among other favorites. Rev. Richard O. Partington, P. D. C.. Pennsylvania Department, presided at the Camp Fire where P. D. C. Frank M. Heacock. Sr. gave the principal address. Invocation and Benediction were given by John C. Yocum, National Chaplain. An impressive "Advance to the Colors" was directed by Lt. Col. Howard Dissinger.

After a Joint Opening Ceremony Monday morning with our Auxiliary under the direction of both Chiefs of Staff, the Encampment business sessions began. On Monday evening the annual dinner of the Past Commanders-in-Chief and Past National Presidents was held followed by Auxiliary exemplification of the Ritual then the Auxiliary Courtesy Hour. Later in the evening a Cabaret Dance and entertainment was presented

by the Encampment Committee.

Tuesday was devoted to business sessions, followed in the evening by the Annual Banquet and Reception honoring the National Officers of the Sons and Auxiliary. National President Alma Blixt of the Ladies of the G. A. R. and representatives of the other Allied Orders were guests. At the dinner Auxiliary National President Emma Wheeler presented a check in the amount of \$500.00 to Commander-in-Chief Rippey as a gift to the S. U. V. C. W. Both Colonel May and Mrs. Gregory extended greetings from our Southern counterparts.

There were no sessions on Wednesday when there was a courtesy bus trip, enjoyed by all who went, including a tour of the Virginia Civil War Centennial Center and the Berkeley Plantation where a box lunch was served. In the evening a gala Military Ball was held in the Virginia Room of the Hotel. Many of our Sons were in SVR uniform and our "ladies" in period dresses of the Civil War era, some in authentic original dresses.

Thursday's sessions were concluded by the election and installing of officers

The Grant Trophy for the largest gain in membership was awarded to the Michigan Department. Past Commander-in-Chief Grant made the presentation to Past Commander-in-Chief Mackey.

National Patriotic Instructor Henry Bowen reported that he had collected the splendid amount of \$916.00. Many of our national activities are financed from this fund.

A list of resolutions adopted will be found in the October-December issue of the BANNER and pages 43-48 of the Annual Proceedings.

On August 25, 1965, the Sons and Daughters of the Confederacy dedicated a monument in Gettysburg National Military Park as A Centennial Commemoration. National Secretary-Treasurer Shriver presented a wreath from our Organization.

Our Commander-in-Chief, Brother Corbin, was hospitalized in November due to a heart condition.

On November 20, 1965, in Ziegler's Grove on the Gettysburg Battlefield, impressive ceremonies were held when representatives of the G A.R. Allied Orders gathered at the Woolson Monument for the dedication of two stone benches. National President of our Auxiliary, Mrs. Edith L. Snyder, made the presentation of one of the benches on behalf of her Organization and the other one was presented by Past National President, Mrs. Dorothy Hilyard.

On February 12, 1966, the S. U. V. C. W. again took part in the Annual Lincoln Memorial Services in Washington, D. C., at the invitation of the Military Order of the Loyal Legion of the United States. Members of Camp 112, Gettysburg, Penna., carried the colors of the Commandery-in-Chief. Music was provided by the United States Marine Band. President and Mrs. Johnson attended the ceremony and placed a wreath. Past Commander-in-Chief Shriver escorted by Col. O. G. MacPherson, Commander of the National Military Department SVR placed the wreath for our Organization. Col. Howard L. Dissinger, SVR, commanded the S. U. V. C. W. color guard. Arthur R. Glenum, S. U. V. C. W.'s District of Columbia representative, placed a wreath for Lincoln-Cushing Camp No. 2, Washington, D. C. United States Senator John J. Sparkman of Alabama delivered the address becoming the first southerner to do so.

The 10th Annual Lincoln Tomb Ceremony commemorating the 101st Anniversary of the Death of Abraham Lincoln was conducted at 11:00 a.m. on April 15, 1966 at the Lincoln Tomb in Oak Ridge Cemetery, Springfield, Illinois by the SUVCW, assisted by the Military Order of the Loyal Legion of the United States, with participation by other patrictic societies and veteran organizations. Due to bad weather this year the exercises usually held out of doors had to be held inside the tomb.

Co-chairman George L. Cashman, Illinois Department, gave the address of welcome. The main addresses were given by Major William N. Coffin. Past Commander-in-Chief. SUVCW and William C. Duval. Commander USNR (Ret.), Past Commander-in-Chief. Military Order of the Loyal Legion of the United States. Co-chairman Thomas L. W. Johnson, Wisconsin Department, acted as announcer. Some 200 dedicated representatives were in attendance and 75 wreaths in memory of the Civil War President were placed, several more than last year.

Following these exercises 127 guests enjoyed a luncheon at the Hotel

Leland. George L. Cashman acted as Toastmaster.

On April 6, 1866 the original post "Old Post No. 1" Grand Army of the Republic was organized in Decatur, Illinois. On April 15-17, 1966 ceremonies commemorating the 100th Anniversary of the birth of our parent organization, The Grand Army of the Republic, were conducted in Decatur under the leadership of the G. A. R. Centennial Committee of the Illinois Department, SUVCW.

The ceremonies started with services at the grave of Major Benjamin Franklin Stephenson "Father of the Grand Army of the Republic." On April 16, a wreath was placed at the tablet which marks the building in which the G. A. R. was founded. This was followed by a re-enactment of the chartering of the first G. A. R. post. At the Soldier's Monument wreaths were laid by National President Mrs. Edith L. Snyder, Auxiliary to SUVCW, the GAR Allied Orders of Illinois, the Military Order of the Loyal Legion and others. Next a parade was held through the streets of

downtown Decatur led off by the SUVCW color guard from the Illinois Department with the colors of our National Organization. There were several uniformed units and members of the Allied Orders followed. Sunday morning church services at the various churches closed the weekend Centennial.

Memorial Day Services were held on Memorial Day, May 30, 1966 at the Cathedral of the Pines, Rindge, New Hampshire, with Brother Kenneth Wheeler, National Patriotic Instructor placing the wreath for the National Organization.

From the BANNER and various other sources, we learn that there is much patriotic as well as social activity in each Department. Keep up the good work, Brothers.

It is a pleasure to record that many Departments and Camps sponsored programs commemorating the Organization of the GAR and that States and Cities issued Proclamations.

REPORT OF THE COMMITTEE ON LEGISLATION

August 15, 1966

To the Officers and Members of the 85th National Encampment of the Commandery-in-Chief Sons of Union Veterans of the Civil War

I have the honor to present herewith the report of the Committee on Legislation of the National Organization for the twelve months period to the present Encampment.

Much of interest has taken place in the law-making bodies of the nation and of the several states notwithstanding the termination of the five-year Civil War Centennial observance undertakings which were most of significance to us.

Your chairman had the good fortune of experiencing the finest cooperation from our own dedicated members and from the public officials when solicited, and has followed the course of proposed legislation, as well as taken steps to promote, that affecting the goals, ideals and purposes of our Order.

The following is a summary of resolutions and acts of interest to our Order, proposed, enacted, or progress thereon in the legislative bodies during the past year.

In the State of Alabama there was passed at a Special Session of the legislature, both houses concurring, Act No. 215 (H. J. R. 74) stating that that body commemorates the one hundredth anniversary of the end of the Civil War, and, while not for one moment forgetting the supreme sacrifices of their forebears, dedicates itself to the principle that the future of this nation requires the putting aside of hateful memories, the binding of old wounds; and calls for a concerted effort on the part of all the people of the fifty states to keep this greatest of all nations free in the true sense of the word.

Introduced in Arizona but none becoming law were an act providing for a bonus to Viet Nam Veterans and their survivors, an act relating to tax exemptions for veterans, a proposal relating to recording of discharge papers preliminary to application for tax exemption of veterans.

California passed Assembly Concurrent Resolution No. 5 requesting the Governor to proclaim Appomattox Centennial Day and Centennial Week, that appropriate exercises be held in the Assembly chamber, and that the State Board of Education be urged to make appropriate recognition throughout the school system. Passed also was Senate Resolution No. 35 urging all residents of the state to show their patriotism and their appreciation to the men and women who are now or have been in the past members of the armed services of this country by displaying the United States flag on November 11th, Veterans Day.

Senate Concurrent Resolution No. 1 of the State of Idaho was passed by the Senate but failed in the House, relating to the prospective demolition of the G. A. R. Hall at Boise for the erection of state buildings, and provided that the Hall be maintained on the site until the land was needed, and that then the feasibility of moving the building to another location be considered and if not feasible that future provision be made for the construction of a War Memorial Museum Building.

In the State of Kentucky several acts were introduced but were not enacted into law, providing benefits for World War 1 and Spanish American War veterans and for support of the Marine Corps Reserve Civic Action Programs for Viet Nam.

The legislature was particularly active on veterans' affairs in Maine. The terms of the members of the Maine Civil War Centennial Commission were extended until December 31, 1966 in order that it may complete the purposes for which it was originally formed, by H. P. 1239 L. D. 1734, Ch. 225 P & S Laws. H. P. 1-L. D. L, Ch. 1 Public Laws, provided educational assistance to orphans of veterans. Passed also was S. P. 157-L. D. 397, Ch. 422 Public Laws, an act Providing for Establishment of a Veterans Memorial Cemetery.

Minnesota passed Ch. 643 Laws of 1965 relating to the Minnesota Soldiers Home. The following bills or resolutions were introduced but not enacted into law: to prevent the closing of veterans hospitals and domi-

ciliary care homes for veterans by the Federal Government, and relating to veterans' preferences in a number of ways.

Enacted into law by the Nebraska State Legislature was Bill 845 providing for exemption from taxation of the homes of certain disabled veterans, and Bill 310 providing World War 1 veterans exemption from payment of fees for hunting and fishing permits.

In Nevada, by Assembly Resolution No. 10 and Senate Resolution No. 4, the state memorialized Abraham Lincoln on the anniversary of his

birth.

New Jersey enacted Ch. 161 of the Laws of 1966 providing that any person who willfully wears the badge, emblem or insignia of the Grand Army of the Republic or certain enumerated other organizations, or uses or wears such badge, emblem or insignia to obtain aid or assistance within the State, unless he is entitled to use or wear the same under the charter, constitution, by-laws, rules or regulations of the organization or of a duly and regularly organized post, camp, branch or charter thereof, is guilty of a misdemeanor.

In Oregon, House Bill No. 2006, providing for administration of veterans' affairs appropriates the sum of \$4,820 for the maintenance and upkeep of the Grand Army of the Republic Cemetery located on Boones

Ferry Road in Multnomah County.

The General Assembly of Pennsylvania enacted Act. No. 11A appropriating \$660,000 to the Department of Military Affairs for assistance to veterans and their dependents, and Act No. 16A appropriating \$81.000 to the Department of Military Affairs for payment of pensions to certain blind veterans. A number of other pieces of legislation on the subject of veterans was introduced but did not become law.

The State of Virginia enacted Ch. 412 of the Laws of 1966 providing that the Governor is authorized to accept in the name of the Commonwealth, the property known as The White House of the Confederacy, any building or buildings which may be erected by the Confederate Memorial Literary Society, and the property known as The Lee House in Richmond with contents, and to maintain them for historic purposes. By Ch. 692 of the laws of 1966 the State provided an appropriation to the Confederate Memorial Associations and the United Daughters of the Confederacy for the maintenance of many designated cemeteries.

In several of the states the legislatures were not in session during the twelve months last past, by reason of their procedure of meeting

every two years.

H. R. 14805 introduced at the 2nd session of the 89th Congress of the United States would establish a national cemetery at the George Washington Park in the Town of Gloucester in the State of Rhode Island.

A hill introduced in the Senate of the United States would amend the first section of the Act of March 2, 1931, as amended (44 U. S. C. 275b) relating to printing the proceedings of the national encampment of the Grand Army of the Republic and certain other enumerated organizations at Government expense as House Documents.

Proposed by a Senator from Illinois is a bill relating to punishment

for desecration of the American Flag.

Congressional bill H. R. 13643 on the subject of reduction of the burial allowance for veterans had reportedly encountered spirited opposition.

In closing this report let me say that our organization is fortunate in having so many able men versed in public affairs, assuring aggressive interest in legislative activities.

I deem it a high privilege to have served our Order again in this position, and I trust that the work of the committee and the results thereof merit your approval.

REPORT OF MILITARY AFFAIRS COMMITTEE

Col. O. G. MacPherson Chm. Nat'l. Mil. Affairs Comm. 10 August 1966

To the Officers and Brothers of the Sons of Union Veterans of the Civil War in the 85th Annual Encampment assembled in the City of Grand Rapids, Michigan.

Greetings:

1. The National Military Affairs Committee continued by the action of the \$4th National Encampment held in the city of Richmond, Virginia. Herewith submit the following report of the Reserve as of 1 August 1966.

2. The Committee held two meetings this year. Gettysburg 22 May and Grand Rapids 14 August. Again we must report the Reserve movement in some Departments is not encouraging due to the non-cooperation of the Officers of said Departments. We have a Military Department with Officers elected or appointed by the Commanding Officer or District Commanders, according to Reserve regulations, approved by the Commandery-in-Chief and on file with the National Secretary-Treasurer. We would like to administer the functions of the Reserve according to the provisions of the regulations and the customs of the regular service (so far as our

limited means will permit) without interference, so long as such administration is not inconsistent with the C. R. and R. of the parent body, The Sons of Union Veterans of the Civil War. We are of the opinion the Order needs the Reserve and that we can work in harmony for the upbuilding of the Order if we have the co-operation of the Civic Body.

3. The Fifth Military District, comprising the states of Colorado, Kansas and Wyoming was deleted from the records of the Department. This action taken after repeated efforts to contact Department officers in the above states failed. We learned the cause for this in conversation

with the National Secretary-Treasurer.

4. The numerical strength of the Department as of 1 August 1966 shows a slight gain of 45 men since last report. Plus the organization of a band in the First Military District. Detailed report herewith:

REPORT OF THE LINCOLN TOMB CEREMONY

(Read by National Secretary Shriver)

June 14, 1966

Dear Commander-in-Chief Corbin:

It is with pleasure that your committee appointed to conduct the

Lincoln Tomb Ceremony submits the following report:

1. In the judgment of your committee the Lincoln Tomb Ceremony is rapidly becoming a durable event on our patriotic calendar. We are encouraged in this belief by the fact that we witnessed a record attendance at both the Tomb exercises (75 wreaths were offered) and the luncheon (127 guests were present) despite the fact that the Centennial observance took place only a year ago and the inclement weather experienced this year. Your committee is also encouraged by the number of Departments that have chosen to take part since a special mailing for Department Commanders and Auxiliary Presidents was undertaken a year ago and continued this year.

2. Due to the incapacity of Commander-in-Chief Corbin, Past Commander-in-Chief William M. Coffin, also of Ohio, represented the National Commandery at the ceremony and included Lincoln's "Farewell to Springfield" among his timely and well chosen remarks. Commander William C. Duval, USNR (Ret.), a Past Commander-in-Chief of the Loyal Legion and an originator of the ceremony, traced the history of the rites from their beginnings and concluded with a prayer which he first offered at the initial gathering in 1957. Also present were the National heads of two of the other organizations associated with the Grand Army family: Mrs. Edith L. Snyder, National President of the Auxiliary to the Sons of Union Veterans of the Civil War; and Mrs. M. Fara Heglar, National President of the Woman's Relief Corps.

3. Again this year music added to the dignity of the occasion. The Springfield Municipal Chorus, under the direction of E. Carl Mundgren, rendered appropriate selections that contributed to the solemnity of the

rites

4. One of the most satisfying aspects of this year's program was the appearance of Mr. Edwin C. Bearss, research historian at the Vicksburg National Battlefield Park, who spoke to the luncheon gathering. His topic was "General McClernand's Role in the Vicksburg Campaign." His forceful delivery, coupled with a mastery of his subject material and a sense

of the dramatic moments in our history, proved to be a delight to his llsteners. Speakers of his calibre are hard to obtain for any occasion, and your committee felt fortunate indeed that his schedule permitted his appearance this year.

- 5. Although a total of \$350.00 was budgeted for the 1966 ceremony, your committee spent from appropriated funds the net sum of \$189.12 in sponsoring all aspects of the ceremony. Careful planning together with a cash balance, realized from the sale of luncheon tickets, contributed to keep net expenses in line with those of previous years.
- 6. RECOMMENDATIONS FOR 1967—The date of April 15, 1967 will fall on a Saturday for the first time in several years. Based upon this fact and the fine response to the ceremony just concluded, your committee believes that it should be prepared for another record turnout. Experience has shown that although total cost figures have been kept well within the annual allotment, individual expense items can vary quite widely from one year to the next. In addition, the demand for printed programs, probably one of the more tangible pieces of goodwill available to our Order, increases each year. In the light of these circumstances, it is recommended that the sum of \$350.00 he appropriated to defray the necessary expenses of the ceremony. In approving this recommendation, it is understood that the co-Chairmen, appointed by the Commander-in-Chief, shall be fully responsible for the planning and execution of the commemorative program.
- 7. For a complete account of the April 15, 1966 Lincoln Tomb Ceremony conducted at Oak Ridge Cemetery, Springfield, Illinois, attention is invited to an early issue of the BANNER.

As he retires from office, he may do so with the confident assurance that he has the good will and approval of his Brothers, that he carries with him the love and affection of all, and our hearty wish for a complete and quick recovery to good health.

The reports of the Senior and Junior Vice Commanders-in-Chief are commended in that they reveal that as occupants of these positions, these Brothers accurately deemed their responsible offices were opportunities for service, rather than mere honors conferred. Such an attitude was to be expected from Brothers of their known loyalty and ability. They have set an example of conduct that should prove very helpful

to our Order.

The report of the National Secretary-Treasurer is a concise comprehensive account of his stewardship, duties which he has faithfully and efficiently performed. His efforts were not confined merely to fulfilling his duties, but by readily and willingly giving helpful suggestions to officers and members. We would like to say "Thanks Chet" for your splendid services.

The report of the National Chaplain is one of service. We commend him for arranging and conducting an inspiring Memorial Service, and

for his zeal, enthusiasm and interest.

The report of the National Patriotic Instructor shows he has given much time and thought to his office. It is fortunate that an enthusiastic and earnest member filled that position. The thanks of the Encampment are due him for his fine efforts and achievements.

The report of the National Counselor and National Chief of Staff shows that they have a grasp of the laws of the Organization and its needs. They can always be depended upon to give continued service.

National Historian Spink shows much effort and work on our behalf. His devotion and love of the Order has been demonstrated for many years, for which we extend deep appreciation.

The reports of the Graves Registration Officer, the District of Columbia Representative, the Personal Aide, and the Editor of the Banner

show a knowledge of their responsibilities as well as an inspired effort to fulfill them. Our appreciation is extended to these Brothers.

R. both on a National scale and a department level has received. I am sure that you realize this event is equally as important as the Memorial Service at the Lincoln Memorial in Washington, D. C., and the Lincoln Tomb Ceremony in Springfield, Illinois. I. therefore, request that the national organization support this annual service with an appropriation of \$100.00 from the G. A. R. Memorial Fund to continue this annual tribute to the Grand Army of the Republic.

Seconded by Major General U. S. Grant III and carried.

Past Commander-in-Chief William M. Coffin: I am happy to make a report on the G. A. R. Centennial Observance held at Decatur, Illinois, where I was privileged to represent your Commander-in-Chief Corbin and their national organization. In view of the complete success of this historical event I move that a rising vote of thanks be given the delegates from the Illinois Department for their efforts.

Seconded by Past Department Commander Harold M. Drown and

carried.

(Recessed at 11:20 a.m.)

(Reconvened at 1:30 p.m.)

Commander-in-Chief Corbin: May we have a report of the Ritual and Ceremony Committee?

Past Commander-in-Chief C. LeRoy Stoudt: Nothing was received so there is nothing to report.

RESTORATION OF RANK

Department Commander Lew W. McKee, chairman, reported nothing received so there was nothing to report.

At this time the Encampment recessed with the entire delegation proceeding to the Ladies of the Grand Army of the Republic to extend their greetings.

The Encampment reconvened at 3:00 p. m.

Commander-in-Chief Corbin: We will now receive the Greetings Committee from our Auxiliary. Will the guide and escorts escort these Sisters into our session?

The Greetings Committee consisted of Edith L. Snyder, National President; Edith Nile, PNP, Ch.; Anita Selby, PNP; Anna Corbin, wife of Commander-in-Chief; Olive Boren, PDP; Marjorie Grate, PDP; Sylvia Litsinger, and Norma Houston.

Commander-in-Chief Corbin: I am very happy to have you here this afternoon. I am sure that we appreciate your company.

National President Edith L. Snyder: Brother Commander-in-Chief Corbin, when we were elected last year I figured we were going to have a wonderful year, but I found it was not up to me to prescribe the future. Nevertheless, as I flew to the coast and attended other functions my thoughts were always with you. Each time there was a different representative for our Commander-in-Chief. I am thankful to God that he was good to you to see that we have our parting days together. Thank you.

Commander-in-Chief Corbin: Thank you very much, Edith, for your kind thoughts. Brother Rippey, will you respond to the Auxiliary?

Past Commander-in-Chief Joseph S. Rippey: It is always a great pleasure for me to be able to address the Auxiliary. They are our helpmates—they stand behind us in every way. It is wonderful of you to come in from our Commander-in-Chief's own state. Best of wishes to you and thank you again for coming to see us.

At this point a Greetings Committee from the Daughters of Union Veterans of the Civil War representing the National President were escorted into the sessions. Erma Stark. P. D. P. of the Daughters, and Madge Fullerton, P. D. P. of the Auxiliary of Pennsylvania constituted this committee.

Commander-in-Chief Corbin: We certainly do welcome you here to this National Encampment. I present to you the wife of our Junior Vice Commander, Erma Stark.

Past Department President Erma Stark: Commander-in-Chief, General Grant, Officers, and Brothers, it is a pleasure to be here representing

my National President Bess Kapp and to bring you her greetings. I bring you my own greetings for good health and a very successful convention. Thank you.

Commander-in-Chief Corbin: Brother Duke, will you respond to the

Daughters?

Past Commander-in-Chief Harold E. Arnold: Commander-in-Chief, Brothers. You have heard the delightful speech of the representative of the Daughters and Erma, you take back to Bess Kapp my greetings and I wish that she were here, but I know that is impossible. Thank you for coming.

After the visitations of the Greetings Committees Past Commanderin-Chief Chester S. Shriver introduced the stenographer, Miss Esther Rohrbaugh

Commander-in-Chief Corbin: We will now recess until Thursday morning, August 18, at 9:00 a.m.

COMMITTEE ON RESOLUTIONS

The following Resolutions were adopted by the Sons of Union Veterans of the Civil War at their Encampment session on Tuesday. August 16th. 1966:

1. Be it Resolved that the Sons of Union Veterans of the Civil War in their annual National Encampment assembled, that we recommend the policy be adopted that no structure or memorial be permitted in any of the National Battlefield Parks or other historical reservations of the Federal Government that does not directly pertain to the history or significance or necessary maintenance and purpose of said reservation. (Adopted)

2. That we request and solemnly urge the Director of the National Park Service to have the descriptive tablets, formerly located on the east side of Route 140, south (East Cemetery Hill) located on the Gettysburg Battlefield Park and also those tablets located on the west side of West Confederate Avenue, be replaced without delay, and further that the other Allied Orders of the G. A. R. be so informed of this condition and Resolution and request them to take a similar petition.

(Adopted)

3. That we are deeply concerned with the damage done to the restored Fort Stevens, in the Civil War fortification of the National Capitol, by its unrestricted use as a Park and playgrounds. As the one place where President Lincoln was personally under enemy fire, namely during the attack of General Early and an officer hit while standing near him on the parapet, it has unique and special historic interest and importance. We therefore urge the Director of the National Park Service to have the parts of the parapet where President Lincoln stood, protected by a fence or otherwise made inaccessible to children at play by a suitable protection erection of some type. (Adopted)

a suitable protection erection of some type. (Adopted)
4. That we urge the passage of H. R. 14805 to provide a National Cemetery for the State of Rhode Island and that we thank Representative Ferdinand J. St. Germain for introducing this resolution and that copies of this resolution be furnished U. S. Senators and U. S. Repre-

sentatives of Rhode Island.

5. That we recommend and urge early passage of legislation to prohibit any alteration in design or removal to another location of any Federal Statue, Monument or Memorial without explicit legislative authority for when it has been authorized by law and the gift accepted in accordance or compliance with the law. (Adopted)

Commander-in-Chief, there were several other Resolutions turned over to your committee on Resolutions but these pertained to good thinking on the part of the Departments from where they came, but these were changes that would mean changing our Congressional Charter and your committee felt that they could not be considered at this encampment. This concludes the Report of the Committee on Resolutions.

Commander-in-Chief Corbin: Thank you General Grant and your committee for that fine report; you have done a fine job in the presentation of our Resolutions for this Encampment.

RESOLUTIONS COMMITTEE—(Preliminary report, August 16, 1966)

(By Maj. Gen. U. S. Grant, 3rd., Chairman)

To the Commander-in-Chief and the Annual National Encampment. Sons of Union Veterans of the Civil War

Your committee recommends the adoption of the following Resolutions:

- 1. That the Sons of Union Veterans of the Civil War, chartered by Act of Congress, in annual Encampment assembled in the City of Grand Rapids. Michigan, strongly urges the passage of S. J. Resolution 148 and request the assistance of U. S. Senator Everett M. Dirksen and the Honorable Mr. Harold Ford by telegram to secure its passage in the U. S. Senate and the U. S. House of Representatives. (Unanimously adopted as read with National Secretary Shriver instructed to forward telegram).
- 2. That the Sons of Union Veterans of the Civil War, Chartered by Act of Congress, assembled in National Encampment in the City of Grand Rapids, Michigan, strongly urges the passage of legislation such as H. R. 15035, to make any mutilation, defacement, defilement or any other desecration of the Flag of the United States, a punishable offense and the subject of appropriate formal protest by the Executive when such outrage occurs in a foreign country, and that our National Secretary shall request the assistance of Senator Dirksen and Mr. Ford in securing the assistance of its passage by a telegram from this Encampment. (Adopted)

Commander-in-Chief, this is a partial report only because these two bills are said to be already in the appropriate committees and our action is important for consideration and recommendation at this time.

THURSDAY, AUGUST 18, 1966

Sessions reconvened at 9:30 a. m.

Commander-in-Chief Corbin: Brothers, we will now continue our sessions. Will the Committee on Credentials submit a final report at this time?

Credentials Committee Chairman MacPherson: We have a total of 104 registered delegates at this time.

Commander-in-Chief Corbin: Thank you Brother MacPherson.

At this time I am going to ask our National Secretary. Brother Shriver to escort into our Encampment and introduce to you a guest who has travelled here to talk to us this morning.

(Secretary Shriver escorted into the session, William J. Brake, National Lecturer of the Grange from Lansing, Michigan and introduced Mr. Brake to the delegates.)

Mr. Brake: It is indeed a privilege and honor for me to be escorted into your business sessions here in Grand Rapids. May I bring you the greetings of the National Grange to you Commander-in-Chief Corbin and your officers and delegation here.

(Mr. Brake then presented background information pertaining to the 100th Anniversary Centennial in 1967, what plans they have and the purpose of erection of the Meditation Memorial in the Gettysburg National Military Cemetery, in memory of William Saunders, first Grand Master of the Grange in 1867 and who laid out the plans for the National Cemetery at Gettysburg. Following a 10 minute address, Mr. Brake asked for any questions.

Past Commander-in-Chief Stoudt: We have the greatest respect for your fine Organization. Our deep concern and reasons for opposing your proposed erection of the Meditation building at the Gettysburg National Cemetery is for the reasons that to permit this, would open the door for other organizations to do the same. Also the fact that Mr. Saunders was not a soldier of the Civil War, would not allow him to be honored with a memorial of this nature.

Other delegates also asked Mr. Brake questions to their proposed Centennial plans and he admitted that while the Director of the National Park Service had approved the idea for the erection of a Memorial, no decision has been made as to the design.

Past Department Commander Heacock: I like LeRoy, oppose your proposed Memorial for these same reasons. We have members of our Organization, who also are affiliated with your fine organization. I probably will start the Battle of Gettysburg of 1966, when I say we appreciate your feelings Mr. Brake . . . but I'm opposed for the reasons that Mr. Stoudt has just referred to.

(Following a short question and answer period, Mr. Brake was escorted out of the Encampment and the business session continued). A Resolution pertaining to the matter referred above was included in the report of the Committee on Resolutions.

Commander in Chief Corbin: I'm proud at this time to introduce to you the Chairlady of our 1967 National Encampment which will be held in Chicago next year, Sister Eva B. Blackman, Past National President of our Auxiliary.

(Mrs. Blackman outlined briefly the plans and promised a good encampment when in Chicago in August 1967.)

Maj. Gen. U. S. Grant, 3rd: It gives me a great deal of pleasure to announce that after checking with the Membership standing and the Department with the greatest percentage of membership increase, that the Department of Wisconsin will receive the U. S. Grant, 3rd. Membership Trophy (Cup). (Since no delegate was present from the Wisconsin Department. National Secretary Shriver was instructed to forward the Trophy to the Department Commander for one year as their reward for their 6.7% membership increase).

We have in Washington, D. C., the erection of a new National Memorial to be known as the Washington Cathedral. There will be contributions given from many historical and patriotic organizations such as ours. One of the many historic remembrances and contributions to be placed in this memorial will be a bust of President Lincoln. There are many types of contributions that we could consider ranging from a

(Following some discussion, a motion was made by U. S. Grant, 3rd. seconded by O. G. MacPherson, to appropriate \$70.00 from the National Patriotic Instructors Fund (G. A. R. Memorial Fund) for the Lincoln project in the Washington Cathedral. (Motion carried)

Commander-in-Chief Corbin: Is the Encampment Committee for 1968

ready to make a report.

Past Commander-in-Chief Stoudt: As of now, nothing concrete has been turned over to this committee for 1968. There has been an oral invitation from the Department of California and Pacific and another from the Allied Orders in Wilmington, Delaware. However, your committee will accept invitations from the Auxiliary and the Ladies of the G. A. R. to help ease the situation in future years.

The greetings committee from the Ladies of the Grand Army of the Republic were escorted into the sessions and the following introduced, all Past National Presidents except the National President, Alice Harwood. The following were introduced: Mabel Taylor, Gussie Moran, Winona

Kahl, Lura Frye, Alice Ure, Molly Mercer, and Irene Mangel.

National President Harwood: Commander-in-Chief, Earl. 1 am so glad to see you presiding here at your National Encampment. Your year has been very trying in that your health gave out on you part way through. We have met several times at official functions and I am glad that you can join the rest of the Brothers here. May I present the sincere greetings of the Ladies of the G. A. R. and those of my own for a very constructive Encampment.

Commander-in-Chief Corbin: Brother LeRoy Stoudt. Will you respond to the Ladies please?

Past Commander-in-Chief Stoudt responded.

Commander-in-Chief Corbin: I would now like to thank the Michigan Department for planning this wonderful Encampment. I think that we are all very grateful for what they have planned for us. Let's all stand and give Past Commander-in-Chief Mackey and his committee our thanks. (Applause followed).

Past Commander-in-Chief Mackey: It was a pleasure for us to entertain you. We had wonderful support from the City and State of Michigan and if you are stuck again and have no place to go, come back to Michigan. Thank you.

Past Commander-in-Chief Albert C. Lambert: Brothers, there is a subject that I would like to refer to in that we are now facing the operation of our National business with a decreasing income and the problem

of balancing our annual budget. For many years, National has contributed to the travel expense for National Encampments to the National Officers at the rate of .02 per mile one way with the exception of the Commander-in-Chief and National Secretary. The time has come that we must continue streamlining this budget. I am sure this is not the way that we would like to do it, but we must now face the problem. In view of this decreasing income, I move that effective at the close of this encampment, that all travel pay for any National Officer be discontinued for future years. Seconded by Paul Grate. Motion carried.

Commander-in-Chief Corbin: I believe we have a delegation here from the Military Order of the Loyal Legion of the United States. Will these

members present themselves at the Altar.

Past Commander-in-Chief Grant: Commander-in-Chief. It is with great humility that I have been asked to be the spokesman for this distinguished group. On behalf of this delegation, may I convey our best wishes to you from the Military Order of the Loyal Legion of the United States and hope that you may continue to be in good health. (Those present with General Grant were: Urion W. Mackey, William M. Coffin, Chester S. Shriver, Frank Woerner, James L. High, Howard L. Dissinger, Charles A. Brady, Jr., and Roderick Van Troump. Commander-in-Chief Corbin responded.

Commander-in-Chief Corbin: Will the National Patriotic Instructor, Kenneth Wheeler, render his final report.

REPORT OF THE BUDGET COMMITTEE COUNCIL OF ADMINISTRATION

Grand Rapids, Michigan August 18, 1966

To: Commander-in-Chief W. Earl Corbin Officers and Members
S5th Annual Encampment
Sons of Union Veterans of the Civil War
Brothers:

We, the undersigned, were appointed by you, Commander-in-Chief Corbin, to serve this Encampment as the budget committee for the purpose of preparing and submitting to you a proposed 1966-67 budget.

In accordance with your instructions we have prepared such a budget, incorporating into this budget the wishes of this Encampment as expressed in the form of floor motions plus all items we felt would constitute a fair and accurate budget of the coming year's expenses. A copy of this budget is attached to this report.

After review of this budget and the current status of the General Fund of this organization our committee feels obligated to offer the following

RECOMMENDATION:

WHEREAS the operating deficit for the year 1965-66 proved to be \$445 in spite of the hopeful budget of last year; and

WHEREAS the operating deficit for the year 1966-67 can logically and reasonably be expected to approximate \$400 at the very best; and

WHEREAS the present surplus in the general fund is now only \$1,869 and cannot continue indefinitely to finance these annual deficits; and

WHEREAS there is not any logical or reasonable indication at the present time of a reversal in our membership trend in the forseeable future which would be capable of giving reasonable anticipation of overcoming our present financial emergency; and

WHEREAS severe economies already enacted in our operating expenditures cannot appear to result in savings nearly large enough to result in a balanced budget; and

NOW THEREFORE BE IT RESOLVED that the annual per capita tax be increased from \$1.00 per member per year to \$1.40 per member per year to be paid to the National Treasurer by the Department Treasurers at the rate of .35 cents per member per quarter, such payment to accompany the quarterly report from the Department to the National; and

BE IT FURTHER RESOLVED that this increase shall take effect on July 1, 1967 in order to allow sufficient time for every Department that wishes to do so to take action of a similar nature in the matter of percapita paid to them by Camps.

Past Commander-in-Chief Stoudt: I move you we accept the report as just read. Seconded by Past Department Commander, Arthur R. Glennum. Carried.

Commander-in-Chief Corbin: This concludes the reports of all Officers and Committees. May we have the final report of the Committee on Credentials. (Chairman MacPherson reported 105 registered Delegates with 92 the voting strength.)

I would like to thank every Brother who assisted me during the past year and also at this Encampment. All Committees are discharged with

my thanks.
