Last Soldier D'Estaing Harrington

D'Estaing Harrington (1843-1935) was the last living soldier of Allamakee County. He served as a Musician in Company C, 13th Regiment, U.S. Infantry. He is buried in the Postville Cemetery which is located south of town on S Lawler Street. While Postville is in Allamakee County, the Cemetery is actually in Clayton County.
