

John Smith Phelps 1814-1886 [Picture of Bearded Phelps] This statesman, as a representative in Congress (1844-1862), helped establish the first Overland Mail. During the Civil War he organized and commanded the "Phelps Regiment," a Home Guard unit, and served as military governor of Arkansas. As a Springfield lawyer, he defended Wild Bill Hickok. He was governor of Missouri (1877-1881). Erected by the Greene County Historical Society -1968.

Phelps Homesite

[Picture of Log Cabin] Phelps Grove Park is part of the 1050 acre farm of John Smith Phelps. The log and frame house stood southwest, the barn west, and the spring south of this marker. During the Civil War troops camped on the farm. Mrs. Phelps had the body of General Nathaniel Lyon temporarily buried here, and she sheltered children orphaned by the war. Erected by Greene County Historical Society - 1968.

JOHN SMITH PHELPS 1814-1886-

This statesman, as a representative in Congress (184 1862), helped establish the first Overland Mail. During and commanded the "Phelps Regiment", a Home Guard unit, and served as

military governor of Arkansas. As a Springfield lawyer, he defended Wild Sill Hickok. He was governor of Sissouri (1877-1881).
