

### PRE-ENCAMPMENT ACTIVITIES

### Council of Administration Meeting, Sunday, August 17, 1969

The Council of Administration meeting was held in the Headquarters Suite of the Sheraton-Jefferson Hotel, St. Louis, Missouri. Meeting was called to order at 1:30 P.M. by Commander-in-Chief Frank M. Heacock. Sr.

The minutes of the August 22, 1968 Council of Administration meeting in Wilmington, Delaware, were approved as read by the National Secretary.

Commander-in-Chief Heacock appointed the following committees:

Audit Committee: Charles A. Brady, Jr.
William W. Haskell
Budget Committee: Fred Combs, Jr.

Norman R. Furman

National Secretary Shriver informed the Council of Administration that the R. M. Smith Number 21 in Beaufort, S. C. (known as the National Camp-at-Large) is now in arrears a total of four quarters with the last report of per-capita paying for the quarter ending June 30, 1968. Discussion of what efforts would best correct this situation after National Secretary Shriver announced that the Camp was mailed a per-capita report each quarter that is past due plus a registered letter on July 20, 1969, the following action was taken:

A motion by Sr. Vice Commander-in-Chief Fred Combs, Jr. and seconded by Council Member Norman R. Furman, that efforts continue with letters to the Camp Secretary and/or Commander, advising the Camp of the status and that a deadline of December 31, 1969, be set for final report and if no word by that date, the Camp would be dropped.

(motion carried)

National Secretary Shriver then announced that the National Organization, SUVCW has received a check in the amount of \$1,000 as a bequest from the estate of Maj. Gen. U. S. Grant, III, as provided in his last Will and Testament. The letter from the Trust Department of the Riggs National Bank of Washington, D. C. was read and it was stated that the bequest was not earmarked for any specific fund.

Copies of the financial report and membership standing was distributed by the National Secretary and each item was reviewed and

explained.

A letter of explanation from Clay W. Garrett, CPA, was read regarding the elimination of an annual inventory of Supplies at National Head-quarters. A recommendation to the effect that the official inventory of Supplies dated June 30, 1969, verified by Clay W. Garrett, CPA, constitute the official stock and that all future annual Supply stock reports be

formulated by adding all replacement of Supplies minus all sales was made. By motion from Council Member Fred Combs, Jr., seconded by Council Member William W Haskell, this recommendation was approved.

(motion carried)

National Secretary Shriver then read a letter from Col. George S. Pappas, U. S. Army, Director of the Military History Research Collection, Carlisle Barracks, Pa., regarding the invitation to use the facilities at Carlisle Barracks to display in museum arrangement books and museum artifacts including GAR or Civil War rosters, diaries, etc. By motion of National Secretary Shriver, seconded by Council Member Furman, the communication will be acknowledged thanking Col. Pappas for his thoughtfulness as well as the possibility that the Carlisle Barracks Museum will be used by our Order in that area. However, it was recommended that a request for information be made concerning whether this applied to all Military Installations, and if so, whether they could be used by our Orders in other parts of the United States.

Brother Albert C. Lambert gave an excellent report of the Banner for the fiscal year ending June 30, 1969. He stated that 3,500 copies are printed quarterly and suggested that the possibility of having a four-page issue instead of the current 8 pages, might solve the cost increase problem. He also stated that the Budget Committee must take into consideration what and how much to appropriate for the Banner. The cost

of \$1,800 per year to edit and mail the Banner was approved.

Brother Lambert also asked Council to seek a replacement for Editor as soon as they can arrange it. Following other comments and possibilities, National Secretary Shriver moved that Brother Lambert be appointed for another year as Editor and that Council check for a new Editor by the National Encampment in 1970. Motion was seconded by Fred Combs. Jr. and carried.

Commander-in-Chief Heacock then reported on the following items:

1. A duplication of a wreath ordered by the Lincoln-Cushing Camp No. 2. Washington, D. C. in addition to the annual wreath ordered by the National Secretary for the Lincoln Memorial Observance on February 12, 1969, was discussed. A motion by Council Member Fred Combs, seconded by George L. Cashman was made that the National Organization reimburse Brother Doran Vest, Commander of Lincoln-Cushing Camp No. 2 the sum of \$35.15 for the wreath ordered in error. (motion carried)

2. That an annual goal be established by the Council of Administration for the National Patriotic Instructor each year so that effort and plans might be promulgated to reach or exceed such goal so that funds will offset annual appropriations to the G.A.R. Memorial Fund. (adopted

by unanimous vote)

3. On a motion by Jr. Vice Commander-in-Chief Brady, seconded by several, that Council go on record of having only one (1) money project annually — namely the National Patriotic Instructor's Fund — unless said project be specially approved by the Council of Administration or action at an Annual National Encampment. (approved and adopted by unanimous vote)

Meeting adjourned at 2:45 P.M.

Credential Committee Chairman Satterthwaite: At this time, we have a total of seventy-seven registered including eight not present.

Commander-in-Chief Heacock: Thank you Brother Satterthwaite. We will now proceed with the reading of the Officers Reports. Sr. Vice Commander-in-Chief. Will you assume command of my station?

### REPORT OF THE COMMANDER-IN-CHIEF

To the Officers and Members of the 88th National Encampment Sons of Union Veterans of the Civil War Greetings:

One (1) year ago the 87th National Encampment selected a slate of officers to serve you and the organization for a term now about concluded. Individually, we will submit our record of stewardship but I must admonish you — those who will hear us and those who will later read these reports — they are words of thought compiled for you who with us, your officers, will help build up, or permit to continue to deteriorate an organization that could be great if we would but let it.

What have we done and whither have we traveled?

A look at the report of the National Secretary-Treasurer answers both questions. Are these the answers that you want? I fear they must be because we have done little very little, if anything to turn the tide; the least that could be done is to stem it.

I have stated a number of times this year that the new members frequently offset the deaths. But the problem that should be of concern, great concern, to all of us are those who are dropped for one reason or another. True, they are all dropped for non-payment of dues, but the real cause for this is back in the individual Camps into which they were mustered. When they joined our ranks there must have been some interest. Did the one-man control Camps dishearten some? Do we provide the type of Camp meeting to retain them? Or do we as an organization completely lack a purpose?

True, we have a purpose that meets our needs because it is the purpose that created this organization, but do we have a purpose once we attract new members that we can hold them.

We had a Program and Policy Committee years ago, but that failed; we had school essay contests years ago, and that fell by the wayside.

Everything we have undertaken, prevails for a few years and then is discarded. There are organizations today whose initiation fees and dues far exceed ours yet who do not require heritage such as ours, who have retained their original purposes without deviating, have broadened them to meet the needs of this generation. But, have we?

Approximately fifty (50) letters were mailed to as many members, some to past Commanders-in-Chiefs, some to National Officers, some to Past Department Commanders, some to Department Commanders, some to Department Secretaries, endeavoring to select a cross section of our National Organization. I needed a criteria, so, selected a matter which was overwhelmingly voted down ten (10) years ago — the New Hampshire Plan. I made no implication that I favored it but merely as a standard for individual thoughts; and, in that letter, I asked one question: What are we doing that we should not be doing or what are we not doing that we should be doing? And truthfully, I was greatly disappointed because those who were kind enough to reply, mostly said they did not favor the New Hampshire Plan. This was decided ten (10) years ago—but what about today?

Constituted as we are by an Act of Congress, we cannot make drastic changes without the approval of the United States Congress but I do think we can legislate honestly and intelligently to prevent our demise. I therefore recommend the incoming Commander-in-Chief be empowered to appoint a committee of not more than seven and not less than five (no two of which shall be from any one Department), to delve into the Reconstruction of our Order and to report back to the 89th National Encampment if it be feasible for them so to do but to report back no later than the 90th annual National Encampment.

This past year, we have been saddened by the death of many brothers which will be reported by the National Secretary-Treasurer. We could not enumerate them but special mention must be made of the passing of General U. S. Grant, 3rd, a Past Commander-in-Chief of not only our organization but also of the Military Order of the Legion of the United States; Past Commander-in-Chief Fred E. Howe, Past Commander-in-Chief Neil D. Cranmer, and from our own official family, Junior Vice Commander-in-Chief Roderick Van Trump, Sr., who was serving his second term in this office and serving his third consecutive term as Department Commander of Illinois. Each of them were eulogized at the Joint Memorial Service on Sunday and words of praise were offered in behalf of all of our departed Brethren. May I merely add the words of the poet written thus:

> "The stars go down to shine upon some other shore But bright in Heaven's jeweled crown, shall shine for evermore."

During the past year, I was very privileged to have a most cooperative National President in the person of Sister Irene K. Murphy of my own Department. In all but one of my visits, I was privileged to have her company. I regret that last minute and unexpected circumstances prevented missing the Departments of Illinois and Wisconsin, planned well in advance of their respective Encampments. Confliction of dates prevented being in Vermont and Indiana. With the timing of our various visits, the Departments just mentioned along with Kansas and Minnesota, just could not be worked in with our other travels.

A report would be most incomplete if words of praise and commendation were not offered to the Auxiliary to Sons of Union Veterans of the Civil War — our Auxiliary. Adequate words fail me in this instance other than to paraphrase a portion of a verse from the Scriptures and say, "Well done thou good and faithful Auxiliary Members, without you, we would find it more difficult than we do." I trust that Irene's year has been everything that she could ever hope for and that her Encampment, a most harmonious and constructive one.

It was our good fortune to have a third Pennsylvania Member as a National head, Mrs. Erma Landis, of Lancaster, Pa., the National President of the Ladies of the Grand Army of the Republic. Our paths did not cross too many times this year but when circumstances would permit Erma and her various representatives were most co-perative with your Commander-in-Chief and I wish for her a happy and harmonious year and encampment.

Mrs. Dorothea Meyers, of Ohio, National President of the Daughters of Union Veterans of the Civil War and Mrs. Florence Willard, of Massachusetts, National President of the Woman's Relief Corps, Auxiliary to the Grand Army of the Republic, have been most co-operative and have

shown considerable interest in our welfare. I trust their respective years were successful ones and that the DUVCW National Encampment held in early August was a most constructive one and the Woman's Relief Corps meeting simultaneously within ours but on the west coast is a most harmonious one.

While I realize our organization must be governed by a close budget yet I feel that there are certain things expected of a Commander-in-Chief that are outside of the realms of his duties. I refer specifically to the Remembrance Day observance in Gettysburg, in November, the Lincoln Birthday ceremonies in Washington, D. C., on February 12th, the ceremonies commemorating the anniversary of the assassination of Abraham Lincoln in Springfield, Ill., April 15th, and the Memorial Day observance at the Cathedral of the Pines, in Rindge, N. H., May 30th. I believe the Commander-in-Chief should attend these if he possibly can but I also believe our organization should be responsible for some of the expense in each of these observances. Therefore, I recommend, if the Commander-in-Chief, during his term of office, attend any of these above mentioned observances, he should receive a sum equal to his expenses or not to exceed fifty dollars (\$50.00) for each of these observances.

Too often, I believe, we as an organization only do little, but ofttimes not in the right field. The annual scholarship is the subject I presently have in mind. I believe we could do well - better as a matter of fact, if we were to follow the pattern of our National Auxiliary in this matter. I found it most difficult to retain myself last year at the presentation of the scholarship, particularly when the recipient stated to those of us present "You must listen to us and you must let us have our say." That has been America's trouble for a great many years, we have listened to too many and permitted too many to have their say and now we find ourselves in near chaos, and growing deeper as each day passes by. I recommend the incoming Commander-in-Chief and each successive Commander-in-Chief shall be permitted to select the recipient of his choice for the annual scholarship and to be presented at such a time and place as the incumbent may desire. Further, in the line of scholarships, which has been of great interest and concern to me since established. I believe we should and could do better than we do. Therefore, I recommend that the scholarship be increased to three hundred dollars in 1970, then to three hundred, fifty dollars in 1971, and to four hundred dollars in 1972, and to four hundred, fifty dollars in 1973, and to five hundred dollars in 1974 and remain at the sum of five hundred dollars per year thereafter.

There is a problem which I think should be remedied and which with careful study and co-operation on the port of the Departments, I believe can be remedied: Department Encampments being held in conflict with others. I therefore recommend Article III, Section 1, immediately following the word "July" have a new sentence, reading "No two (2) Department Encampments shall be held at the same time so as to conflict." Since Department dates for 1970 may already be set, it is further recommended that the above become effective in 1971.

I have noticed time and again Departments having Officers in addition to those prescribed. In order to legalize such Department Officers for which no provision is made in Article IV, Officers, I recommend the word "and" in line 9 be eliminated and inserted in lieu thereof, a comma (.), replace the period (.) after the word organization with a comma (.) and add the following: "and such other Department Officers as may be pre-

scribed in the Department By-Laws if and when approved by a Commander-in-Chief."

Article II, Section 1, Chapter 3, third paragraph should be changed in my belief which may help increase the attendance at the National Encampments. I therefore recommend the substitution for the words "one delegate", "two delegates", change the comma (,) after the word Department to a period (.) striking out the remaining portion of the paragraph and insert a new paragraph to read as follows: "Of two (2) delegates from each Camp, including Camps-At-Large." If approved, paragraph shall be abolished. The sixth paragraph provides for the bestowal of rank of Past Department Commander upon a Department Secretary or Treasurer who shall have served twenty-five years. I recommend this be changed to a more considerate figure of ten consecutive years.

I am in full accord with the Grand Army of the Republic Highway Committee and its functions but there is in reality, no committee since only one person is appointed. I therefore recommend that the above named committee be abolished and the office of "National G.A.R. Highway Officer" be created, the duties of such to be consistent with those duties of the presently existing Highway Committee and/or as such as may be required by action of any Encampment; and be it further recommended that the proposed National G.A.R. Highway Officer be an appointive officer, appointed annually and in like manner with all other appointive National Officers.

One of our problems, I believe, is the lack of advertising. But, how can we advertise without sufficient funds to advertise? Any company worth its salt, will advertise but only so far as the funds will permit. I therefore recommend that each member of our organization be invited to contribute annually to their respective Camp Treasurers, the Camp Treasurers to the Department Treasurers, and the Department Treasurers to the National Secretary-Treasurer, such funds to be collected on or as near as the 29th day of September of each year, the anniversary of the founding of our organization by the Anna M. Ross Post, Grand Army of the Republic, in Philadelphia, in 1879. I have submitted to you that which I think is pertinent to the continuity of our organization; I truthfully believe in everything I have so recommended, but not too obstinately to listen to reasoning that may be better.

To all of my officers, each and every one, a great big "Thank You" for your support and co-operation, particularly to Brother Shriver, the National Secretary-Treasurer, P.C.-inC. Brother Al Lambert, my Counselor, to John C. Yocum, Natl. Pers. Aide and to all who have in any way helped along the way to build a bigger and better Sons of Union Veteraus of the Civil War.

I could not close without one more word of thanks — to my wife Anna who was able to join in some of our visitations but when remaining at home with our son Gar, understood the reason for my absence from the family fireside.

To all for their support and courtesies shown throughout the many Departments, my sincere and grateful thanks.

### REPORT OF JUNIOR VICE COMMANDER-IN-CHIEF

To Officers and Members of the 88th National Encampment. Sons of Union Veterans of the Civil War

The report I bring you will be a short one, due to the brief period for which I have occupied this office and the limited number of requests made of me.

I was appointed to the position of Junior Vice Commander-in-Chief upon the death of Roderick Van Trump, who had been serving in this capicity for a second term. By the time the appointment was made, the term was already half over, and it did not seem wise at that point to attempt to initiate a membership drive — especially since I had no knowledge of what Brother Van Trump may have already set into motion through correspondence with the various Department Commanders, etc. As a matter of fact, I am not even in a position to discuss the Order's membership trend, as I have never been notified of the gains, losses, etc. for the various Departments.

I did have an opportunity, however, to represent the Order on a number of occasions. The first was in February at the Washington National Cathedral, Washington, D. C., where I carried the colors with Brother Arthur Glennum, the District of Columbia Representative, in the proces-

sion at the annual Lincoln Memorial Service. In April, I represented our Order at the dedication of the new national headquarters building of the Daughters of Union Veterans of the Civil War, in Springfield, Ill., and shortly thereafter participated in the annual Lincoln Tomb Ceremony in that same city. In June, I served as Commander-in-Chief Heacock's representative at the Illinois Department's encampment, when he found that he would be unable to attend as he had expected to do. Through the courtesy of the Secretary-Treasurer of the state Camp in the Department of Colorado-Wyoming, who is a Past Commander of Beverly Hills Post of the American Legion in Chicago, I was invited to be speaker of the evening at that Post for its June meeting.

Upon receipt of a request from the Rock Island arsenal in Illinois, forwarded by National Secretary-Treasurer Shriver, I supplied the names of Civil War soldiers from designated counties in Illinois and Iowa who had been awarded the Congressional Medal of Honor, that their names might be inscribed in the Honor Roll book being placed in the arsenal's newly constructed Court of Patriots.

In the way of recommendations, I have only one matter which I would like to touch on. For some time it has troubled me that our Application for War Medal form does not indicate that this medal may be awarded to men in any war more recent than "World War." If it may indeed be awarded to men who served in the Korean War, and now in the Viet Nam War, as I believe it should, then such notation should appear on the form. Therefore I make this my

### RECOMMENDATION NO. 1

That the words "Korean War" and "Viet Nam War" (or similar words to suggest those periods of conflict) be added to the Application for War Medal form.

It would not be necessary to have the present forms reprinted to accomplish this purpose. The wording could be added by merely applying a rubber stamp.

With further reference to the war medal, these are listed on the Requisition for Supplies form as a camp supply item, yet the application form clearly indicates that they may be awarded only after approval by the Department Commander. To correct this inaccuracy I offer

### RECOMMENDATION NO. 2

That war medals be issued only upon requisition by the Department, following approval of the application form by the Department Commander.

Again this can be accomplished very simply. When the Requisition for Supplies forms are next printed, we need only move the war medal listing from the camp supply section to the department supply section. Camps can then forward payment for the medal with the application form to Department headquarters, and after approval of the application, the Department can requisition the medal, indicating on the requisition form that it should be shipped to the camp where it can be presented to the recipient.

1. It is with deep humility and pride that I submit to you, this formal report of activity and progress that has been credited to this Administration under the leadership of Commander-in-Chief Frank M. Heacock, Sr., his Staff of Officers and to all brothers of our Organization.

2. The books, records and Financial standing have been audited by Clay W. Garrett, Certified Public Accountant, Hanover, Pennsylvania, for the fiscal year ending June 30, 1969, copies of the summarization of the CPA report distributed to the delegates registered at this Encampment. The CPA Audit was examined and approved by the Council of Administration and will be forwarded to the Congress of the United States to conform to our Act of Congressional Charter.

3. Our analysis of the membership standing and the income from per-capita continues downward. Current standing of membership as of June 30, 1969, is contained on a separate report attached to this report and reproduced on the special financial statement distributed to the mem-

bership present.

4. Our main source of reserve continues to be the Permanent Fund which consists of increases from the accumulated dividends of \$1.778.80 during 1968-69. Life Membership fees and donations to the Honor Roll added an additional \$225.00. - 7. Investments for the Permanent Fund continued with the purchase of 35 shares of Wellington Fund at \$14.97 on October 7, 1968. The total of investments current number 1985 shares with a market value of \$24,256.70 as of June 30, 1969 plus a cash balance of \$1,511.45.
- 8. The General Fund of our Order continues to deplete due to increased operational expense. Extra expense for stocking supplies, letterheads, and change in date of payment of Encampment appropriation for G.A.R. Campfire program, caused disbursements to be higher during the past fiscal year than average. Officers elected at this Encampment must strive to maintain our Order's prestige, promote our principles to the Memory of the Grand Army of the Republic, yet strive to operate on a sound financial budget within our current status. Recommendations will be presented at this Encampment to reduce several items from future obligations.
- 9. Reports and communications arrive daily at your National Headquarters and number into the hundreds annually. Every request for information is acknowledged. Minutes of the meetings of the Council of Administration are recorded. Copies of the 1968 (87th) Annual National Encampment Proceedings with a copy of the C.P.A. Audit Report, have been forwarded to the Congress of the United States and Library of Congress for record. A supply of forms, badges, etc., are maintained at your National Headquarters. Increase cost of printing and manufacture results in some items' increase each year said item is restocked.
- 10. The democratic principles of our Nation today, formed by our fathers and grandfathers over 100 years ago, are now tested in every part of our world today—harder than ever. Our enemy of the communistic world consist of well-trained men who are trained to overthrow our way of life through the defacing of "Old Glory"; disturbances on the campuses of our colleges and universities, interruptions and stalling around peace tables, all of which is to destroy our pride, reduce faith in our Country, become lax in our display of patriotism and above all forget God.

The eruption of certain facets of our National, State and local governments continue to test our Country's patriotism. We have suffered greatly on the Battlefields of Viet Nam, as we suffered on the Battlefields of Vicksburg and Gettysburg a century ago. It will make our Organization stronger in purpose and promote our Order into the status that the Grand Army would be proud.

Our friendship has experience working on Camp and Department projects and now you have proven successful in leading our Order as its Commander-in-Chief. My deepest appreciation to serve with the Staff of Officers who served with you.

very satisfactory. U. S. grave flags, also Sons Organization flags, have either been furnished or information given where they could be obtained.

Co-operation with other Patriotic organizations has been on the highest level, seeming to improve from year to year.

My sincere thanks to Walter R. Menear of Pittsburgh, Pa., for sending me several lists of grave locations in West Virginia. Also to Charles E. Sharrock of Lamar, Colorado who from time to time throughout the year has sent lists of graves in Colorado, Kansas and Illinois. Brother I. Richard Reed, New York Department Graves Registrar, sent in his annual report — the only report from a Department as such received by this office. He reports designing and using a special paper which the manufacturer assures him will last at least 100 years without turning yellow or becoming brittle.

Since 1966 the New York Department has recorded the graves of 16,964 Civil War veterans in 34 counties of their state. This represents a total of 329 cemeteries, in 34 counties. Brother Reed further states that hardly a month goes by that letters are not received from various parts of the country asking about the location of a grave. It is estimated that there are at least 500,000 burials in New York State. The task is far from complete for only three of the counties have been covered with any degree of completeness and in about half of the counties are the graves recorded. Richard Reed states he is proud of the work done so far, and well he should be.

I am proud of the work he has done, for it points up the vastness of the task, also the dedication and devotion needed, and the pride and satisfaction of a work well done, which is an inspiration to further effort. We salute these Sons and wish them success in their continuing efforts. Many departments either have not done any work along the line of Grave Registration or else it is too incomplete to report. A number of people have promised reports but for one reason or another have failed to send in the lists so far.

I feel sure most of these promises will be fulfilled at some future date. This work of Registration is a duty particularly of interest to our members. Its fulfillment is long overdue and the time is running out. I hope the years immediately ahead will see increased interest and definite progress in this field.

Finally, Commander-in-Chief Frank, I am most appreciative of the honor of serving as one of your staff of Officers.

RE: The Legislative Report

Greetings!

Your Committee on Legislation begs leave to submit the following report of its activities and interests during the past year.

To the extent possible we have used The Banner as our principal means of communication. In so doing we have elected to concentrate not on the headline stories but rather on those that might have escaped attention in the ordinary perusal of the daily press. Examples of these efforts include the story on the reconstitution of what was formerly the House Committee on Un-American Activities and the description of the case involving the New York flag desecration statute. We conceived of our task as being primarily educational, and to this end The Banner served as a useful and respected outlet for the release of interim reports.

A year ago we reported on the passage in Congress of the Uniform Holiday Act, Public Law 90-363. Under our system of dual responsibility that legislation will apply only to federal employees, installations and residents of the District of Columbia. Since the first of the year (1969), the great majority of our states have been holding legislative sessions. And as of late May, a total of 32 states had passed legislation comparable to the federal statute. In some states minor revisions were included to conform with local custom. In Illinois, for example, Abraham Lincoln's birthday was added to the list of dates to be commemorated on a Monday. The Emancipator's birth will be observed on the first Monday in February. In nine other states a bill had passed one house and was awaiting action in the second chamber. In five states the matter had been introduced and in four states their legislatures will not convene this year.

Your chairman is most familiar with the State of Wisconsin which currently is one of the five states in which final action has not been taken by either house. On April 8 and again on May 15 your chairman appeared before committees of the Assembly to testify in opposition to the proposed changes and particularly to the shifts proposed for Memorial Day and Veterans Day. Wisconsin is in the throes of a bitter fight over the adoption of a budget, and action on a host of other matters

including this one is not expected before fall.

Although the legislation will vary with the state, it is interesting to note that in the two proposals introduced to date in Wisconsin, neither one provides for "holidays" per se. The bills simply prescribe when the days affected will be observed. This is interesting because proponents of the measures stress the "holiday" aspects of the change and promote the idea that more three-day weekends and leisure time will be created. Consequently, people are led to support the bills thinking their passage will add leisure time to the calendar. In Wisconsin, at least, this is just not so.

At the national level Representative Martin B. McKneally of New York State has introduced HR 6247 which would restore Memorial Day to May 30 and Veterans Day to November 11 by repealing a portion of the measure enacted by Congress last year. The bill has been referred to the House Judiciary Committee where it is expected hearings will be scheduled. Without a wave of public protest and indignation demanding a return to the traditional dates, it is difficult to see how the measure stands a realistic chance for passage. Nevertheless, those who feel strongly about this proposal - including your chairman - are urged to write Rep. McKneally to express your support of his position and to Rep. Emanuel Cellar to urge that hearings be slated on HR 6247.

Other measures relating to holidays and historical dates of interest have been introduced in the 91st Congress. HR 2171 would create a Commission on National Observances and Holidays to advise the President; HR 75 would set aside September 17, Constitution Day, as a legal holiday; HR 9859 would make the Presidential Election Day a legal holiday; HR 1168 would make the General Election Day in each even numbered year a legal holiday; HR 2120 and 4207 would declare Flag Day, June 14, a legal holiday; HR 7042 and 7044 would make inauguration Day, January 20, a legal holiday every four years; S 839 would make Lincoln's Birthday, February 12, a legal holiday; HR 757 and a host of companion bills would declare January 15, the birthday of Dr. Martin Luther King, Jr., to be a legal holiday; HR 10766 would set aside Franklin Roosevelt's birthday, January 30, as a legal holiday; HR 3836 would retain Veterans Day on November 11; and S 1497 and HR 8381 would declare Veterans Day to be a legal holiday but commemorate it on the second Monday in November.

As a result of the success of the Apollo 11 flight, at least three Congressmen have suggested that a day be permanently set aside to commemorate man's first visit to the moon. Rep. William Jennings Bryan Dorn has introduced a resolution to Make July 21 a holiday; Rep. Glenn M. Anderson has introduced a measure that would designate the third Monday in every July as a national day of recognition; and Senator Abraham Ribicoff stated that he would introduce a resolution to

declare July 20 as "Apollo 11 Day."

Unlike a generation and more ago when Congressmen led more leisurely lives and spent considerably more time back in their districts, Congress remains in session nearly the year around. This makes direct contact with Representatives and Senators increasingly difficult for the average person. As a substitute for these personal contacts, brief and pointed but courteously written letters can be effective in making individual views known. Although state legislators and local officials are more approachable, they, too, are feeling the pressures of increasing responsibilities as government at all levels continues to grow. To help bridge this "communications gap," Western Union has devised a new service known as Personal Opinion Message. For 90 cents, Western Union will send a 15-word telegram to the office of the President, your Governor, Representative or Senator, or State Legislator and your signature and address will be included free. You need not even know your man's name. Western Union will look it up for you. To send a POM, you need only pick up the telephone. The 90 cents will be added to your telephone bill.

As this report is written, the controversy over the anti-ballistic missile program continues with prolonged debate in the Senate. Sponsored by the Nixon Administration, the proposal is hardly a partisan one. In fact, it has effectively cut across party lines in the Upper House. For example, Senators Aiken and Percy, as Republicans, are outspoken in their criticism of the plan while Senators Stennis and Jackson, both Democrats, have made a spirited defense of the President's recommendations. At this juncture, it appears as if the Senate is closely divided on the

merits of the measure.\*

\*On August 6 the Senate by a vote of 51 to 49 defeated the Cooper-Hart amendment, the passage of which would have barred the deployment of the ABM system for at least one year. Although other amendments will be considered, the rejection of that key proposal apparently signals the eventual success of the ABM program in the Senate.

Unfortunitely for the average person, the merits of the controversy are difficult to sort out. Defense policy has long passed the point where its effectiveness could be equated with the seaworthiness of 50 over-age destroyers as in the days just prior to World War II. While the doughboy and his sea and air counterparts are called upon to do battle in Vietnam and guard our interests the World over, defense policy has assumed a dimension not thought possible a generation ago. Polaris submarines, missiles, and the logic of the computer have combined to put beyond our grasp the ability to judge the adequacy of the defense establishment. Too often because of this feeling of inadequacy, we are willing to settle for a catch-all phrase to describe a point of view. How many times in recent months have we heard the words "military-industrial complex" and assumed that they signified some diabolical plot to enrich the pockets of the munitions makers at our expense? And how rarely has this phrase been used to characterize the "arsenal of democracy" concept popularized by President Roosevelt in 1940?

Times change and those who advocate preparedness in one generation become the neo isolationists of another. But the fact remains that our foreign and defense policies are hopelessly interwined and largely the responsibility of the President. Recently former Secretary of State Dean Acheson spoke out in support of President Nixon's position on the ABM. He cited the importance of the President in determining long range goals and observed that to deal successfully with the Russians and other communist powers, we must do so from a position of strength.

Your committee believes that our President — regardless of party — should be given the tools he believes necessary to carry out his responsibilities as the chief architect of our foreign policy. If the ABM represents such a tool — and we believe it does — Our Congress should close ranks behind the President on this issue reserving its right, of course, to exercise surveillance over the execution of the program.

Recently Senator Barry Goldwater, in a Senate speech, made this observation: "Now that we have the industrial capacity to equal the Russians in space or in matters related to defense, there seems to be a nation-wide effort to make us feel guilty . . Rather than deploring the existence of a military-industrial complex, I say we should thank heavens for it. It is the bubble under which our nation prospers. It is the armor which is unfortunately required in a world divided."

As members of a patriotic organization interested in preserving our nation's heritage on the one hand and in promoting her future on the other, we have a duty to be vigilant lest well-meaning but misguided souls — and those with less honorable intentions — bargain away our hard won advantages and make the cause of a just peace even harder to attain.

In closing, your committee hopes that it has played a role in contributing to a better understanding of some of the issues before us. If we have even approached that goal, our efforts will have received their due. Your chairman wishes to thank his associates in this work—William M. Coffin, Arthur R. Glenum, Charles A. Brady, Jr., and William J. Blakeley—for their encouragement and support. He has enjoyed his tenure as chairman and is proud to have been of service to our beloved Order.

## REPORT OF LINCOLN TOMB CEREMONY COMMITTEE

July 1, 1969

Greetings:

Your committee, appointed to conduct the annual ceremony at Lincoln's Tomb, begs leave to submit the following report.

1. Again this year the invitation to join our Order and the MOLLUS in honoring the memory of Abraham Lincoln on his death day, April 15, met with a gratifying response. A total of 58 wreaths were offered in tribute to our Sixteenth President and 113 guests assembled in the dining room of the State House Inn for the luncheon following the exercises. Inasmuch as April 15 fell on a Tuesday this year, this response was most encouraging.

2. We were pleased to welcome our Commander-in-Chief, Frank M. Heacock, Sr., who acquitted himself in a most exemplary fashion in his talk at the Tomb and later during brief remarks at the luncheon. The familiar presence of Commander William C. Duval, USNR (Ret.), a past Commander-in-Chief of the MOLLUS and an originator of the ceremony, added to the dignity of the rites. Cmdr. Duval represented his chief, Lenahan O'Connell, who was unable to be present.

3. Music for the ceremony was provided by the Concordia Seminary chapel choir under the direction of Professor Daniel G. Reuning. Selections included some familiar Civil War compositions as well as those of more recent date.

4. A long-time friend of this ceremony and faithful attendant over the years, Dr. Wayne C. Temple, assistant archivist of the State of Illinois and editor of the LINCOLN HERALD, gave the principal address this year. Speaking with wit and aware of the interests of his audience, Temple discussed some episodes from Lincoln's life as they were related to a Springfield landmark of the era, the St. Nicholas Hotel.

5. A moment of silence was observed in honor of the memory of Dwight D. Eisenhower, late President of the United States. Brief tributes were given in memory of Major General U. S. Grant, 3rd, USA (Ret.), a founder of this ceremony, and Roderick Van Trump, Sr., the late commander of the Illinois Department and steadfast friend of this observance.

6. Among the distinguished guests present this year, we were honored to have Mrs. Irene K. Murphy, president of our Auxiliary; Mrs. Erma Landis, president of the Ladies of the Grand Army of the Republic; and Mrs. Denny Tilley, president-general of the Daughters of the Union 1861-1865.

7. Your committee takes pride in reporting that its expenditures incurred in the sponsorship of this ceremony were within the appropriation

granted by the 1968 National Encampment. A total of \$278.24 was expended in meeting the official expenses reported. It should be emphasized, however, that this relatively low total was made possible only by reason of the fact that the services of both the choir and of Dr. Temple were graciously provided without cost for the occasion.

S. RECOMMENDATION FOR 1970 — Your committee recommends that the annual appropriation of \$350.00 be continued for 1970. We realize that the cost of every project and purchase undertaken by our Order has risen in response to the pressures of inflation and that money is not easy to come upon. But we wish to continue providing the type of ceremony that befits the stature of President Lincoln and of our Order. In approving this recommendation, it is understood that the co-chairmen, appointed by the Commander-in-Chief, shall be fully responsible for the planning and execution of the commemorative program.

9. For a complete account of the April 15, 1969, Lincoln Tomb ceremony conducted at Oak Ridge Cemetery, Springfield, Illinois, your

attention is invited to the Summer issue of THE BANNER.

## REPORT OF CONSTITUTION AND REGULATIONS COMMITTEE

The following Resolution was adopted at the 87th Annual Encampment of the New Jersey Department, Sons of Union Veterans of the Civil War:

WHEREAS: We heartily agree in principle with the resolution submitted by the Vermont Department relative to Associate Members, therefore be it

RESOLVED: That the following change be made in the Constitution of the Sons of Union Veterans of the Civil War:

Article 7—Membership Section 3—Page 5

Line 3—Add the word "National" between the words "hold and elective", so that it shall read: "Said Associates shall not hold National elective office," etc.

California-Pacific Department submits the following for consideration by the 88th National Encampment to be held in St. Louis, Missouri, August 17-21, 1969.

- 1. RESOLVED: That the Department of California-Pacific concur in, and fully support the resolution submitted by the Vermont Department: "That Associate members be granted the right to hold all elective offices, at the discretion of their departments.
- 2. The Department of California-Pacific believes, that by utilizing the Patriotism, Interests and Capabilities of these members, the order of The Sons of Union Veterans of the Civil War will be benefited through increased activity and growth, and that it will provide an avenue whereby young and active workers for the good of the order may contribute to the perpetuation of those ideals to which we are dedicated.

The Vermont Department, at their Annual Encampment assembled in the City of Burlington, Vermont. June 27-28-29, 1968, instructed their Department Secretary to draw up and send to the National Encampment, meeting at Wilmington, Delaware, August 18-22, 1968, the following resolution:

- 1. RESOLVED: That since it is well known that many of our Associate members in all Branches of our Order have proved many times over that they are Patriotic, Loyal, Faithful, Hard-working and enthusiastic members:
- 2. That we feel that oftentimes we are deprived of the full benefit of their capabilities, and that the Order as a whole is the loser:
- 3. THEREFORE the Vermont Department, Sons of Union Veterans of the Civil War, at their 86th Annual Encampment, recommends: That Associate members be granted the right to hold all elective Offices, at the discretion of their Departments.

NOTE: This Resolution was submitted at the National Encampment at Wilmington, Delaware in 1968, but was not acted upon.

The Vermont Department wishes to re-submit this to the next National Encampment to be held in St. Louis Missouri, in August of 1969.

Regarding the recommendations from the Vermont Department, the Department of California-Pacific and the New Jersey Department relative to Associate Memberships, the Committee does not support these resolutions relative to Associate Members for the reasons, among others, that allowing the associate members to hold elective office would substantially change the nature of the Organization, and would mean in substance that there would be no effective continuation of the hereditary requirements for membership, and that the Organization could be eventually largely composed of interested persons having no blood relationship to a Civil War Veteran. For example, the Woman's Relief Corps is of that nature.

(The recommendation of the Committee was concurred in relative to the California and Vermont resolutions, but not relative to the New Jersey resolution. By standing vote of the Encampment the New Jersey resolution was adopted by a vote of 43 to 7.) The following pertains to the recommendations contained in the report of the Commander-in-Chief:

Regarding the recommendation in reference to regulations. Chapter 2, Article III. Section I, that the regulations be amended by adding a sentence that no two Department Encampments shall be held at the same time so as not to conflict, the Committee on Constitution and Regulations does not approve, for the reasons that the question of who is to resolve the conflict is not stated, that a forced decision could cause resentment and dissatisfaction, and that a Department may itself avoid a conflict by inquiring of the Commander-in-Chief or National Secretary as to what dates are available before determining the time of its Encampment. (Recommendation of committee adopted)

Regarding the recommendation for change of Regulations Chapter 2, Article 4, Section 1, in effect to permit such other Department Officers as may be prescribed in the Department By-Laws if and when approved by the Commander-in-Chief, the Committee on C. and R. does not approve such amendment, for the reasons that it deems the offices specified in the Regulations to be adequate, that the proposed amendment would take the decision out of the hands of the National Encampment, that it would permit offices to be created by By-Laws instead of Regulations, and that if a particular additional office were to be desired the proposed amendment should specify it and be confined to it.

(Recommendation of Committee adopted)

Regarding the recommendation in reference to Regulations Chapter 3, Article 2, Section 1, as to which it is recommended by the Commander-in-Chief in substance that each Department shall have two delegates to the National Encampment instead of one, striking out the words "whatever its membership", deleting the remainder of the paragraph and substituting the words "two delegates from each Camp. including Camps at large", this Committee does not approve of the form or substance of such proposed amendment for the reason it believes that the desired representation from the Department is already covered in the Regulations as now written, and that any significant increase in attendance at a National Encampment would not be gained by the change proposed. However, if it had been recommended that regardless of membership each Camp be allowed a minimum of two delegates, the Committee would regard it with favor.

(By motion made by P. C. in C. Lambert, seconded and adopted, Chapter 3, Article 2 (Membership) was amended by changing the third paragraph to read: Of one delegate from each Department, whatever its membership, and one additional delegate for every twenty-five members. or major fraction thereof in good standing, based upon the report next

preceding the National Encampment.)

Regarding the recommendation as to the provision in the same section on conferring the rank of Past Department Commander on a Department Secretary or Treasurer after service for ten consecutive years service instead of 25 consecutive years, the Committee concurs with the proviso that the matter be made permissive instead of required. This will substitute the word "may" for "shall" in the second line of the paragraph.

at which a President was present, and while part of the parapet is preserved today in memory of Lincoln and the soldiers who defended the Capital, it is fast deteriorating into nothing more than a playground for neighborhood children.

RESOLVED: That the National Capital Region of the National Park Service be requested to protect the area of the parapet which has been restored, with the same care that would be given to any great monument, and to preserve its dignity within a suitable inclosure that will encourage visitors to respect it as the Fort that defended the Capital from General Early's attack.

(Resolution approved unanimously)

WHEREAS, Certain Astronauts during flight into space desired to and admitted having read the Holy Bible; and

WHEREAS, Their belief in and recognizing God as their Creator, reatherns our confidence and faith in these men:

THEREFORE BE IT RESOLVED that the National Organization Sons of Union Veterans of the Civil War in this the 88th National Encampment assembled in the City of St. Louis, Missouri, wholeheartedly support the astronauts' decision to read from the Holy Bible in space and that we express in behalf of the entire membership, our grateful appreciation to NASA and these astronauts for speaking out for that in which they believe and for recognizing God as their Creator; and

BE IT FURTHER RESOLVED that a Copy of these Resolutions, duly signed and attested, be forwarded to the NASA Officials forthwith. (Approved unanimously)

WHEREAS it has been brought to public attention that the United States Aircraft Carrier Yorktown and United States naval personnel have been or are to be used as accessories in the production of a motion picture film "TORA, TORA, TORA" by and for the benefit and profit of the Darryl Zanuck-20th Century Fox Company, a private industry, and

WHEREAS The theme of such film is associated with a day of infamy and of great disaster to the United States, and the showing of such film will be detrimental to the public image of and respect for the United States.

BE IT RESOLVED: by the Department of New York. Sons of Union Veterans of the Civil War, in annual encampment assembled, this 28th day of June 1969, that this body opposes the use of the aircraft carrier Yorktown and of any naval personnel in the production of the motion picture film, "TORA, TORA, TORA", and

FURTHER RESOLVED: that it is the sense of this body that private industry be not permited the use of property or personnel of the United States without fair and adequate compensation to the United States, and

FURTHER RESOLVED: That it is the sense of this body that property or personnel of the United States be not used to the detriment of the United States, and,

FURTHER RESOLVED: That a copy of this resolution be sent to the President of the United States, the clerk of the United States Senate, the clerk of the House of Representatives, and to all other persons as may be determined by the Department Commander or the Department Secretary.

(Adopted unanimously)

WHEREAS The Sons of Union Veterans of the Civil War are pledged to perpetuate the memory of the Grand Army of the Republic, to teach patriotism and duties of citizenship, and love and respect for the laws of our Country, they wish to go on record as expressing themselves for or against certain propositions as follows:

BE IT RESOLVED: That the Sons of Union Veterans of the Civil War 1. Urge the continued appropriations of funds necessary for the National Defense and Security.

- 2. That we urge the balancing of the National Budget by reducing as rapidly as possible expenditures for Foreign Aid and other Federal Projects which encroach upon the prerogatives reserved to the states by the Constitution.
- 3. Urge support of police and constituted authority in preserving law and order, and that offenders be punished by the courts to the full extent of the law
- 4. That we condemn Campus disorders that infringe upon the rights and safety of the vast majority that do not participate.
- 5. We ask that the courts stop being lenient in the matter of drug addiction, and that pushers and addicts both be controlled by whatever means is necessary.
- 6. That we condemn any member of our legislative body, either the Senate or House. for uttering statements against our government, which border on sedition and treason, and give aid and comfort to our enemies.
- 7. Insist that those in authority have the strength of purpose to uphold the principles of our forefathers and the Constitution and to protect those who fight and work to preserve a just and orderly government. Adopted unanimously by the New Jersey Department, Sons of Union Vetcrans of the Civil War at their 87th Department Encampment, at Avon, N. J., June 14, 1969, and ordered sent to the National Organization for their consideration.

(Adopted unanimously)

WHEREAS, said article indicated all fresh cut flowers were taken from Veterans Graves at the Gettysburg National Cemetery on the afternoon of May 29th and will continue to be removed as it appears by this article that their removal is (was) a War Department Order, quoting the article, "They might kill the grass",

THEREFORE BE IT RESOLVED, the Pennsylvania Department, Sons of Union Veterans of the Civil War in this the 89th Annual Department

Encampment assembled in the City of Harrisburg, Penna, condemn this action as being shocking, dastardly and discriminating and protest such an edict and request such action be reversed; and

BE IT FURTHER RESOLVED, that copies of this Resolution, duly signed and attested, be forwarded to the Superintendent of the Gettysburg National Cemetery, the Secretary of Defense and the Secretary of Interior, and

BE IT FURTHER RESOLVED, that a copy of this Resolution be forwarded to the 88th Annual National Encampment in St. Louis, Mo., and request their concurrence therein. (adopted unanimously)

WHEREAS, Willful, lawless and violent groups, often acting in association, are distrupting the order of our society and the foundations of our educational system, and

WHEREAS, American leadership needs the broadest possible public support if it is to meet this challenge to the fabric of our national existence, now, therefore, be it

RESOLVED By the 88th National Encampment of the Sons of Union Veterans of the Civil War meeting in St. Louis, Missouri, August 17-21, 1969, encourage and will give its active support to public and private officials who will persevere in the following efforts:

To expose and put down organized anarchy;

To preserve public and private institutions from usurpation or destruction by mob rule;

To insure the safety of all citizens from willful harm;

To stand firm against threats and criticism in performing their duties to protect, and promote the public interest;

To lead our country to rational and peaceful solutions to our ever-

changing problems;

To instill in the American people a new growth of civic responsibility, love of country and faith in God. (Adopted unanimously)

- 1. The 11th Annual Grand Army of the Republic Remembrance Day program was held in Gettysburg, Pennsylvania, on Saturday, November 16, 1968, with Commander-in-Chief Frank M. Heacock, Sr. and the four National Presidents representing the Allied Orders of the G.A.R. present. The five Pennsylvania Department heads of the Allied Orders were also present as were several from other Departments.
- 2. The observance began with a parade of National and Department Heads in automobiles, units of the Sons of Veterans Reserve, Veterans

units as well as dignitaries from area Military units. The procession was led by the Gettysburg Senior High School Band, from the Holiday Inn to Zeigler's Grove on the Gettysburg Battlefield at the Albert Woolson Monument.

- 3. Col. William A. Campbell, Professor of Military Science and Tactics at Gettysburg College, delivered the Remembrance tribute to the Grand Army. Memorial wreaths were placed by each National and Pennsylvania Department head as was their remarks concerning the importance and value of this occasion. The firing of the volley, Taps and a closing prayer ended the observance with upwards of 500 people present.
- 4. Although this report does not contain other important details relative to the program, those who have attended this annual event realize the significance of having all five Orders of the Grand Army family meeting in solemn tribute honoring the Grand Army veterans. The color and cooperation by veterans, Military and our own organizations have proved this an important day on our official calendar for each year.
  - 5. The following recommendations are therefore submitted:
    - A. That the incoming Commander-in-Chief appoint a General Chairman for one year to plan the events for the 12th Annual G.A.R. Remembrance Day Program.
    - B. That upwards of \$150.00 be appropriated towards the expense of music, programs, wreaths, etc. — said appropriation from the G.A.R. Memorial Fund.
    - C. That a report of this event be submitted to the 89th Annual National Encampment in 1970.

# REPORT OF THE COMMANDING OFFICER NATIONAL MILITARY DEPARTMENT SONS OF VETERANS RESERVES

To the Officers and Delegates Sons of Union Veterans of the Civil War 88th Annual National Encampment St. Louis, Missouri

#### Greetings:

- 1. The following report constitutes the activity and progress of the National Military Department, Sons of Veterans Reserve for the fiscal year June 30, 1968 to June 30, 1969, supplementing the report of the N.M.A.C.
- 2. Muster Roll and strength reports show 76 Commissioned Officers and 346 enlisted men comprise the Sons of Veterans Reserve as of 30 June, 1969. A survey shows that every Officer must be a member of a Sons of Union Veterans of the Civil War Camp in good standing, and that 78% of all enlisted personnel are members in good standing.
- 3. Totals in paragraph 2 includes 7 Units of WAC/SVR with a strength of 7 officers and 62 enlisted members.
- 4. The activity and program operations during the last year has seen the Reserves assisting many Camps in various observances. Number one on every Reserve Units list of importance is the assistance of many Memorial Day events to the Camps. A breakdown of the overall activity and promotion in each district is listed as follows:

FIRST MILITARY DISTRICT: — LTC Thomas A. Chadwick, Commanding. In the six New England Departments comprising this District, events were held on a formal public appearance in Vermont, New Hampshire, Massachusetts and Rhode Island. Units of this District travelled to Gettysburg and other places for re-enactments of Civil War

events. The annual parade, inspection and drill competition on the boardwalk at The Weirs in July is viewed by hundreds of vacationers there. This is a part of the New England Regional meeting. The image of the Civil War is promoted in this District.

SECOND MILITARY DISTRICT:—LTC John A. Stark, Commanding: Includes the basic SVR original organization—The Pennsylvania Brigade. These units are located in Pennsylvania in addition to Ovid, N. Y. and Trenton, N. J. Events on a local basis plus District level with a weekend bivouac and August family picnic with an inspection and evening parade. Membership in the Camps have been retained and in some, membership increased through the Reserve activity.

THIRD MILITARY DISTRICT: — LTC E. A. Nutt, Commanding. The District is located basically with units in Ohio and Northern Illinois. These units include many units of Infantry, Artillery and Cavalry with these Officers and men financing their uniforms and equipment. Units in this District travel to the south and east for many Civil War renactments during the past year. This they have been doing for 10 years and represent our SUV Camps 100% with a true Civil War image.

FOURTH MILITARY DISTRICT: — MAJ E. A. vonFrankenberg, Commanding. Located in Wisconsin, these men are well equipped with individual muskets. They too travel to many skirmishes held each year as a followup to the Civil War Centennial. Other promotions include exhibits at the Wisconsin State Fair where over 2,000 SUV promotional folders were distributed and several applications received into the Camps in the Wisconsin Department.

SIXTH MILITARY DISTRICT: — LTC C. R. Butcher, Commanding. This is a ceremonial Unit wearing the Civil War uniforms known as the Oregon Blues Brigade Fife and Drum Corps and has appeared in many civic functions in the Departments of Oregon. Washington and California. They presented a concert for Commander-in-Chief Heacock upon his visit to their area when Brother Frank was visiting the Oregon Department.

- 5. A training program for Officers and enlisted personnel, plans for future activity based on the Civil War authenticity period and promotional plans to expand SUV recognition are on the agenda for 1969-70. The Sons of Veterans Reserve is promoting the Civil War image, remembering the story of the American Civil War and are dedicated in carrying on the heritage passed on to us. At the same time, ever respectful of the powers which created the SVR and stand ready to assist the Sons of Union Veterans when called upon.
- 6. A financial report of income and disbursements incurred for the period June 30, 1968—June 30, 1969, is attached to this report.

## REPORT OF THE NATIONAL MEMBERSHIP SURVEY COMMITTEE

Commander-in-Chief Heacock Officers and Delegates

Brothers All:

I have the honor to present herewith the report of the National Membership Survey Committee that was authorized by the 87th National Encampment concurring with Commander-in-Chief Haskell's recommendation No. 1: "That the incoming Commander-in-Chief appoint a committee to make a study to see what means we can use to secure new members and to report as soon as possible".

In the early months of this year after Commander-in-Chief Heacock sent a circular letter out, our duties were expanded to find a program for

continuing the Order and building it.

By the very nature of our Committee, we were to conduct a survey yet through an oversight no appropriation was made for it in our 1969 budget. Notwithstanding over 300 survey forms representing about one-tenth of our membership were mailed out or otherwise distributed. Selection of names and addresses presented a second problem as no master-list of members is available so our Committee gathered names from numerous sources which included all Past Commanders-in-Chief, all National Officers and committee members, all Department Commanders and Department Secretaries of 1968-69 and all those

newly elected Department Commanders and Secretary-Treasurers that were reported to Chester Shriver by July 1, 1969; to these were added all commissioned Sons of Veterans Reserve Officers, various Camp Commanders, Secretaries, and members.

We realize this survey was lengthy and detailed, but from it have emerged the most complete findings and opinions of the general membership in over thirty years. We believe we were able to obtain a true spectrum of the membership as the average age of members answering was 59 with the youngest being 23 and the oldest being 92. Some with over 60 years membership and others with only a few years.

We have discovered some of our weaknesses and some of our stronger points. Our survey has revealed many areas that can advance the Order to former heights through the adoption of short-term and long-term programs, but immediate action must be taken at this Encampment. For too many years, we have been content to allow status quo and now each year the Order grows weaker and smaller — we must here decide to re-dedicate ourselves and our Order or admit our failure — the decision is yours.

As with the survey itself, this report shall be divided into important topics and each shall contain recommendations for growth. Please consider them carefully.

## The Purpose of our Order

Although Article II of our Constitution states the present purposes of the Order, these can be simplified into two areas: 1. Americanism and Patriotism and 2. A living memorial to the Grand Army of the Republic. Our Order is based on sentiment and at present it exists on sentiment. This same observation was made almost 50 years ago, when one brother wrote, "It would arouse the indignation of every man who has been a member if we proclaimed that he lacked a proper reverence or respect for his (Union ancestor's) and was not duly proud of his ancestor's service for the Union. This is sentiment. The patriotic feature of the Order have rendered a broad service for national citizenship and patriotism is also sentiment." These sentiments should be fostered and expanded, but we must also become much more HISTORI. CAL, much more EDUCATIONAL and much more CIVIC MINDED.

(The balance of this lengthy report was referred to the Council of Administration, who in turn has referred it to the new Committee on Reconstruction of our Order.)

Commander-in-Chief Heacock: You have heard the report of the Budget Committee as presented. Are there any questions?

Discussion then followed by many regarding the expenses for the coming year compared to those of the past years with printing, postage, etc. increasing. With the Standards of our Order to be retained, several brothers discussed possible solutions to the condition of the General Fund which is decreasing each year.

A motion was made by Past Commander-in-Chief Albert Lambert and seconded by Past Commander-in-Chief Joseph Rippey to increase the per capita tax from \$1.20 per member per year to \$1.40 per member per year beginning with the Fourth Quarter of the year 1969—ending December 31, 1969 and due at National Headquarters by January 30, 1970 to correct the condition of the decrease of the General Fund. Motion carried.

- 5. Following discussion on future projects and appropriations from the G.A.R. Memorial Fund, on a motion by Brother Heacock, seconded by Brother Furman that a suggested goal of \$1.200.00 be given to the National Patriotic Instructor.
- 6. The Council of Administration went on record as having received verification from the Members of the Council of Administration during the fiscal year 1968-1969 whereby Brother Charles A. Brady, Jr. was duly elected by mail to replace Brother Roderick Van

Trump, Sr. as Jr. Vice Commander-in-Chief due to the sudden death of Brother Van Trump.

7. The Council of Administration voted to forward a letter of Thanks to the family of U. S. Grant, III for his gift of \$1,000 to our Order as part of his last will. This action by motion of Brother Durkee, seconded by Brother Heacock.
