CinC Orr Uses Power of General Orders

Commander in Chief Richard D. Orr is exercising his authority and, according to his most recent General Orders, that authority includes recognizing outstanding performers and disciplining those who have become disruptive to the harmony for which we strive.

General Order Number 7 presents the Meritorious Service Award to Past National Secretary James Lyons of the Department of Michigan, National Membership List Coordinator Richard Williams of the Department of Michigan and David Bailey Sr. of the Department of Illinois. Brothers David Hann, Frank B. Harned and Allan W. Howey were named National Aides for recruiting five or more members.

In General Order Number 8 the Commander in Chief announces the issuance of camp charters to:

Lt. Commander Edward Lea USN. Camp 2, Department of the Southwest; William D. Allen Camp 96, Department of Iowa; V. P. Trombly Camp 2, Department of Iowa; William Covill Camp 56, Department of Wisconsin; Henry Quigley Camp 147, Department of Michigan and Col. George W. LaPoint Camp 76, Department of Michigan. Also Albert & James Lyon Camp 266, Department of Michigan; Lucius L. Mitchell Camp 4, Department of Florida; Archibald Stewart Camp 259, Department of Michigan; James D. Morgan Camp 70, Department of Michigan and James A. Wilson Camp 1, Department of Tennessee.

Dr. Walter Powell, Abner Rainbow and Laverne Louie have been dishonorably discharged from the Order for failure to meet their fiduciary responsibilities while officers of Gettysburg 112, Department Pennsylvania. They are further barred from future membership in this Order. This action is contained in General Order Number 9. These men engaged in actions which are consistent with an intent to force the closing of Gettysburg Camp 112 while serving as board or committee members of Historic Gettysburg-Adams County [see front page of last edition of The Banner].

General Order Number 10 deals with problems in the Department of Massachusetts and voids specific portions of Massachusetts Department Order No. 6. Brother Frank Tucker, in General Order Number 11, is removed from office as department commander, stripped of his rank as Past Department Commander, stripped of his rank as Past Camp Commander and ordered to hold no office in the Order for a period of 10 years.

In both disciplinary actions a Trial Commissioner has been appointed to hear arguments in accordance with the Regulations of the Order.

National Encampment to attack serious questions

the 117th Encampment of the Sons of Union Veterans of the Civil War is expected to set records for productivity and at least equal the fun factor shown last year in New York.

Scheduled for Aug. 6-9 at the Holiday Inn Conference Center, in New Cumberland, Penna. near Harrisburg, current plans call for a broad legislative schedule for the general meetings and some special surprises on the entertainment end. All culminating in a six-hour tour of Gettysburg Battlefield after the encampment closes on Sunday.

Commander in Chief Richard D. Orr expects to preside over an encampment that resolves difficult issues, such as: Per Capita tax collection procedures; Membership-increasing the enrollment rate from national leads; Paid National Staffing; Revisions to the Regulations on disciplinary procedures; deletion of provisional camps and departments from the Constitution & Regulations and approval of a Banner Policy. In addition there will be action on changes to the Sons of Veterans Reserve Standard Operating Procedure, discussions on re-claiming G.A.R. property and a series of changes to the job descriptions.

The U. S. Army Infantry School at Ft. Benning, Ga. has suggested that we commission a monument to the Union Infantryman in a field of honor that they are establishing-the cost would be around \$50,000. That opportunity will be discussed fully.

There will also be some fireworks in the form of appeals from rulings by the Commander in Chief on issues of uniforms and the authority of department commanders. Add to all of this significant committee reports and election of officers and we will have a fast-paced and productive encampment.

Friday evening will be the annual Campfire program where the Patriotic Instructors of the Allied Orders make donations to local charities. Guest speaker will be Dr. John Latschar, Superintendent of the Gettysburg Military Park, and entertainment will be provided by a local musical review, courtesy

 of Brindle Camp 50 of Carlisle.

The banquet on Saturday evening will offer your choice of Stuffed Chicken Breast or Sliced Top Round of Beef Bordelaise for only \$23 per person (a child's chicken nuggets dinner is available at \$11 for children only). Entertainment at the banquet, a closely held secret, will be a uniquely Pennsylvania experience. Past Commander in Chief Bud Atkinson reported, "New York's Scottish Bagpipe Band last year will be hard to beat, but we think that we have lined up something that National Encampment organizers will be trying to top for years". Atkinson is chairman of the National Encampment Committee for the host Department of Pennsylvania.

Meeting at the same time and place will be the National Encampments for the Auxiliary to the Sons of Union Veterans of the Civil War and the Ladies of the Grand Army of the Republic. Representatives of the Woman's Relief Corps and Daughters of Union Veterans of the Civil War are also expected to attend.

All department commanders have

been asked to make their department flag available to the encampment so that the organization can display their "massed flags". All departments have also been encouraged to send a full slate of delegates to this important encampment. "This is where the final decisions are made, this is where the absolute power in our Order rests," said Commander in Chief Orr. "There are some important issues that will be resolved and any department not fully represented will be unable to properly present their opinions."

In a break from tradition the host department commander, Glenn Knight, is inviting all to the Dutch-Treat, Pennsylvania Luncheon on Saturday. "Our department wants to be your host for the encampment and the traditional Pennsylvania Luncheon will be open to all," said Knight. "Our event will include a chance to meet and greet others as well as Civil War period entertainment."

Internet Site Offers Allied Orders A New Place to List Ancestors

Members of the Allied Orders of the Grand Army of the Republic now have a way to proclaim their pride in their Civil War ancestor, literally, to the world. The National Communication Technology Committee in cooperation with Brøderbund Software has established a SUVCW page on its popular Family Tree Maker web site. Members of the Allied Orders are invited to list their personal lineage on this page which will be maintained by Brøderbund and made available to everyone on the Internet.

"This was a natural match," notes National Signals Officer Glenn B. Knight, "we needed to write a very complex form to gather the data on our members' ancestry and make it available to the world." "Brøderbund, whose Family Tree Maker genealogical software is used by millions, was looking for emerging data bases for their web site and they have the high quality web technicians who could write the code for the site."

Members of all of the Allied Orders can enter data that is passworded and that, with the password, can be changed if corrections need to be made later. It also makes it impossible for someone else to change the data on your genealogy. The best place to start is with the instructions located at http://suvcw.org/tree.htm. From there, click on the link to http://www.fam-ilytreemaker.com/suvcw/ and follow the instructions.

The pages can be searched for key words from the Family Tree Maker search page at http://www.familytreemaker.com/search.html.

There is no charge for either listing your ancestors or searching the database. The database is open to everyone and as members of the Allied Orders get on line the base will grow. It's a win-win situation for all participants and is an excellent example of a cooperative effort between a for profit and not for profit.

The next step is to take the National Secretary's records and input them into the database so that the genealogy of the hundreds of thousands of men and women who have been members of the Allied Orders throughout the years are available for open research. Trust: The Secret of True Brotherhood

Recently, a camp secretary wrote to his commander complaining about the department and its lack of response to the needs of the camp. He concluded by suggesting that even if everything was done well and on time the department would probably add roadblocks which they inform him of

The camp is not active in the Department Encampment and is generally unresponsive to requests for information or offers of help. It's a good camp, doing the mission of the Order at the community level and that is outstanding.

But to effectively meet the total missions of the Order-to do what our ancestors of the Grand Army of the Republic charged us to do, we need an active department and a strong National Organization. What appears missing from comments like those above is TRUST. That trust can only be built if the people become more than just duty titles. The camp secretary needs to become "Bob" to the department officers; the department patriotic instructor needs to become "Fred".

A number of tools exist to develop that trust but it takes some work and may sometimes force you to re-think your position on some things. An underlying problem with the continuing lack of communication is the interpretation and application of regulations. It is extremely picko of the national or department counselor to say that your by-laws are not in compliance-after all they work well for you. The problem is, that as we encroach deeper and deeper into the legal arena to redress grievances against the callous disregard of the sacrifices of the men of the G.A.R., we are increasingly being asked to prove that we have a set of rules and that we have followed our own rules. Courts just love to stick it to organizations that complain about the actions of others while not abiding by their own rules.

So if the "roadblocks" appear "after the fact" then there is generally a very good reason and the person raising the roadblock is probably not too happy about it either.

A department commander faces the same problems that a camp commander faces plus all of the problems of each of the camps in his department. The commander in chief is responsible for everything that goes on-even if he is not fully aware of the events. Department and national staff officers and committee members are all doing the best they can. They are no different than our camp secretary above-and in many cases also serve in important positions in their local

The best solution to this impersonalization of department and national officers is for each camp to send its entire authorized delegation to the Department Encampment and see both how the department functions but what the department officers are doing. Similarly, each department needs to send a complete caucus of delegates to the National Encampment. Organizationally, we are a representative democracy and, as in our national democracy, those who don't vote have no right to complain-yet they are usually the ones shouting the loudest.

GENERAL ORDER NO. 7 SERIES 1997-1998

National Headquarters Sons of Union Veterans of the Civil War

- 1. On behalf of the National Organization, the National Officers and myself may each Department have a productive and harmonious encampment. As you deliberate the issues before you remember why we exist and always conduct your affairs with an eye towards fraternalism. We have been experiencing an epidemic of petty bickering, improper use and abuse of the disciplinary process, and abuse of authority by a very small group of Department officers. When the Department officers cannot resolve differences among themselves, how can they expect the Brothers to follow them or heed their directions. The continued abuse of authority and out right warfare in one department will not be tolerated. We have made too much progress as an Order and have too many positive actions being taken by the vast majority of the Brothers to allow the bickering and egos of a few to hinder contin-
- 2. Every camp is encouraged to send your total compliment of delegates to your Department Encampment. The SUVCW functions through a representative form of government. When you do not participate, you are allowing others to decide the future direction of your Department. Every camp which is in good standing (all fees, per capita tax, and reports filed) is entitled to send a delegation composed of the Camp Commander, all Past Camp Commanders one delegate plus one delegate for every ten members or major fraction (six or
- Every department is encouraged to send its full compliment of delegates to the National Encampment. The National Encampment is the supreme authority of the Order Any action by a National Encampment can only be changed by another National Encampment. This is the body which determines the direction we will follow for the coming year. Elsewhere you will find information on some of the topics to be discussed at this years encampment. If any Department does not know the number of delegates to which they are entitled, please contact the National Secretary.
- 💶 The 118th National Encampment will be held in Harrisburg, Pennsylvania August 5-9, 1998. The tentative agenda and preregistration forms are elsewhere in this issue of the Banner. The host committee is hard at work and has planned a tremendous program. Bring your family. World renowned Hershey Park is a short distance away. If you buy your admission tickets at the hotel they will provide free shuttle service to and from the park.
- 5. All appointed officers and committee chairmen are reminded that their next quarterly reports are due to the Chief-of-Staff by May 15, 1998. All elected officers are reminded that their next quarterly report is due to this office by May 15, 1998. All officers and committee chairmen are advised that their respective reports to the National Encampment should be limited to a maximum of five (5) minutes unless prior arrangements have been made with this office. When possible, all reports should be submitted to the National Secretary on a 3 1/2 inch IBM compatible computer disc. The documents should be in Word Perfect 6.1 or less, MS Word 5.0 or less or an ASCII text file. Additionally, two copies of all committee reports must be presented in typed form and three copies of all officers reports must be presented in typed form. All reports should be sent to the National Secretary prior to July 25, 1998.
- & Pursuant to action of the Council of Administration, the service area of the Department of Colorado & Wyoming is hereby expanded to include the State of Utah and the State of Montana retroactive to March 1997
- 1. The service area of the Department of Wisconsin is hereby expanded to include the State of Minnesota effective January 1, 1998.

- 12. Brothers are reminded to support the Senior Vice Commander-in-Chief's Fund, the Grand Army of the Republic Fund, the Permanent Fund, and the National Headquarters Fund. Send all donations to the National Treasurer. Please be sure to indicate the fund to which you are donating. All contributions to the SUVCW are tax deductible (1941 IRS ruling).
- 18. Department Commanders. Department Secretaries, Camp Commanders and Camp Secretaries are reminded that it is vital that you submit the names, addresses, telephone numbers and e-mail addresses where they exist of new officers to the National Secretary. Also, you need to submit your EIN number. We must verify these with the IRS annually. When applying for or amending an EIN you must inform the IRS that you are a subordinate unit of the National Organization SUVCW and provide the Group Exemption Number (GEN) 0429. This number references the IRS exemption ruling and is not valid for exemption from any state or local sales taxes etc. This is not an optional submittal. The Regulations require you to submit this information. Any Department or Camp which does not submit the required information (Form 22. Form 49 EIN, quarterly reports and the above information) is not in good standing and is not entitled to representation at the National or Department Encampment respectively.

- 1. During the course of investigating the situation with the G.A.R. Hall in Gettysburg. Penna., it has become painfully clear that certain members and former members of Gettysburg Camp 112 did act in a manner inconsistent with the well-being of Gettysburg Camp 112, Pennsylvania Department, Sons of Union Veterans of the Civil War and the members of Corporal Skelly Post 9, Pennsylvania Department, Grand Army of the Republic.
- 2. These certain individuals did negotiate the sale of the G.A.R. Hall to Historic Gettyeburg-Adams County, Incorporated (HGAC) with full knowledge of their personal conflict of in erest. That these individuals represented the SUVCW while at the same time serving HGAC as either a member of the HGAC Board of Directors or as a member of the **HGAC Building Committee**,
- 2 These individuals did fail to perform their fiduciary responsibility to Gettysburg Camp 112 in a manner which best served the interest of the Camp.
- 4. That two of these individuals did conspire to deprive the SUVCW and the G.A.R. of their rights as specified in the Deed of the property know as the Corporal Skelly Post 9 G.A.R. Hall and further they conspired to bring about the demise of Gettysburg Camp 112.
- 5. Based upon the foregoing information provided by members of Gettysburg Camp 112, contemporaneous notes of meetings taken by a member of Camp 112, examination of the records, actions of one of the individuals mentioned below, comments from one of those individuals, the recommendation of the Pennsylvania Department Commander, the recommendation of an Assistant National Counselor, the recommendation of an independent legal scholar and pursuant to the authority invested in me by Chapter V, Article VI, Section 6 the following actions are ordered:
- A Dr. Walter Powell, formerly Secretary-Treasurer and a member of the Camp council of Camp 112, is hereby prohibited from ever again holding membership in the Sons of Union Veterans of the Civil War. He shall be borne upon the rolls of this Order as having been dishonorably discharged
- B. Abner Rainbow, formerly a member of Camp 112, is hereby prohibited from ever again holding membership in the Sons of Union Veterans of the Civil War. He shall be borne upon the rolls of this Order as having been dishonorably discharge
- Lavern Louey, formerly member of the Camp council of Camp 112 and currently a member of Camp 112, is hereby expelled from the Order and prohibited from ever again holding membership in the Sons of Union Veterans of the Civil War. He shall be borne upon the rolls of this Order as having been dishonorably discharged
- & Pursuant to the requirements of Chapter V, Article VI, Section 6, Brother Charles Kuhn, Jr. Vice Commander of the Department of Pennsylvania is hereby appointed Trial Commissioner to take written and/or verbal testimony relative to the above items and to ascertain if further action is required by this office.

GENERAL ORDER No. 10

- 1. A request for a ruling having been made to this office relative to the validity of Massachusetts Department Order No. 6 Series 1998 dated March 17, 1998 issued by Frank Tucker, Massachusetts Department Commander and attested by Edward W. Parks, PDC Department Secretary, the following ruling is hereby made and is effective immediately.
- 2. Item one (1.) Of said order suspends Charles Russell Lowell Camp 9 for failure "...to hold nomination, election and installation of said Camp as mandated by the C & R.... Additionally, item one (1) states that Commander Thomas Smith, Camp 9 failed to appoint a trial commissioner to hear charges filed against Brother Leslic Covey
- & Chapter I. Camps, Article I, Charters, Section 7 states: "A Camp failing to pay per capita tax or neglecting to forward reports within the time specified by law may be suspended by the Department Commander." No other provision exists within the C & R permitting a Department Commander to suspend a camp. Camp charters are issued by the National Organization. Therefore without specific language adopted by the National Organization, no Department Commander has the authority to suspend a charter for any reason other than that quoted above. Pursuant to the provisions of the C & R, this authority resides solely with the Commander-in-Chief and the National Encampment.
- 4. Chapter V. General Regulations, Article VI Discipline, Section 1 states: The Commander-in-Chief shall have original jurisdiction over charges preferred against Departments of the Order and also against members and Camps when Camps or Departments fail or neglect to act upon any breach of discipline within their jurisdiction." It it was believed that Camp 9 failed to act in regard to the charges filed against Brother Covey, the established course of action is to refer the case to the Commander-in-Chief and not to suspend the Camp charter.
- use the actions specified in item one (1) of the Massachusetts Department Order No. 6 Series 1998 is contrary to the provisions of the Constitution and Regulations and in so issuing this Order, the Department Commander exceeded his authority as granted by the Constitution and Regulations, Item one (1) of the Massachusetts Department Order No. 6 Series 1998 is null, void and vacated.
- 8. Item two (2) of said Massachusetts Order stripes Brother Leslie Covey of rank as a Past Department Commander and Past Camp Commander for a variety of reasons. The reasons stated for this action are charges of misconduct. The removal of past rank is a disciplinary action. No trial has been held according to Item one (1) of same Order. This is a summary discipline action by the Department Commander.
- 7. Chapter V. General Regulations, Article VI Discipline, Section 6 states: "The Commander-in-Chief may in extraordinary circumstances summarily discipline a member No such authority is given to a Department Commander.
- 8. Therefore, item two (2) of Massachusetts Department Order No. 6 Series 1998 is null. void and vacated as no Department Commander has the authority to take such action.
- 8. Any action taken at the Massachusetts Department Council meeting on March 28, 1998 is null void and vacated as the premise for any action (item one [1] of said Order) is invalid.
 - 10. Item five (5) of Massachusetts Department Order No. 6 Series 1998 is null, void and

Civil War Memorials Preservation effort

The National Civil War Memorials Committee appreciates the reception that Form CWM 61 has been given and the thorough data that is being submitted, by volunteers in various departments across the country.

The SUVCW Civil War Memorials Project has two, complimentary purposes. The first, is to maintain a search for, and physical condition assessment of, ALL tributes to Union Civil War soldiers & sailors. For exclusions, please see C-In-C Orr's G.O.1, Par. 14 (The Banner, September '97). Periodic re-examinations for damage by weather and/or vandalism should be planned. The second purpose, is to promote the perpetual care of these tributes. Data evaluated from the forms will help prioritize which memorials should receive attention before others. Please refer back to the "Project SOS!" article on pages 1 & 2 of the April 1997 issue of The Banner for more background information on this effort.

With the approval & support from CinC Orr, our committee has recommended that each department form its own Civil War Memorials Committee. This team would have the responsibility of assigning mutually agreeable areas of geographic responsibility to the various camps in their department, for the search & physical examination of Civil War memorials. The concept may also be adopted by each camp so that a committee (or coordinator) at that level, can control the project & thus avoid duplication of effort. The department level committee would be responsible for the collection of the assessment forms and entry of the information in a computer database that is being developed. Departments are encouraged to consider publishing photos of the memorials, plus brief references. The Dept. of New York did this in 1992 and its sale proved to be an excellent fundraising effort for them. The document can also be shared with libraries & other historically minded groups, to advance the name of the Order. Departments could also have a brief "cyber-catalog" of memorials linked to their wcb page (ref. Iowa & Michigan examples).

In promoting the proper care of memorials, we can continue referring responsible parties to the folks at Project SOS! for fundraising ideas and to learn the value of hiring professional conservators. Since our last article, Jill Wiley, who spoke at the 116th National Encampment, has become their new contact person. Joining her, is. Hilary Hoopes, who can advise anyone interested in applying for an SOS! grant (of up to \$1,000) for a professional conservator to determine what work actually needs to be done on a memorial, (that includes sculpture) & estimate the cost. They can

both be reached at 800 422-4612.

The September 1997 issue of The Banner has a listing of our committee's members and addresses. Each member serves as a project liaison with his own, and neighboring departments. In alphabetical order & affiliated departments: Armstrong — Illinois, Iowa, Michigan, Missouri, Wisconsin; Bauer - Florida, Indiana, Ohio, Tennessee; Martin — Maryland, New Jersey, New York, Pennsylvania; Peterson - Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, Vermont; Speaks - California & Pacific, Colorado & Wyoming, Kansas, Southwest. All of us are eager to help & advise.

When a memorial's restoration is complete, we should all maximize the media coverage of the fact — whether there is a formal rededication ceremony or not. These accomplishments are a big part of what we're all about. They present yet another opportunity to put the name of the Order in the public eye and gain community good will. We can thus offer an example to be proud of and thereby attract new members and associates. Please continue to submit your accomplishments for publication in The Banner, too.

- Department of Indiana approval for a special medal for the 1999 Encampment commemorating the 50th anniversary of the last Encampment of the G.A.R.

New approval was given to the following:

- Garfield Camp 1, Department of Maryland for the Coat of Arms for personal metal nameplates. This will expire June 30, 2000.
- Dennison Camp 1, Department of Ohio for various wearing apparel. Permission was granted pending review of items. This will expire June 30, 2000.

The Council unanimously endorsed the following Bills in congress. (For a full description see January issue of the banner)

- H.R. 157 Request the President to award the Medal of Honor posthumously to BG Strong Vincent
- H.C.R. 147 The issue of a commemorative stamp honoring General Lawrence Chamberlain.
- H.R. 2153 Commemorative coins honoring African-American Civil War Veterans
 - H.R. 2346 Prohibit desecration of Veteran Memorials.
- H. R. 1602 Restore Veteran's allowance for non-government headstones

Approved the expenditure of \$3,240, for purchase of 10 Son's swords. The swords can only be order in 10 sword lots. The Ames Sword Company, the same company that made the originals, will make these swords. The company will be using the original molds. These swords will be for sale to the members.

Department information packets were previewed. These packets will be mailed to all Department Commanders.

Letter of appreciation to Dean Speaks for all of his hard work on the Membership -at -Large.

The Council was brought up to date on negotiations with Historic Gettysburg - Adams County.

The Council is looking into the possibility of placing a monument honoring Union Infantry at Fort Benning's Sacrifice Field. (See letters January issue of *The Banner*)

Approved a Provisional Charter. This Charter will be issued to the Provisional Camp at no charge. The Camp will still have to pay the \$25 Charter application fee and will received the full charter when it reaches 15 members or 3 years existence.

National Organization

Policy on the use of Badges, Emblems, Seals and Symbols

- No person, business, organization, government agency or other entity may use the name Sons of Union Veterans of the Civil War, except as provided in the Articles of Incorporation Section 17, without the express written consent of the National Organization Sons of Union Veterans of the Civil War.
- 2) No person, business, organization, government agency or other entity may manufacture, duplicate, or replicate any badge, emblem or seal, including but not limited to the 1881 membership badge, the 1893 membership badge, the 1907 membership badge, the 1922 membership badge, the current membership badge, associate badge, Camp Commander badge, Past Camp Commander badge, Department Commander badge, Past Department Commander badge, Commander-in-Chief badge, Past Commander-in-Chief badge, 50 year member badge, War Medal, miniature badges, the various ribbons attached thereto, the coatof-arms, seal, or any other badges or medals previously adopted and used or which may be adopted and used in the future or otherwise perform any action which results in the manufacture, duplication, or replication of said items without the express written consent of the National Organization Sons of Union Veterans of the Civil War.
- Departments and camps may photographically or through any generally available means reproduce images of the badges, emblems, and seals for the production of department or camp letterhead, envelopes, newsletters, business cards and other material necessary for the conduct of their respective activities related to the purposes of the Order. This general authorization does not extend to any of the adopted and copyrighted forms, rituals, literature, or other items supplied by the National Organization nor to embroidering or of any badge, emblem, or deal or the production of decals or other similar devices.
 - National, 4) Current department and camp officers and those entitled to "Past" honors of office may photographically or through any generally available means reproduce images of the badges, emblems, and seals for the production of letterhead, envelopes, business cards and other material necessary for the conduct of their respective activities related to the purposes of the Order. This general authorization does not extend to any of the adopted and copyrighted forms, rituals, literature, or other items supplied by the National Organization nor to embroidering of any badge, emblem, or seal or the production of decals or other similar devices
 - current officers and former officers may not authorize any nonsubordinate entity to use the name Sons of Union Veterans of the Civil War or reproduce, manufacture, or otherwise duplicate or replicate any badge, emblem or seal of the Order except as specified in items 3 and 4 above except that the National

Treasurer and National Quartermaster may cause such items to be produced for the National Organization Sons of Union Veterans of the Civil War in the performance of the duties of their respective offices.

- The Sons of Veterans Reserve is hereby authorized to use the name Sons of Union Veterans of the Civil War in the conduct of all their business related to that Organization until notified in writing to the contrary. The National Organization Sons of Union Veterans of the Civil War expressly withholds authorization from the Sons of Veterans Reserve to authorize any nonsubordinate entity to use the name Sons of Union Veterans of the Civil War or any of its badges, emblems, or seal. In the event that the Sons of Veterans Reserve should cease to exist as it is now constituted, the above authorization shall not accrue to any successor organization.
- 7) The National Organization Auxiliary to the Sons of Union Veterans of the Civil War, Inc. and its subordinate units are hereby authorized to use the name Sons of Union Veterans of the Civil War in the conduct of all business related to that Organization until notified in writing to the contrary. The National Organization Sons of Union Veterans of the Civil War expressly withholds authorization from the National Organization Auxiliary to the Sons of Union Veterans of the Civil War, Inc. and its subordinate units to authorize any non-subordinate entity to use the name Sons of Union Veterans of the Civil War or any of its badges, emblems, or In the event that the National Organization Auxiliary to the Sons of Union Veterans of the Civil War or a subordinate organization should cease to exist as it is now constituted, the above authorization shall not accrue to any successor organization or subordinate organization.
 - 8) The Commander-in-Chief after consultation with the Council of Administration or after an affirmative vote of the Commandery-in-Chief may authorize the use or reproduction of the badges, emblems, seals, or coat-of-arms or other symbols of our Order.


117th Annual National Encampment Registration

GENERAL LOGAN'S MEMORIAL ORDER

General Order No. 11 May 5, 1868 Headquarters, Grand Army of the Republic Washington, D.C.

I. The 30th day of May, 1868, is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now lie in almost every city, village, and hamlet churchyard in the land. In this observance no form or ceremony is prescribed, but posts and comrades will in their own way arrange such fitting services and testimonials of respect as circumstances may permit

We are organized, comrades, as our regulations tell us, for the purpose, among other things, "of preserving and strengthening those kind and fraternal feelings which have bound together the soldiers, sailors, and marines who united to suppress the late rebellion." What can aid more to assure this result than by cherishing tenderly the memory of our heroic dead, who made their breasts a barricade between our country and its foe? Their soldier lives were the reveille of freedom to a race in chains, and their death a tattoo of rebellious tyranny in arms. We should guard their graves with sacred vigilance. All that the consecrated wealth and taste of the Nation can add to their adornment and security is but a fitting tribute to the memory of her slain defenders. Let no wanton foot tread rudely on such hallowed grounds. Let pleasant paths invite the coming and going of reverent visitors and found mourners. Let no vandalism of avarice or neglect, no ravages or time, testify to the present or to the coming generations that we have forgotten, as a people, the cost of free and undivided republic.

If other eyes grow dull and other hands slack, and other hearts cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remain in us.

garland the passionless mounds above them with choicest flowers of springtime; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us as sacred charges upon the Nation's gratitude,—the soldier's and sailor's widow and orphan

II. It is the purpose of the Commander-in-Chief to inaugurate this observance with the hope it will be kept up from year to year, while a survivor of the war remains to honor the memory of his departed comrades. He earnestly desires the public press to call attention to this Order, and lend its friendly aid in bringing it to the notice of comrades in all parts of the country in time for simultaneous compliance therewith.

We were all impressed with the many projects and the enthusiasm the SUVCW and the SVR in Michigan are involved with in preserving the memory of our ancestors. While we were there, we presented Brother Richard Williams a Commanding Officer, SVR Letter of Commendation for his efforts in preventing a thief from stealing a woman's pocketbook. Brother Williams received several wounds for his efforts.

With Memorial Day rapidly approaching, I encourage all SVR units to render honors on behalf of our ancestors. In today's world, many citizens have forgotten what Memorial Day is and how it was founded. In some minds it is a three day weekend from work. It is our duty to educate everyone on the significance of Memorial Day.

- 4. Until a Military District Commander is appointed, Col. Robert Bateman, SVR Deputy Commander, will remain the 5th Military District Commander.
- 5. This realignment action is taken with the approval of the National Military Affairs Committee.

vacated. Since there is no basis under the Constitution and Regulations for the suspension of Camp 9, exclusion of delegates from Camp 9 at the Department Encampment by reason of suspension of the camp is invalid. Camp 9, unless there are other grounds for exclusion, is entitle to their full compliment of delegates to the Massachusetts Department Encampment. For the same reason the members of Camp 9 shall not be excluded from receiving the Banner.

11. Pursuant to the provisions of the Constitution and Regulations this

GENERAL ORDER No. 11

1. Since 1991 the National Officers of this Order have repeatedly found it necessary to intervene in disputes within the Department of Massachusetts. Beginning with the reversal of a merger of two camps in 1991. PCINC George Long, then National Secretary James Lyons and then National Treasurer Richard Orr traveled to Boston to audit the camp's books and arbitrate a plan for the division of the camp property. The division of the Camps was a result of disputes between two groups of brothers one lead by Frank Tucker and the other by James Marley.

This was followed by accusations against Brother Marley by Brother Tucker. These accusations concerned topics which had and have nothing to do with the SUVCW. Then came the disputes between Frank Tucker and Douglas Knight which lasted several years. This was succeeded by Frank Tucker, as Department Secretary, forging the signature of Ellsworth Brown, Department Commander, to a number of letters and documents. The forgery was accomplished through the use of a signature stamp. Frank Tucker sent letters to numerous Brothers over the "signature" of the Department Commander and presented the content of the letters as official Department positions. When Commander Brown was asked about these letters and position, he had no knowledge of them. And now we have the Frank Tucker - Leslie Covey - Camp 9 1998 version of this behavior. There is an obvious common thread in all these problems.

- 2. It is the finding of this office that Brother Frank Tucker:
- (A) Has been and continues to be a disruptive force within the Department of Massachusetts;
- (R) Has repeatedly exceeded his authority to wit:-Suspended Camp 9 without authority to do so Stripped Brother Leslie Covey of rank as a Past Camp and Pass Department Commander without authority to do so Issued Department position statements when Department Secretary without authority to do so and without the Department Commander, Department Council or Department Encampment approving the position statements, Caused the Department Commander's signature to be affixed to letters and documents without specific authorization to do so;

(C) Has removed Leslie Covey from the officer of Department Secretary for allegedly failing

to perform his duties without requiring the previous Department Secretary to provide the records necessary for Brother Covey to perform the duties of his office.

(L) Has failed to take action against the current Department Secretary for the same failings as alleged against Brother Covey. (The Department of Massachusetts has failed to file its quarterly reports on time and is currently in arrears.) Has violated his oath of office by failing to rule with urbanity by failing to rule with impartiality by failing to assure compliance with the Constitution and Regulations of the Order by failing to bring the Department of Massachusetts Department by-laws into agreement with the National Constitution and Regulations as required by Chapter II Article VIII of the Regulations By failing to adhere to the Constitution and Regulations in the performance of his duties as Department Commander

- 2. After consultation with the Council of Administration and other National Officers, for all of the foregoing and pursuant to the authority vested in me by Chapter II, Article IV, Section 7 of the Regulations, Brother Frank Tucker is hereby removed from the office of Department Commander of the Department of Massachusetts.
- 4 After consultation with the Council of Administration and other National Officers, for all of the forgoing and pursuant to the authority vest in me by Chapter V, Article VI, Section 6 of the Regulations Brother Frank Tucker is stripped of rank as a Past Department Commander. He is stripped of rank as a Past Camp Commander. He is barred from holding any appointed or elected National office, any appointed or elected Department office and any appointed or elected Camp office for a period of ten (10) years. He is barred from serving on any National or Department committee. He is prohibited from representating the Sons of Union Veterans of the Civil War in any capacity other than as a member of his local camp.
- 6. All Department property in Frank Tucker's possession shall be conveyed to Brother Frederick Cauldwell, Department Sr. Vice Commander within five (5) days of the date of this Order. All camp property in Frank Tucker's possession shall be conveyed to the proper camp officer within five (5) days of the date of this Order.
- 8. Department Sr. Vice Commander Cauldwell and Department Treasurer Edward Parks shall immediately notify any and all organizations, governmental agencies and financial insututions with whom the Department of Massachusetts has established relationships that Frank Tucker no longer represents this Order in any official capacity by presenting a copy of this Order to those organizations, agencies and institutions.
- 7. Pursuant to the requirements of Chapter V, Article VI, Section 6, Brother Gregg Mierka. Commander of the Department of Rhode Island is hereby appointed Trial Commissioner to take written and/or verbal testimony relative to the above items and to ascertain if further action is required by this office.

Internet Access Soars Under New Webmaster

On Jan. 1, PCinC Keith G. Harrison was appointed by CinC Richard D. Orr as National Webmaster of the Sons' World Wide Web page. The appointment was made at the request of a highly dedicated but then much overloaded Brother Glenn B. Knight, who was serving as Webmaster in addition to Chair of the National Committee on Communication Technology, National Signals Officer, The Banner Editor and Pennsylvania Department Commander. Since January, PCinC Harrison has logged over 100 hours per month, updating, streamlining and expanding the national web site. The extra time has paid off with a per day visit increase from just over 2,000 hits per day in January to a current average high of 10,000 hits per day. Brother Harrison also serves as the National Webmaster for the Sons of Veterans Reserve and the Military Order of the Loyal

Legion of the United States.

Some of the updates and improvements that have taken place on the SUVCW web page include: (1) the availability of the Order's Constitution and Regulations, National Policies, Sons of Veterans Standard Operating Procedures, updated National and Camp and Department Job Descriptions, complete National Proceedings for the years of 1984, 1988 and 1994, and General Orders and CinC National Encampment presentations back to CinC Allen Moore. Three noteworthy new features include a program to begin cataloging G.A.R. and Civil War monuments nationally, a cooperative undertaking between the SUVCW and Brøderbund Software Family Tree Maker to develop a large Civil War genealogical database and the availability of a new Announcement/Inquiry Forum page for use by the Order and the public. The site is affiliated also with two Internet rings, Civil War Heritage Ring and Civil War Circuit. The affiliations have also helped to increase the use of the site.

In addition to the site's excellent in house references to the histories of the G.A.R. and the SUVCW, the site also provides top notch links to other World Wide Web sites dealing with the G.A.R., individual unit and general histories of the Civil War, genealogical links, and reenactment organization links. The Sons' web page even provides a link to our Civil War cousins, Sons of Confederate Veterans.

Currently anticipated new features for the future include the development of on-line Department reporting capabilities and the availability of additional downloadable National forms including the Order's membership application.

Becoming Proactive

Camps, Departments Take on Legal Battles

Legal action seems to be the direction of things within the Sons of Union Veterans of the Civil War, many of whom are now starting to assert their position as legal heir to the Grand Army of the Republic.

In the last edition of The Banner was an article about a Michigan Cemetery where a canon was sold without the permission of the SUVCW. In that case the court required the cemetery company to buy back the canon and re-install it.

In the Scranton, Penna. area Lt. Ezra Griffin Camp 8, Department of Pennsylvania is on the court calendar to complain about the sale of canon in a local cemetery there, while in Lebanon, Penna., the commander of 7 Shay's Camp 7 is pursuing legal action for the removal of canon from a Grand Army of the Republic monument in Fredericksburg, Penna.

In Union City, N.J., City Parks Commissioner James Madonna just simply threw away two cannon during renovations of Ellsworth Park. The commissioner thought the two tubes were in bad shape and gave them to the contractor to be melted down for scrap.

Meanwhile, word comes from Lawrence, Mass. that a hobby-group looking for a project decided to adopt a G.A.R. plot in the St. Mary Cemetery. With the permission of the cemetery board they erected a flagpole (with a suitable plaque dedicated to themselves with no mention of the G.A.R.) and arranged for a re-dedication ceremony with much fanfare. At the ceremony it was noted that the group had moved four stones from various places throughout the cemetery and added them to the G.A.R. plot. Members of Camp 21, Department of Massachusetts, stepped in noting that state law had been violated and that their rights as heirs to the G.A.R. were trampled. The camp was able to produce the deed to the G.A.R. plot and the errors were corrected.

In Gettyshurg, the local preservationist group Historic Gettyshurg-Adams County continues to refuse to abide by the terms of a deed they signed in 1988 and honor the memory of the men of the G.A.R. Gettysburg Camp 112, Department of Pennsylvania, has asked the Commander in Chief for help in negotiating since their own negotiations and those of the department both ended unsatisfactorily. In the mean time the camp has sent a letter to HG-AC activating an unused portion of the deed which gives them unimpeded access to the building. They have informed HG-AC that they will be using the hall for the next 365 days-effectively making it unavailable for income-producing rental. Legal action is being planned with the help of a former U.S. Attorney.

The bottom line is that we must be ever vigilant and pro-active in asserting our rights as the legal heirs to the Grand Army of the Republic," notes the Honorable Jim Pahl, National Counselor. "Our rights to the property of the G.A.R. include our responsibilities to be their representatives in an uncaring world. The Order's top legal officer suggests that camps and departments find out where the property of the G.A.R. is located and immediately lay claim to it-so that incidents like those above can be avoided in the future.

Memorial Day is central to our obligation

Of prime importance will be the observance of the Memorial Day Holiday with appropriate celebrations and remembrances. Each camp is encouraged to participate in organized observations and each member is encouraged to participate as well. Please let me know how your camp participated in these activities.

In celebration of Memorial Day, I have had printed Commander in Chief of the G.A.R. Logan's General Order Number 11 in a format suitable for framing. These are on 8.5 X 11 inch heavy paper, tan in color, and are available for a self-addressed stamped envelope 9 X 12 inches in size with appropriate postage for 2 ounces (\$.55). Please do not send an envelope smaller than the 9 X 12 since I don't want to fold the document. Send the SASE to:

I have been asked to again issue the certificate of appreciation to those members who display the United States flag on a 24 hour a day basis (lighted, etc.). Thus, I have prepared a suitable computer format and can prepare these with the appropriate name. The only problem is that there will be a cost involved for the certificate forms and their mailing. This is in the neighborhood of \$3 for each certificate. In terms of an application form, a letter stating the name of the member, his address, etc... a check made out to myself as National Patriotic Instructor, and a photograph of the flag showing the lighting will suffice. Use the mailing address listed above. Any funds left over from the certificates will be used for other National Patriotic Instructor activities.

Getting back to Memorial Day: During the late 1940s and 1950s, when I was a child in Northern Indiana, each Memorial Day was spent travelling from cemetery to cemetery, laying flowers on the graves of our ancestors. Therein, on the graves of all veterans were small United States flags, placed primarily by members of the American Legion and Veterans of Foreign Wars. Many of these were placed in the bronze G.A.R. emblems which marked many of the graves. Unfortunately, today many of these markers have been removed from the graves, sometimes by vandals, more often by cemetery workers who were too lazy to mow the grass around them. This fate has also befallen many of the military headstones that formerly marked the graves of many veterans, not only of the Civil War, but other wars as well.

In another ceremony, this sponsored by the American Legion and VFW, the flags placed on the graves were removed on June 13 and then suitably destroyed (burned) on Flag Day, June 14. As a member of an American Legion Junior Drum and Bugle Corps, and Senior Corps as well, I often played taps at these ceremonies. This was after a firing squad had fired three volleys in salute of the flags that had served their purpose well.

Even though it should go without mention, I sincerely urge each and every SUVCW member to take an hour, or two, and actively participate in the recognition of not only those who served in the Civil War, but all those ancestors who now lie in perpetual slumber.

Again, I urge all who participate in any activity promoting the SUVCW to send that information to me. Please include photographs, newspaper clippings, and the like. I would like to include this information to the entire organization via The Banner, as well as a help for ideas for camps that seek my advice on these matters.
