SPECIAL REPORT ... "FRIENDS OF GRANT'S TOMB" NEED ASSISTANCE

On April 27, 1897, Grant's Tomb, the final resting place of Civil War General Ulysses S. Grant who had later served his Nation as President and who had died on July 23, 1885, was dedicated. Of classical lines and constructed of white granite, the structure designed by Mr. John H. Duncan was a towering 150 feet in height and had cost \$600,000. Such a sum, in those days, was unbelievable especially since it had been raised by public subscription. Not even the Statue of Liberty had cost more. An estimated one million Americans crowded the site at 123rd Street and Riverside Park in New York City to see the Grand Army of the Republic, regular U.S. Army units and President William McKinley pay their respects. The spectacular monument had been built by the Grant Monument Association who was to continue its faithful stewardship of the monument year after year. From 500,000 to 600,000 visitors a year poured into the monument before the turn of the Century when the population of the United States was much smaller than it is today. The tomb required police guards around the clock to protect it from overly zealous souvenir hunters. Over time and in the course of two World Wars in the first half of this Century, visitations fell off at the Tomb. Fewer people remembered the Civil War or its heroes. Finally, in 1959, the tomb was turned over to the National Park Service and was officially renamed the GENERAL GRANT NATIONAL MEMORIAL. The Park Service quickly provided much needed improvements to the heating, plumbing, electrical systems, etc.

But with the new management of Grant's Tomb was to come unwelcome changes. Early in the 1970's the administration of the National Park Services which had responsibility for the Tomb and other historic sites in the New York City area, apparently decided that these were "dreary old buildings in need of livening up". Without any sense of history or tradition and certainly without any concern for the intent and purpose of the Tomb nor the wishes of those subscribers who paid for it, the National Park Service sponsored a community art project. A small artists' group, Cityarts Workshop, co-sponsored the project and supplied Mr. Pedro Silva who, in 1972, became the artist charged with "livening up" Grant's Tomb.

Pictured above is but a single example of the results. A three year project which costs the taxpayers (no outpouring of public subscriptions paid for this work) \$50,000 resulted in three sides of the tomb being surrounded by approximately 350 feet of hideous, blob-like, garishly colored mosaic benches. These are covered with nudes, taxi cabs, images of Mickey Mouse and a thousand and one other unbelievable sights. Views of the tomb from the east, west and north are totally dominated by these horrors. The north, or rear, stair approach is flanked on either side by ten feet high abstract portraits.

The National Park Service apparently did not officially endorse this action by its local Superintendent and in fact it might be argued that the modifications are in violation of the Historic Preservation Act of 1966, which prohibits alterations to historic sites. However, the pro-bench and artist groups are vocal in their endorsement of these modifications, and they care nothing whatsoever about the history or intent of the structure they have used to express their artwork. They have placed the National Park Service under significant pressure to not remove their creations. In response several groups began to pressure for the removal of the benches, etc. with letters to the National Park Service. A new group, Friends of Grant's Tomb, was formed with active support of various Civil War Round Tables and other interested persons.

YOUR HELP IS URGENTLY NEEDED. Please write to the Honorable Cecil Andrus, Secretary of the Interior, in support of the restoration of this monument to its original condition and intent. Published below is a sample letter which you may use, but regardless of the form of your letter ... Please Write. Also published below is a petition being circulated under the name of GRANT (Grandly Renovate A National Tomb). I am sure they would be grateful for an outpouring of signatures, literally from Coast to Coast, which they can also present to Secretary Andrus. The Cause is not lost and it is not hopeless, we have reason to believe there are many within the National Park Service who can and do agree with us. What is needed is a massive demonstration for our friends and supporters so that they and the administration of the Park Service, can know the real wishes of the majority of Americans. On this specific issue and on the general topic of preservation of our heritage, we are honor bound to speak.

Dear Secretary Andrus:

I am writing to add my voice to those advocating the removal of the mosaic benches at Grant's Tomb. To be blunt, the benches are totally out of place in their present location. **

Grant's Tomb is the final resting place of the man who led the Union armies to victory during the Civil War, and who twice served as president of the United States. His Tomb is a national memorial and deserving of the respect traditionally given such sites throughout the country. I find it hard to believe that the Park Service permitted one of its officials to install the benches in the first place. But I find it still harder to understand why the Park Service allows the benches to remain.

Surely works of "art" such as the benches have their place in the world - in children's parks or Coney Island. But do they belong around the Lincoln Memorial, the Washington Monument or Grant's Tomb? The answer is clearly no, they do not.

Old Grand Army records are to be found in varied and unusual places. Some in the possession of SUVCW camp and department officers, others in rapidly disappearing GAR halls and many in individual homes.

Wouldn't it be nice if they were all in one location where they would be repaired, catalogued, stored systematically and most of all be readily available to the historian or genealogist?

Such an offer has been made by the U.S. Army Military History Institute at Carlisle Barracks, Pa. 17013. The Institute Director, Col. Donald P. Shaw has contacted Maryland Department Commander Schlenker regarding the possibility of creating such a collection. The Institute currently has 300,000 books, 30,000 bound volumes, 8700 boxes of manuscripts and thousands of photographs. In addition to GAR records they would be interested in keeping outdated SUVCW papers, correspondence, annual reports, proceedings, periodicals, etc. as is being done for other military hereditary societies. This appears to be a wonderful opportunity to save for posterity a valuable and scattered collection which could easily disappear in time.

OUR HERITAGE REMEMBERED

Each year in this issue your Editor strives to print some article or item to remind us all of the important Memorial Day Holiday and of the sacred obligations on that day which are a part of our heritage and our duty as Sons of Union Veterans. This year we are combining this reminder to every Brother of our Memorial Day obligations with a broader look at various critical dates which deserve our remembering and our respect. Re-printed below are excerpts from a 4th of July article by Brother James G. Dennis Marley, Patriotic Instructor of the Department of Massachusetts.

JULY 4 IMPORTANT DATE IN CIVIL WAR HISTORY

With the annual observance of Independence Day, it has become customary to look back with pride at the events that led to the formation of our country, and indeed, it is altogether fitting and proper that we should do so. However, this week also marks the anniversary of two other momentous events - military episodes of the Civil War - which surely must be r garded as turning points in our history as a nation. These are the Battle of Gettysburg, which took place July 1-3, 1863, and the Confederate surrender of Vicksburg, Mississippi on July 4, 1863, after an intense 61/2 week seige by General Ulysses S. Grant.

In a sense, it is regretable that the anniversaries of these three events coincide, for the long-standing observance of Independence Day has tended to eclipse the great significance of the victories won at Gettysburg and Vicksburg in the effort to save the Union.

THE BATTLE OF GETTYSBURG started at a time and in a place where neither opponent expected a major engagement. The horough of Gettysburg, located in southern Pennsylvania 35 miles southwest of Harrisburg, lay in a beautiful rolling country of fertile farms. Neither its location nor its geography was particularly notable from a military standpoint: yet this battle is generally regarded as the turning point of the Civil War.

Lee's bold assault into Northern territory was intended to take advantage of the defeatist sentiment that was gradually spreading through the loyal states, and through military

successes further demoralize the Union side. Such success, it was hoped, would induce the European powers to give diplomatic recognition to the Confederacy, a long sought objective of President Jefferson Davis and his cabinet.

Instead, within a matter of days, the dreams of the Confederacy were shattered. Gettysburg, rather than proving to be a decisive Southern victory, became "the high tide of the Confederacy." By July 4, the day after the final engagements of the battle, Lee began his retreat to Virginia.

DURING THE WINTER and early spring of 1863, the Union assault on the Battlements at Vicksburg began. Even after Grant assumed full and personal command, the Federal forces sustained nearly a half-dozen setbacks. Finally, not to be outdone, and showing some of that doggedness and resourcefulness that was to make him famous, General Grant decided on a bold move that succeeded beyond his wildest expectations. Beginning with a naval assault under Admiral David Farragut on April 16, followed by a skillfully planned land attack. Grant had, by May 18, completely surrounded the city and cut off its supply lines.

Despite the Union casualties of over 16,000, Grant's effort was a complete success: the Mississippi was open, the Confederacy divided; and combined with Meade's victory the day before at Gettysburg, the fall of the South was but a matter of time.

For all of us. Independence Day is surely one of the most significant patriotic observances in the long course of the year. And indeed, for each of us the historic appreciation of this day should be enriched by the knowledge that July 4 not only commemorates the birth of a nation but, equally, recalls the stirring events of 1863, which turned the tide in the struggle for its preservation.

THE LEGISLAIVE REPORT

Perhaps it is a sign of the times but after half a century, the House of Representatives this year dispensed with the reading of George Washington's, "Farewell Address" on the anniversary of the first President's birth. The Senate maintained the tradition begun in 1929 with a reading of the address by Sen. Donald W. Stewart of Alabama. The House Leadership maintained that the customary reading failed to attract attendance on the part of House members and felt the gesture to be fruitless. Considering the state of affairs in our nation today, however, perhaps members of Congress would be well advised to give some attention to the content of that speech.

Recently enacted legislation in Illinois will require the recitation of the Pledge of Allegiance in Illinois' elementary schools. In the words of a sponsor of that measure, "having our youngsters begin their day with the pledge to the flag will help mold them into good citizens.

For the first time since 1971 when Wisconsin adopted the fourth Monday in May as the date for its observance of Memorial Day. no bills have been introduced in the Legislature to return the Badger State's commemoration to May 30. With the Senate and Assembly about to adjourn from the final general session for the year, it appears that a measure to return Memorial Day to May 30 must await the arrival of a newly elected Legislature in 1981.

A hill to reaffirm Civil War pension legislation was recently placed before Gov. John Dalton of Virginia as the result of action taken by the General Assembly to correct a mistake made two years ago when the state codes were undergoing revision. At that time the pension law for surviving widows and daughters of Confederate veterans in Virginia was inadvertently abolished in the belief that it was no longer needed. It was soon learned that two widows and more than 200 daughters were still collecting the benefits and provisions were made to permit the women to continue to receive their checks pending passage of new legislation. In South Carolina, the House of Representatives voted recently to raise the annual pension of the last surviving Confederate widow in the Palmetto State from \$200 to \$1,200.

On March 12, 1980, the U.S. Senate paid tribute to Sen, Milton R. Young of North Dakota, on the occasion of his completion of 35 consecutive years of service in the Upper Chamber, Sen. Young, who is 82 years old and expects to retire next January, is one of only two members who can date their service from the presidency of Franklin D. Roosevelt, Sen, Warren G. Mangnuson of Washington State preceded Young by a few months. Both serve on the powerful Appropriations Committee where Sen. Magnuson is the chairman and Sen. Young is the ranking member.


