# Lincoln Memorial

They called it the "Blizzard of '83" which hit the eastern seaboard from the Carolinas to Maine, dumping from one to three feet of snow, depending on where one lived.

It was the day before Lincoln's Birthday as the phone calls went to Washington, DC from New England, New York, Ohio, Penna. cancelling reservations and the journey to DC by National Officers, their representatives, parade units, etc. Several started out and became stranded.

However the pledge made in 1923 was kept. "There will be an observance of the Lincoln Memorial on February 12 each year, regardless of the day of the week or the weather."

The snow stopped falling about 11 p.m. on Friday the 11th and the Commander-in-Chief and National President shoveled for two hours to uncover their car and driveway from a two foot blanket of snow. During the night the snow plow made one pass thru their street, it being a snow emergency route.

As Saturday dawned bright and sunny they began their trek into DC following routes which had been plowed. It was almost ghostly as people were beginning to dig out. Fortunately our wreaths of tribute were obtained from the florist in the early stages of the snowfall as upon arrival at Lincoln Memorial they found no deliveries were made of other tributes. Those of President Reagan, the Interior Department and the Diplomatic Corps were likewise hand carried by the presenters. National Park Service personnel laboured all night and the Memorial area was in excellent condition by 10 a.m.

We are proud that our wreaths were the only organizational tributes presented in addition to the three official ones. The Joint Services Color Guard and Cordon were magnificant as always. A fine crowd of tourists and outdoorsmen was on hand.

President Lincoln was indeed remembered on the 174th anniversary of his birth.

# Memorial Day 1983

"We note, with regret, the apparent indifference with which the people of our land greet this sacred day, and earnestly hope that the time is not far hence when a baptism of appreciation for the labors & sacrifices of the saviors of our Nation shall come upon every individual who lives under the Stars & Stripes.

Memorial Day has lost much of its influence & its power as a commemorating force is fast slipping away. If you will continually remember what Memorial Day signifies; if you will labor to support your understanding & work out your convictions; if you will earnestly & actively consecrate yourselves to the support of the noble principles which Memorial Day commemorates, you will become powerful agents for giving thoughts on patriotism the place they deserve in the public mind; for winning for the memory of the defenders and preservers of our nation the homage that is due, and potent factors for the salvation of this holy day. ### IRS Notice

# ATTENTION ALL DEPARTMENT SECRETARIES AND CAMP SECRETARIES

Please be reminded that instructions issued by the Internal Revenue Service in Washington, D.C. require that, IN ADDITION TO THE EMPLOYER IDENTIFICATION NUMBER (EIN) WHICH YOU HAVE BEEN ACCUSTOMED TO RECORDING ON YOUR IRS FORM 990 WHEN YOU HAVE PREPARED IT FOR FILING, YOU MUST ALSO SHOW IN PART I, ITEM 18 (b), OUR NATIONAL GROUP EXEMPTION NUMBER WHICH IS (GEN) 0429.

Keep in mind that each Department Secretary and each Camp Secretary should have filed a Form 990 in accordance with the instructions found thereon WITHIN 45 DAYS AFTER THE CLOSE OF THE ANNUAL ACCOUNTING PERIOD OR FISCAL YEAR OF THE CAMP OR DEPARTMENT\*. Full compliance with this requirement and the applicable instructions is essential with this requirement and the applicable instructions is essential and urgent in order to conform to the original tax exemption ruling of the IRS dated June 11, 1941 and to avoid any penalties.

Failure to comply with this requirement may result in checking by the IRS and/or the infliction of penalties upon the negligent Camp or Department.

### Ratification Vote Due

The following amendment to the Constitution was adopted by a two-thirds vote as required and it is now in order to submit the same to the Departments for ratification before the 1983 Natl. Encampment:

Article VI Formation and Disbandment. Delete from Section 3, "to consist of five or more camps with a minimum aggregate membership of one hundred and fifty members." Thus causing it to read: Section 3: A Department may be formed by authority of the Commander-in-Chief, Add a new Section 4 reading: A Provisional Department may be created in states having 3 or more regular or Provisional Camps. The Commander-in-Chief may call a meeting for the purpose of organizing a Department and election of Department Officers, After one year a Provisional Department shall be granted permament Department status by the Commander-in-Chief. Sections 4 & 5 renumbered 5 & 6".

Much of the written history of the early years of Lincoln's life has been based on folklore and tradition, and must be evaluated through simple logic, where no reliable evidence can be found. One of these stories concerns the type of dwelling provided by Thomas Lincoln. father of Abraham, for his family upon their arrival in Indiana from Kentucky Biographers, Hendon, Tarbell, Sandburg, and others, have claimed that the Lincoln family spent the first year in Indiana living in a half-faced camp. This type of shelter was constructed of poles and bark with brush thrown over the top, and with one side open to the elements, protected only by a brush fire in front which was kept burning day and-

in the Fail of 1816 Thomas Lincoln made the journey from his Knob Creek cabin in Kentucky for the purpose of locating a new home in Indiana where he could be assured of the legality of the survey for the home that he would build. Staking his claim on Little Pigeon Creek, Spencer County, he returned to Kentucky and made preparations for moving his family to the site he had chosen for their new home. He arrived there sometime between Thanksgiving and Christmas, in the dead of the winter.

When they arrived at the Little Pigeon Creek site there were already eight families living within one mile of the place, and another six families, within a two mile radius. Austin and Davis Lincoln, sons of Hananiah Lincoln, a relative of Thomas Lincoln, were settled within six miles of the home site. Pioneer families were hospitable and it is logical to suppose that at least one of these near neighbors would furnish the Lincoln family with shelter for a short period. Harvest was over, and with time on their hands, it is again logical to suppose that these friendly people would pitch in and help Thomas Lincoln erect his cabin immediately. We have one record to show, that with a little help, a cabin of the size and type generally found at that period, could be erected and ready for occupancy in four days. Thomas Lincoln was a strong, hardworking, qualified carpenter with cabin buildig experience, and so we may safely assume tht the Lincoln family were living in their own cabin home within one week of their arrival at the Little Pigeon Creek. There is not a shred of reliable evidence which could be used to substantiate the claim of the Lincoln family living for even a day in a halffaced camp. It is another of the many fables woven around the life of Lincoln.



The Sons have seen many growth cycles...Grand Army influence, prosperity, decline in membership immediately after the Spanish-American War WWI, WWII, and during the late 1960s. Many were tied to anti-patriotic moods or interest in other veterans groups.

It is time to look ahead to plan to rebuild Camps and new Departments. The Department of Ohio held a Special Mid-Winter Meeting on March 19th for the expressed purpose of passing their ratification vote and urging all the other Depts. to also ratify this important amendment. We can see the hope for Departments in all 50 states and overseas, too.

### New Civil War Discoveries

Florida's Forgotten Union Forts

With acts of succession US forts in the Southern states were taken over or abandoned with little or no struggle & only four remained in Federal hands after President Lincoln's inauguration on March 4, 1981.

Ft. Sumter, SC was soon forced to surrender. Ft. Pickens in Pensacola, Fla. was reenforced & remained in Union control. Ft. Jefferson on Dry Tortugas is located 68 miles from Key West in the Gulf of Mexico & is accessible even today only by sea plane or boat. This became Dr. Mudd's famous prison home & while the exterior remains intact it largely needs restored.

But the real treasure has been overlooked for years in Key West. Until the Over seas Railway and now U.S. Route 1 joined the Florida Keys to the mainland. Key West was just a little island for from the rest of the US.

Fort Zachery Taylor was built in 1836 about 1000 feet off share from Key West. During the Civil War it became the headquarters of the Atlantic & Gulf Blockade of the Confederacy and continued to be of importance until after the Spanish American War. During this century expansion of the Naval Station there filled the water & today Ft. Taylor is located within the confines of the U.S. Naval

What makes Ft. Taylor important today? Because of its remote location its Civil War armaments & artifacts remain intact. No war surplus dealer wanted its scrap cannons after the War. During the Spanish American War the top two stories of the fort were blasted off as it was ruled too high a target & it lied forgotten. This fort has more artifacts & guns from the Civil War than all other Civil War forts put together. It is believed that over 250 guns will finally be recovered. Most wree the fort's own weapons, but others were brought in for disposal. So far the largest weapon recovered is a 50,000 pound Rodman Cannon capable of hurling a 15 inch, 480 pound cannonball for miles...and some of the more unusual finds include a Gatling Gun and a 7000 gallon a day desalinization plant that supplied the fort with fresh water. Ft. Taylor was designated a state park in 1976 and Howard English, a 68 year old retired

Comdr-in-Chief Frederick Davis, 1952, might well be called a man ahead of his time.
