National Officers Elected in Richmond, Virginia



COMMANDER-IN-CHIEF RICHARD E. WAMAN

Richard E. Wyman of 51 Beech Street, Keene, New Hampshire joined Gen. S. G. Griffin, Camp 10, Sons of Union Veterans of the Civil War on April 15, 1938 at the Department of Encampment in Concord, New Hampshire. His eligibity comes from his maternal Grandfather. Luther M. Parker, who served in Company C, 14th New Hampshire Volunteers. He served as Camp Commander in 1942. He has held all offices on the local level and is now Secretary-Treasurer, an office he has held since 1951.

On the Department level he has held all offices except Treasurer. He is now Department Secretary and Campfire Chairman. He has served as Department Commander on three occasions, 1956, 1974, and 1975.

Mr. Wyman was elected to the office of New England Regional Commander of the New England Regional Association in 1958. He served as General Chairman when the New England Regional Association celebrated its 40th Anniversary in 1975.

On the National Level he has served as National Chaplain twice. Chairman of Americanism and Education Committee, Junior Vice Commander-in-Chief, and Senior Vice Commander-in-Chief.

Mr. Wyman served in the United States Army in the United States, New Guinea, the Philippines Islands, and Japan from 1942 to 1946. He was a surgical technician in the 35th General Hospital and the 168th Evacuation Hospital. He was discharged as a Staff Sergeant.

At present Mr. Wyman is the third grade teacher at Lincoln School in Keene, New Hampshire. He served as the first President of the Teachers' Association of the old Union No. 38. He served as the first President of the Monadnock Regional Teachers' Association. He is a member of the Keene Education Assoc., the New Hampshire Education Association, and is a life member of the National Education Association. He is a Past Master of Cheshire Grange No. 131. He is at present the Secretary of the Keene Community and School Safety Committee in

The Legislative Report

Memorials, National Monuments and Historic Sites - The "National Park and Recreation Act of 1980" passed the House of Representatives in May and is now before the Senate. It provides for the expansion of several existing sites and the designation of new sites of particular interest to groups and individuals concerned with American history. Among the sites associated with the Civil War proposed for expansion are the Richmond National Battlefield Park in Virginia, the Monacacy National Battlefield in Maryland, the Stones River National Battlefield and Stones River National Cometery in Tennessee, and the Harpers Ferry National Historical Park. One of the new sites proposed would honor lames A. Garfield. 20th President of the United States and a Union general, by establishing a homestead at Mentor. Ohio, as a national historic site.

In addition, provisions of the bill would establish the Martin Luthern King Jr., National Historic Site and the Martin Luther King Jr., Preservation District, both located in Atlanta, Georgia, to commemorate the life and work of the slain civil rights leader.

Civil War Dead Will Rest in Peace - Public outrage led the Veterans Administration to announce in early July that it had abandoned its effort to relocate the bones of the unknown Civil War veterans buried in a West Virginia cemetery. This followed an earlier VA announcement that it intended to place the remains of unknown Civil War Veterans in mass graves at National cometeries beginning with the National cemetery in Grafton, W. Va. The plan was designed to make space available in existing cemeteries for veterans of more recent wars in recognition of the severe space shortage in many of the 108 National cemeteries in the country.

Robert Beller, director of cometeries for the VA, reported that 55 National cemeteries no longer accept veterans without reserved sites. One approach to the problem is the creation of regional cemeteries like the facility recently opened near Harrisburg, Pa. Nine others are either planned for or in the process of development. But the use of these facilities will mean that veterans in the future may be buried at a considerable distance from their homes and next-of-kin-

Measures Relating to Holidays and Special Observances - The first Monday in February would be designated a holiday in honor of the birth of Abraham Lincoln under terms of H.R. 5360, Under S. 2289, February 22 would be established as a holiday to mark the birth of George Washington. In a speech to the Senate on February 18 of this year, Sen. Jennings Randolph of W. Va., reminded his colleagues that he had introduced S. 517 to return Memorial Day to May 30 and stated that both Washington's Birthday and Memorial Day deserve to be observed on their traditional calendar dates. H.R. 6204 would amend Title 5 of the U.S. Code to provide for federal observances of Washington's Birthday, Memorial Day, Columbus Day, and Veterans Day on appropriate Sundays. The measure would also adjust the pay and leave status of federal employees so that the "holiday Sundays" would not be considered as holidays for compensation purposes. House It. Res. 472. which passed the House on May 30, 1980, would designate October 19, 1981, as the "Day of National Observance" of the 200th Anniversary of Gen. Cornwallis' surrender at the Battle of Yorktown at the close of the Revolutionary War. Senate Jr. Res. 82, which passed the body on February 26, 1980, would designate the week beginning with the third Monday in February of each year as "National Patriotism Week."

On Saturday evening, August 16th, a Blue & Gray Dinner was held in the Roof Garden of the hotel. It was very well attended and a good time was had by all.

On Sunday morning, non-denominational worship services were conducted by Rev. Richard O. Partington, P.D.C. of Penna, for those who did not wish to leave the hotel to attend services at various other churches nearby.

Registration desks for delegates were set up in the upper lobby for the three organizations and at 1:00 p.m., Department Presidents and Department Commanders met with the Chaplains of the Sons and Auxiliary for rehearsal for the Memorial Services.

The National Council met at 1:30 p.m. for the annual audit of the books of the Secretary and Treasurer.

An impressive joint Memorial Service was held on Sunday afternoon and the Campfire was held on Sunday evening. Both were well attended. Full details appear elsewhere in the Banner.

ing and since we had to vacate the room by 4:00 p.m.. the meeting was adjourned until 9:00 a.m., Wednesday morning. The Banquet on Tuesday evening was a most delightful affair under the direction of National Chief of Staff Jane Graham, assisted by P.C.C. Norman Furman, Chief of Staff of the Sons, Dancing followed the din-

ner and was enjoyed by all. National President Hawley and Commander In Chief Koch then held open house in their suites immediately following, and everyone was invited to visit them to see their gifts. The final session of the Encampment was called to order on Wednes-

day morning at 9:00 a.m. After the altar was attended, the minutes of the Tuesday sessions were read and approved.

Past Commander In Chief, Frank Heacock and Past Commander In Chief William Haskell of the Convention Site Committee were escorted in and Brother Heacock announced that the 1981 Encampment would be held in Philadelphia.
