As of the 2002 National Encampment, the National Secretary reported 6,724 Brothers in Good Standing within the Sons of Union Veterans of the Civil War. This total represents: 5,829 Members; 20 Real Sons; 298 Life Members; 3 Honorary Members; 85 Juniors; and 489 Associates. The total also reflects an increase in membership of 298 from 2001, for a 4.69% gain. Our membership is spread throughout 217 Camps within 26 Departments, 3 Camps-at-Large, and a National Membership-at-Large (NMAL). (The NMAL is composed of Brothers who live in a state that is not currently administered by a Department.)

13th Ohio Brother is elected National Commander

At the 121st National Encampment in Springfield, Illinois on August 10, 2002, the Sons of Union Veterans of the Civil War elected Robert E. Grim of Sabina, Ohio as their 116th Commander-in-Chief. He is the thirteenth Commander-in-Chief from the Department of Ohio.

Robert Elroy Grim was born at his parents' home in Madison Mills (Fayette County) Ohio. He is the fifth of ten sons born to Raymond Morgan Grim, Sr. and Nellie Irene Schomburg.

The family moved to nearby Bloomingburg when he was two years old. He entered the first grade at Bloomingburg High School and twelve years later graduated from that school.

Following high school he served a four-year enlistment in the United States Air Force. He was assigned to the Strategic Air Command (SAC) and served during the beginning of the Vietnam War. He served a two-year tour of duty in Morocco, North Africa. He's a member of the Paul H. Hughey Post No. 25 American Legion.

He completed three years of college work while serving in the U.S. Air Force and finished the work for his Bachelor of Arts Degree on the University of Maryland campus at College Park, Maryland. He worked as an insurance adjuster for a brief period before taking a job as a teacher at Miami Trace High School near Washington Court House, Ohio in 1967. He earned a Master of Education Degree from Xavier University, Cincinnati, Ohio in 1969. He retired in 2001 from Miami Trace High School after 34 years as an educator. At the time of his retirement he was serving as President of the Miami Trace Education Association and had been Chairman of the Social Studies Department for ten years.

He served as President of the Bloomingburg Board of Trustees of Public Affairs from 1968-1970. That is the publicly elected body that manages the village utilities. He was elected to the Bloomingburg Village Council in 1970 but resigned his seat to fill an unexpired term as Village Clerk-Treasurer (Chief financial officer of the village) from 1970-1972. He was elected and served as Village Clerk-Treasurer from 1972-1976. He also served as Chairman of the Bloomingburg Bicentennial Commission from 1974-1976. He has been a member of the United States Selective Service Ohio Board No. 15 (Covers Clinton and Warren Counties) since 1990. He was a volunteer deputy voter registrar from 1991-2001.

He married Charlotte Ann Morris on July 31, 1976. They have lived on a farm outside Sabina, Ohio since that time. They have one son, Irven Robert, who is married to Carolin J. Gruber. They have two grandsons: Jason Robert born April 7, 2000, and Michael David born Feb. 18, 2002.

He is active in a variety of civic and fraternal organizations and is past District Deputy Grand Master of the Free and Accepted Masons; a Knight of the York Cross of Honor and a member of the Ancient Accepted Scottish Rite.

He is currently serving as National Secretary of the National Society Sons of Colonial New England, and as National Secretary of the National Secret

tional Registrar of the General Society of the War of 1812. He served as Vice President General for the State of Ohio of the General Society of the War of 1812 from 1988 to 1993. He is a Past President of the Ohio Society of the War of 1812 and has been the Ohio Society Graves Registration Officer since 1996. He is also a member of the Mary-



land Society of the War of 1812. He is the Secretary-Treasurer of the Arthur St. Clair Chapter of the Ohio Society of the Sons of the American Revolution.

Commander-in-Chief Grim joined the Sons of Union Veterans of the Civil War in 1988 as a member-at-large in the Ohio Department.

His membership in the SUVCW is based on the military service of his Great Grandfather Private William F. Grim, who served in Company K. 8th Ohio Volunteer Cavalry, from 29 Feb. 1864 to 30 July 1865, and was a member of the Marian Judy Post of the Grand Army of the Republic at Bloomingburg, Ohio. Grim has proven eleven other ancestors who served in the Union Army during the Civil War.

At the National level Brother Grim served as National Guide (1993-94); National Color Bearer (1995-96); Acting Chaplain (1995) and was elected to the National Council of Administration (1994 -97). He was National Patriotic Instructor (1998-99); Junior Vice Commander-in-Chief (2000-01) and Senior Vice Commander-in-Chief (2001-2002). He served as Chairman of the Scholarship Committee (1995-2000); Chairman of the Resolutions Committee (1996, 1999, 2000 and 2001); Member of the Program and Policy Committee (1992 -2000) and chairman of that committee (2001-2002); Member of the Budget and Finance Committee (1997) and was the Master of Ceremonies for the Allied Orders Banquet in 1996 and 1997. He attended his first SUVCW National Encampment in 1993 at Portland, Maine and has not missed an encampment since.

He currently holds the rank of Colonel and is serving as the Deputy Commander of the Sons of Veterans Reserve (SVR). In 1998 he was appointed SVR Adjutant General and promoted to Lt. Colonel and in 2000 was promoted to Colonel. In 2001 he was awarded the SVR Distinguished Service Medal and named Deputy Commander of the SVR.

Commander-in-Chief Grim also belongs to the Military Order of the Loyal Legion of the United States; the Honorable Order of Kentucky Colonels and the Lt. Jonathan Bressler Camp No. 1536 Sons of Confederate Veterans.

In his free time, Commander-in-Chief Grim and his wife Charlotte enjoy Western Square Dancing. They are members of the Clinton County Country Squares and served the club as Co-Secretary in 1993. They dance at least once a week and have missed only one national square dance convention since 1993.

Cynthia Brown elected new Auxiliary President

A native of Lawrence, and a lifelong resident of the Greater Lawrence area. Cynthia Brown bases her membership in the Auxiliary on the service of her paternal great grandfather. James Walsh, who served with the illustrious Sixth Massachusetts Volunteers, in Company 1. The Sixth Massachusetts was begun during the Revolutionary War, and continued in service to Massachusetts until it was absorbed into the Yankee Division. James Walsh served in southern Virginia in the siege of Suffolk, against General Longstreets' troops. He was mustered out of the 6th in June of 1862. Family legend has it that he then served a paid enlistment in the 9th New Jersey, but research thus far has failed to document this.

Cynthia has served her Auxiliary in many capacities. Currently, she is the Secretary-Treasurer of Auxiliary 128, of Lawrence. She has also served as Massachusetts Department President for three terms as well as other Department offices, Currently, she is Secretary of the Department of Massachusetts. Nationally, she has served as Council 42. Chief of Staff for PNP Mary Scofield, and Vice President under Faye Carlisle. She is also a member of the Daughters of Union Veterans Mrs. Governor Andrews Tent #1 of Boston.

Cynthia is a nurse. Her career was in the Operating Room of the Lawrence General Hospital, followed by some time as a private Surgical Assistant for a plastic surgeon. She was co-founder and part owner of a nursing agency providing temporary personnel to operating rooms throughout the eastern Massachusetts/southern NH area. Currently she is doing pediatric private duty on a part time basis.


Cynthia has six children: Pastor Edward Cullen of NY:



POST ENCAMPMENT REPORT OF THE NATIONAL COUNSELOR AMENDMENTS TO THE REGULATIONS at the 121st Annual Encampment, SUVCW.

MEMORIALS & MONUMENTS OFFICER -CAMP AND DEPARTMENTS.

Amend National Regulations Chapter I, Article IV Officers, Section I. to add as underlined:

> "Section 1. The officers of a Camp shall be: Commander, Senior Vice Commander, Junior Vice Commander, three Members of the Camp Council, Patriotic Instructor, Chaplain, Secretary, Treasurer (or Secretary- Treasurer), Historian, Guide, Color Bearer and Guard and a Camp Memorials and Monuments Officer. The Commander, Secretary and Treasurer shall not serve on the Camp Council."

Amend National Regulations. Chapter I, Article IV DUTIES OF OFFICERS, by adding a new section II.

"Section II. The duties of the Camp Memorials and Monuments Officer include the locating, physical examination of, and recording of all memorials dedicated to Union Civil War soldiers and sailors (outside the care of the National Military Parks, and the U.S. Departments of Defense, or Veterans Affairs) in the location served by the Camp. This includes all sizes of monuments (with or without sculpture), those with Civil War era cannon and inert ammunition, memorial fountains, memorial buildings, memorial windows (stained glass), historical markers, and even small plaques. Reports on the various memorials and monuments located within the Camp area shall be made from time to time to the Department Memorials and Monuments officer upon appropriate form."

National Regulations, Chapter II, Article IV OFFICERS, amend Section I to add as underlined:

"Section 1. The officers of a Department shall be a Department Commander, Senior Vice Department Commander, Junior Vice Department Commander, three members of the Department Council, Department Patriotic Instructor, Department Chaplain, Department Secretary, Department Treasurer (or Department Secretary-Treasurer), Department Historian, Department Counselor, Department Graves Registration Officer and at the option of the Department, a Grand Army of the Republic Highway Officer, a Civil War Memorials & Monuments Officer, and such other officers as may be established in its By-laws

National Regulations, Chapter II, Article V, DUTIES OF OFFICERS, add new section 13:

"Section 13. The duties of the Department Memorials and Monuments Officer include the locating, physical examination of, and recording of all memorials dedicated to Union Civil War soldiers and sailors (outside the care of the National Military Parks, and the U.S. Departments of Defense, or Veterans Affairs) in the Department. This includes all sizes of monuments (with or without sculpture), those with Civil War era cannon and inert ammunition, memorial fountains, memorial buildings, memorial windows (stained glass), historical markers, and even small plaques. Reports on the various memorials and monuments located within the Department shall be made from time to time to the National Memorials and Monuments officer upon appropriate form."

MEMBERS OF THE NATIONAL ENCAMPMENT

Amend National Regulations Chapter III. Article II Membership, Section 1, by eliminating the underlined language as follows:

It's own elective and appointive officers (except brothers detailed for special duty).

Appropriate credentials for all Past Commanders-in-Chief and National elective and appointive officers shall be issued by the office of the National Secretary. Appropriate credentials for all Department Commanders, Past Department Commanders, delegates and alternates shall be issued by their respective Department Secretar

MILITARY SERVICE MEDAL:

Amend National Regulations, Chapter V, Article III BADGES AND **DECORATIONS Section 3**

New Section G and re-letter all subsequent sub-sections:

Military Service Medal: Authorized for any Brother who has served honorably in any branch of the Armed Forces of the United States. If a brother is qualified for this medal and the War Service Medal, the brother may purchase both, but may only wear one or the other at any

Amend National Regulations, Chapter V, Article 5, by adding the underlined language

> Group C War Service Medal Military Service Medal

When worn, the War Medal or Military Service Medal must be accompanied by a Group A or Group B Badge of the Order. The War Medal is approved for wear by the Brother's Camp and shall include a device identifying the period of qualifying service. Those devices shall not be worn upon any other badge. Administration. are removed from the National Web Site.

AMENDMENTS TO NATIONAL REGULATIONS TO CHANGE FROM PAYMENT OF PER CAPITA FROM QUARTERLY TO ANNUAL

CHAPTER I

Section 1. Before proceeding with the Installation, the Installing Officer shall require the Camp Treasurer to produce receipt from Department Headquarters for payment of per capita tax in full, including receipt of last Quarter,

Section 1. Before proceeding with the Installation, the Installing Officer shall require the Camp Treasurer to produce a receipt from Department Headquarters for payment of per capita tax in full. (eliminate: including receipt of last Quarter,)

Speech by: Charles C. Horton, Colonel, 2nd Iowa Volunteer Cavalry Regiment Commandant, Iowa Soldiers Home - Marshalltown, Iowa. Delivered at the 3rd Reunion of the Iowa Cavalry, Muscatine, Iowa, October 1887

Submitted by: John H. Brockway, grandson of Col. Horton, and Member of Greenville A Dodge Camp #75, Dept. of Iowa

Yes, go back to your homes and loved ones, tell your children of the ties and comradeship that bind us together; tell them the story of the war; see that they read aright the history of the great conflict, the great sacrifice of life and treasure, necessary to the preservation and perpetuation of the Union; but teach them no sectional bitterness; instill within their hearts no hatred or animosity toward the boys in gray, who met us in honorable warfare. Teach them that they were as brave (and) as gallant as any men who ever drew saber or shouldered a musket. Teach them that we are one people, whose aims and interest, hopes and fears, should and must be the same. But teach them the difference between loyalty and treason; teach them that the cause for which the Union army fought, was the cause of justice and humanity; that it was right- eternally right. That the cause of secession and disunion was the cause of oppression, and was of necessity wrong, eternally wrong. Teach your boys to love and venerate the old flag with the same sentiment, the same enthusiasm. that led you to rally in her defense. Teach them all this. and you will leave the flag, and all that it represents, in the hands and to the protection of sons worthy of the sires to whose gallantry and patriotism we owe the present prosperity and grandness of this nation.

[EDITOR'S NOTE: One Hundred and Fifteen years later, Col. Horton's message still has special meaning to the "sons" and successive descendants of those who *Saved the Union*. These sentiments are lost on many of those who teach 'history' today, and we owe it to these men to share this insight of their postwar patriotism.]

Effective April 30, 2003 the camp secretary must submit by the 15th day of the following month to the Department Secretary two copies of a Camp Status Report form when one of the following changes occur: (1) A new brother joins the camp (2) A brother is reinstated after being dropped for non payment of dues (3) A brother dies (4) A brother has a change of address (5) A brother transfers in or out of the camp. If the Camp Status Report form reports a new brother, then a pro-rated per capita amount for the remainder of the year shall accompany the form. Such pro-rated amount shall be calculated on a quarterly basis. If the Camp Status Report form reports a brother reinstated after being dropped for non payment of dues, then the full annual per capita for that brother shall accompany the form.

Add Section 8. Effective May 30, 2003 the Department Secretary must submit a copy of all Camp Status Report Forms to the National Executive Director by the 15th day of the month following the submission, along with a check for the proper amount of money due the National Organization for a new brother or a reinstated brother as provided for in Section 7.

Council of Administration Meeting August 8, 2002, Springfield, IL

After a prayer for guidance and Pledge of Allegiance to the Flag discussion commenced on the budget. It was moved by the National Quartermaster PCinC Bud Atkinson, seconded by Council of Administration (CoA) Member Ron Gill, and unanimously approved to propose a \$6.00 National Annual Per Capita increase in order to maintain current quality of the Banner and foreseeable increase in request for monument and memorial restoration project money.

Ir. Vice C-in-C Kent Armstrong moved, Brother Gill seconded and passed by unanimous vote to cash in "E" bonds in exchange for "H" bonds.

CoA member Don Darby moved, CoA Member Bob Petrovic second and unanimously passed to remove "Return to Sender if Undeliverable" on future mailings of the Banner. This was due to the high cost being incurred by too many numerous copies being returned because the recipient was no longer at the address and we did not have a more current one.

PCinC Atkinson proceedings to show the ROTC medal and ribbon that will be available soon for camps or departments to present to ROTC and Jr. ROTC cadets. Brother Petrovic moved. Brother Darby second and unanimously passed to have a simple form made up to be submitted to the National Patriotic Instructor giving pertinent information such as the name of the camp or department awarding the medals, Name of the recipient, name of ROTC unit as well as name and address of school. In the case that the name is unavailable at the time the medal is ordered, it may be provided later.

Moved by PC-in-C Atkinson, seconded by Sr Vice C-in-C Bob Grim to have the National Treasurer give concealed copies of the National Officers E-mail address passwords to the Nation Signals Officer to hold for safe keeping as a second party. It passed by unanimous ballot.

The CoA heard a request from Brother Mark Trout of the Missouri Department for support of the Missouri Civil War Museum at Jefferson Barracks. It was decided to have a letter of support written but to table any financial support at this time.

The Department of Missouri request to use SUVCW emblem on their own logo to be placed on items for sale. It was noted that the logo would then be the SUVCW emblem within a variation of the seal of the State of Missouri. Brother Gill moved, National Treasurer Max Newman second to deny the use of the SUVCW emblem in this manner. The motion to deny was passed.

Sr. Vice C-in-C Grim moved and Brother Darby second for PCin-C Richard Schlenker to be Washington DC Representative Emeritus. The motion was passed by unanimous ballot.

The meeting was adjourned by C-in-C George Powell.

The meeting of the Council of Administration (CoA) was casted to order by C-in-C Grim at 8:01 a.m. The C-in-C welcomed JVCin-C Steve Michaels to Council of Administration.

The next order of business was to set when the National \$6.00 Per-Capita increase would take effect. Moved by Don Darby many seconds to take effect January 1, 2003. Passed unanimously.

Moved and seconded to increase NMAL Per-Capita from \$25.00

to \$30.00 to begin January 1, 2003. Passed by unanimous vote. Vote unanimously for Life Member plan prior to 1996 reimbursement to camps to remain at \$4.00 for this fiscal year.

Vote unanimously to set On Line Application Fee from \$35.00 to \$41.00 with the increase to be effective January 1, 2003.

C-in-C Grim mentioned the decision of the National Encampment to institute the Service Medal and appointed PDC Darby to chair the committee for the design and assigned the Program and Policy Committee to create the Service Medal Application Form. The Program and Policy Committee was also commissioned to make the form for the ROTC Medal Application and look into revising the Camp Officer Election and Installation Form 22.

The Encampment also chose to do something with the National C-in-C Seal since it is in such bad condition. Max Newman moved, Ron Gill seconded to appropriate funds to repair or replace the Seal. Passed unanimously. C-in-C Grim appointed Program and Policy Committee to propose a plan for this.

Brother Don Darby moved, second by Bob Petrovic to supply additional funds to purchase a portrait case for the Seal to be transported and protected in. Passed unanimously.

- 1. The 121st National Encampment increased the National level per capita tax \$6.00 per year effective January 1, 2003 and changed the Quarterly Reporting system to an Annual Reporting system, effective January 1, 2003.
- 2. Department and Camp Secretaries will follow the current Quarterly Reporting system and per capita tax structure for the quarter ending September 30, 2002 and the quarter ending December 31, 2002.
- 3. Effective January 1, 2003 the Annual Reporting system will replace the Quarterly Reporting system.
- 4. Camp Secretaries must file the new Annual Report form (same type of information as on the current Quarterly Report form) with the Department Secretary by April 30, 2003 and include the per capita tax reflecting the \$6.00 increase for the entire period January 1 - December 31, 2003.
- 5. Brothers who have not paid their dues (per capita tax) by the date that the Annual Report is submitted by the Camp Secretary, should be dropped for non-payment. If a Brother is dropped from the Camp membership roster prior to the Annual Report being submitted, the Camp need not pay the per capita for such a dropped Brother.
- 6. Department Secretaries must file the new Annual Report form reflecting the \$6.00 increase in per capita tax with the National Executive Director by May 31, 2003.
- 7. After the Annual Report form is filed, if one of the following events occur, the new Camp Status Report form must be filed by the Camp Secretary with the Department Secretary - (a) A new Brother joins the Camp (b) A Brother

is reinstated after being dropped for non-payment of dues (c) A Brother dies (d) A Brother has a change of address (e) A Brother transfers in or out of the Camp.

- 8. After April 30 of each year (beginning in 2003) two copies of the Camp Status Report form must be filed by the Camp Secretary with the Department Secretary no later than the 15th of the month following the event that prompted the need to file the Camp Status Report. If a new Brother is being reported, then the pro-rated per capita for the remainder of the calendar year shall accompany the form. Such pro-rated amount shall be based on a calendar year quarterly basis. If the Camp Status Report form reports a Brother reinstated after being dropped for non-payment of dues, then the full annual per capita for that Brother shall accompany the form.
- 9. After May 31 of each year (beginning in 2003) the Department Secretary must submit a copy of all Camp Status Report forms to the National Executive Director by the 15th of the month following the submission, along with a check for the proper amount of money due the National Organization for a new Brother or a reinstated Brother.
- 10. The new Camp Status Report form and the new Camp and Department Annual Report forms are being developed by the National Program and Policy Committee and should be available from the National Quartermaster or the SUVCW website by December 1, 2002.

Brother Newman moved and PC-in-C Powell second to pay from Reserve if needed to print all proceedings that have yet to be printed. Motion passed by 8 votes for and 1 vote against.

The meeting was adjourned.

Final Roll Call for Past C-in-C Joseph S. Rippey

Joseph S. Rippey was elected Commander-in-Chief of the Sons of Union Veterans of the Civil War twice (the sixth and last Brother to do so). The first time was at the 82nd National Encampment held in Miami, Florida, August 18 - 22, 1963 and the second time at the 83rd National Encampment held in Providence, Rhode Island, August 16 - 20, 1964. He was a Life Member of the SUVCW and our Senior PCinC. Brother Rippey's great-grandfather, John Smith, enlisted with the 69th Pennsylvania Volunteers, and his grandfather, Bernard Smith, was a member of Company I. 54th Regiment, New York National Guard.

Brother Rippey joined the SUVCW in 1948, becoming an active Member of the Department of New York's Glidden-Pierce Camp #6 (now chartered as Abraham Lincoln Camp #6). He held the office of Camp Commander and most other Camp offices. Brother Rippey was elected New York Department Commander in 1958 and again in 1959. He also served the National Organization as a member of several committees, and as chairman of the Committee on Americanism, chairman of the Committee on Legislation and as Senior Vice Commander-in-Chief.

After graduating from college, Brother Rippey entered the United States Navy prior to World War II. He saw combat duty as an officer aboard ship in the Southwest Pacific and was later assigned to Naval Intelligence and the office of the Chief of Naval Operations. Gaining the rank of Lieutenant Commander, he continued to serve our country in the Naval Reserve after the war.

In civilian life, Brother Rippey was an attorney and partner in the law firm established by his father. He had the honor of being chosen by the Chief Justice of the United States Supreme Court to present nine cases during his career all of which were successful.

Brother Rippey was active in many other organizations, including the Abraham Lincoln Association of Rochester, NY, serving a term as its President. He was a decades long member of Calvary St. Andrew's Episcopal Parish in Rochester, serving as a Vestryman. Senior Warden and as Head Usher at the time of his death on July 28, 2002.


