Commander-in-Chief Gordon R. Bury II is a thirteenth generation descendant of the Rev. John Wing, whose son Daniel settled in 1632 in Boston, MA. Daniel's descendant, Capt. Thomas Wing, fought in the Connecticut Militia during the Revolution and married Phoebe Tyler Ward, whose mother was of President Tyler's family and the family of Artemus Ward which included Henry Ward Beecher, Harriet Beecher Stowe, and Julia Ward Howe.

He is also a member of the Military Order of the Loyal Legion, and derives collateral descent from Major David H. Brooks, who was the regimental surgeon of the 103rd Ohio Volunteer Infantry out of Cleveland, OH. He reorganized Given Camp #51 of Wooster, OH in 1974, and served as Department Commander in 1975-76.

"Rick" has served as National Patriotic Instructor, Junior Vice Commander, Senior Vice Commander, and was General Chairman of the 1984 National Encampment in Akron, OH.

Membership of Subcommittee on Census and Population — Assignments to the House Subcommittee on Census and Population, the panel which initiates holiday legislation in the lower house of Congress, were completed and announced in April. The chairman is Rep. Robert Garcia of New York, a veteran member. Other members of the majority party are Rep. Mary Rose Oakar of Ohlo, and Rep. Garly L. Ackerman of New York. The ranking minority member is Rep. James V. Hansen of Utah, and serving with him on the minority side is Rep. John T. Myers of Indiana. Reps. Ackerman, Hansen and Myers are new to the subcommittee which was reduced in size from six to five members. The chairman of the parent Post Office and Civil Service Committee continues to be Rep. William D. Ford of Michigan, and the ranking minority member of the full committee is Rep. Gene Taylor of Missouri. Questions and concerns relating to the status of holiday legislation and particularly the return of Memorial Day to May 30 should be addressed to one or more of the individuals as listed

Acid Rain and Civil War Monuments

- Among victims of acid rain are 300 major monuments and sculptures at the Gettysburg National Military Park in Pennsylvania. Along with vandals, acid rain has caused such damage to the monuments that the National Park Service has estimated that it will cost \$2 million to repair them. But it is very difficult to obtain Federal funds for this work, and the Park Service has asked state governments and private groups to "adopt" memorials by donating money for their restoration. About \$30,000 has been raised thus far led by North Carolina which donated \$10,000 to restore its memorial. The Indiana and Pennsylvania Legislatures have similar bills pending, and other states including California, Michigan, Ohio and Virginia have made inquiries concerning the pro-

Resources Protection Act, the plundering of historic sites by digging up battlefield artifacts like bullets, buttons and other valuable souvenirs will be subject to federal prosecution by the National Park Service. Within the past year two individuals caught using a metal detector at the site of the Battle of Richmond were convicted of violating the Act and each received jail terms. The statute provides a clearer definition of what an antiquity is and makes prosecution easier to sustain. According to a spokesman for the Park Service, "Now it's a problem of educating the legal community so that judges don't view this as some minor nuisance requiring only a slap on the wrist. We're trying to protect the common heritage of all Americans, something that should not be ripped off for private profit."

Marking Centennial of Death of U.S. Grant - Measures to commemorate the 100th anniversary of the death of Ulysses S Grant, our 18th President, have been introduced in both houses of Congress, S. Jt. Res. 105 would designate July 23, 1985 as "Ulysses S Grant Day." It is sponsored by Sen. Mark Hatfield of Oregon, with the cosponsorship of Senators from Ohio, Illinois and New York, states associated with the principal phases of Grant's life. H. Con. Res. 59, introduced by Rep. Kenneth J. Grav of Illinois, would also mark the anniversary of U.S. Grant's death. Sen. Hatfield has also introduced S. Res. 141 to recognize General Grant's birthday on April 27.

Charter for Daughters of Union Veterans — Under H. R. 1806, the Daughters of Union Veterans of the Civil War, 1861-1865, would be granted a congressional charter. Jointly sponsored by Rep. Thomas N. Kindness and Rep. Michael G. Oxley of Ohio, and by Rep. Doug Bereuter of Nebraska, the bill passed the House on May 13, 1985, and has been referred to the Senate Judiciary Committee chaired by Sen. Strom Thurmond of S. Carolina.

Burials in National Cemeteries — Under terms of H. R. 399 introduced by Rep. Jimmy Quillen of Tennessee, burials would be permitted in national cemeteries on weekends and holidays.

Designation of a National March— Rep. Quillen is sponsoring a bill that would designate "The Stars and Stripes Forever" as the nation's official national march. First performed before Pres. McKinley in 1897, the Sousa march has "captured the hearts and imaginations of Americans" in the words of Rep. Quillen.

Replacement of National Anthem — Rep. Andrew Jacobs of Indiana has introduced H. R. 1052 which would authorize replacement of "The Star Spangled Banner" as our national anthem with "America the Beautiful."

Proposed Change in House Rules Concerning Designation of Special Days — Rep. Jim Bates of California believes there are better ways for the Congress to spend its time than to designate special days in honor of historic, cultural or commercial events or happenings. He has introduced H. Res. 111 which would amend the House Rules to prohibit the consideration of legislation introduced for the purpose of proclaiming special days to commemorate or recognize particular events.

Topics Related to the Civil War — In July 1986 the House of Representatives passed H. R. 4259 which would authorize federal acceptance of a 31 acre tract as a part of the Gettysburg National Military Park. This measure had failed to pass under suspension of the rules in mid June.

The Daughters of Union Veterans of the Civil War, 1961-1865, received its federal charter when President Reagan signed PL 99-172 on December 9, 1985. A Senate passed measure to grant a federal charter to the Confederate Memorial Association is now in the House Judiciary Committee.

Bills Relating to Memorial Day - In June 1985, Rep. Helen Delich Bentley of Maryland introduced H. R. 2655 which would return the observance of Memorial Day to May 30 at the federal level. In announcing the measure, Rep. Bentley said, "If we wish to retain our traditions and restore our national identity, we can give up celebrating the first Monday of summer. Compared to the debt we acknowledge on Memorial Day. it doesn't seem such a large burden." Her bill joins H. R. 84 introduced by Rep. Phil Crane on the first day of the 99th Congress. Neither measure has received a hearing before the House Subcommittee on Population and Census, chaired by Rep. Robert Garcia of New York.

The Legislative Report

English As Official U.S. Language — In November 1986, California voters will be asked to pass on a proposition that would declare English as the state's official language. By early 1987, advocates of a similar measure in Florida expect to have signatures on petitions to put the question before voters in that state. Other states targeted for attempts to put the issue on the ballot in the next year or two include Alabama, Idaho, lowa, Kansas, Maryland, Massachusetts, Missouri, New Hampshire,

New Jersey, New York, Washington state and Wisconsin.

Six states, Georgia, Kentucky, Illinois, Indiana, Nebraska, and Virginia already have such laws, but several date back many years. Supporters of the U.S. English movement have been prompted by recent increases in the rate of imigration, especially from Latin American and Asian countries. Critics of the "English only" drive argue that most immigrants want to learn English and more energy and money should be devoted to that effort.

Designation of Special or Commemorative Occasions — Rep. Dave McCurdy of Oklahoma has introduced H.R. 692 which would establish an eleven member advisory commission which would assume responsibility for designating commemorative days. The bipartisan panel would consist of two Senators, two Representatives, and seven citizen members. The commission would function similarly to the Postal Commission which reviews proposals for new postage stamps. Similar legislation was introduced in the last Congress by Rep. Whitehurst.

After three years a Provisional Department shall be granted permanent Department status by the Commander-in-Chief."

Section 5 renumbered from 4. Section 6 renumbered from 5.

Chapter I, Article I, Charters.
The word "Camps" is added after the

The word "Camps" is added after the words "Chapter I" in the title.

Section 1 is changed to provide that when a provisional camp has existed for three years (instead of two) the commander-in-chief shall declare it a fully established camp.

Chapter III, National Organization. Article II, Membership.

Section 5, a sentence is added at the end thereof as follows: "No per capita tax shall be paid to the National Or-

ganization on life members."

Section 3 to read as follows: "On assuming office, the Commander-in-Chief shall appoint all other officers and national committees, and may appoint such aides as he may deem necessary, for such services as he may designate, except that he shall not appoint the editor of The Banner."

Article V, Duties of Officers.

Section 9, a sentence is added at the end thereof as follows: "The United States Army Military History Institute at Carlisle Barracks, Pennsylvania, is designated the official repository for Grand Army of the Republic and Sons of Union Veterans of the Civil War historical material no longer in general use."

Article VI, Finances.

Section 6 (new): "There shall be

established a Senior Vice Commanderin-Chief's Fund to be used for the promotion of the Order."

Chapter V, General Regulations. Article I.

Section 2, Subparagraph (c), original reading stricken out and original subparagraph (D) renumbered (C).

Section 2, subparagraph (D) renumbered from original (E) to read as follows: "Each Department Secretary is required to mail a complete mailing list of the Department to the Editor of The Banner on or before January 1st of each year."

Section 2, subparagraph (E) (new): "The Editor of The Banner is required to mail one copy of each issue of The Banner to each member of the Order."
