

# 1966 – G.A.R. CENTENNIAL YEAR

The Civil War Centennial is over. It offered an excellent opportunity to bring before the American public the story of the struggle to preserve our national unity a century ago - giving new understanding to the events which led up to that great conflagration, the conditions under which it was fought. and the colorful personalities involved. For the most part, that centennial was carried out under the direction of historians and avid Civil War buffs, who, while expertly informed concerning the era, did not necessarily have any family connection with the men who fought (and in many cases died) on those blood-stained battlefields which 100 years later have become such popular tourist attractions.

Now it is time for another centennial . . . one that belongs solely to the descendants of the famed "boys in blue." This is our opportunity to tell the story of how the returning Civil War veterans banded together in a great society to aid the war widows and orphans, as well as their needy comrades, while guiding the destiny of a nation newly emerging as an international power, and educating the future generations to the true meaning of patriotism. How well we tell the story depends upon how enthusiastically the various Departments — and the local Camps and Auxiliaries — undertake this project. It could result in considerable publicity and an increase in membership if handled properly.

## ILLINOIS GOVERNOR RECEIVES CENTENNIAL COMMISSION AWARD

Governor Otto Kerner of Illinois was presented with two awards by the National Civil War Centennial Commission following the culmination of the centennial observance. One of the framed citations was issued to the Illinois Civil War Centennial Commission, which he accepted on its behalf; the other was awarded to him personally for his support of the centennial. The presentation was made at the October meeting of the Chicago Civil War Round Table, and on hand to make it was-Fred Schwengel, former Congressman and a member of the national commission. Citations were also issued to the U. S. Grant Association and to Ralph Newman, who had served as chairman of the Chicago Civil War Centennial Commission. A posthumous award was made to Adlai E. Stevenson, former ambassador to the United Nations, which was accepted by his son, Adlai III. ## On the Subject of Patriotism

At the encampment in Richmond, Va., Commander-in-Chief Earl Corbin appointed me to the office of National Patriotic Instructor. I am very honored to serve as a member of the Corbin team.

As most of you know, the National Patriotic Instructor has a budget to meet, and, this being my first letter in THE BANNER, I am making an appeal for ALL Department Patriotic Instructors to contact their Camp Patriotic Instructors in my behalf. This is a task I cannot hope to do alone, so I am asking for the cooperation of all the members in our organization.

As I sit here composing this letter, I am wondering what the men of the Grand Army of the Republic would have thought about the conditions existing in our great country today. Do you think that, were they living today, racial strife, crime, violence and fear of walking the streets would be on the march as it is at this moment? It seems to me they would have risen up in a body and demanded that concrete action be taken to make this a country in which we could live in safety.

At the same time, Governor Knowles presented his grand-father's cavalry saber to the State for display in the G.A.R Hall, located in the Capitol

The first Warren P. Knowles, a Captain in Company G, 1th Wisconsin Cavalry, enlisted in 1861 and served throughout the Civil War, seeing service principally in Mississippi and Louislana.

We, the Sons of Union Veterans, must work hard to carry out the principles for which our forefathers fought. They were patriotic men, and it behooves us to show a little more patriotism in our everyday living. There are too many things being done today for purely political purposes rather than for the good of the country as a whole. This country was not founded on socialistic principles, but upon that of freedom for a man to do for himself the things needed to give him a good life. I am sorry to say that, today, our freedoms are being taken away from us one by one, so that individual initiative is lacking in a large share of our people. They are looking more and more toward the government to take care of them. There is only one way this can end, and we should all pray to God that this does not happen.

## DEDICATE BENCHES AT GETTYSBURG G.A.R. MONUMENT

Ziegler's Grove on the Gettysburg battlefield was the scene November 20 of an impressive dedication ceremony, when representatives of the G.A.R. Allied Orders gathered at the Woolson monument for the formal dedication of two stone benches. Mrs. Edith L. Snyder, National President of the Auxiliary to Sons of Union Veterans of the Civil War, made the presentation of one bench on behalf of the Auxiliary's national organization which had purchased it. The other bench was presented by Mrs. Dorothy L. Hilyard, Past National President of the Auxiliary to SUVCW, who explained that this one had been purchased by the local auxiliary at Wilmington, Del., and was being dedicated to Miss Celeste D. Genticu, also a Past National President of the Auxiliary to SUVCW, for her long and outstanding service to the Order. A tribute to Miss Gentieu was given by Frank M. Heacock, Sr., Past Dept. Commander (Pennsylvania), who said in part: "Were it possible to have statesmen as devoted to the cause of peace and prosperity in the world as Miss Gentieu was to the Grand Army of the Republic and its Allied Orders, we would today have the millenium, a world with peace and prosperity for all." Miss Gentieu, who is 86, was unable to attend the dedicatory program because of illness

Scheduled only to give welcoming remarks, C. LeRoy Stoudt, Past Commander-in-Chief of SUVCW, found himself in the role of Master of Ceremonies when another Past Commander-in-Chief, Harold E. Arnold, was delayed by traffic and did not arrive until near the end of the ceremony. Dr. Howard S. Fox, pastor of Trinity United Church of Christ, gave the invocation and benediction, and P.D.C. Heacock read Lincoln's Gettysburg Address. Also included in the program were greetings from the G.A.R. Allied Orders. brought by the following national and department heads: W. Earl Corbin, Comdr.-in-Chief, and Clarence J. Riddell, Dept. Comdr. (Pa.), SUVCW; Mrs. Edith L. Snyder, Natl. Pres., and Mrs. Madge Fullerton, Dept. Pres. (Pa.), Aux, to SUVCW; Mrs. Alice F. Harwood, Natl. Pres., and Mrs. Edrie Renner, Dept. Pres. (Pa.), L. of G.A.R.; Mrs. Bess Kapp, Natl. Pres., and Miss Mary Jane Bannan, Dept. Pres. (Pa.), DUVCW; Mrs. Bessie Coughlin, Natl. Secty., and Mrs. Alverna Erdman, Dept. Pres. (Pa.), W.R.C.

In accepting the benches, which are described as *mahogany* granite, Kittridge A. Wing, Superintendent of the Gettysburg National Military Park, said: "The benches add the final elegant touch to a most excellent monument. The Grand Army of the Republic marker, to my mind, is one of the three or four top pieces of the sculptor's skill on the battle-field. When the constant approach of tourists to the statue destroyed the grass, you conceived the idea of this patio, which is such an excellent idea we are considering something similar at other highly popular monuments on the field. The addition of these truly beautiful benches fittingly completes the monument. We of the Park Service are delighted with what you have done here."

## Presentation of Memorial to MacArthurs Made by Veterans of Foreign Wars

A memorial tablet honoring the late General Douglas MacArthur and his father, Lieutenant General Arthur Mac Arthur, as "heroic military leaders in the most critical periods of the history of the Republic" was presented to the MacArthur Memorial at Norfolk, Va., on this past November 11 (Veterans Day) by the Veterans of Foreign Wars. The presentation was made during a ceremony held in the Monticello Hotel, to which the public was invited. Principal speaker was Andy Borg, Commander-in-Chief of the V.F.W. Mayor Roy Martin accepted the tablet on behalf of the MacArthur Memorial, and General Courtney Whitney (Ret.), longtime aide to General MacArthur, also spoke.

In explaining the reason this tribute had been planned for these two distinguished Americans, Commander Borg said that the V.F.W. had many reasons to feel close to both men. Genl. Douglas MacArthur was a life member of the V.F.W., and it was the long, detailed message he sent to that organization's 51st annual convention which precipitated his removal from command by President Truman during the Korean Conflict. His father, Genl. Arthur MacArthur, was commander-in-chief in 1906 of one of the early Spanish War Veteran's organizations which merged to form the Veterans of Foreign Wars, so that he is considered one of the founders of the V.F.W. (He had also been a commander-in-chief of the Civil War officers' society, The Military Order of the Loyal Legion of the United States.)

Speaking reverently of Genl. Douglas MacArthur's eminent qualities, Comdr. Borg said:

"At this stormy stage of human history, in a time when some who call themselves Americans no longer believe in the execution of the responsibilities that their birthright requires — nor appreciate the principles that give them, and gave their immigrant forebears, freedom and opportunity — we are proud to rededicate ourselves, to reaffirm our faith in the lofty ideals of General MacArthur, to pay homage to his name, and to give thanks for his chivalrous military service. We hope that his personal moto and that of his beloved U. S. Military Academy — Duty, Honor, Country — will long remind us that men do not live by bread alone. No one knew better than the great General that a society wedded to material things, or lost to a sense of history and worthy tradition, may be perilously close to what is known in the vernacular as 'on the way out.'

"We know that neither men nor nations can live in the past; that both pass down the inevitable road of time; that both leave records and milestones. It is our high honor to place at this revered sarcophagus a memorial, a remembrance, in order that future generations may know how deep a regard we had for his patriotism and his fame. He made worthy traditions that will never die. In the words of a French leader, we feel that 'to honor tradition is not to gather ashes, but to keep a flame burning.' And may that spiritual flame ever remind the hearts of Americans that freedom is our heritage, that freedom is the responsibility of each citizen, and that freedom may require great sacrifice, even life itself. These were basic and fundamental directives in the credo of the great patriot we this day so proudly honor."

Immediately following the program in the hotel, Comdr. Borg proceeded to the MacArthur Memorial where he placed the memorial tablet and also placed a wreath at Genl. Mac Arthur's tomb. It is interesting to note that Genl. Douglas MacArthur—one of the most highly decorated men ever to have served in the American military forces—was the holder of the Medal of Honor, as was his father also. They are the only father and son to have received this award in the history of our nation.

### A Message from the Junior Vice Commander-in-Chief

Due to deaths, advanced age and infirmities, the Pennsylvania Department's membership in the Grand Army of the Republic declined from a high of 44,613 in 1889 to 3,809 in 1926. As of June 30, 1965, the membership of SUVCW's entire National Organization was 3,773 — slightly below the membership of the G.A.R.'s Pennsylvania Department in 1926!

The Grand Army owed no apology for its eventual demise, but what is our excuse for a continual decline in membership? Are we going to wait until we pass the point of no return? Statistics are facts . . . and the fact remains that an individual membership drive by each department is imperative if we wish to ensure the continuity of our organization and our heritage. Definitely, there is no dearth of eligibles! It is up to YOU if we are to enjoy a reversed set of statistics, in honor of our heritage, by the time we meet at Grand Rapids, Mich.

Camp Commanders have been requested by the Commander-in-Chief to appoint a membership Committee. At a later date, I will contact each Department Commander and Department Secretary relative to membership. I would suggest that each department hold a class initiation at their annual convention.


