#### 20TH ANNUAL REMEMBRANCE DAY - GETTYSBURG - 1977

P.C. in C. Joseph S. Rippey was Master of Ceremonies for the 20th Annual Remembrance Day Program held in the Visitors Center Auditorium at the battlefield of Gettysburg on November 20, 1976. The opening and closing prayers, as well as the Prayer of Tribute, were offered by the Rev. Dr. Robert A. MacAskill of Gettysburg Presbyterian Church. Other highlights of the program included music by the Lancaster Fencibles Fife and Drum Corps, the playing of Taps by Karl Frantz of Camp 33, York, Penna., the playing of the Star Spangled Banner by the 11th Pa. Vol. Inf., SVR, Fife and Drum Corps and the firing of a Volley by Co. H, 7th Pa. Regt., 36th Inf., SVR.

There where brief remarks and greetings from: Commander-in-Chief Kenneth T. Wheeler; National President Minnie E. Madeiros of the Auxiliary; National President Syrenia Chick of the Woman's Relief Corps; National President Elizabeth B. Koch of the Ladies of the GAR, and Past National President Grace P. Broderick of the Daughters of Union Veterans.

The main address was given by Lt. Col. Francis X. Vossen, Professor of Military Science at Gettysburg College, Lt. Col. Vossen has held a number of Command and Staff positions since entering the Regular Army in 1956. His decorations include the Legion of Merit, Bronze Star (with v device), Meritorious Service Medal, Air Medal, Army Commendation Medal, Combat Infantry Badge and several foreign decorations. Paying tribute to the men of both the North and the South during the course of his remarks, Col. Vossen stated the Military Leadership was responsible for the Union victory at Gettysburg. He noted that the enlisted man in the Union ranks was often between 16 and 19 years of age and that the mark of a good military leader is one who cares for and leads his men. In conclusion he remarked that "We have seen our nation advance for the many years since this battle was fought here. Our future is bright for we have a good heritage. The ideals of the Grand Army of the Republic have been carried down through the generations, through their children and to our grandchildren.

At the evening dinner, Commander-in-Chief Kenneth T. Wheeler presented the national SUVCW scholarship to Matthew D. Shannon, a student at Gettysburg College. This scholarship, funded thru the National Patriotic Instructor's GAR Memorial Fund, is awarded annually to an outstanding History student at Gettysburg College. Dr. Charles Glatfelter, professor of History at the College, introduced Mr. Shannon.

Approximately 200 persons attended the "Blue and Gray Dance" which followed the evening dinner and program. There were over 700 in attendance at the afternoon program at the Albert Woolson Statue. In addition to the formal programs in the afternoon and evening, the gathering was the occasion for several brief meetings by various National Committees, by the Council of Administration and by various units of the Sons of Veterans Reserve.

# REPORT OF CENTRAL REGION CONFERENCE

The annual meeting of the Central Region Conference was held on October 9 and 10 at the Holiday Inn in East Peoria, Illinois. In attendance were delegates from Illinois, Indiana, Iowa, Ohio, and Wisconsin. The theme was "The Heritage of Our Bicentennial," and featured a talk by Grover R. Huff on the importance of the Northwest Territory to American history followed by a talk by Helen Huff on the importance of women in history.

At the banquet session, Dr. Oliver K. Zivney, pastor of the United Methodist Church of Danville, Ill., and Illinois Department Chaplain of The American Legion, spoke on the fate of the signers of the Declaration of Independence in an address entitled, "Putting Their Lives on the Line."

At the Sunday morning session much discussion ensued concerning ways of gaining membership for the Order. The Conference agreed to authorize a committee chaired by G. Edward Coltrin to compile a directory to aid non-members in learning where to obtain records on veterans of the Civil War so as to establish eligibility for membership. It was also agreed that the theme for the 1977 Conference will be, "The Contribution of Your State to the Civil War" with Thomas L. W. Johnson as moderator.



- All Department and Camp Secretaries are to send a copy of their charter to the National Secretary. This was to have been done by December 31, 1976. It is my hope that we have accomplished this project 100% before the end of my year.
- 3. Due to the fact that no Department has presented a firm invitation for the 1978 Encampment, the Council of Administration met in Gettysburg and decided to implement the plan proposed two years ago and appoint a Convention Planner. P. C. in C. Chester S. Shriver has been appointed to this position. To replace Brother Shriver on the Encampment Site Committee, I appoint P. C. in C. William W. Haskell of Massachusetts.
- 4. The National Patriotic Instructor, Charles A. Brady, Jr., has a quota of \$1,500 to reach. Please help him all you can as this money is used to support various worthwhile programs on the National level. Checks should be made payable to the National Organization, SUVCW and be mailed to Brother Brady.
- Please do not forget the Senior Vice Commander's Fund. The money solicited will go into the One Hundredth Anniversary Fund which will be used to celebrate the 100th Anniversary of the National Organization in 1981.
- 6. If any Department Secretaries did not advise of their Encampment dates in time for inclusion in this issue of THE BANNER, will they please advise me of these dates. I must arrange my itinerary for the year and it is my desire to attend all Encampments.
- 7. The one ingredient necessary to keep our Camps, Departments and National Organization strong is new members. #### THE LEGISLATIVE REPORT

A final review of legislation pending before the 94th Congress reveals the following activity since the publication of our last Report.

On October 11. President Ford signed into law PL 94-479 which posthumously awarded the six-star rank of General of the Armies to George Washington, an honor which the 5th Congress had intended to bestow in 1799 but did not do so due to the untimely death of our First President in December of that year. Some congressmen adothers had criticized the present Congress for spending valuable time on the matter, but the sponsor of the measure, Rep. Mario Biaggi, put it this way: "It is most appropriate in our Bicentennial year to pay special tribute to those Americans who made it possible for us to be in this great country... I agree that honoring Washington in this way is not an earth-shattering activity for Congress. However, the entire Bicentennial celebration is made up of a series of gestures, small in themselves, which together create a spirit of patriotism that has been something very special this year."

In another action related to the observance of the Bicentennial, on October 19, the President signed PL 94-556 which authorizes the Secretary of the Interior to "study the feasibility of" and to make recommendations for honoring Alaska and Hawaii at the Lincoln Memorial in Washington, D. C. As the last two States to be admitted to the Union, the names of Alaska and Hawaii have not been inscribed on the Memorial as have the names of the other 48 States. In the debate in the House, a question was raised as to the space available for additional names. For that reason the measure was amended to require the Department of the Interior to make a study and submit a plan for the most suitable means of including the 49th and 50th States on the Memorial.

Under terms of legislation signed by the President on October 12 'PL 94-483', the American Legion has been accorded the honor of placing its Freedom Bell on federal property in the District of Columbia to be designated by the National Park Service. The Freedom Bell was an integral part of the displays aboard the Freedom Train during the past two years.

Other measures of note dealing with such subjects as restoration of May 30 as Memorial Day, expansion of the Antietam National Battlefield Site, provision to honor a soldier from the Revolutionary War at the Tomb of the Unknowns at Arlington National Cemetery, and the establishment of George Washington's boyhood home as a National Historic Site languished in congressional committees and must start the process anew in the 95th Congress which will convene in January 1977. Individuals interested in these and other measures should be in touch with their Senators and Representatives early next year to insure that they receive the attention necessary for enactment into law.

FOOTNOTE - A total of 24,283 measures were introduced in the 94th Congress but for the record figure, one must go back many years. In the 61st Congress (1909 - 1911), 44,363 measures were dropped into the hopper. The 94th Congress did succeed in enacting 588 Public

#### 95th ENCAMPMENT APPROVED CONSTITUTION AND REGULATIONS CHANGES

The following amendments to the C & R were presented by the Committee of Constitution and Regulations and were approved at the 95th Encampment of the SUVCW in Columbus last August.

#### CHAPTER III

Article VII

Committees

Section 1. The regular committees of the National Organization shall be a Standing Committee on Constitution and Regulations, Legislation, Military Affairs, Membership, Americanization and Education, Lincoln Tomb Observance, Remembrance Day, Fraternal Relations, and Encampment Site.

Section 2. Special committees may be created by action of a National Encampment and shall be for the period of time designated in the creation thereof. Their duties and responsibilities shall be simultaneously defined

Section 3. The regular national committees shall consist of five members of the Sons of Union Vetcrans of the Civil War, except the Membership Committee which shall consist of the Junior Vice Commander-in-Chief as chairman and the junior vice commanders of all Departments and Camps-at-Large, and except the Encampment Site Committee which shall consist of three members. All shall be in good standing in their respective Departments and Camps.

Section 4. It shall be the duty of the Committee on Legislation to watch matters of proposed legislation affecting the welfare of the Order or the Constitution or welfare of the United States of America, proposed either in the Congress of the United States or elsewhere: to oppose such as are inimical to the same and to make a written report to the Commander-in-Chief at the session following its appointment.

#### CHAPTER III

Article IV

Officers

Section 3. On assuming office, the Commander-in-Chief shall appoint all other officers and national committees, and may appoint such aides as he may deem necessary, for such services as he may designate.

#### CHAPTER IV

Section 2

Sons of Veterans Reserve

Effective 1 January 1977, to be eligible for membership in the Sons of Veterans Reserve, a brother shall be a member in good standing in the Sons of Union Veterans of the Civil War.

Members of the ladies organizations of the Allied Orders of the Grand Army of the Republic may affiliate with subordinate units. and be identified as members of the SONS OF VETERANS RESERVE NURSE CORPS, with uniform, dress and duty conforming to that of the period of the Civil War. Members of the SONS OF VETERANS RESERVE NURSE CORPS shall NOT pay dues. file forms or have rank structure.

#### **DEDICATION SERVICE HELD AT NEWLY RESTORED TOMB OF GENERAL WINFIELD SCOTT HANCOCK**

Philadelphia Camp #200, Sons of Union Veterans of the Civil War, held a dedication service at the newly restored tomb of Major General Winfield Scott Hancock on Sunday, October 24, 1976 at Montgomery Cemetery, Norristown, Pennsylvania. Although a light rain fell most of the day, over one hundred people were in attendance. Representatives from several military units and historical organizations were present, with many in full Civil War dress.

The General Hancock Tomb Restoration Fund started over two years ago after reports were received about vandalism to the tomb structure and surrounding area. At a cost of over five thousand dollars, which was raised from donations from all over the United States, the tomb is now restored and the grounds landscaped. An eight foot fence has been erected to help protect from further damage. Dave Charles, Jr., Chairman of the Hancock Committee, said "over half of the funds raised have come from our friends down South," "this shows the respect and admiration that General Hancock has attained both North and South." A plaque entitled, "HANCOCK THE SUPERB" was placed at the new heavy stone seal to the entrance of the tomb. The plaque gives special thanks to Mr. Eli Lilly, Honorary Commander-in-Chief of the Military Order of the Loyal Legion of the United States, the National Commandary of the Loyal Legion, the Historical Society of Montgomery County, the Sons of Union Veterans and "many other historical organizations and concerned Americans throughout the United States."

Major General Winfield Scott Hancock so distinguished himself during the Civil War that he earned the praises of all army commanders he served, from General George Gordon Meade to General U. S. Grant. He was cited by the U. S. Congress in 1864 for "gallant action at the battle of Spotsylvania Court House, Virginia." He served as Military Commander of the Department East after the war and in 1880 he ran for President of the United States. He was narrowly defeated by James Garfield by a few thousand votes out of almost ten million cast. The General died in New York City in 1886 at the age of sixty two.

The Sons of Union Veterans of the Civil War will maintain a standing committee at Philadelphia Camp #200 to provide a continuous watch on the tomb and grounds and provide for its perpetual care. Repairs of any damage will be made immediately when needed. The Hancock Committee is still accepting donations which will be placed in a special savings account and be used for this specific purpose. Memorial Day services will be held each year by Camp #200. ## DECENDENTS MAY NOT WEAR FOREFATHER'S WAR MEDALS

From time to time, the National Organization receives inquiries from members who wish to wear the Civil War Campaign Medals of their grandfather or great grandfather. Although this subject has been discussed previously, Commander-in-Chief Wheeler recently sought a fresh opinion from his Congressman in Washington. The reply is from Colonel A. P. Hodges, Director of Personnel Administration, Office of the Assistant Secretary of Defense for Manpower and Reserve Affairs, Colonel Hodges warns that Section 704, Title 18, United States Code prohibits such wearing and provides that violators "shall be fined not more than \$250 or imprisoned not more than six months, or both." Colonel Hodges explained that decorations are awarded on a restricted individual basis to military personnel to recognize acts of heroism or outstanding service/ achievement. They are not intended for wear by anyone other than the military person so recognized, and that next of kin of deceased military personnel can only display such awards but may not wear them. This rule applies to all military awards, including those made during the Civil War which now are in the possession of grandsons or great-grandsons.
