For the 24th year approximately 1.000 descendants of the men who fought the Civil War gathered in Gettysburg Saturday, November 15, 1980 to pay tribute to the men who gave their lives that this country might live. The five Allied heads were gathered in front of the statute of Comrad Albert Woolson at Zeigler's grove on the battlefield, in order to lay wreaths and take part in the services which honor the memory of these great men. Comrad Woolson of Duluth, Minn. was the last survivor of the Grand Army of the Republic. He died at the age of 102 on August 2, 1956, Past Commander-in-Chief Elton P. Koch served as master of ceremonies at the dedication ceremonies and General Chester S. Shriver SVR was in command of the parade. G. Henry Roth, editor of the Gettysburg Times was the keynote speaker for the ceremonies held in the Cyclorama on the battlefield with the music being presented by the Lancaster Fencibles.

3. Received the report of the Editor of the Banner and authorized the additional cost of \$200.00 to issue the July 1980 Banner due to the cost beyond the Budgeted amount. Also approved recommendations that the subscription rate of the Banner remain unchanged.

4. Report of the Coordinator for the Membership-at-large and presented a check in the amount of \$423.00 to the National Organization.

5. Approved the sum of \$300.00 from the 100th Anniversary Fund be used toward the special July 1981 issue of the Banner previously accepted as the Special "Centennial Issue."

6. Established the amount of \$300.00 to be used toward the GAR Campfire at the 100th Anniversary National Encampment from the GAR Fund.

7. A sympthy card in the passing of Past Commander-in-Chief Allen B. Howland by sent to his surviving daughter and family.

8. Approved a one page National Encampment Standard Survey Form to be distributed at the Department Encampments for the membership to use regarding their intentions of presence at the 1981 and future National Encampments to help the National Encampment Committee and host hotel in advance planning. Commander-in-Chief will also distribute forms on his travels.

9. Established the amount of \$6.00 for the intest payment on Lite Memberships payable January 1, 1981 to respective Camp Treasurers.

10. The goal for the National Patriotic Instructor for the fiscal year 1980-1981 be set at \$2,000.00.

11. Approved the appointment for PDC Thomas W. Graham (Ohio) as Editor of the Banner for the fiscal year 1980-1981.

12. Approved the acceptance of Provisional Camps.

13. Approved the increase of the membership per-capita tax from .55 per member per quarter to .65 per member per quarter effective with the April 1, 1981 Department Reports. The Jan.-Feb.-Mar.-1981 remains at .55 per member.

Report of

Junior Vice Commander-in-Chief

Your delegates to the 99th National Encampment approved a resolution allowing for Provisional Camps to be organized with as few as five members with regular status granted when fifteen are obligated or at the end of two years.

New York and Maryland Departments are the first to institute new camps under the new rules. In October camps were formed in Osego, N.Y. and Virginia Beach. Va. Prospects are good for forming more camps in the near future.

Following the National Encampment, letters were sent to all Department Commanders and Secretaries requesting a listing of Camp officers in order that contact might be made regarding membership strength and recruiting plans. To date eleven of our nineteen Departments have responded as a result sixty-five Camps have been contacted for an exchange of information and ideas. It is hoped that Camps will share their successes that all may benefit. We must continue to grow if only to overcome attribition. Last year we recruited 334 members and lost 234 for net gain of 100. We organized 3 Camps and lost 2 for a gain of one. There are now 2662 of us in 157 Camps to spread the gospel of our organization and a like number in our Auxiliary.

Libby prison, CSA Remembered

January, 1981

It wasn't the Hyatt nor the Hilton - it was Libby Prison, CSA, Nonetheless, it was the best of accommodations the Confederates had to offer their reluctant Federal guests during the 1861-1865.

In one of the unique events in recent history the Sons of Union Veterans and the Sons of Confederate Veterans joined in re-erecting and rededicating of the historic plaque which had been lost for decades. The plaque marked the original site of Libby Prison in Richmond, Va.

The large bronze marker had first been placed on an old building at 20th and Dock Streets in Richmond in 1911 by the Confederate Memorial Literary Society. But when the building was torn down in the early part on this century the marker found its way to the Lee House. There it lay unnoticed amongst a large collection of memorabilia of that tragic period of our history. It was just recently found by Dr. Campbell. director of the museum and was offered to the Sons of Confideracy.

There an idea was born for its re-erection and rededication and October 4, 1980 at 2 p.m. in the afternoon the Sons of Confederate Veterans and the Sons of Union Veterans held ceremonies unveiling the new Monument, General Chester S, Shriver SVR served as a representative and speaker for the Sons of Union Veterans. A direct descendant of the owner of the old warehouse which became Libby Prison, Mr. Luther Libby unveiled the old historic marker.



The Legislative Report

Appearance of Grant's Tomb --- The controversial mosaic benches built on the site of U.S. Grant's Tomb on New York's Riverside Drive may be removed. Duane Pearson, superintendent of Manhattan sites for the National Park Service, and a member of task force studying the issue, said recently that the panel hopes to have a recommendation ready in December for consideration by the Park Service's regional director in Boston. One possible outcome will be a plan to preserve the benches but remove them to another location. They were constructed in 1973 by community volunteers in an effort to involve neighborhood groups in the project and reduce graffiti at the Tomb. But the "Art Work" is considered by many to be totally inappropriate for use in a memorial erected to one of our nation's Civil War heroes and President of the United States

On October 10, 1980, President Carter signed into law P.L. 96-428 which authorizes the establishment of the Martin Luther King, Jr., National Historic Site in Atlanta, Georgia. Included are 23.5 acres surrounding Dr. King's birthplace which will be used to preserve the neighborhood as he knew it during his formative years.

The Park and Recreation Act of 1980 is still awaiting final action by the Senate before adjournment of the 96th Congress. The House version, H.R. 3, passed that body on May 20, 1980. The Senate's bill, S. 2363, passed the Upper Chamber on June 5, and was amended and passed by the House on June 17. It is this amended version that once more must be considered by the Senate. The bills would create or enlarge several historic parks and sites, many of them relating to the Civil War period.

Massachusetts

We in Massachusetts are most indebted to PDC Ernest Wells for his vision and hard work in establishing the shrine.

Ohio

On Nov. 1, 1980 there was a dedication of the monument and surrounding area in Alliance, which commerates the fact that Mr. Lincoln stopped in Alliance and gave a short talk on his journey to Washington for his inauguration.

The monument is constructed of field stone that was brought from the Lincoln farm in Kentucky.

The campaign to revamp the area surrounding the monument was chaired by the Commander of the Alliance American Legion Post. Past Commander-in-Chief, Richard Greenwalt, and his wife Bea represented the Sons of Union Veterans of the Civil War and Auxiliary wearing their civil war uniforms and period dress.

House supporters of S. 450, a bill to remove federal court jurisdiction in all cases involving school prayers, are making a last attempt to have the Judiciary Committee discharged from responsibility for the measure and force a vote on the House floor prior to final adjournment of the present Congress. The bill passed the Senate in April of 1979. The nation's religious leadership is split on the wisdom of enacting such legislation, Supporters of the bill believe that state courts would look more favorably on state laws designed to permit voluntary prayers in public schools. Opponents abhor any attempt to legislate on the matter and fear that state enacted measures would tend toward intolerance of minority religious beliefs. Lawyers are divided over the issue of the advisability of limiting the jurisdiction of the federal courts in this fashion.

When the 97th Congress convenes in January 1981, the Senate will be without a member who will have served continuously in that body since the presidential years of Franklin D. Roosevelt. Sen. Warren G. Magnuson of Washington State became a member of the Senate on December 15, 1944, and was the President Pro Tempore at the time of his defeat at the polls in November 1980. Sen. Milton R. Young of North Dakota was first appointed to his seat on March 12, 1945, and decided to retire at the close of his present term.
