# California Dedication of the G. A. R. Highway

Shown below is a portion of the large attendance at Long Beach, Calif., where on Sunday, May 3rd the Western Terminus of the Grand Army of the Republic Highway (U. S. No. 6) was dedicated. Immediately surrounding the temporary marker are (left to right) Melville Riggs, then Dep't Commdr.; Vernon T. Cheney, Chairman Highway Committee; Frank Woerner, Chairman of Fund Raising for Memorial; Wm. L. Anderson, P. C. in C.; James R. Riggs, Dep't Chief of Staff; and Woody Cammett.

Thus the longest continuous highway in the United States-3654 miles-beginning at Cape Cod, Provincetown,



Mass., and ending at Long Beach, Calif., was formally dedicated. Promptly at 2 P. M. at the sound of a bugle, invocation was given by Lt. Comdr. W. D. McCabe, Chaplain U.S. N. Then P.D.C. Frank Woerner after a brief review introduced Dep't Comdr. Melville R. Riggs who gave a hearty and sincere address of welcome and then presented the Master of Ceremonies, Comdr. Glenn Skogman, U.S. N. Ret., a member of our Order. Speakers included Hon. Lyman B Sutter, Mayor of Long Beach; Commander-in-Chief F. K. Davis; Beatrice Riggs, N. V. P. Aux.; National Highway Chaiman Vernon T. Cheney; P. C. in C. Wm. L. Anderson; Maj-Gen. Hobart R. Gay, Commanding General 3rd Army Corps; Capt. Minor C. Heine, Commander Long Beach Naval Base; Maj-Gen. C. F. Schilt, Commanding General Fleet Marine Force; Capt. John Trebes, Commander 11th Coast Guard District; Col. Ronald F. Walton, Commanding Officer, 2370 Air Base; and Wilbur Feineman, Capt. U.S. N. Ret. representing the Long Beach Chamber of Commerce Highway Committee.

Music was furnished by the Aircraft Fleet Marine Force Band of Long Beach, with Color Guards furnished by the U.S. Army, U.S. Navy, and U.S. Marines.

# Iowa Dedicates G. A. R. Highway

Simultaneously with the California exercises, Iowa conducted dedication exercises conferring upon U.S. Highway 6, its new official name "The Grand Army of the Republic Highway". The ceremony took place in Des Moines with P. C. in C. Roy J. Bennett presiding. Others on the program included Roy C. Lawson, Nettie LeGrand, Rev. Frederick J. Weertz, Lawrence K. Boutin, Dep't Comdr. Edward Kuba, and Dep't Pres. Amy Noll. Iowa sent scrolls commemorating Oley Nelson, P. C. in C. of the G. A. R., and Henry Bray, the first member of Robert Anderson Post G. A. R. of Waterloo, to be placed in the monument dedicated in Long Beach.

# Highway Dedication in Indiana


The Indiana Dep't participated in the Nat'l Dedication of U. S. Highway 6 as a memorial to the Grand Army of the Republic. Those taking part in the program included Mrs. Harold Kantz. Thomas M. Horn. N. C. Brown, Walter Wellman, S. L. Isaac, Rev. Earl Heimburger, Mrs. H. M. Johnson, State Senator Richard O. Ristine, and the Walkerton High School Band. Color Guards were present from the Veterans of Foreign Wars, American Legion, Disabled War Veterans, Lafayette Navy Club, and Sons of Union Veterans of the Civil War. Participating organizations included our Auxiliary, Women's Relief Corps, Ladies of the G.A.R., Daughters of Union Veterans, and American Legion Auxiliary.

Senator Ristine termed the dedication "The most outstanding event in the history of Civil War men-Ninety years ago the Boys in Blue made history from the Atlantic to the Pacific-In 1860 while at Springfield, Ill., Abraham Lincoln stressed the fact that all men are created free and equal while today men are still struggling for freedom and equal rights".

#### Dedication in Massachusetts & Ohio

The Dep't of Ohio conducted a program on the public square in Cleveland simultaneously with those held in other parts of the country dedicating Grand Army of the Republic Highway. The vital role played in the development of Greater Cleveland and Ohio by U. S. Route 6 was recalled as the route was formally dedicated as Grand Army of the Republic Highway. William G. Rose, representing the Cleveland Chamber of Commerce, reviewed the history of the route and said, "We predict the usefulness and beauty of the Grand Army of the Republic Highway, developing the resources of the great nation we love". Clarence B Woods, Dep't Comdr.; W. C. Thobaben, P.D.C.: Louis Drashler, State Highway Engineer; Brig.-Gen. Richard L. Mc-Nelly: and George A. Green, Deputy County Engineer, also spoke. Ohio acted in 1936 to rename the highway, but other states delayed action until last year.

At the same hour services were held at New Bedford. Mass, at the approach to the Fairhaven Bridge, Exercises were also held in Nevada, and at other points but have not been reported in detail.

The measure was passed by voice vote after adoption of amendments to a Senate-approved bill introduced by Sen. Martin (R) of Penna. The House struck out a provision calling for a fine of \$250 or six months in jail for violators.

The measure will make it an offense against the United States to display the United Nations flag or any other national or international flag equal to or above Old Glory.

One exception, display of the United Nations flag above all others at the United Nations Headquarters. was allowed.

# Reader Agrees With Gen. Grant

In a letter to the Editor of the Newark News on Feb. 28, Charles F. Schrade of Washington, N. J. said, "I was more than pleased to read the comments of Gen. Ulysses S. Grant 3rd pertaining to the lack of patriotic teaching in the nation's public schools. . . . In the 1880s and 1890s groups of men of the Grand Army of the Republic visited the public schools and gave talks that instilled the spirit of patriotism in the hearts and souls of youth. . . . That is the kind of patriotism Gen. Grant speaks of, and war veterans understand. Today it is next to impossible to secure a speaking appointment in the public schools."

#### G. A. R. Office Moved

On June 1st, the Nat'l Headquarters of the Grand Army of the Republic was moved to the Fenton Memorial Building, Jamestown, N. Y.

This building was once the home of R. E. Fenton, Governor of New York State during the Civil War. It is now owned by the City of Jamestown and is used as a Memorial to the Grand Army of the Republic by the various patriotic organizations of Jamestown. For a number of years it was the meeting place of the James Brown Post, G. A. R. of which Past Commander-in-Chief Robert M. Rownd, and P.D.C. Martin V. Stone were members Charlotte Cook Brown Tent, D.U.V.C. W. have held their meetings in this building for many years, and it is fitting that the closing years of Grand Army of the Republic Nat'l Headquarters will be in such a historic building. As long as there is a member of the Grand Army of the Republic living the organization continues, after which the books and records will be placed in the Congressional Library, Washington, D. C., and the flags, badges, official seal, etc. will be given to the Smithsonian Institution.

### Standby Military Reserves

One very important phase of the Nation's manpower problems—that of reserves—is getting some muchneeded intensive consideration in the Defense Dep't.

Under a loosely worded law, little enforced, draftees after completing a two-year tour of duty, are supposed to serve six years either in Federal Reserve organizations or the National Guard. Large numbers of returned draftees have never participated in this duty.

Army studies have been seeking ways to streamline the reserve situation. There are plans to cut down the annual turnover in active forces by relieving service men who take a third year in them from further reserve responsibility or to allow the same future release after three full years in the Organized Reserve or the National Guard.

Still another proposal is to stop deferments of youths 17 to 181/2 who enter the National Guard and, if they remain in it for nine years, can be relieved of active military duty entirely. This is a touchy subject with National Guard officials. But Dr. John A. Hannah, Asst. Sec'v of Defense for Manpower, points out that with 2,000,000 men coming back from active service annually there will be plenty of manpower to keep up both the Guard and the Reserves.

These matters are in discussion stages. They should not be dealt with narrowly, but must be met to maintain for a long period ahead a large backlog of trained men that will keep America's defenses on the sound basis demanded by serious world conditions.

Accompanied by my wife, I visited seven Dep't Encampments—all but one of them in June. Starting with California on the Pacific coast, we concluded these visits with attendance at the Encampment of the New York Dep't at Elmira.

Appreciation goes to the staff officers who represented the Commandery-in-Chief at most of the other Encampments. Nat'l Patriotic Instructor DeHaven, Nat'l Chaplain Brockway, and Nat'l Counselor Bauer trayeled considerable distances on these missions. P.C. in C. Roy Bennett went to Minnesota and Missouri at my request. Others were in attendance in their own Dep'ts. Appreciation is also extended Sr. Vice C. in C. Grant and Jr. Vice C. in C. Richardson for representing our Nat'l Organization on various occasions in different Dep'ts. I have been most fortunate to have such an outstanding staff of officers, and their unfailing consideration is unforgettable. My thanks and gratitude go to them all.

#### National Encampment Features

A feature of the program of the Encompment at Buffalo (which has been printed elsewhere), will be a free 4-hour bus tour to Niagara Falls on Wednesday afternoon, Aug. 26. It will include viewing the Falls from Canada-a most memorable sight.

It has been suggested that we show some of our Lincoln-story pictures on the screen on Monday evening at the Encampment, with historical commentary Considering that we are essentially a historical organization, we have done amazing little to supply historical programs for the use of Departments and Camps. Our place in the national community, it seems to me, has been poorly analyzed and met with in many respects.

# National Encampment Membership

The password having been dropped, paid-up membership cards are now required. The C. & R. designates the voting membership. Dep'ts should note that each is entitled to one delegate, plus one delegate for each fifty members or major fraction thereof, based on its report next preceding the Encampment. It does not count Past Dep't Commanders or Past Commandersin-Chief who are seated in their own right. Members not entitled to participation in business sessions may be

admitted as guests upon payment of the registration fee, but may not vote nor have a voice in the proceedings. Vacancies in the allowed delegate representation may be filled by the Dep't Commander. If not present the chairman of the delegation may act for him.

# Permanent Monument to Replace the Temporary One at Long Beach

The permanent monument designating the western terminus of the G.A.R. Highway cannot be built for two years. An improvement program in its location will raise the grade several feet higher than at present. The plaque that will be used in the permanent monument was placed in a temporary one, and later the temporary monument with a new plaque will be placed somewhere else along the highway.

The Colorado Dep't is planning to build a similar monument where U.S. No. 6 starts into the Rocky Mountains, about 15 miles west of Denver. They held a dedication service at this point in a snow storm on May 3 with State Officials, Veterans Organizations, and a 75 piece band taking part.

PROPOSED AMENDMENT TO CONSTITUTION for consideration of 72nd National Encampment;
The Constitution is hereby amended by renumbering Article 8 as Article 9, and by adding the following new Article;
ARTICLE 8--PERMAMENT FUND
Section 1--The Permanent Pund of the Order shall consist of funds now invested in U. S. Savings Bonds, such moneys as have been or may be given or bequested to the National Organization in memory of a Civil War Veteran, all moneys given or bequesthed to the National Organization and not designated for some other purpose by the donor or testator, and such other moneys as may be added thereto by vote of the Commandery-in-Chief or of the Council of Administration. Moneys given or bequeathed in memory of a Civil War Veteran shall be accounted for under a separate heading as the "Honor Roll Pund".
Section 2--Such funds shall be kept on deposit in some one or

ed for under a separate heading as the "Homor Roll Pund".
Section 2--Such funds shall be kept on deposit in some one or more bank--institutions whose deposits are fully insured to the amount of the deposit, or invested in obligations of the United States or in the securities of corporations or trusts located in the United States, which ascurities are listed or admitted to trading privileges on the New York Stock Exchange or are registered under the so-called "Blue Sky Law" in the State where such corporations or trusts are located, and no investment shall be made in the securities of any corporation or trust which has not paid regular dividends on its common stock, or on its capital stock if it has only one class, for at least three years prior to such investment.

Section 3--All moneys shall be deposited and all investments made in the name of the Order.

Section 4--All moneys given or bequeathed to the National Organization upon any express trust shall be held and the income and principal thereof shall be used only in accordance with the terms of the trust, but the restrictions in this Article upon the investment and use of funds shall apply to Trust Funds, in so far as they are consistent with the terms of the trust.

Section 5--Except as may be provided in the will or donation giving trust funds, no part of the principal of any of the funds covered by this Article shall ever be spent, and all moneys accruing from the sale of rights and all stocks received as a dividend shall be held as a part of the principal of the fund to which they accrue.

Section 6-E9 vote of the Commandery-in-Chief or of the Council of Administration and subject to the restrictions governing any trust funds the income of the funds covered by this satisle accounts; in the year in which such vote is passed, or any portion of such income, may be trunsferred to the General Fund and used for the expenses and purposes of the Order, but any income not so transferred shall be added to the principal.

PROPOSED AMENDMENT TO CONSTITUTION for consideration of 72nd National Encampment:

ARTICLE 3 of the Constituion is hereby amended by changing the period at the end thereof to a semi-colon and by adding at the end the following clause:

"Provided that where a Soldier, Sailor or Marine, who served as aforesaid has left no lineal descendants, lineal descendants of a brother or mister of such Soldier, Sailor or Marine, may be admitted under the same conditions as lineal descendants of a Soldier, Sailor or Marine himself".

ASSOCIATE MEMBERSHIP: addition to Article 7 of the Constitution by adding a new section, to be known as Section

Section 3--Departments and Camps may establish Associate membership. Said Associate Member must be ineligible for full membership due to lack of lineal descent from a Union Veteran of the Civil War. Said Associate Member shall not hold elective office, or be entitled to vote, but he may serve as an appointive officer or as a member of a committee. The wearing of the membership badge is prohibited.
