

LINCOLN TOMB CEREMONY





Past Commander-in-Chief U. S. Grant 3rd appeared in Springfield, Illinois three times on April 15 in connection with

the commemoration of the ninety eighth anniversary of Abraham Lincoln's death.

Church of your Choice

At the seventh annual Memorial Service conducted at the Lincoln Tomb in Oak Ridge Cemetery under the sponsorship of our National Organization, assisted by The Military Order of the Loyal Legion of the United States, General Grant placed the first of 62 wreaths offered by 46 separated patriotic societies and veterans organizations. The General's wreath represented his personal tribute to the man who preserved the Union a century ago. The solemn exercises fittingly honored the memory of our sixteenth President.

Our Commandery-in-Chief colors were carried by the Color Guard of General George A. Custer Camp No. 1, Illinois Department, clad in Civil War uniforms and armed with muzzle loading muskets. The Memorial Salute was fired by a squad composed of two riflemen from the Custer Camp detail and two from the Department of Illinois, Military Order of the Purple Heart.

As in the past, there were two addresses at the Tomb. Commander-in-Chief Chester S. Shriver of our Order recited Mr. Lincoln's February 11, 1861 Springfield farewell and was followed by Lieutenant Colonel Donald M. Liddell Jr., Past Commander-in-Chief, Mollus.

After the service in the cemetery, General Grant addressed a luncheon gathering of 94 quests at the State House Inn, his subject being "A Unique Friendship-Lincoln and Grant." Mayor Nelson O. Howarth of Springfield extended a cordial welcome to the out-of-towners. A moment of silence was observed in memory of Past Commander-in-Chief Richard F. Locke, who passed away shortly after the 1962 ceremony, and Loyal Legion Companion Frank B. Huntington, who died suddenly on April 14, 1963 as he was about to start the journey to Springfield. Both of these gentlemen had taken active parts in organizing the Tomb exercises in the early years. Each person at the luncheon received a plaster Lincoln head presented by the Loyal Legion,

A chartered bus, furnished through the courtesy of the Sons of Union Veterans, operated between the State House Inn and the Tomb.

Co-Chairmen of the Committee in charge were P.D.C. (Illinois SUVCW) George L. Cashman, Curator of the Lincoln Tomb, and James L. High, Recorder of the Illinois Commandery of the Loyal Legion. The other committee members were James M. Blackman, M. J. Burns Jr., Department Commander W. Glen Davis and Carl G. Hodges, all of Illinois.

General Grant's third appearance of the day took place at an evening meeting of the Sangamon County Historical Society, where he spoke on "Grant and Lincoln-The Victorious Team." During his talk, the General quoted his grandfather as having said "Lincoln was the greatest man I've ever known and the day of his death was the darkest day I've ever known." It was fitting that this meeting was held in the Old State House (Sangamon County Court House), since it was here that the first General Grant worked while mustering new regiments into Federal service during the early days of the Civil War; it was here that he received his first commission as an officer in the Union forces; it was from this historic old building that he stepped forth on the road to fame and immortality.

The Historical Society graciously presented Past Commander-in-Chief Grant with a handsome fountain pen desk set mounted on a base of stone taken from Mr. Lincoln's first burial vault and containing a piece of wood from a roof timber of the Old State House.

SCHOLARSHIP

The annual scholarship award of the National Auxiliary was presented by Sister Anna Stoudt, to Ronald Young a member of the graduation class at Scotland School for Veterans Children, Scotland, Pa, on June 1st.

This school was founded in 1895 by the Grand Army of the Republic, for orphans of veterans of the Civil War, and today there are 560 children of veterans of all wars, finding a home and education at this fine school. It is the desire of the Auxiliary to award this scholarship to a descendant of a Union Veteran where possible, however, due to these children coming from broken homes it is difficult to trace their ancestry. Consequently, upon the recommendation of the Superintendent of the school, Dr. Willard M. Stevens a member of the Reading Pa. Camp, the award went to Ronald Young.

Ronald is a Colored boy who was one of the most outstanding members of the graduating class. He has the highest scholastic average; is treasurer of the class; a cadet officer; an outstanding athlete playing football, basketball and track. He was trombone soloist in the band where he won the John Philip Sousa Memorial award for excellence in music.

Ronald has been accepted for admission to West Chester State College, where he will major in higher mathematics. Unfortunately, coming as he does from a poor family, he can expect no financial assistance from them, consequently, Sister Stoudt was delighted to be of some help to this deserving son of a veteran.

SCHOOL PRAYERS

The Supreme Court has made the predictable decision that reading the Bible and recitation of the Lord's Prayer in the public schools is unconstitutional.

The task of the court was to clarify the First Amendment, which asserts that "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof."

The lone dissenter, Justice Potter Stewart (a member of our Order), accused the majority of trampling upon the second guarantee. Justice Stewart contended that "we err . . if we do not recognize as a matter of history and as a matter of the imperatives of our free society, that religion and government necessarily must interact in countless ways."

"UNDER GOD" now threatened. The American Civil Liberties Union has filed suit in Superior Court declaring inclusion of the words "under God" in the United States pledge of allegiance is unconstitutional. Suit started on behalf of Haswell Parker, 51, a Los Angeles high school history teacher who says that he did not belong to any church and objected to being required to take part in a pledge which includes the phrase "under God."

Proposed Amendments to Constitution

For consideration of 82nd National Encampment

Strike out Section 3 of Article 7, and in lieu thereof insert the following

Section 3. The phrase "All male descendants, * * * that are blood relatives of soldiers, sailors or marines,

* * * as used in Article 3 of this constitution is understood and defined to mean all male descendants of a Union Veteran of the Civil War who have a common ancestor, and includes the sons, grand-sons, and greatgrand-sons of such veteran or of a brother or sister of such veteran.

Section 4. Associate Membership (a) Departments and camps may admit as Associate Members those collateral male descendants who are not blood relatives of a Union Veteran of the Civil War.

(b) An Associate Member shall not hold elective office, or be entitled to vote, but he may serve as an appointive officer or as a member of a committee. The wearing of the membership badge is prohibited, except with some distinguishing mark, to be prescribed in Regulations.

(c) No Camp shall, at any time, elect Associates when the number of Associates will exceed one half the number of regular members at the time of such election.

Add an additional section to said Article 7, as follows: Section 5. Honorary Members. The Commandery-in-Chief upon recommendation from a Camp, Department, or the National Council of Administration, may grant honorary membership to persons of acknowledged eminence who are especially distinguished for conspicuous and consistent loyalty to the Constitution and laws of the United States of America, and who have been active and eminent in maintaining the supremacy of the same, and are not known to be eligible for membership in the Order.
