22nd ANNUAL LINCOLN TOMB CEREMONY

The 22nd annual ceremony commemorating the death of Abraham Lincoln took place at the tomb of our 16th President in Oak Ridge Cemetery, Springfield, Illinois, on Saturday, April 15. Wreathbearers representing 75 patriotic and veterans organizations participated in the rites sponsored by the Sons of Union Veterans of the Civil War as assisted by The Military Order of the Loyal Legion of the United States.

After the playing of the National Anthem and the invocation by the Rev. Dr. Harry M. Kreibel, Thomas L. W. Johnson, master of ceremonies, gave a brief welcoming address. Tributes to the memory of Abraham Lincoln were given by Harold T. Beilby, Commander-in-Chief of the Sons of Union Veterans; CDR. William C. Duval, the surviving founder of the cermony begun in 1957; and by COL. Joseph B. Daugherty, immediate Past Commander in-Chief of the Loyal Legion, representing the Commandery-in-Chief.

Following the ceremony, a luncheon was held at the State House Inn attended by 130 persons. Edward G. Pree, Esq., a Springfield attorney, presented a program in sound involving famous military bands and an excellent selection of martial music by American com-

Elements of the 114th ILL. Vol. Inf. Regt. under the guidance of Capt. Robert M. Graham of Headquarters Co., served as an honor guard and provided escorts for the wreathbearers. At the close of the rites the troops fired a memorial salute and taps was sounded by M/SGT. J. Stephen Hall. Capt. Graham also served as a cochairman of the ceremony committee.

Music was provided this year by the Springfield Municipal Band under the direction of Homer Mountz. The band added a great deal to the significance of the occasion. We were also pleased to have with us the Fife and Drum Corps from the 74th ILL. Vol. Inf. Regt. and Camp Fuller of Rockford, David Franz, Principal musician. This group provided traditional fife and drum selections both prior to and following the cermeony.

In addition to Commander-in-Chief Beilby and COL. Daugherty, we were pleased to have in attendance the national heads of the women's organizations that comprise the Grand Army family. They are Marion E. Combs, Nat'l Pres., Auxiliary to Sons of Union Veterans; Henrietta Bodge, Nat'l President of the Ladies of the G.A.R.: Anna E. Kinnison, Nat'l Pres., Daughters of Union Veterans; and Lois M. Didier, Nat'l Pres., Woman's Relief Corp.

Anne L. S. Pritchard, a member of the Dames of the Loyal Legion, represented her Nat'l President, Florence S. Corson.

Thomas L. W. Johnson presided at the luncheon in the absence of Wayne C. Temple. The Loyal Legion's Illinois Commandery presented each of the luncheon guests with a copy of The Story of the Only Home Abraham Lincoln Ever Owned, by Thomas J. Dyba.

Among the many wreaths presented were several from the Sons of Union Veterans and the Loyal Legion. Departments and/or Auxiliaries of the SUVCW represented by wreaths were Illinois, Indiana, Iowa, Missouri, and Wisconsin. TENNESSEE MONUMENT COMMISSION REPORTS PROGRESS

On April 27, 1978 the Tennessee House of Representatives passed H.J.R. #591, a Resolution to urge the Tennessee State Building Commission to approve funding for a Tennessee monument at the Gettsburg battlefield. That same month, Illinois Governor James R. Thompson acknowledged the invitation to Illinois to participate in the "stepping stone plan" (see April 1978 article) and referred this matter to the Illinois Department of Business and Economic Development. Effective May 1, 1978 Mrs. Melanie T. Petroskey of Mannond, Indiana (a member of the Daughters of Union Veterans) became Secretary of the Indiana Division of the Tennessee Monument Commission. Later, on May 23rd, Mr. Frank W. Welch, President of Lincoln Memorial University in Harrogate, Tennessee formally accepted a plan to have the various state stepping stones kept on display in the Abraham Lincoln Library and Museum at the University until such a time as they are ready for installation at the new monument site at Gettysburg. Brother William H. Hendley of Indianapolis, who is Chairman of the Indiana Division of the T.M.C., reports endorsements for the monument project from the Indiana Department of SUVCW and the Indiana Department of the ladies of the G.A.R. Brother Hendley also hopes to attend the National Encampment at Grand Rapids in his efforts on behalf of the monument project

THE LEGISLATIVE REPORT

On April 18, the U.S. Senate consented to the ratification of the second of two treaties concerning the future of the Panama Canal. The second treaty provides for the transfer of the Canal to Panama as of December 31, 1999, and for a phaseout of U. S. responsibility for the operation of the waterway between now and the end of the century. The roll call vote of 68 ayes and 32 nays was identical to that cast in support of the first treaty in March.

Although ratification has been accomplished, legislation relative to the details of the transfer must still be acted upon by both houses of Congress. To date the Administration has not presented its proposals to make the second treaty operationally effective. But already, there are signs that the House of Representatives is restive at having no voice in the process of ratification. Under the Constitution, only the Senate is empowered to pass on treaties negotiated by the Executive. During the Canal debate, however, the Senate refused to consider a proposal that would have given the House a vote on this particular measure alone. On May 9, the House voted to require that the monies from tolls collected from vessels using the Canal become subject to the process of congressional appropriation rather than automatically remain under the control of the Canal authority. This would represent a departure from past practice and although its fate in the Senate is uncertain, the action indicates the mood of the house at this time. More recently, on June 1. the House voted to deny funds to the State Department for use in implementing the provisions of the second treaty. In the coming months we can expect more infighting on this subject.

Followers of the Senate debates on the Canal issue regardless of their persuasion on that matter, were saddened to learn of the unexpected death on June 1 of Sen. James B. Allen of Alabama. Sen. Allen was a master of the rules of the Senate and skillfully used them in defending the principles in which he believed. He respected the rights of the minority side on a given issue and did not believe in the hasty enactment of legislation. Sen. Allen was a vocal opponent of the Panama Canal treaties and was in the forefront of the battle over ratification. Known among his colleagues as a "floor Senator" because of his frequent presence in the Senate Chamber even during what appeared to be routine business, his influence on the side of traditionalism in American politics will be greatly missed.

In the Pennsylvania primary elections held in April, Rep. Robert N. C. Nix of Philadelphia was defeated for renomination by the voters of his party. Rep. Nix chairs the Post Office and Civil Service Committee which considers legislation relative to federal holidays. A subcommittee of that panel has before it several proposals to return the federal observances of Memorial Day to May 30, but to date it has declined to hold a hearing on the subject.

MEMORIAL DAY RESTORATION . . . TIME IS WORKING AGAINST US

July, 1978

Any observor who followed Radio, TV or the printed media over the recent Memorial Day weekend could not help but be struck by what was universally referred to as "the Memorial Day confusion" In many states the traditional May 30th Holiday was observed due. in large part, to the patriotic efforts of organizations such as our own. However, most national businesses and all Federal agencies observed the new "three-day weekend rule". Key Federal support services were closed on Monday (May 29th) and key State support services were closed on Tuesday (May 30th). The impact on certain local Governments and School Districts was so confusing that in the Chicago, Illinois area many schools took a four day weekend rather than try to decide how to handle the situation.

A critical point is raised by the 1978 experience. The various media reporters are calling, quite properly so, for an end to such wasteful confusion. Yet not one reporter observed that Memorial Day has existed for over 100 years (since 1868) without any such confusion. Most of the public do not understand the intent nor the impact of the new Federal laws governing holidays. With the public media calling, virtually without exception, for the fun-packed and economically advantageous three-day weekend there is going to be swift, new pressure brought to bear in those States which observe May 30th. That pressure will stress everything except the nature. intent and meaning of Memorial Day. This constitutes a clear, new threat to our heritage as a people and to the memory of the Americans who died in our various wars.

Let us gain the initiative and start our own campaign to end the"Memorial Day Confusion" once and for all. To end it in the only way that can possibly protect the meaning of that sacred day . . . by removing Memorial Day from the government's list of "funweekend holidays". PLEASE let your position be known to your State and Federal representatives. Call them, write them, nag them. They are elected to represent all of the people, let them know your wishes and let them know that they are being watched.

Keep in mind that each Department Secretary and each Camp Secretary should have filed a Form 990 in accordance with the instructions found thereon WITHIN 45 DAYS AFTER THE CLOSE OF THE ANNUAL ACCOUNTING PERIOD OR FISCAL YEAR OF THE CAMP OR DEPARTMENT. Full compliance with this requirement and the applicable instructions is essential and urgent in order to conform to the original tax exemption ruling of the IRS dated June 11, 1941 and to avoid any penalties.

Failure to comply with this requirement may result in checking by the IRS and/or the infliction of penalties upon the negligent Camp or Department.

Past Commander in Chief Allen B. Howland has been in the Hospital but now is at home and doing well.


Past Department Commander Charles also has been in the Hospital is now at home but will re-enter the Hospital Mon. June 19. for an eye operation.
