

Lincoln Tomb Ceremony

To commemorate the ninety-ninth anniversary of the death of Abraham Lincoln the eighth annual Lincoln Tomb Ceremony was conducted in Oak Ridge Cemetery under the sponsorship of our National Organization, assisted by The Military Order of the Loyal Legion of the United States. A total of 51 wreaths were offered as a solemn tribute to the memory of our sixteenth President.

A ritual team from the Veterans of Foreign Wars posted the colors and the Memorial Salute was fired by a squad composed of members of the Veterans of World War I of the U.S. A.

Two addresses were delivered at the Tomb. Commander-in-Chief Joseph S. Rippey of our Order included Mr. Lincoln's Springfield Farewell Address of February 11, 1861 with his timely remarks and was followed by Commander William C. Duval, USNR (Ret.). Past Commander-in-Chief, MOLLUS, who gave a memorable talk on the principles of patriotism.

After the service at the cemetery, Mr. Harry Page, Director of Public Relations for the Illinois Superintendent of Public Instruction, addressed a luncheon gathering of 90 guests at the Hotel Leland, his subject being "Abraham Lincoln." City Commissioner William Cellini of Springfield extended a warm welcome to those present. At the luncheon three of the five men who were principally responsible for originating the ceremony in 1957 were present. They are Commander Duval, James L. High, Recorder of the Illinois Commandery of the Loyal Legion and a member of our Order, and Past Commander-in-Chief William M. Coffin of Ohio. Each person at the luncheon received from the Loyal Legion an interesting booklet entitled "Little Known Facts About Abraham Lincoln and the Civil War" edited by George L. Cashman.

A chartered bus, furnished through the courtesy of the Sons of Union Veterans, operated between the Hotel Leland and the Tomb.

Cathedral of the Pines

Memorial Day was observed at the beautiful Cathedral of the Pines, Rindge, New Hampshire, when again every State in the Union was represented.

Past Commander-in-Chief Albert B. DeHaven of Maine placed a wreath on the Altar of the Nations on behalf of our Order in memory of our deceased members and the Union Veterans of the Civil War. National Chief of Staff Emma Wheeler of New Hampshire placed a wreath on behalf of our National Auxiliary.

Over fifty wreaths were laid on the Altar by representatives of Veteran and Patriotic organizations. A large wreath was

sent by President Lyndon Johnson, and another from the Kennedy family.

The Altar is made up of stones from every state, and from many battlefields. There are G.A.R. as well as SUVCW and Auxiliary bronze markers fastened in stones furnished by us. A white rose was placed for each of the Governors of the fifty states.

It Wasn't Athens

An article in our January-March issue mentioned the Battle of Athens as the farthest north of the Civil War. Some of our good readers and historians seemed to disagree, which stimulated interesting correspondence.

We are indebted to P. C. in C. Grant for the following: "For a long time I believed it to be so. However, when we came to making up the map for the April 1961 National Geographic Magazine, we discovered that actually the fight in which the Morgan Raid was stopped and the raiders captured at Salineville. July 26, 1863, was further north in northeastern Ohio. Of course, there was also a Confederate invasion from Canada by 30 Confederates in civilian clothes on Oct. 19, 1864 which ended at St. Albans, Vermont. But this can hardly be classed as a fight of the Civil War; it was rather a local bit of mob violence."

- 2. I have been informed that there are yet many who have earned the right to wear the National Ribbon for obtaining five or more new members for our Order during my administration, the names of all of whom have not yet been made known. Will those so entitled please notify me at once so that the distinguishing ribbon may be awarded at once.
- 3. The National Grand Army History Committee is engaged in compiling the story of the Grand Army of the Republic since the last known publication of its history in 1889, and is well advanced in this Centennial undertaking of our Order. Much more information is needed concerning individual departments. Please send all data, proceedings, clippings and information you have or can obtain to Chairman Ernest G. Wells. 121, Tufts Street, Cambridge, Mass. 02139.
- 4. This is the time for each member, Camp and Department, if you have not already done so, to send your contribution to our National Patriotic Instructor Arthur L. Ballou, R.F.D. 1, Bellows Falls, Vermont 05101, for our Grand Army of the Republic Memorial Fund, a most necessary source of funds for financing special projects of our Order. It is my hope that we may proudly announce at the next National Encampment a splendid balance.

5. The 83rd Annual Encampment of the Sons of Union Veterans of the Civil War is hereby called to meet in the City of Providence, Rhode Island, August 16-20, 1964, with Headquarters and all business to be conducted at the Sheraton-Biltmore Hotel.

The following are appointed to the Committee on Credentials: Paul Selby, Ohio, Chairman; Harold Shepardson, Massachusetts; James Blackman, Illinois; Clarence Young, Rhode Island; and Chester S. Shriver, Pennsylvania.

It is suggested that proposed resolutions, other than those of a routine nature, and proposed amendments, be submitted to the National Secretary. Chester S. Shriver, P. O. Box 24, Gettysburg, Pennsylvania 17325, in advance of the opening day of the Encampment to allow ample time for full consideration. They should be in final form when submitted as they will be considered in the form in which received.

Officers will please prepare their reports in writing for reading at the first business session.

Camps and Departments are requested to submit to their Department Secretary and the National Secretary, respectively, full reports promptly when due, to assure the availability of the necessary data for correlation well in advance of the Encampment.

Departments wishing to entertain the National Encampment in 1966, please present to the National Secretary as early as possible invitations from the Department, and the Chamber of Commerce. Convention and Publicity Bureau, the City, or other authoritative agencies.

This being the last General Order of the current administrative year, I take this occasion to express my sincere thanks and gratitude to everyone in all the many places that I have visited and to my many correspondents for the splendid cooperation and courtesies extended to me and for the honors accorded to my office.
