# REMEMBERING THE COMRADES OF THE GRAND ARMY OF THE REPUBLIC

The seventy-five Civil War veterans who rest in the public cemetery at DeWitt, Michigan have been honored by having their individual graves specially marked with reproductions of a Grave Marker / Flag Holder that was originally furnished by DeWitt's George W. Anderson Post No. 58 of the Grand Army of the Republic (G.A.R.). Many of these veterans were G.A. R. members (Comrades) but the Post extended the honor, of specially marking burial places, to all Civil War veterans. The particular style of marker that was chosen by this Post was unique. It was patterned after the membership badge of the G.A. R., with the initials "GWA" (for the namesake of the Post) and "Post 58" being cast within the center-circle of the badge's star.

In 1995, a Camp of the SUVCW was Charted in DeWitt, MI and its membership chose to give new life to the name and number of the G.A.R. Post that had been there. Camp 58 soon set about the good work of inspecting the graves of Civil War veterans and assessing the G.A.R./Civil War related memorials in Michigan's Clinton, Gratiot, and Ionia counties. When it was discovered that only two of the original G.A.R. Markers / Flag Holders "survived the years," the Camp approached the City of DeWitt, asking that consideration be given to funding reproductions of these unique symbols of local heritage. This request was granted, as well as funds being made available for a new 30-foot flagpole to replace one that had been damaged & removed from the G.A.R. plot of the cemetery, years earlier.

The new marker / flag holders were cast in aluminum, the molds having been made from a carving based on the design of the original cast-iron markers. To hinder theft, Camp 58 volunteers set the markers in 2-lb. coffee cans, filled with cement. After the cement hardened, the markers were installed with the top of the cement just below the sod-line, adjacent to the veterans' gravestones. With permission from the cemetery sexton, the government style stones that were sunken or tipped were raised, cleaned and straightened and those that had become weatherworn were replaced with new stones from the Veterans Administration, via labor donated by Camp 58 volunteers.

Not all of the G.A.R. Post 58 members are buried in the DeWitt Public Cemetery. Camp 58 located the graves of 23 other Post 58 Comrades who rest in the cemeteries of six nearby townships and the City of St. Johns. Cooperation was garnered from these local governments to purchase the special castings and allow Camp 58 volunteers to install them.

An additional item helped make the tribute to these veterans complete. A special plaque was commissioned for installation at the base of the new flagpole in DeWitt. It states –

# Council of Administration Meeting November 17, 2000 Gettysburg, Pennsylvania

An informal meeting of the Council of Administration was held at the Eisenhower Inn, Gettysburg, Pennsylvania.

Voting members of the Council of Administration (CoA) present were Commander-in-Chief (C-in-C) Edward J. Krieser, Senior Vice Commander-in-Chief (JVC-in-C) Robert Grim Past Commander-in-Chief (JVC-in-C) Robert Grim Past Commander-in-Chief (PC-in-C) Danny Wheeler, National Secretary Todd Shillington, National Treasurer James Pahl, National Quartermaster (QM) Elmer Atkinson, PC-in-C. and CoA members Gary Gibson, and Donald Darby. Non-voting CoA members present were PC-in-C. Carles Coriman, Andrew Johnson, Alan Loomis, David R. Medert and Richard Schlenker, Attending as a guest was Brother Timothy J. Schaible, candidate for the position of Executive Director.

The meeting began with Brother Schaible telling the CoA about his education and employment experience. He then fielded questions from the CoA concerning the performing of duties of Executive Director. Brother Schaible was provided with the most recent version of the Executive Director service agreement, to peruse outside the meeting, while the CoA discussed the matter. After a brief discussion. Treasurer Pahl moved to offer the position of Executive Director to Brother Schaible, under the same terms as agreed to by previous Executive Director Lyons, with the understanding that the National Headquarters would be available for the performance of his duties, even though it will not necessarily be furnished and operable immediately upon opening. Motion carried.

After returning to the meeting. Brother Schaible was informed of the vote of the CoA, and promised to have an answer to the offer at the meeting of the CoA scheduled for November 19, 2000.

SVC-in-C Powell and QM Atkinson, having investigated the matter, presented proposals and samples to the CoA from Star Printing and Publishing, as a source to print The Banner. After discussion, it was determined to pursue additional information, with specifications different from those quoted, and the allowance of paid advertising.

The meeting was adjourned.

### Council of Administration Meeting November 19, 2000 Gettysburg, Pennsylvania

A meeting of the Council of Administration was held at the Eisenhower Inn, Gettysburg, Pennsylvania.

Voting members of the Council of Administration (CoA) present were Commander-in-Chief (C-in-C) Edward J. Krieser, Senior Vice Commander-in-Chief (SVC-in-C) George Powell, Junior Vice Commander-in-Chief (JVC-in-C) Robert Grim, Past Commander-in-Chief (PC-in-C) Danny Wheeler, National Secretary Todd Shillington, National Treasurer James Pahl, National Quartermaster (QM) Elmer Atkinson, PC-in-C, and CoA members Kent Armstrong, Gary Gibson, and Donald Darby. Non-voting CoA members present were PC-in-C's Charles Corfman, Andrew Johnson, Alan Loomis, David R. Medert, Richard Orr, and Richard Schlenker. Attending as guests were Chief-of-Staff Ron Gill. PDC, Brother Timothy J. Schaible, candidate for the position of Executive Director, and Brother Ken Hershberger, PDC.

The meeting was opened by C-in-C Krieser. PC-in-C Schlenker delivered the invocation.

Secretary Shillington read the minutes of the CoA meeting of August 20, 2000. The minutes were approved. PC-in-C Corfman commented that he is working to add additional microphones to all future National Encampments.

Treasurer Pahl informed the CoA that he would soon be re-investing funds of the Order into higher interest accounts. Rates of return on investments were discussed.

Discussion took place concerning the report of Rebecca Pratt, the recorder and transcriptionist for National En-

campments. Secretary Shillington to contact her, and clarify the National Organization's desires.

Council Member Armstrong suggested that Departments contact Edward J. Duffel, National Committee on Legislation Chairman, in order to find the most effective statutes, to coordinate efforts nationally.

On the recommendation of Secretary Shillington, SVC-in-C Powell moved, seconded by CoA Member Armstrong, that a set of instructions be written to direct Camp and Department Secretaries on the proper completion of Forms 27 and 35. These are to be mailed to all Secretaries, and posted on the Order's webpage. The motion was carried unanimously.

SVC-in-C Powell told the CoA that the Department of Massachusetts JVC informed him that Massachusetts has rededicated part of U.S. Route 6 to commemorate Korean War veterans. PC-in-C Loomis noted that there was Federal legislation passed around 1930,

with each of the States through which Route 6 runs also passing resolutions designating it as The G.A.R. Highway. Discussion took place speculating as to whether legislation was passed in Massachusetts removing the G.A.R. Highway designation from Route 6.

PC-in-C Johnson raised the question of updating the software used by the Civil War Memorials Committee, as noted on the report of Civil War Memorials Chairman and CoA Member Donald Darby. Discussion took place concerning the non-compatibility of Microsoft Access 97, and Access 2000, the current Memorials application being based on the former. PC-in-C Orr expressed his idea that in the near future, the Order's website should be based on Cold Fusion, as opposed to the current HTML, which would allow interactive capabilities. Civil War Memorial and Graves Registration data could be entered directly from a user's web browser to a national database. C-in-C Krieser expressed his desire that the Communication and Technology Committee (Continued on page 7)

work with the Graves Registration and Civil War Memorials Committees to come up with a solution. PCin-C Johnson indicated that action is needed on the issue. Council Member Armstrong suggested that Donald Darby, Richard Williams, PC-in-C Orr and PC-in-C Keith Harrison. Chairman of the Communication and Technology Committee work together to resolve the issues. Council Member Darby agreed to contact Brother Scott Baker, to determine if the code that he wrote for a Graves Registration program would be available to use for this project.

Brother Schaible informed the CoA that he would accept the terms offered in the contract of the Executive Director. Council Member Darby moved, seconded by PC-in-C Atkinson, that Timothy Schaible be retained as Executive Director, effective December 1, 2000. Motion carried.

PC-in-C Orr updated the CoA on accounts to be transferred to Treasurer Pahl for re-investment at higher rates of return.

After discussion of the matter, CoA Member Darby moved, seconded by PC-in-C Wheeler, that the C-in-C appoint a Special Committee to devise a plan to facilitate a Life Membership program, to report to the CoA by January 31, 2000. Before voting took place, further discussion took place, including comments from PC-in-C Wheeler stating that the Membership wants a Life Membership program. PC-in-C Orr provided the CoA with the history of the Life Membership program, explaining how, in its previous forms, it became financially unsound. Treasurer Pahl said questions to be answered by such a committee should include does the Order continue a Life Membership program, if so, how, and under what conditions? If not, why? The motion was carried.

Council Member Armstrong introduced, to be included in the record, an article from the October 2000 issue of The Civil War News, in which are described efforts to restore the G.A.R. Hall of George W. Perry Post 31, of Scituate, Massachusetts.

A motion was made by PC-in-C Wheeler, and seconded by Council Member Darby, to change the password to the CoA Electronic Boardroom, to grant access to incoming Executive Director Timothy Schaible. Motion carried. CoA Members then introduced themselves to Brother Schaible.

Treasurer Pahl moved to terminate Ken Richmond as Editor of The Banner, requiring him, within thirty days, to turn over all materials to the Publisher. make a final accounting, and to present a final bill for services. The motion was seconded by PC-in-C Wheeler, and carried.

PC-in-C Orr announced that the Proceedings for the 1998 National Encampment should be ready for publication in December 2000. Many updates were subsequently given, by PC-in-Cs, of the status of their respective Encampment Proceedings, with many nearing completion.

The subject of approval of a commemorative SVR medal, submitted by Department of Tennessee Commander Frank Harned, to be sold to raise funds for a marker at the tomb of an unknown soldier in Chattanooga, was referred to the Military Affairs Committee.

PC-in-C Atkinson moved to donate \$300.00 from the interest of the permanent fund to assist in paying for the marker for the unknown soldier in Chattanooga. JVC-in-C Grim seconded the motion, which was carried.

Treasurer Pahl moved to decline an offer from United Society of Arms and Armour to produce a collector's edition firearm. The motion, seconded by SVC-in-C Powell, was carried.

PC-in-C Atkinson, Chairman of the National Committee on Remembrance Day, reported on the previous day's ceremonies. Despite a few small problems, most involved, including Gettysburg National Military Park Superintendent John Latschar felt that it was the best program ever done in the park. PC-in-C Atkinson added that due to the amount of work involved, it would be helpful to have the appropriate committees in place at an earlier date. PC-in-C Johnson stated that there were still problems with the parade route, and that two long ceremonies following the parade are excessive.

The meeting was adjourned.

TWO PHILADELPHIA LEGISLA-TORS OPPOSE CIVIL WAR MUSEUM MOVE

HARRISBURG, February 15, 2001 - A priceless collection of Union Civil War artifacts housed in Philadelphia is in grave risk unless steps are taken quickly to protect it, state Senator Vincent J. Fumo and state Rep. James Roe-

buck, (both D-Philadelphia) said today. The Board of Directors of the Civil War Library and Museum is proposing to transfer all or part of the collection outside of Philadelphia, including much of it to a new museum planned in Richmond, Va. This transfer could result in the dissolution of the collection, or the degradation of its historical significance. It might also be illegal, the lawmakers believe. This would be a major cultural and historical loss for the city of Philadelphia, Fumo said.

The museum was founded in 1888 by the Military Order of the Loyal Legion of the United States (MOLLUS), an organization of Union officers and their descendants which assembled the collection. It turned operation of the museum over to a nonprofit board in 1986, but might still have legal rights of ownership to the collection.

The current Commander-in-Chief of MOLLUS, Major Robert J. Bateman, said: The original charter for the CWLM stated that it was to be in Philadelphia. The Union officers and their families who gave or loaned items to the collection thought that those items would remain forever in Philadelphia, and we do not believe it is legally or morally acceptable to the Society's rich holdings of Meade and other Civil War participants from Pennsylvania and adjacent states. 
Today, the 5 x 8 foot U.S. Flag donated by Camp 58 flies "24-7," with lighting provided by the City of DeWitt.




### Department of Florida

On Veterans Day, November 11, 2000, the Lucius L. Mitchell Camp No. 4 of the Florida Department joined with the city of St. Cloud to dedicate a new 12 toot monument and commemorative paque honoring the Grand Army of the Republic and those Union veterans, who in 1909, settled the 'wonder' city

of St. Cloud. The ceremony was conducted by the Commander of the Camp, Ron McCracken.

The G.A.R. and the National Tribune came to Florida and organized the Seminole Land and Investment Company., purchasing 35,000 acres on the south edge of East Lake Tohopekaliga. They held a lottery in Atlantic city, New Jersey, offering building lots at \$50 each to include a 5 acre farming plot just south of town for each buyer. This wonder city soon sprang up as many veterans in their late years had expressed the need for a suitable climate in which to retire.

Upon arrival with their personal effects and families, they lived in tents provided by the Army. In no more than two years the town was up and running with a charter, a downtown district, water and electric plants, and more.


Major General Thomas H. Ruger Camp No. One North Carolina

On Saturday, August 26, 2000, sons of Federal Soldiers and sons of Confederate solders met in harmony to honor a fallen Union soldier 135 vears after his death. Benjamin Frank Powers enlisted January 21, 1865 at Cincinnati, Ohio, He was mustered into Company A, 5th Ohio Cavalry. His unit and regiment marched throughout the Carolinas as part of Sherman's campaign to end the war. Private Powers was stationed at Camp Heath, Morgantown, North Carolina, where he died August 31, 1865 and was buried in the Grace Episcopal Church Cemetery. For 135 years Frank Powers had no marker for his final resting place. Thanks to the work of Jim Pierce, Adjutant and the Col. Samuel McDowell Tate - Burke County Camp No. 9836, SCV Graves Registration Project. Douglas Elwell, Commander, Maj. General Thomas H. Ruger Camp No. 1, SUVCW and the Department of Ohio. SUVCW, that is no longer true. On Friday August 25, Jim Pierce, Doug Elwell, and Richard Bishop prepared the ground for the next day's ceremony by adding a box of Ohio soil sent by that Department to the resting place of Pvt. Powers.

The next day saw prayers, the laying of wreaths, a volley, and the marker unveiling. After the dedication, the SCV and the SUVCW members met for refreshments and the raising of flags. A new American flag and a new North Carolina flag were donated to the Morgantown Library.

# Commandery-in-Chief Sons of Veterans, U.S.A.,

FIRST ANNUAL SESSION, HELD AT PITTSBURGH PA

Headquarters Commandery-in-Chief Sons of Veterans. United States of America Pittsburgh, Pa., Oct. 18, 1882

Pursuant to orders issued by Col. H. T. Rowley, Provisional Commanderin-Chief of the Sons of Veterans, the Commandery assembled at the headquarters of Davis Camp, No. 1, and organized by electing Major John A. Wood, of Garfield Camp No. 3, temporary chairman, and Major John H. Sieferth, of Davis Camp No. 1, temporary secretary.

Representatives present:

Col. Charles M. Morton and I. B. Stanton, of New York.

W. C. Wikoff and W.R. Byers of Ohio.

Col. H. T. Rowley, Maj. John A. Wood. Maj. John H. Sieferth and Lieut. H. W. Wilker of Pennsylvania.

On Motion of Capt. W. C. Wikoff it was resolved that the provisional officers of the Commandery-in-Chief be made the permanent officers until the regular election.

Captain Wikoff also moved that the rules adopted for the government of the provisional organization be made the rules governing the Commanderyin-Chief, excepting New York.

Bro. Stanton moved to amend the motion, so to place New Jersey on the same footing as New York (on the minutes). Amendment accepted, and motion and amendment adopted.

Col. Morton moved that when we adjourn we adjourn to meet at 7 o' clock P.M., and the first business to be transacted at the evening session be that of fixing the revenue to be paid the Commandery-in-Chief by the several Camps. Carried.

On motion, adjourned to meet at 7 o'clock P.M.

#### **EVENING SESSION**

Col. H. T. Rowley presiding and Lieut. H. W. Wilker as secretary.

Colonel Morton offered the following resolution, which was upon motion adopted

Resolved. That a charter fee of ten dollars be charged against each Camp now working under the system of Ritual and Rules as originated by Western Pennsylvania, and that a notice of this action be forwarded to the respective Commanders of the various Camps, and that they be instructed to forward in m. diately to the Quartermaster general the above-named sum. The sum shall entitle the various Camps to a Charter, the necessary number of Rituals, and samples of the blanks required to organized a Camp. On motion the Unwritten Work (signs, grips, etc.), as illustrated by Brother Stanton was adopted.

Colonel Mornon moved that the per capita tax be fixed at fifteen cents per year, until the next annual meeting. Carried.

Report Morton moved that bonds to the amount of \$1,000 (to bear six percent interest he issued in sums of from ten dollars to twenty-five dollars of the control of lars each by the Commandery-in-Chief and the Council-in-Chief (provided that they see fit to do so), in order to relieve the Commandery of any indebtedness that may be incurred.

Brother Stanton moved that we now go, into nomination and election of officers to the Commandery-in-Chief. Carried.

Colonel Morton then moved that when we adjourn, we adjourn to meet between the 10th and 20th of August, 1883, the exact time to be promulgated by General Orders of the Commander-in-Chief. Carried.

The following telegram was then read:
