### ST. LOUIS CONVENTION REPORT

It was hot and humid when we gathered in St. Louis Missouri, Aug. 17-21, but the hotel was comfortable, and the atmosphere was friendly and congenial.

After attending Church Services of their choice, each organization conducted registration of delegates on Sunday afternoon. The SUVCW registration was 83 - Auxiliary was 181 - Ladies of the G.A.R. was 140. Along with family and friends total attendance was well in excess of 400.

An impressive and inspiring Memorial Service was conducted at 3 P.M. on Sunday arranged by National Chaplains B. Franklin Lucas of the the Sons and Mrs. Jessie Wells of the Auxiliary in the Boulevard Room of the Hotel Sheraton Jefferson

The annual Revival of the G.A.R. Camp Fire was held on Sunday evening in the Ivory Room of the Hotel with P.C. in C. Lambert presiding, to a capacity andience from the three organizations. The principal address was given by Dr. Milton Carpenter. Music was furnished by the Military Airlift Command Band of Scott Air Force Base with Lt. Kenneth Green conducting. Distinguished guests included Paul E. Williams, representing the State of Missouri; Sam Louis, representing the City of St. Louis; Commander-in-chief Frank Heacock; Aux, Natl. Pres. Mrs. Irene Murphy: Ladies of the GAR Natl. Pres. Mrs. Erma Landis; and representatives from the Daughters of Union Veterans of the Civil War, Woman's Relief Corps. Military Order of the Loyal Legion, and Dames of the Loyal Legion. A presentation of a Lincoln painting and volumes of the collected writings of Abraham Lincoln were presented to Sister M. Willibald, Librarian of St. Andrew's School by Commander-in-Chief Heacock. Rev. Joseph T. Shocklee asked the invocation as well as the benediction.



Other actions approved included: Report of special committee on Survey was referred to the Council of Administration: Committee on Reconstruction of the Order recommended by the Commander-in-Chief was also referred to Council: the choice of placing the scholarship for the coming year was left to the decision of the incoming Commander-in-Chief; any member serving as Dept. Secy-Treas. for a period of ten years will have the title of P. D. C. conferred; the G.A.R. Highway Committee was abolished to be replaced by an officer to be known as G.A.R. Highway Officer; regulations were amended so that each Department will be entitled to one delegate at large and one delegate for every 25 members or major fraction thereof; the War Medal regulation was amended to include veterans of the Korean and Viet Nam conflict; \$350.00 was appropriated for the Lincoln Tomb service, and \$150.00 for the Remembrance Day ceremony. \$100.00 was appropriated to the Military Affairs committee.

## **RESOLUTIONS ADOPTED**

- 1. Grateful appreciation to the Convention Committee and to the Hotel for courtesies extended for the comfort and pleasure of the delegates.
- 2. Support of the efforts of the Daughters of Union Veterans of the Civil War in their quest for a Congressional Charter.
- The Per Capita Tax from Departments to National was increased to \$1.40 yearly, payable .35c quarterly per member, starting with the December quarter, payable Jan. 1, 1970
- 4. The Constitutional Amendment regarding Associate Members was approved by a vote of 43 to 7. This Amendment will now be referred to the various Departments for approval. It will become effective when approved by eleven Departments.
- 5. The \$1000.00 bequest from the Estate of Gen U. S. Grant 3rd was ordered added to the Permanent Fund.
- 6. Approval was given to the action of the Astronauts in using prayer and bible readings while in space.
- T. The use of the Aircraft Carrier Yorktown in making of motion pictures by private companies was condemned.
- 8. The detornation of Ft. Stevens in Washington, D. C. (where President Lincoln witnessed the battle) was noted and action taken to request cooperation of the Parks Department in restoring and preserving it.
- 9. The action of the authorities at Gettysburg Cemetery in removing fresh flowers the same day they are placed was condemned with a request that this procedure be revised.
- 10. Opposition to organized anarchy was expressed, and that we condemn campus disorders that infringe upon the rights and safety of the vast majority that do not particinate
- 11. That we urge continued appropriations of funds necessary for the National Defense and Security.
- 12. Urge support of police and constituted authority in preserving law and order, and that offenders be punished by the courts to the full extent of the law.
- That we ask the courts stop being lenient in the matter 13. of drug addiction, and that pushers and addicts both be controlled by whatever means is necessary.
- 14. Insists that those in authority have the strength of purpose to uphold the principles of our forefathers and the constitution and to protect those who fight and work to preserve a just and orderly government.

# COUNCIL OF ADMINISTRATION

Referred the report of the Committee on Survey of the Order to the newly authorized Committee on Reconstruction of the Order. This new committee of five to report either in 1970 or 1971.

Authorized purchase of \$2,000.00 in Wellington Fund from the Permanent Fund cash balance.

Suggested a goal of \$1,200.00 in the future for National Patriotic Instructors.

Ordered a letter of appreciation to be sent to each of the children of Gen. U. S. Grant for his bequest of \$1,000.00.

Authorized P. C. in C. Lambert to Edit and Publish The Banner for the coming year.

At the suggestion of the Certified Public Accountant. authorized the Natl. Secy-Treas. to delete inventory from future listing of assets.

# LEGISLATIVE COMMITTEE REPORT

A year ago we reported on the passage in Congress of the Uniform Holiday Act, Public Law 90-363. Under our system of dual responsibility that legislation will apply only to federal employees, installations and residents of the District of Columbia — At the national level Representative Martin B. McKneally of New York State has introduced HR 6247 which would restore Memorial Day to May 30 and Veterans Day to Nov. 11 by repealing a portion of the measure enacted by Congress last year. The bill has been referred to the House Judiciary Committee where it is expected hearings will be scheduled soon. Without a wave of public protest and indignation demanding a return to the traditional dates, it is difficult to see how the measure stands a realistic chance for passage. Nevertheless, those who feel strongly about this proposal - including your chairman - are urged to write Rep. Mc really to express your support on his position and Trunnuel Cellar to urge that hearings to be slated to Rep '7 - As a substitute for personal contacts, brief in HF. 1 but courteously written letters can be effective and Di individual views known. - To help bridge a in more "commun.cations gap" Western Union has devised a new service known as Personal Opinion Message. For 90 cents, Western Union will send a 15 word telegram to the office of the President, your Governor, Representative or Senator, or State Legislator and your signature and address will be inPage Five

cluded free. You need not even know your man's name, Western Union will look it up for you. To send a POM, you need only pick up the telephone. The 90 cents will be added to your telephone hill.

As this report is written, the controversy over the antiballistic missile program continues. - Your committee believes that our President - regardless of party - should be given the tools he believes necessary to carry out his responsibilities as the chief architect of our foreign policy. If the ABM represents such a tool - and we believe it does - our Congress should close ranks behind the President on this issue reserving its right, of course, to exercise surveillance over the execution of the program.

Recently Senator Barry Goldwater, in a Senate speech, made this observation: "Now that we have the industrial capacity to equal the Russians in space or in matters related to defense. there seems to be a nation-wide effort to make us feel guilty . Rather than deploring the existence of a military-industrial complex. I say we should thank heavens for it. It is the bubble under which our nation prospers. It is the armor which is unfortunately required in a world divided."

As members of a patriotic organization interested in preserving our nation's heritage on the one hand and in promoting her future on the other, we have a duty to be vigilant least well-meaning but misguided souls - and those with less honorable intentions - bargain away our hard won advantages and make the cause of a just peace even harder to

Col. Chester S. Shriver, Past Commander-in-Chief, Sons of Union Veterans of the Civil War has been made a member of the Honorary Committee of the Fort Monroe Casemate Museum, Fort Monroe, Virg.

In any close study of history, especially as it concerns prominent public individuals, one must inevitably come to the realization of the truth of Gresham's Law. This law, paraphrased, is "a good reputation is driven out by the bad." And, so it is with the Mary Todd Lincoln legend. A legend which incorporates distortion, half-truths and deliberate falsehoods, foisted upon an unsuspecting public by a vengeful character assassin, whose hatred of Mrs. Lincoln surpasses all understanding.

MARY TODD LINCOLN

The malicious treatment accorded Mary Tood Lincoln before, during and after the White House years, is undoubtedly the blackest stain upon the pages of American history. Mary Lincoln was a woman of culture, charm, warmth and refinement. She was a loving wife and mother, and was responsible, to a large extent, for the success of her husband.

We have many published eye-witness reports with which to substantiate any claim that the Lincolns' domestic life was one of understanding and tranquility. The following is but one random sample of many accounts. "Mr. Lincoln's domestic relations were happy, and his devoted attachment to his home and family was always one of the marked traits of his personal character, in this quiet domestic happiness . .

Where gratitude should be shown to Mary Lincoln, we find condemnation and abuse. Her life was one of tragedy, she witnessed the deaths of three of her four sons, and the assassination of her husband. She had four brothers and four brothers-in-law who served the Confederacy, but her loyalty to her husband and the Union cannot be questioned. Her mind became clouded, but she was never insane, as some historians would have us believe.

It is true that Mary Lincoln was committed, as incompetent, to a private sanitarium at Batavia, Illinois, in 1875. As an inmate she was permitted complete freedom of movement, going wherever and whenever she chose, when accompanied by a nurse or a friend. Four months later she was paroled in the custody of her brother-in-law, Ninian Edwards of Springfield, in whose home she lived until her second trial in 1876. when she was adjudged sane and released. All of which would seem to create doubt that she was ever mentally deranged.

Shortly after her release, Mary Lincoln embarked for an extended sojourn in Southern France, where she remained until 1880. Her reason for going abroad was simply that having been branded with the stigma of insanity, she could not bear to face her friends.

On July 16, 1882, Mary Todd Lincoln, the woman who played a very large part in molding the destiny of the immortal Abraham Lincoln, died, in the quiet of the Edwards home, misunderstood, misquoted, misjudged and much maligned figure. Someday, Mary Lincoln may be awarded her proper niche in America history.


