COMMANDER-IN-CHIEF ALLEN B. HOWLAND

Elected Commander-in-Chief of the Sons of Union Veterans of the Civil War at the 92nd National Encampment held in Palm Springs, California, August 5-9, 1973.

Brother Howland's grandfather, Alonzo Howland, served with Company A, 3rd Massachusetts Volunteer Infantry, during the Civil War.

Brother Howland joined General Hartsuff Camp No. 50, Rockland, Massachusetts, August 18, 1926, and was elected to the office of Camp Commander in 1929. He has served the Camp as its Treasurer from 1937 until the present time.

He was elected Department Commander of Massachusetts in 1928, and has been a member of the Department executive board since 1952. He is also President of the Hartsuff Post Memorial Association, Inc., which operates and maintains the GAR Memorial Building in Rockland, Massachusetts. This building is presently the Headquarters of the Massachusetts Department, SUVCW.

Commander-in-Chief Howland first attended a National Encampment in 1929 and has attended many subsequent Encampments. He has twice served the National Organization as a member of the Council of Administration and has held the offices of National Patriotic Instructor, Junior Vice Commander-in-Chief and Senior Vice Commanderin-Chief.

Brother Howland is currently employed by the Carver Division of Rockwell-International.





NATIONAL PRESIDENT MRS. JESSIE G. WELLS

Elected National President of the Auxiliary to the Sons of Union Veterans of the Civil War at the 87th National Encampment held in Palm Springs, California, August 5-9, 1973.

Her great-grandfather, Abial Cheney, served with the 1st New Hampshire Volunteer Infantry and her grandtather, Carlos S. Cheney, saw service with the 1st Reg't., New Hampshire Vol. Cavalry, Co. C, during the Civil War.

National President Wells became a member of Charles Russell Lowell Auxiliary No. 78, Department of Massachusetts, February 26, 1930. She served as Auxiliary President four times, most recently in 1966, and was elected Department President in 1959. She has previously served the National Organization as Chief of Staff, Personal Aide, Chaplain and Patriotic Instructor.

Sister Wells is also a Past President of the Massachusetts Department, Ladies of the Grand Army of the Republic, a Past President of Roger Wolcott Auxiliary No. 22 Spanish American War Veterans, and Past Noble Grand of Amity Rebecca Lodge No. 15.

92ND ANNUAL NATIONAL ENCAMPMENT

Our 92nd Annual National Encampment was held August 5-9 at the Riviera Hotel and Country Club in Palm Springs, Calif-ornia. It was extremely hot all week, but this did not distrac-from the enjoyment of the splendid accommodations and programs arranged by the California Committee. Everyon are pro-that this was one of the finest of recent conventions. Registration was as follows: SUVCW = 67; Auxiliary = 120; and Ladies of the GAR-76. Though attendance was smaller than usual, everyone enjoyed a week of interesting reports of national officers and committee chairmen, along with purposeful and meaningful discussions, patriotic fellowship and enjoyable entertainment.

A joint opening ceremony of the Sons and Auxiliary Encamp-ments was held on Monday at 9:30 A.M. in the Normandy Ball-room, under the direction of Auxiliary Chief of Staff Jane Greenwalt and National Chief of Staff of the Sons C. Leroy Stoudt. After National President Bremme and Commander-in-Chief Yocum extended greetings, the Sons retired to their meeting room for the opening business session in the Martinique Room. Business sessions were held on Monday, Tuesday and Thursday, with Wednesday as a free day for sightseeing.

On Tuesday evening, an enjoyable banquet, with C. Leroy Stoudt serving as toastmaster, was held in the Normandy Ballroom, and was followed by a reception honoring National Officers of the Sons and Auxiliary.

On Wednesday many took bus trips, and others took the ride on the Aerial Tramway. On Wednesday evening, we were the guests of the California Department at an outstanding show featuring Mr. Ken Delo of the Lawrence Welk T. V. Show and Miss Rose Marie Welch, an outstandingly entertaining singing star.

Other social events during the week included the Past Com-manders-in-Chief and Past National Presidents banquet on Monday evening and numerous State delegation dinners on Wednesday evening.

The Encampments concluded on Thursday with final business sessions and the election and installation of National Officers for 1973-74.

Y.; Resolutions — Harold E. Arnold, R. L; and Visiting Committees — C. Leroy Stoudt and Joseph S. Rippey.

Excellent reports were submitted by National Officers and were referred to the Committee on Officers' Reports for consideration prior to presentation of recommendations to the Encampment.

Outstanding committee reports were submitted by the respective chairmen — Thos. L. W. Johnson, Legislative; George L. W. Cashman, Lincoln Tomb Ceremony; George W. Long, Remem-brance Day Ceremony; Harold E. Arnold, Natl. Military Affairs Committee; and by Kenneth Greely, Natl. GAR Highway Officer.

During the visit of the greetings committee from our Auxiliary, consisting of National President Viola Bremme; PNP Anna I. Stoudt, Chairlady; Penna. Dept. Pres. Claire Monohan; PNP Hazel Moushey; Nat'l. Sec'y. Caroline Riddell; PNP Margaret McKinney and the entire Pennsylvania delegation to the Auxiliary Convention, many gifts were presented. The Ladies of the GAR visiting committee consisted of Natl. President Margaret Orr and all of her Past Natl. Presidents who were in attendance P C in C. Chester S. Shriver responded to the Auxiliary and P C in C. Norman R. Furman responded to the Ladies of the GAR. Letters and telegrams were received from Burton Kannenburg, Wisconsin: Arthur Glenum, Washington, D. C.; George Cashman, Illinois: Frank Heacock, Sr., Delaware; and Thomas L. W Johnson, Wisconsin.

David Gates of California offered to make a new set of stands for our Commandery-in-Chief colors. His offer was accepted gratefully.

It was decided that in the future all candiates for National Office must secure a Department Endorsement to be forwarded to National Headquarters in advance of the National Encampment.

In his report to the Council of Administration, Editor of The Banner Fred H. Combs, Jr. refunded \$220.60. He was given a hearty vote of thanks for the outstanding appearance of our рарег.

In a letter of regret at not being present, our District of Col-umbia Representative, Arthur Glenum, enclosed a personal check in the amount of \$250.00 for use of the Order. A rising vote of thanks was given to Brother Glenum.

National Patriotic Instructor Harry Gibbons reported a net amount of \$1,025.00 for his National Patriotic Instructor Fund. It is from this fund that many of our patriotic activities are financed. Sr. Vice Commander-in-Chief Allen Howland reported contributions of \$200.00 for the 100th Anniversary Fund.

The U.S. Grant Trophy for the Department showing the largest percentage increase in membership was awarded to the Illinois Department. The Illinois Department was also awarded the Harold Arnold Plaque for the greatest number of new members received during the past year.

Jr. Vice Commander-in-Chief Robert Wolz announced that he will award two cash prizes for increased membership during the coming year.

Commander-in-Chief Yocum presented his Officers, Committee Chairmen, and former Commanders-in-Chief with handsome remembrances.

Newly elected officers were installed by Past Commander-in-Chief Norman Furman, with Edwin Kramer as Guide, James Ledwith as Color Bearer, and Clarence Riddell as Chaplain. The Past Commander-in-Chief's badge was presented to Brother Yocum by P. C. in C. Stoudt, and a personal gift of a gold lapel button was presented by National Sec'y-Treas. Shriver.

RESOLUTIONS ADOPTED

Resolutions pertaining to the following were adopted by the Encampment:

- 1. Opposing general amnesty to Viet Nam deserters and draft evaders.
- Condemning deterioration of Ft. Stevens National Park in 2. Washington, D. C.
- 3. Deleting the qualification that requires a member to have served as Camp Commander to be eligible for election to the office of Department Commander.
- Favoring return of Memorial Day to May 30th.
- Favoring return of our educational system to emphasis on 5 the teaching of patriotism in our schools and among our citizens as in former years.
- 6. Favoring elimination of the Electoral College and the holding of one single primary in lieu of the scattered state primaries.
- Supporting insistence upon more effective means to wipe out the horrible national disease of drug addiction.
- 8. Reaffirming our support of the Federal Bureau of Investigation for its dedicated work in exposing subversives, its relentless work in fighting the criminal element, and its overall devotion to the principles of our Nation.

REPRINTED BY DIRECTION OF THE 92ND NATIONAL ENCAMPMENT

(This Directive was Adopted by the 86th National Encampment in 1967 in Chicago, Illinois)

- (A) The Commander in Chief shall promulgate his General Orders and communicate with the membership in a publication to be known as The Banner.
- (B) These orders shall be printed and distributed at least four times yearly, and sufficient quantities be provided to supply one copy to each member of our Order.
- A sufficient quantity is to be sent to each Department Secretary according to the membership of the Department.
- Each Department Secretary is required to mail one copy of each issue of The Banner to each member within his Department within 10 days of the receipt of same.
- (E)The Council of Administration shall elect the Editor of The Banner and determine the amount to be appropriated in each yearly budget to defray the cost.

Changes in the Constitution, as voted at the 1972 Encampment and ratified by the required number of Departments and ordered implemented by the Council of Administration, and changes in Regulations adopted at the 1973 Encampment are effective and in force immediately. (Printed elsewhere in this issue)
- 4. Membership is still our primary concern; therefore, Special Aide designation will be continued for all Brothers recruiting three new members and ribbons will be awarded. In addition, a limited number of Grand Army Special Aide Badges are available and will be presented to Brothers securing six or more members, at least three of which are to be hereditary members.
- 5. All Camp, Department, and National officers are urged to re-read the Constitution and Regulations to become more proficient in their duties. Any help in answering questions will gladly be given by this office.
- 6. To the newly-elected National President of the Auxiliary, Mrs. Jessie Wells, I offer congratulations and a promise of

close cooperation. To Mrs. Della Richards, National President of the Ladies of the Grand Army of the Republic, and to the National Presidents of the Daughters of Union Veterans of the Civil War and the Women's Relief Corps, I extend congratulations and best wishes for prosperous, harmonious and united administrations as leaders of their respective Organizations.

CONSTITUTION AND **REGULATIONS AMENDED**

CONSTITUTION, ARTICLE III, ELIGIBILITY TO MEMBERSHIP (Full text now reads as follows)

"All male descendants, whether through the paternal or maternal line, not less than fourteen years of age, that are blood relatives of Soldiers, Sailors or Marines, who were regularly mustered and served honorably in, or who were honorably discharged from the Army or Navy of the United States of America, during the War of the Rebellion of 1861-65; and who have never been convicted of any infamous or heinous crime, or who have, or whose ancestors through whom membership is claimed, have never voluntarily borne arms against the Government of the United States of America."

Approved by action of 91st National Encampment, Phila., Pa. 1972;

Approved by action of the required number of Departments at their Department Encampments in 1973.

CONSTITUTION, ARTICLE VII, SECTION 3, MEMBERSHIP (Full text now reads as follows)

"Departments and Camps may establish Associates, provided that the number of Associate Members in any Camp shall not exceed one-third of the total membership of the Camp at the time of election. At no time during a meeting of a Camp, a Department, or the National Organization can business be transacted if the number of Associate Members in attendance exceeds forty-nine per cent of the total attendance then present at said meeting. Said Associates must be ineligible for full membership due to lack of lineal descent from a Union Veteran of the Civil War."

REGULATIONS, CHAPTER IV, SONS OF VETERANS RESERVE

(Full text now reads as follows)

SECTION 1. The Sons of Veterans Reserve shall constitute the authorized military feature of the Order. It shall include all military bodies of the Order with the exception that Camps may maintain an independent military organization as a Camp guard or unit for parade and service under the auspices of the Camp with which such unit is associated.

SECTION 2. Effective 1, January 1975, to be eligible for membership in the Sons of Veterans Reserve a person shall be a member of the Sons of Union Veterans of the Civil War, the Auxiliary to the Sons of Union Veterans, the Daughters of Union Veterans of the Civil War 1861-1865, the Ladies of the Grand

Army of the Republic, or the Women's Relief Corps. SECTION 3. The Sons of Veterans Reserve as it now exists or may hereafter be organized shall be governed solely, except as herein stated, by the rules and regulations adopted or subsequently modified or amended by the National Military Affairs Committee upon approval by the National Organization, Sons of Union Veterans of the Civil War. Such rules and regulations shall not be inconsistent with National or State laws or the Constitution, Regulations or general welfare of the Order.

SECTION 4. The combined units of the Reserve shall be known as the National Military Department, Sons of Veterans Reserve. The National Military Department shall be divided into Districts geographically for administrative and command purposes. There shall be no military rank in the Reserve higher than a Brigadier General.

SECTION 5. The uniform and regulations shall conform as nearly as practicable to the less advanced U. S. Army regulations, preferably nearer to those of the Union Army during the period of the Civil War.

The 87th Annual National Encampment, Auxiliary to the Sons of Union Veterans of the Civil War, was held the week of Aug. 5th in Palm Springs, Calif. Healquarters was in the Riviera Hotel and Country Club where all the affairs of the Encampment were held. Accomodations provided by the hotel were most enjoyable and all who attended had a wonderful time. Much credit for the convention must be given the California Department for all the wonderful plans made and for the splendid cooperation of the Department with the committee in charge.

Delegates started arriving as early as Friday, and through Saturday and Sunday the lobby of the hotel was a beehive of activity. Sunday morning many of the delegates attended the church of their choice, and from then on the organization activities took over. Registration of delegates started at 12:30 P.M. and lasted until 3:00 P.M. when the registration was closed so all could attend the Memorial Service of the Sons and Auxiliary. National Chaplains Clarence Riddell and Marion Young are to be complimented on the impressive program prepared for this service. A copy of the program will be printed in the next Banner. On Sunday evening at 7:30 P.M. a Band Concert by the Fleet Marine Force Pacific Band from 29 Palms was enjoyed by all. At 8:00 P.M. the Camp Fire was held, and this program, in its entirety, will be printed in the next Banner.

On Monday morning the joint opening of the Sons and Auxiliary was called to order by National Chiefs of Staff Jane Greenwalt and C. Leroy Stoudt. Nat'l. Aides marched into the room to form an aisle through which the National Officers were escorted and introduced followed by the Past Commanders-in-Chief and Past National Presidents. The theme of the Nat'l. Pres. "Save America, Plant a Tree" was carried out by the placing of silver branches in a stand to form a silver tree which stood in the meeting room throughout the convention. Following a word of welcome to the delegates by C.-in-C. Yocum and Nat'l. Pres. Bremme, the Sons retired to their meeting room to start their business sessions.

Nat'l. Pres. Bremme called the meeting to order at 10:45 A.M. Convention Appointees were named, and the opening of the meeting proceeded according to Ritual with the arranging of the altar and the prayer. The pass word was taken up followed by the flag salute and the singing of the National Anthem and America and the recitation of the American Creed.

Roll call of National Officers, Past National Presidents, Sitting Department Presidents, and Immediate Past Department Presidents was made. Each of the above received a gift from Sr. Bremme with a word of thanks for all their help during the year. Chairmen of Standing Committees and the Chairman of the Convention Committee were introduced and given gifts as were the appointed officers of the National Convention. Recess was called at 11:35 A.M.

The afternoon session was called to order at 1:50 P.M. The first order of business was the reading of the National President's report, which was most interesting and inspiring and which was received with much applause. PNP Margaret McKinney then presented the National President's testimonial of \$200.00 to Sr. Bremme and expressed the thanks of the organization for her year of fine service. National Officers' reports followed. Throughout the week Department reports were interspersed with National Officers' reports and committee reports.

At 3:00 P.M. the National Patriotic Instructor made her presentation of a check for \$350.00 in the name of the Grand Army of the Republic. This money is to be used to erect a Flag Pole in the new Palamar Scout Camp on Palamar Mountain. Native Rock is to be used for the base of the flag pole, and a bronze plaque will be placed on the base designating the name of our Organization as the donor of the flag pole.

The recipients of the check were Mrs. Sanford Newton, Public Relations Committee Chairman of the Girl Scout Council; Senior Scout Linda Renek: Brownie Iris Denmond; and Junior Scout Teresa Candias. Nat'l. President Bremme and PNP Beatrice Riggs also participated in the presentation of the gift to the representatives of the Girl Scout Council.

Mrs. Newton spoke to us of the work the Girl Scout Council is doing and on behalf of the Scouts expressed their thanks for the check. Each of the three Scouts who were present spoke briefly expressing their thanks, and all were enthusiastically received by the members. It was a pleasure to have them attend the convention. Later in the week a telegram was received from Mrs. Newton again expressing her thanks and the thanks of all the Scout Council for our generous gift.

More National Officers' reports followed. The report of the Committee appointed in 1972 to have the Charter re-instated made their report that all matters pertaining to the Charter had been taken care of and that our National Organization was once again in good standing with the State of Ohio where a record of our Charter has been filed. National Secretary Riddell read all correspondence on hand after which the session was recessed at 4:00 P.M.

October, 1973

On Monday evening the annual banquet of the Past Com-manders-in-Chief and Past National Presidents was held. At 7:00 P.M. the Ritual was exemplified by a team from The Penna. Department, and this was followed by the Courtesy Hour. Nat'l. Pres. Bremme and C-in-C Yocum were seated in the front of the room with Nat'l. Officers each side of them. Roll call of Departments was then made, and representatives of the Departments came forward to extend their greetings and bring gifts to our presiding officers. Preference was given at this roll call to the Penna. Dept., the Home Department of our two National Heads. Gifts were later distributed to the other National Officers in attendance.

The Tuesday morning session was called to order at 9:25 A.M. The minutes of the Monday sessions were read and approved. Partial reports were made by the Nat'l. Pat. Instr. and Nat'l. Chief of Staff. Financial reports to be made by these two officers were deferred to Thursday morning. Standing Committee reports were then made starting with the Historical Report and Legislative Report. The Committee on C.R. & R. then reported with a recommendation included in their report to raise the Per Capita Tax from the Departments to National to fifteen cents per quarter per member instead of the eight cents per member we had been paying for so very many years. Following some discussion, this was put to a vote and passed. This increase in Per Captia Tax will start with the end of the December quarter.

The Resolution Committee then gave a partial report. Resolutions had been received from the Past National Presidents' Assoc. changing the term of office of the Nat'l. Secretary, Treasurer and Budget Director from three years to five years, this action to be retroactive to the officers now in office. This resolution was approved by the committee, and the committee was sustained by the convention. The second Resolution was received from the New Jersey Department suggesting that in the future the Pass Word and Grip be eliminated from our procedure, that in place of a password, a paid-up membership card be issued by the Auxiliaries to their members, and that the showing of this card at the door of any Auxiliary meeting would entitle the member to attendance. It was further suggested in this resolution that any reference to password or grip be stricken from both the C.R. & R. and the Ritual. This resolution was approved by the committee and after some discussion, mostly for clarification, the resolution was approved and adopted by the delegates assembled.

The afternoon session was called to order at 1:30 P.M. Nomination of Officers for the coming year was the first order of business. A complete listing of Officers and their addresses appears in another part of this Banner. An addition to the Legislative report was made at this time and ordered incorporated with the report given in the morning. The Ritual Committee then made their report, which was followed by a report of the Committee on Revision of Blanks who offered a revised form for the Auxiliary and Department Secretaries and Treasurers in making their quarterly reports to headquarters. This new form which is a more condensed form, will be in duplicate and will eliminate having to use Duplicate Sec'y, and Treas, report books in the future. These new forms will be distributed by the Nat'l. Secretary as soon as they can be printed.

The Resolution Committee then presented the Courtesy Resolutions which were approved by the delegates and ordered incorporated with the partial report given during the morning session. Reports of the Press Committee and Badge Committee followed. The greetings Committees from the Ladies of the GAR and the Women's Relief Corps were received. On the Ladies' Committee were PNP Erma Landis, Pa.; PNP Marian Leach, N. J.; and PNP Betty Manalatos, Calif. and the W.R.C. representative Irene Rowlands. All extended greetings to the Auxiliary and wished our Organization well in our work. Their visit was followed by an impressive committee from the Sons of Union Veterans who were enthusiastically received by the Auxiliary. All extended their greetings and expressed their appreciation to the Auxiliary for all their help. Following their retirement from the room, the Committee reports continued.

The Rehabilitation report was received, and this was followed by the report of the Committee on Officers' Reports. The results of the action on the various recommendations received will be published in the Nat'l. President's first order. The meeting then recessed at 4:00 P.M.

On Tuesday evening a most enjoyable banquet was held. Plans for this banquet were under the direction of Nat'l. Chief of (Continued on Page 7)

THE LEGISLATIVE REPORT

Following its August recess, Congress returns to the Capitol 10 consider a long agenda studded with several major pieces of peding legislation. One measure that is expected to receive early consideration is the "War Powers Resolution of 1973." In July each house passed its own version of the measure designed to curb the ability of the President to commit U.S. troops to foreign nostilities without congressional approval. A Senate-House Conference Committee has been working on a compromise resolution in the hope that it will be acceptable to both houses. In the event a revised resolution is passed, it could face a possible Presidential veto. When the matter was being debated in the House, Rep. Gerald Ford, the minority leader, read a telegram from President Nixon in which he described the legislation as "dangcrous and unconstitutional." The President did leave the door ajar, however, when he continued, "However, I fully support the desire of members to assure Congress its proper role in national decisions of war and peace, and I would welcome appropriate legislation providing for an effective contribution by the Congress."

Based on the roll-call votes recorded in July, it would appear that the Senate could override a veto but that the House would fall short of the votes necessary to overcome a veto message.

Under the Senate version, troops could be committed for 30 days before the President would be required to seek congressional authority to continue overseas hostilities. The House measure would expand the emergency period to 120 days before legislative approval would have to be sought. In addition, the House version would permit Congress to order termination of hostilities at any time by passage of a concurrent resolution which would not be subject to veto action.

Sen. Barry Goldwater of Arizona and Sen. John Tower of Texas led opposition in the Senate to the War Powers Resolution. Scn. Goldwater argued that the measure "clashes with the true division of powers" between Congress and the President as outlined in the Constitution. He observed, "The truth is that the Founding Fathers intended for the President to be charged with primary responsibility for the nation's safety."

The House version was guided to passage by Rep. Clement Zablocki of Wisconsin, the ranking member of the House Foreign Affairs Committee. Rep. Zablocki had been a stalwart supporter of our involvement in Southeast Asia but believes that Congress must assert itself in dealing with the warmaking power. In his judgment the 120-day period specified in the House resolution should give the President ample time to deal with true international emergencies.

The issue of the proper exercise of Executive authority is not new. In the early years of the Eisenhower Administration some 20 years ago, the ill-fated "Bricker Amendment" attempted to deal with the treaty-making power and the authority of the President to make Executive Agreements with foreign countries that had the effect of law. Ironically, some of the most outspoken supporters of the War Powers Resolution today bitterly opposed all efforts to curb the effects of the treaty-making power two decades ago. * * *

At last count Veterans Day will be observed on November 11 in 30 States, the most recent converts being Idaho, Kansas, Louisiana, and South Carolina. In Kansas, however, the November 11 date will not become official until 1976.
