Regular business should be referred to the office of the National Secretary-Treasurer, Box 24, Gettysburg, Pa. 17325.
- 2. Department of Massachusetts is commended for the excellent arrangements and service given as hosts of the National Encampment.
- 3. Standing Committee appointments have been made and all officers, Committee chairmen and members have been notified. All previous appointees are hereby relieved and gratitude offered to those who expended so much time and energy for the good of the order. It is expected that all retiring officers and committee chairmen will effect a smooth transfer of information to their successors.
- The Committee on Legislation will pursue efforts to return Memorial Day to May 30.
- John B. Davis of Virginia Beach, Va. is appointed Aide to act as liaison to USS Monitor National Advisory Committee.
- Jerome L. Orton of Syracuse, N.Y. is appointed Aide to co-ordinate the writing of the History of SUVCW.
- Graves Registration Officer William W. Vanderhoof will compile a register of burial sites of our qualifying Civil War ancestors as they are furnished to him.
- 8. Brothers who recruit three new members will be appointed Aide and will be issued a National Ribbon to be worn through the next National Encampment. Those who recruit five new members will be awarded a Certificate of Merit.
- Members are reminded of the support needed for the National Patriotic Instructors Fund to uphold our patriotic work and the

- Sr. Vice Commander-in-Chief's Fund to continue promotion of our Order.
- 10. Camps are now electing new officers for the next year. We congratulate those assuming new duties and pray that they may give inspiring leadership which will result in a closer and growing brotherhood.

At 10 am, the first business session of the Sons was opened in ritualistic form by Commander-in-Chief Harry Gibbons. The reports of all our national officers proved our trust was well placed in their election a year ago and a deep dedication to serve was seen throughout all national committee reports.

The Commander in Chief and National Secretary urged continuance of our national projects: Lincoln Memorial, Lincoln Tomb, Cathedral of the Pines, GAR Scholarship and GAR Remembrance Day. In all, the delegates concurred.

Secretary Shriver's report revealed Honor Roll contributions of \$181.50 and Life Membership purchases of \$850.00. Both these amounts invested in our Permanent Fund. New Members exceeded losses by 21 and 4 new Camps were chartered this past year. PC-in-C Fred Combs, Jr. chaired a certificate committee that presented a new Tri-color Membership Certificate. This attractive design was approved by the delegates and will be available in the near future from Natl. Headquarters at a cost of \$5.00 each.

Two social groups held early morning breakfasts. The SVR Club on Tuesday and the new Masonic Club on Wednesday morning. Both clubs are purely social whose name indicates their interest. No club officers or dues exist in either club.

The Allen Howland Award for total membership gain by a Department was presented to the Dept. of Pennsylvania.

The Constitution & Regulation Committee was one of the hardest working committees with a number of proposed changes submitted to it this year. The text of the adopted amendments appears in this issue of the Banner.

Natl. Patriotic Instructor James Marley gave his financial report of \$1776.00 collected for the GAR Fund with the heartfelt thanks of all Brothers.

The Budget Committee offered a balanced budget of \$24,000.00 which was read and approved.

The final report of the Credential Committee listed 84 registered delegates, 17 not present with 67 delegates voting and present.

Within minutes of the Wednesday noon closing of the encampment, the election and installation of our 1983 officers was held.

Next year's National Encampment will be held Aug. 14-17, 1983 at the Holiday Inn, 88 Spring St., Portland, Maine. We hope you'll plan your vacation to be there.

#### AMENDMENTS ADOPTED

The following are amendments to the SUVCW Regulations adopted at the 101st Natl. Encampment:

- Chapter III Article II Membership Section 5, on the subject of life members, there is added at the end of the section the words "No per capita tax shall be paid to the National Organization on life members."
- Chapter III Article IV Officers Section 3 The Commander-in-Chief shall appoint all other officers, etc., there is added at the end of this section the words, "except that he shall not appoint the Editor of the Banner."
- Chapter V, Article I Section 2, General Regulations, the subparagraph C is deleted in its entirety. Subparagraphs D & E are renumbered C & D, and D is amended to read "Each Department Secretary is required to mail a complete mailing list of the Department to the editor of the Banner on or before January 1st of each year", and a new section E is added that reads: "The editor of the Banner is required to mail one copy of each issue of the Banner to each member of the Order."
- Chapter V, General Regulations Article III Badges and Decorations Sec. 4 add a new paragraph at the end "Brothers may wear as a buttonhole decoration a red, white and blue rosette not to exceed 5/8" in diameter, the central circular disk to be divided into four segments more than half the area being devoted to opposed segments of blue alternating with white, and the band to be composed of alternating red and white.
- Other proposals regarding badges were tabled until next year's encampment.
- The following amendment to the Constitution was adopted by a twothirds vote as required and it is now in order to submit the same to the Departments for ratification before the 1983 Natl. Encampment:

Article VI Formation and Disbandment, Delete from Section 3, "to consist of five or more camps with a minimum aggregate membership of one hundred and fifty members." Thus causing it to read: Section 3: A Department may be formed by authority of the Commander-in-Chief. Add a new Section 4 reading: A Provisional Department may be created in states having 3 or more regular or Provisional Camps. The Commander-in-Chief may call a meeting for the purpose of organizing a Department and election of Department Officers, After one year a Provisional Department shall be granted permament Department status by the Commander-in-Chief. Sections 4 & 5 renumbered 5 & 6".

### "The Lincoln Tradition"

It is doubtful if any natural mother could have shown more kindness and understanding than did Sarah Bush Lincoln in rearing her stepson, Abraham Lincoln. While Sarah could not read or write, she had a deep appreciation for education and she encouraged the young Abraham to take every opportunity to read and study. The much maligned father, Thomas Lincoln, sympathized with his son's ambition for an education and sent him to subscription schools whenever there were any in the neighborhood.

The marriage of Thomas Lincoln and Sarah Bush Johnston was significant in bringing together in a humble but comfortable cabin home a widower, a widow and two families of orphan children into one happy and loyal family group. That event came at a most opportune time when the Lincoln children had been deprived of motherly care and affection for more than a year.

Sarah was a kind and loving mother, showering her affection without distinction among all of the children and creating a congenial and helpful home environment for the rearing of a boy of destiny.

Much emphasis has been placed about the early home surroundings in Kentucky and Indiana which has supplied a wholly distorted and unfortunate picture of Lincoln's youth. Abraham Lincoln was most fortunate in the women in his life.

Nancy Hanks Lincoln, his mother, who supplied the moral and spiritual home atmosphere of his early years; Sarah Bush Johnston Lincoln, a most remarkable stepmother, who gave him the much needed love and devotion, the inspiration and encouragement which sparked his ambition for betterment, and Mary Todd Lincoln, his wife, a woman, of culture and refinement, who in many ways was responsible for his success.

Abraham Lincoln manifested his great love and concern for the kind step-mother throughout his lifetime in many ways. Of Sarah he said that she had been his best friend in this world and that no son could love a mother more than he loved her.

Lincoln is quoted as having said, "All that I am, or hope to be, I owe to my angel mother." Of whom was he speaking? Was it his mother, Nancy Hanks Lincoln, or was it his beloved stepmother, Sarah Bush Lincoln? We shall never know.

### Legislative Report

Status of Memorial Day-Any possibility of action on measures to return Memorial Day to May 30 appears to be dead for the remaining months of the 97th Congress. In a recent letter from Rep. Robert Garcia, chairman of the Subcommittee on Census and Population, he stated, "I regret to advise you that there does not presently exist widespread support for changing the holiday observance. Consequently, we do not plan, at this time, to initiate any action on the bills."

Enactment of Public Laws-During the past year, several events, significant dates and individuals that have played prominent roles in our history have been recognized through legislation, some of which is listed as follows:

- P.L. 97-28 to designate the week of March 7, 1982 as "Women's History Week."
- P.L. 97-32 to designate August 13, 1981 as "National Blinded Veterans Recognition Day."
- P.L. 97-43 to designate September 13, 1981 as "Commodore John Barry Day,"
- P.L. 97-131 to designate the week beginning with the third Monday in February as "National Patriotism Week,"

Commodore John Barry's name may not strike a responsive note with everyone. However, he is considered to be the holder of the first commission granted in the U.S. Navy and commanded the Lexington, the first ship purchased and equipped by the Continental Congress for sea duty in the Revolutionary War.

Other legislation recently signed into law by President Reagan included a measure to designate July 9, 1982 as "National POW-MIA Recognition Day." and a bill to authorize construction of a memorial to Franklin D. Roosevelt in Washington, D.C.

- S. 2387 to designate the birthday of President Franklin D. Roosevelt, January 30, as a national holiday.

#### "THE BLUE AND THE GRAY"

"Bruce Catton's The Blue and The Gray." an eight-hour mini-series set during the American Civil War is planned for broadcast on the CBS Television Network in November with Stacy Keach and John Hammond in the starring roles

According to William Self, Vice President Motion Pictures for Television and Mini-Series. CBS Entertainment," 'The Blue and The Gray' is the most ambitious television project the Network has ever undertaken." Five years in development, the drama covers the tumultuuus period of American history from John Brown's trial and hanging in 1859 to Abraham Lincoln's assassination in 1865. The story includes 781 scenes, all of which were filmed on location at 102 different sets in northwest Arkansas and Oklahoma, Many of the battle scenes were filmed at Prairie Grove Battlefield State Park site of an actual Civil War battle in Arkansas in December 1862.

The production utilized 175 speaking roles, 4.500 extras, hundreds of horses, and a wardrobe whose replacement value has been ascertained at \$20 million. Cameramen shot 410,000 feet of film, of which 44,020 will appear on screen.

"Bruce Catton's The Blue and The Gray" is based on two-time Pulitzer Prize-winning historian Bruce Catton's personal views and impressions of the American Civil War.

The plot focuses on two related familiesone in the North and one in the Southwhose lives become interwoven by the various momentous events of the Civil War. The central character who serves as the most prominent link between these families is John Geyser (John Hammond), a talented young artist who leaves his family farm near Charlottesville. Va., to work as an illustrator on his uncle's newspaper in Gettysburg, Pa.

John's first assignment is to cover the trial of abolitionist John Brown. There, the young illustrator meets Jonas Steele (Stacy Keach), a spy, scout and personal bodyguard to Abraham Lincoln. Throughout the next six years, John's encounters with this mysterious government agent will help to shape the boy's life.

With the war imminent, John returns home, where he witnessed the murder of a free black man on the Geyser farm. Shaken, the youth leaves Virginia and refuses to ever defend his native soil. Yet he also finds himself unable to fight for the North, since that might force him to bear arms against his brothers in the Confederate Army.



H.R. 2327 would increase the maximum penalties for desecration of the U.S. flag from one year's imprisonment and/or a \$1,000 fine to five years' imprisonment and/or a \$5,000 fine. No action has been taken on the measure by the House Judiciary Committee.

Memorial to Vietnam Veterans-The memorial to veterans of the Vietnam War will be completed in time for its dedication on Veterans Day, November 11, 1982. For a time earlier this year it appeared that the fate of the project might be in doubt due to the original design of the memorial which was to include no flags, statues or other reminders of the military contribution to the war. Last January, Interior Secretary James Watt withdrew his initial approval of the design and called for revisions to meet the critics' objections. After intense negotiations, it was agreed that the design would include an American flag, a larger-than-life statue of an American soldier, and in the words of Secretary Watt, a "better and proper" inscription that will bring "honor to all 2.7 million Americans" who served in the war
