# The Camp Fire of the Grand Army of the Republic Revived by their Descendants

The program started at 7:30 P. M. with a concert by the band. A combined Color Guard representing Sons of Veterans Reserve, Homestead Air Force Base, and the American Legion, was under direction of Maj. Howard Dissinger. The group was welcomed by Past Commander-in-Chief, U. S. Grant 3rd. Outstanding addresses were delivered by United States Senator Spessard L. Holland (Florida), Mayor Melvin J. Richard, and Hon. Geo. A. Wells of Massachusetts. Each National President was called upon, as well as P.N.P. Grace Hahn representing the National Woman's Relief Corps. Miami Beach Mayor Richard distributed Keys to the City. The entire program was televised over CBS-TV. "Taps" were sounded and the Colors were retired by the combined Color Guard.

# Miami Beach Encampment Report

From August 18th through August 22nd, the officers, delegates, members and friends were treated to a truly memorable program at the 82nd National Encampment, along with the 77th National Encampment of our Auxiliary, and the 76th Annual Convention of the Ladies of the Grand Army of the Republic. Actually a very great number came several days in advance of the Encampment and stayed several days after it was over, taking side trips to all parts of Florida and to

All three organizations were housed at the fabulous Deauville Hotel, where all business and social functions were held. Registration was as follows: SUVCW 96, Auxiliary 186, Ladies of the G.A.R. 126. Each organization also had nonvoting members and guests in attendance.

Delegates attended the church of their choice on Sunday morning. In the afternoon each organization registered delegates and at 3 P. M. the SUVCW and Auxiliary conducted Memorial Service under direction of their National Chaplains in the Napoleon Room. The entire program will be printed in the proceedings.

The Joint Opening of the SUVCW and Auxiliary was held on Monday morning in the Napoleon Room. Business sessions of the SUVCW were held Monday, Tuesday, and Thursday in the Charlemagne Room.

On Monday evening, the annual banquet of the Past Commanders-in-Chief and Past National Presidents was held in the Charlemagne Room, which was followed by the Auxiliary Courtesy Hour at 7:30 P. M., and at 9 P. M. a Water Show was presented in the beautiful Deauville Pool, courtesy of the Convention Committee. Everyone was pleased with the graceful swimming, diving, and the comedy routine of the performers.

The SUVCW and Auxiliary banquet was held on Tuesday evening, in a dream setting. The beautiful Napoleon Room looked like a movie set with it's floral decorations and arrangement. A feature of the banquet was the performance of Johnny Morgan, an outstanding comedian of night club and television fame. Following the banquet a reception and dance was held in the Charlemagne Room honoring the National Officers of both organizations. American Legion Natl, Vice Commander Pascal C. Reese gave inspiring addresses at the banquet, and also at our meeting.

Wednesday was a free day. A courtesy boat trip was provided to all delegates on beautiful Biscayne Bay. Members and friends enjoyed this trip, did some shopping, and many enjoyed the luxury of the Deauville swimming pool and ocean bathing. With business sessions starting at 11 A. M., many availed themselves of the pool and ocean each morning.

On Wednesday evening, an authentic Hawaiian Luau was held with all three organizations participating. Close to 400 persons enjoyed the exotic food, entertainment and dancing to make this one of the features of the Encampment. The Hula, Fire Dance, and Sword Dance was performed by native performers. The ladies amateur Hula contest was won by Hazel Moushey of Missouri, while the men's amateur contest was won by Chet Shriver and Frank Heacock. Winners received bottles of champagne as prizes.

Following the close of business sessions on Thursday, the New Jersey Department sponsored a dance and entertainment in the Charlemagne Room at 9 P. M. for the entire delegation of the SUVCW and Auxiliary. Music was furnished by Billy Bellac and his orchestra, featuring the dance team of Tanya and Biagi, and Helene Darcel, Parisian comedienne.

The entertainment throughout the week was outstanding, aided and abetted by fine performances by our own Mary Gordon of the Massachusetts Department.

On Sunday evening, following the Camp Fire, Col. Rolfe R. Holbrook of Coral Gables, Florida displayed a valuable collection of Civil War mementoes and badges.

## Business Sessions

Were held in the Charlemagne Room. The first session was called to order promptly at 11 A. M. on Monday.

Commander-in-Chief Shriver appointed Hiram Nichol of Pennsylvania (a member for 66 years) to fill the chair of Jr. Vice Commander-in-Chief during the Encampment.

The following committee chairmen were appointed: Credentials, Arthur L. Ballou of Vermont; Press, Albert C. Lambert of New Jersey; Officers Reports, Albert DeHaven of Maine; Resolutions, U. S. Grant 3rd of Washington; Constitution and Regulations, William M. Coffin of Ohio; Ritual and Ceremonies, Harold E. Arnold of Rhode Island; 1965 Encampment City, Fred E. Howe of New York: Fraternal Greetings, William M. Coffin of Ohio. The entire SUVCW convention accompanied the Fraternal Relations Committee to the Auxiliary and to the Ladies of the G.A.R. P.D.C. Charles A. Brady Jr. of Illinois acted as Convention Guide. The following Resolution was adopted by all three organ-

1. That we urge the continued appropriation of the funds necessary for the National Defense and Security.

2. That we urge the balancing of the National Budget by eliminating as rapidly as possible expenditures for Foreign Aid, and other Federal Aid projects which are the means of encroachment by the central government on the responsibilities and prerogatives reserved to the states by the Constitution because "he who pays the piper calls the tune." This will eliminate much wasteful extravagance and unnecessary government employment,

3. That, as a means to return the functions of the Federal Government to those prescribed by the Constitution, we urge the adoption of the Liberty Amendment.

4. That we believe our national safety requires the elimination, as rapidly as possible, of the Communist base in Cuba and firm insistance upon the carrying out of obligations assumed in the past by the Soviet Govern-

5 We emphasize that the abolition of slavery was achieved by our ancestors in the Civil War, together with the protection guaranteed the non-white citizens by the Constitutional Amendments adopted immediately afterwards. We have noted with interest the great advances in education, prosperity and civilization made by American negroes during the intervening years, and we favor full enjoyment of the rights of citizenship, but not of special privileges that encroach on the rights of their fellow citizens of other races.

#### Other resolutions recommended that:

- A. November 19th be proclaimed as "Dedication Day," this being the Anniversary of the date on which President Lincoln delivered his Gettysburg Address.
- B. That we urge passage by Congress of the Bill now before the Judiciary Committee to restore posthumously, full rights of citizenship to General Robert E. Lee.
- C. That we endorse H. R. 1101 to provide for the establishment of the Fort Delaware National Historic Site at Delaware City, Delaware,
- D. That appreciation be extended to the New Jersey Department for providing such an outstanding, interesting and agreeable Encampment; to Hon. Melvin J. Richard, Mayor of Miami Beach for his attendance and address of Welcome at the Camp Fire; to Col. Henry B. Hohman, Base Commander, Homestead Air Force Base, for contributing Colors and Color Guard for our Camp Fire, which brought the desired patriotic note to the occasion and added immeasurably to the colorfulness and dignity of the ceremony; to Thomas F. Smith. Executive Director, Miami Beach Convention Bureau. for their cooperation and assistance in making our Encampment here a great success; to Don Coplin, Convention Coordinator, Hotel Deauville for the unfailing cooperation and effective assistance given by the staff of the hotel in providing for our needs during our Encampment; to Col. Rolfe R. Holbrook, for his attendance at the Camp Fire and for providing the display of a part of his collection of Civil War mementoes; to Albert C. Lambert, covering his services as National Secretary-Treasurer; and to Encampment Stenographer Mrs. Annamae Berhalter, covering her services for the past twenty-two years.

Richmond, Virginia (the Capitol of the Confederacy) was selected as the place for the 1965 National Encampment. The 1964 National Encampment will be held in the city of Providence, Rhode Island.

The Encampment voted to send a telegram of good will to the National Convention of the Daughters of Union Veterans of the Civil War, in session in Cleveland, Ohio at the same time that we were in session.

Our National Auxiliary greetings committee was composed of the entire Pennsylvania delegation, with P.N.P. Katherine Joyce as Chairman. Personal gifts were presented to Commander Shriver.

The Pennsylvania Department then presented Commanderin Chief Shriver with a chest of Sterling Silver as a token of their affection

The Silver Loving Cup donated by P. C. in C. Grant for the Department showing the largest net increase in membership for the past year was won by the Departments of Wisconsin and Indiana. These two Departments each ended the year with the exact same percentage increase. The Cup was presented to Edward Biering, Dept. Secv. of Wisconsin by General Grant. The Wisconsin Department is to hold the Cup for six months, and then turn it over to the Indiana Department to hold until the next National Encampment.

National President Anna I. Stoudt, accompanied by her Personal Aide, Mrs. Irene Murphy, and Mrs. Ruba Shriver and Daughter Donna paid a courtesy visit at which time the National President presented our National Organization with a love token of \$500.00.

National Secretary-Treasurer Albert C. Lambert tendered his resignation effective March 31, 1964. During election of officers, Chester S. Shriver was elected to take over the duties of National Secretary-Treasurer on that date.

#### ALTAR CLOTH

By action of the Encampment, an official Altar Cloth is to be used in the future, and that General Instruction 5. Page 3 of the Ritual be changed to read;

"The Altar will be placed in the center of the room. It will be covered with an Altar Cloth of solid blue color for Camps, red for Departments, and gold for National, and resting thereon will be a bible. The Color Bearer will arrange the Altar, and Station Banner.'

The office of National Recorder was authorized for one more year as an experiment, and the name of the office is to be changed to National Genealogist.

National Patriotic Instructor, Clark W. Mellor of Massachusetts reported an excellent fund of \$911.02 which will be used to finance the special appropriations from the G.A.R. Memorial Fund. He, and the entire organization are to be complimented.

The National Military Affairs committee was authorized to continue for one more year. It was recommended that we encourage voluntary contributions, for their expenses,

Each Department is urged to review it's By-Laws, and if necessary make changes to conform to the C. & R., and that a copy of each Department By-Laws be filed with the Commander-in-Chief and the National Secretary-Treasurer before the 1964 Encampment.

Annual observances at the Lincoln Memorial, the Lincoln Tomb, the Cathedral of the Pines and the G.A.R. Remembrance Day at Gettysburg were authorized for the coming

The Council of Administration authorized the placing of a \$250,00 scholarship this year at Gettysburg College. They also authorized P. C. in C. Albert C. Lambert to edit and publish The Banner for the coming year.

Constitutional Amendments approved at the Miami Beach Encampment will be submitted to the various Departments for consideration at their 1964 Department Encampments.

Newly elected officers were installed by P. C. in C. Fred E. Howe of New York. As the outgoing Commander-in-Chief had received his Past Commander-in-Chief badge last year, a Life Membership was presented to Brother Shriver on behalf of the Order, by Past Commander-in-Chief U. S. Grant 3rd.

The seventh Annual G.A.R. Remembrance Day service will be held on Saturday, November 16th at Ziegler's Grove, Gettysburg Battlefield, at 3 P. M. National and Department Heads of all the Allied Orders are expected to be present for the program arranged by Camp 112. Maj-Gen. Thomas R. White Jr., Adjutant General of Pennsylvania will be the speaker. Music will be furnished by the 125 piece Gettysburg High School Band in Civil War uniforms. The 33rd Dedication Day dinner sponsored by the Past Commanders and Past Presidents Assoc, will be held at 6:30 P. M. in the Hotel Gettysburg. An excellent program honoring the 100th anniversary of Lincoln's Gettysburg Address will be presented. Reception to Penna. Dept. Commander John H. Stark will follow the program, at 9:30 P. M.

On Sunday, Nov. 17 the opening of the Civil War Conference will be held at Gettysburg College. This will be televised nationally with Edward R. Murrow narrating the 100th anniversary.

The National Aides-twenty-four in number-entered the room each carrying a large Florida palm leaf to which had been fastened a light. Standing in two lines they formed a lighted arch of palms through which our National President Sister Anna Stoudt and our Commander-in-Chief Chester Shriver were escorted to the front of the room. The Department Presidents of the various Departments then marched in, each carrying long stemmed red roses and took their places between the lighted palms. National Officers of both Organizations were then escorted in and introduced as were the Past National Presidents and Past Commanders-in-Chief. While our National Musician Mary Gordon sang "One Rose" (a favorite of our National President) the Department Presidents presented the roses to Sister Stoudt forming a beautiful arm bouquet of thirty six long stemmed roses. The National President and Commander-in-Chief were then escorted up to the platform and were handed the gavel of their respective Organization. The Sons then retired to their own meeting room and we started the business of our convention.

The National President read her convention appointments and committee appointments, after which the National Secretary called the roll of Past National Presidents, National Officers. Department Presidents and Immediate Past Department Presidents. Sister Stoudt recognized these various officers, welcomed them to the convention and presented them with a remembrance from her. All convention appointees were also recognized with a gift from the National President. The reading of the report of the National President was the first order of business for the convention. This report was a complete outline of the work of the National President during her year and was well received by the delegates assembled. A check for \$200.00, a testimonial from the National Organization to the National President, was presented to Sister Stoudt by P.N.P. Katherine Joyce. Other National Officers reports followed and as they were read were turned over to the Committee on Officers Reports. At 4:00 P. M. we recessed for the day which left us time for relaxation before the events of the evening started. During the entire day on Monday free orange juice was dispensed in the lobby of the hotel, compliments of the Citrus Fruit Commission of Florida.

A banquet for the Past National Presidents and Past Commanders-in-Chief was held at 5:30 P. M. At 7:30 P. M. the Courtesy Hour was held. This affair, held under the supervision of the National Chief of Staff, is set aside for the purpose of making any presentations to the National President that the members might want to make. The opening of the Courtesy Hour was in the form of a book telling of the activities of our National President during her membership in our Organization. The National Chief of Staff narrated the story of her membership and work in her Auxiliary, Department and the National Organization and while the story was being narrated members of the New Jersey Department presented the pages of the book which were then fastened together and presented, as a book, to the National President. The Pennsylvania Department then had a beautiful presentation for the National President and Commander-in-Chief since both of these Officers came from that Department. From there on, the Departments were called on in alphabetical order and presentations were made not only to the National President but to the other National Officers as well. Following the Courtesy Hour we all went pool-side to watch the water show which was provided for our pleasure by the Joint Convention Committees.

On Tuesday morning the National President's group comprising all sitting Department Presidents met together for

breakfast and formed their club which was named "Anna's Laurel's." This club group got off to a flying start by making a \$50.00 contribution to the National Chief of Staff fund and \$30.00 to the National Patriotic Instructor's Fund. Officers reports were completed at this time and some committee reports were given. Department Presidents read reports of the activities of their Departments during the past year. After a brief recess at 1:15 P. M. we had nomination and election of officers. A listing of the new officers appears in another part of this publication. There were 188 registered delegates reported, also many visiting sisters and friends. We were then honored with greetings committees from various Patriotic Organizations who brought us messages from their respective Organizations. The entire delegation of the Sons convention headed by the Commander-in-Chief and a distinquished group of Past Commanders-in-Chief visited us at this time and brought timely messages and good wishes to us. We were also honored to have a visit from Sister Ruba Shriver and Donna Shriver, wife and daughter, of our Commander-in-Chief. The last order of business on Tuesday was the presentation by our National Patriotic Instructor given in memory of the Grand Army of the Republic. The presentation this year was a check in the amount of \$250.00 and was given to the Veterans Administration Hospital at Coral Gables, Florida. Mr. Frank E. Williams. Administrative Assistant to the Chief of Staff received this gift on behalf of the hospital and expressed the thanks of the hospital for our generosity. He told us the money would be used to purchase an electric bingo board as part of the rehabilitation program for the veterans at the hospital. We were then recessed until Thursday morning, since it was planned there would be no meetings on Wednesday so the delegates could enjoy a free day for any trips they might want to take.

Tuesday evening the banquet and reception honoring the National President and Commander-in-Chief were held. The banquet room was beautifully decorated with flowers and candles on all the tables and the atmosphere of the room was really delightful. After a most enjoyable dinner, brief remarks were made by the distinquished guests. Entertainment was provided at the banquet after which we retired to the Charlemagne Room for the reception and dancing. The whole evening was one to remember for a long time to come. On Wednesday evening after a day of boating, swimming, shopping, touring and for a few just resting, all the delegates went to the Luau. This also was an outstanding affair with authentic Hawaiian food, music and dancers. Everyone entered into the spirit of the affair and many wore outfits suited to the occasion. There were lots of laughs when some of our members entered an audience participation program with the entertainers who were there. After the Luau was over some stayed to join a community sing after which we all retired—tired but happy.

Thursday was the final day for business. It was voted to discontinue the Americanization Committee and combine this work with the work of the National Patriotic Instructor. Plans were discussed for putting a flag stone patio around the Woolson Monument in Gettysburg. This project will cost approximately \$400.00 and will be under the supervision of Past Commander-in-Chief C. Leroy Stoudt who has kindly consented to take on this job for us. The two money officers reports were read. Only the finest commendations can go to these two officers for the wonderful reports turned in. The cooperation of the membership is evidenced by the two fine sums of money reported. The National Patriotic Instructor reported \$1,006.86 raised through her office and the National Chief of Staff reported the sum of \$2,700.52, after expenses, raised through the help of the National Aides. The financial report was read by the P.N.P. Anne O. Clayton. A really fine example of loyalty to our Organization. Installation of Officers was the last order of business. P.N.P. Edith Nile installed the new officers in a very fine manner and the good wishes of everyone was extended to the National President Anita Selby of Ohio for a wonderful year. Sister Anna Stoudt received her Past National Presidents badge from P.N.P. Katherine Joyce and her P.N.P. pin from P.N.P. Anne O. Clayton. The meeting was then closed and the convention was over for another year. The National Council met both before and after the convention to audit the books of the National Secretary and Treasurer.
