



# RICHMOND-100 YEARS LATER

Starting Sunday, August 15, members of the SUVCW, our Auxiliary, and the Ladies of the G.A.R. arrived in Richmond by auto, bus, plane and railroad. Following church services in the morning, each organization conducted registration. The SUVCW registration was 116-Auxiliary was 224-Ladies of the G.A.R. was 109. On Sunday afternoon a beautiful and impressive Memorial Service was conducted by National Chaplains John C. Yocum and Eileen Coombs in the Marshall Room of the John Marshall Hotel.

On Sunday evening, Mayor Morrill M. Crowe, in a dramatic moment at the Camp Fire welcomed the Northerners. Other distinguished guests present included Col. John A. May, Commander-in-Chief of the Sons of Confederate Veterans; Hon. James J. Geary, Executive Director Virginia Civil War Commission: Mrs. Sara Binder Moore, National President, Dames of the Loyal Legion; and Mrs. Quentin Gregory, National President General of the United Daughters of the Confederacy. Prior to and during the Camp Fire, the United States Continental Army Band from Fort Monroe, Va., played "The Battle Hymn of the Republic" and "Marching Through Georgia" among other favorites. Rev. Richard O. Partington, P.D.C., presided at the Camp Fire where P.D.C. Frank M. Heacock, Sr., gave the principal address. Invocation and benediction were given by National Chaplain John C. Yocum. An impressive "Advance to the Colors" was directed by Lt. Col. Howard Dissinger.

Monday saw business sessions preceded by a Joint Opening of the Sons and Auxiliary under direction of Chief of Staff Miss Viola L. Bremme and Chief of Staff C. Leroy Stoudt. On Monday evening the annual dinner of the Past Commandersin-Chief and Past National Presidents was held, followed by Auxiliary exemplification of the Ritual and Auxiliary Courtesy Hour. Later the same evening a Cabaret Dance and entertainment was presented by the Convention Committee.

Tuesday was devoted to business sessions, followed in the evening by the annual Banquet and Reception honoring National Officers of the Sons and Auxiliary. National President Alma Blixt of the Ladies of the G.A.R. and representatives of the other Allied Orders were guests. At the dinner National President Mrs. Emma Wheeler presented a check in the amount of \$500.00 to Commander-in-Chief Rippey as a gift to the SUVCW. Both Colonel May and Mrs. Gregory extended greetings from our Southern counterparts.

Wednesday was a free day featured by a courtesy bus trip which included a tour of the Virginia Civil War Centennial Center and the Berkeley Plantation. Walking into the Virginia Room on Wednesday evening at the Military Ball was like entering a time machine. The five crystal chandeliers reflected from gold and white walls and down on authentically costumed Sons of Union Veterans of the Civil War and their ladies. The men wore Union uniforms. Many wore officer's insignia, reflecting their rank. The ladies wore silks and sating, the majority of which were in bright reds, yellows and a dozen or more shades of blue. Many of the women were wrapped in long shawls. Some ladies, in hoop skirts, curtsied gracefully on the arms of their escorts. The aura of authenticity was enhanced by an occasional Confederate uniform gliding in tight circles to a waltz. Blue and Gray were grouped together as Virginians and Rhode Islanders chatted about the details of "the late war." The South was represented, in addition to the Confederate uniformed good will emissaries, by a group singing southern songs of the Civil War neriod

Thursday saw concluding business sessions, election of officers, installation of officers and closing council meetings.

Coffin of Ohio; Ritual and Ceremonies, Harold Arnold of Rhode Island; Restoration of Rank, Urion Mackey of Michigan; Fraternal Relations, Fred Howe of New York; Publicity, C. Leroy Stoudt of Penna.; and Convention City for 1967, C. Leroy Stoudt.

The Convention Committee welcomed the Encampment and presented a large bouquet of flowers that graced the Commanders Station throughout the Encampment. A delegation from New York Department SUVCW made a presentation to Commander Rippey expressing their admiration for him. Officers Reports and Committee Reports indicated a year of active and effective work in the interest of our beloved Order. They were enthusiastically received and acted upon, and will be reported in the printed proceedings of the Encampment. Commander-in-Chief Rippey thanked his staff officers for their cooperation, and presented gifts to each of them.

Visiting Committees from our Auxiliary consisting of all members present from the New York Department as well as National President Emma Wheeler and P.N.P. Anita Selby was an enjoyable occasion. National President Wheeler presented Commander Rippey with a personal gift from her organization. The visiting committee from the Ladies of the G.A.R. consisted of all their Past National Presidents present. We in turn sent all of our Past Commanders-in-Chief to visit with the Ladies of the G.A.R. During our visitation to our Auxiliary, our entire Encampment took part.

The Military Order of the Loyal Legion visiting committee consisted of the following: Brothers Grant, Coffin, High, Brady, Dissinger, Shriver and Van Trump.

# **RESOLUTIONS ADOPTED**

WHEREAS, the Sons of Union Veterans of the Civil War in National Encampment assembled, views with concern and deep regret the large amount of legislation of an obviously socialistic tendency or in the opinion of many, inconsistent with the intent of our National Constitution:

THEREFORE BE IT RESOLVED that the Sons of Union Veterans of the Civil War:

- 1. Oppose any modification or weakening of the Connally Reservation, reserving the right of the United States to decide what matters are essentially domestic in character and within the jurisdiction of the United States and therefore not subject to the jurisdiction of the United Nations World Court.
- 2. Oppose any yielding of the United States sovereignty and control of the Panama Canal or Guantanamo Naval Base.
- Oppose any limitation of the State's jurisdiction over "right to work" laws and similar matters of largely local interest reserved to the States by the Constitution.
- 4. Oppose the Federal Government's contributions to the cost of education and similar financial aid to the States which inevitably extend Federal control over matters heretofore responsibilities of the States.
- 5. Oppose liberalization of the McCarran-Walter Act and welcome the support of other patriotic organizations and
- individuals to work for it's retention."
- 6. Urge effective enforcement of the Monroe Doctrine and appropriate protection of United States Flag and property abroad
- 7. Urge the Congress to define more precisely the jurisdiction and limitations of Federal Courts.
- 8. Urge the stoppage of free distribution of Communist propaganda by the Post Office Department, and the establishment of appropriate penalties for malicious injuries to public property and deliberate violations of the Flag Code at home
- 9. Urge that foreign aid be terminated as soon as practicable and accounts audited and settled.
- 10. We urge our members to communicate personally these recommendations to their Senators and Representatives in Congress, and ask their active assistance in making them effective at every possible opportunity.

## **Auxiliary Convention News**

Starting on Saturday, August 14th and continuing through Sunday, August 15th, the lobby of the John Marshall Hotel in Richmond, Virginia, was a very active and happy place to be. Delegates arriving for the 79th National Encampment of the Auxiliary were busy greeting many friends and getting settled in their rooms. The National Council met to audit the books of the National Secretary and National Treasurer and the Credentials Committee were seated to receive credentials and distribute programs.

On Sunday afternoon a beautiful Memorial Service was conducted in the Marshall Room of the Hotel. This program was planned by National Chaplain John Yocum of the Sons and National Chaplain Eileen Coombs of the Auxiliary. Very fine tributes were given in memory of our deceased Brothers and Sisters. P. C. in C. Chester Shriver gave a tribute to the memory of P. C. in C. Earl F. Riggs and the tribute to P.N.P. Mary E. Stapleton was given by P.N.P. Edith Paulding. It was at this Memorial Service that we received the news of the death of P.N.P. Lena G. Barrett of California. No details of her death were available to us and to date none have been received Sister Barrett served as our National President in 1948-1949 and a tribute to her memory will be included in the Memorial Service of our next National Encampment.

The opening of the business sessions of the Encampment was a joint affair with the Sons participating with the Auxiliary. Commendation is due the National Chief of Staff for the impressive ceremonies. The National Aides entered the room carrying flags and formed an aisle through which the National Officers would be escorted. They were followed by the Sitting Department Presidents, carrying beautiful gladiolus, who took their place next to the flag bearers. Through this aisle were escorted the National President and the Commander-in-Chief who took their place at the head of the room to receive their National Officers, Past National Presidents and Past Commanders-in-Chief.

Following the receiving of these officers and guests the Department Presidents presented their lovely flowers to the National President. Martha Wilson and Dorothy Kern both of Carlisle, Penna., sang songs to our presiding officers. Appropriate words, composed by Martha Wilson, were sung to the Commander-in-Chief Joseph Rippey to the tune of "Melody of Love." The tune to the song sung to National President Emma Wheeler was a delightful melody composed by Hamlet Jeitles and as yet unpublished entitled "Let's Go America."

Words of welcome were extended to all the delegates by the National President and the Commander-in-Chief after which the Sons retired to their meeting room to start their business sessions. The meeting of the Auxiliary was called to order by the National President at 10:30 a.m. Sister Wheeler made her official appointments for the convention and what substitutions were necessary on her committee appointments.

All Past National Presidents in attendance were introduced to the delegates as were the National Officers, National Convention appointees, Immediate Past Department Presidents and the Sitting Department Presidents who all received a token of remembrance from the National President.

Following the introductions Sister Wheeler read her report which was a most complete accounting of her activities during the year. Sister Wheeler had in her report four recommendations, the first regarding a memorial page in the Proceedings for P.N.P. Mary Stapleton, the second regarding the continuation of the Per Capita Tax at our present rate, the third recommendation was for our Love Token of \$500.00 to the Sons and the fourth was regarding the placing of a wreath by the National Organization in the National Cemetery in Beaufort, S. C.-this wreath to be placed each Memorial Day in the future. These recommendations were later approved by the convention.

During the reading of her report Sister Wheeler reported the sum of \$708.17 realized by contributions toward the Bell Tower at the Cathedral of the Pines in New Hampshire.

Following the reading of the National President's report P.N.P. Ethelyn Tucker, National Counselor, presented to Sister Wheeler her testimonial from the National Organization. The testimonial was a beautiful diamond ring for which Sister Wheeler expressed her sincere thanks. At this point a motion was made to recess until 2:00 p.m. for lunch.

The meeting reconvened on Monday afternoon at 2:00 p.m. and the first part of the session was taken up with the reading of the reports of the National Officers. At 3:30 p.m. we were pleased to receive into our meeting two ladies representing the Crippled Children's Hospital of Richmond, Va. A most interesting and informative talk was given by Miss Karleen Ingersoll, Administrator of the Hospital. This hospital, established in 1928, is strictly a charitable institution. They have 100 beds available and the patients are children under seventeen years of age. This hospital strives to restore each child to physical health and normalcy. For all children the objective is the same: to meet the physical, emotional, educational and spiritual needs of each child so that he will be able to return to a meaningful life. Our gift to this hospital was a check for \$250.00 which was to be used to purchase overhead bed traction. Miss Ingersoll expressed the sincere thanks of the hospital for our gift and invited us to visit the hospital while we were in Richmond. Miss Ingersoll was accompanied on her visit to us by Mrs. Mozelle Burton, Assistant Administrator.

The presentation of the \$200.00 scholarship which is made each year by the National President was made at this time. This scholarship was presented to Miss Charlotte Lawson of Milford, N. H., who plans to use the money to attend North Eastern University in Boston. Miss Lawson was present at the meeting and graciously accepted the scholarship with her sincere thanks. Following these two presentations we still had time for a few standing committee reports before the meeting was recessed at 4:30 p.m.

On Monday evening the Past National Presidents and Past Commanders-in-Chief had their annual dinner at which time the Commander-in-Chief and National President were guests. Later in the evening a degree team of members from the N. H. Department gave the exemplification of the Ritual and this was followed by the Courtesy Hour conducted under the

direction of National Chief of Staff Viola Bremme. The National President was remembered with many lovely gifts as were the other National Officers. At 9:30 p.m. on Monday evening a Cabaret Dance, sponsored by the Penna. Department, was held and everyone seemed to enjoy it very much.

The meeting on Tuesday morning was called by the National President at 9:10 a.m. Minutes of the Monday session were read and approved. Communications were read and ordered filed. P.N.P. Dorothy Hilyard presented to the National Organization two checks totaling \$275.00 from Appomatox Auxiliary No. 2 of Wilmington, Del. This money is to be used to purchase a bench to be placed at the site of the Woolson Monument in Gettysburg. The bench is to be of the same type marble as the base of the Monument and will be placed in honor of P.N.P. Celeste Gentieu who was Chairman of the G.A.R. Memorial Committee during its entire existence. These checks were gratefully received by the National Organization and the placing of the bench will be a fine compliment to the Monument.

Following a report of the Committee on Rehabilitation, the Committee on C. R. and R. reported. A review of all the changes in the C. R. and R. since its last revision in 1954 was made by the committee with a final recommendation that all these changes be listed and conies made and distributed to the various Auxiliaries for their guidance and direction. This recommendation was approved and a listing of these changes will be forthcoming in the near future.

Further Committee reports were given and some of the Department reports were read. We were pleased to receive a visit from the Commander-in-Chief of the Sons of Confederate Veterans Colonel John May. Colonel May is the Chairman of the South Carolina Civil War Commission and the holder of the Distinguished Service Award. Colonel May gave us an interesting and inspiring talk and extended to our Organization the hand of friendship from his Organization, P.N.P. Edna Lambert responded to Colonel May.

Following the announcement by the credential committee of 206 delegates and 13 guests registered we recessed for lunch. The first order of business on Tuesday afternoon was nomination of Officers for the coming year with election of officers ordered for Wednesday morning. Following the nominations our National President retired from the room to make her visit to the Sons in their meeting. During her absence the Resolutions Committee gave their report presenting the usual courtesy resolutions which were accepted by the convention, The Ohio Department presented a resolution to the convention requesting that a Life Membership be conferred on P.N.P. Edna Bergwitz of the Ohio Department. Sister Bergwitz is our oldest living P.N.P. in point of service having served as National President in 1914. The conferring of this life membership was approved by the delegates assembled.

Soon after the return of our National President from her visit to the Sons we were honored by a return visit from them. All the Sons in attendance at the convention came to our meeting in a body. P. C. in C. Fred Howe of N. Y. was the spokesman for the group and expressed their pleasure in being with us. They also extended their thanks to us for the Love Token from our Auxiliary which the National President had presented to them. Commander-in-Chief Joseph Rippey and P. C. in C. William Coffin also spoke briefly, P.N.P. Anne O. Clayton responded to these Brothers. Following the visit from the Sons we recessed until 9:00 a.m. Thursday morning, Wednesday was a free day for the planned bus tour, shopping and sightseeing.

Tuesday evening the banquet and reception of the Sons and Auxiliary was held in the Virginia Room of the hotel. These were both enjoyable affairs and were under the direction of the two Chiefs of Staff, Sister Viola Bremme and C. Leroy Stoudt, P. C. in C. Brother Stoudt acted as Toastmaster for the banquet.

Thursday morning the meeting was called at 9:15 a.m. to complete the business of the Encampment. The committee on C. R. and R. completed their report which was accepted as a whole. A greetings committee from the United Daughters of the Confederacy were escorted into the room. The representative of this Organization spoke of a monument erected in memory of the Soldiers and Sailors of the Confederacy and to mark the passing of the last Confederate Veteran that would be dedicated in Gettysburg on August 25th of this year and members of our Organization were invited to attend this dedication. Our National President Sister Wheeler announced she would be attending this dedication and invited our members to be present with her. A motion was made and seconded that our National Organization place a wreath at this monument at the time of the dedication which motion was accepted by the convention.

The two money officers. National Patriotic Instructor Florence Jansson and National Chief of Staff Viola Bremme were the last two National officers to report to the Encampment. Sister Jansson reported on the fine work done throughout the various Departments in patriotic work and then gave her financial report. Sister Jansson reported the very fine total of \$1.271.95 turned over to the National Treasurer for Patriotic work. Sister Bremme then gave her report which was also excellent. She reported \$2,096.59, after expenses, raised by National Aides, personal and club contributions. Both of these Sisters are to be commended for their outstanding efforts in our behalf and the thanks of the National Organization was extended to them and to the membership at large for their fine cooperation.
