

BUFFALO ENCAMPMENT OUTSTANDING

DULUTH SELECTED FOR 1954

From Saturday, August 22 through Thursday the 27th, the officers, members, and delegates participated in the various activities of the 72nd Nat'l Encampment of the S.U.V.C W. and the 67th Nat'l Encampment of the Auxiliary. The Lafayette Hotel was the headquarters of both organizations, where all meetings and social affairs were held. Over 500 members of the two organizations took part in the many joint meetings and social affairs.

Grant gave his audience a vivid picture of his grandfather in his later years at the famous cottage at Long Branch, N. J. He told of the Grant family's life there and related his boyhood brushes with the Grant discipline. Gen. Grant sprinkled his talk with amusing and illustrative anecdates. The latter part of his talk was devoted to a summation of his grandparent's administration in the White House.

The public rooms were beautifully decorated with a profusion of flowers, palms, flags and banners which gave a festive and patriotic appearance. On Sunday morning, delegates attended the church of their choice. In the afternoon there was registration of delegates, council meetings and routine committee meetings. Each delegate registering received a beautiful convention program, a convention badge, and a variety of souvenirs of Buffalo and New York.

JOINT MEMORIAL SERVICES

Immediately preceding the Memorial Service on Sunday evening, the assemblage was treated to a vocal concert by The Sylvania Choraliers, shown below.



"Members of the Sons of Union Veterans of the Civil War were called upon by their new Commander-in-Chief, Maj.-Gen. U S. Grant 3rd, to resist the subversive activities of the enemy of religion, of personal liberty, and the rights of the individual. Gen. BUSINESS SESSIONS

The first business session for the S.U.V.C.W. opened at 9:30 A.M. in the Mahogany Room of the Hotel Lafayette on Aug. 24. At the opening session prayer was offered by Nat'l Chaplain Rev. Hermon L. Brockway. All officers were present except Nat'l Council Member Laurence J. Parker, and Personal Aide Dr. L. L. Baker. The Commander-in-Chief appointed Allen Spink to serve on the Council and Cleon Heald as Personal Aide during the Encampment C. in C. Davis then appointed Howard Waite of Mass as Guide; Leslie More of N. Y. as Color Guard; and Truman Vincent of N. Y. as Guard. He also appointed John B. Davis of Mass. as musician.

Reports of all officers were read and referred to the proper committees, after which communications and resolutions were read and referred to committees for study. These reports and resolutions will be printed in full in the proceedings. Among communications received were greetings from Comrade Albert Woolson, Miss Cora Gillis, Sec'y to the G.A.R., and many Past Commanders-in-Chief and Past Dep't Commanders. Two

council members from the City of Buffalo were escorted into the room and extended greetings and welcome from the City Government. They assured the Encampment of their cooperation in maintaining G.A.R. rooms in Buffalo.

Legislation enacted includes the following: The Americanization Committee title was changed to Americanism Committee; Dep'ts were urged to work for the proper marking of the G. A. R. Highway under supervision of the Nat'l Committee; Camp Secretaries are urged to solicit subscriptions among their members to The Banner; The Nat'l Sec'y was ordered to investigate prices on bars for Dep't or Camp Commanders; That we continue efforts to impart true Civil War information and discountenance display of any flag in a manner that raises doubt of undivided loyalty to the United States or stimulates sectionalism. The encampment voted to continue to assist in supporting G.A.R. Headquarters; The Nat'l Sec'y was authorized to stock small numerals designating years of service to the order such as 30-35-40-45-55-60-65. By action of the Encampment, Camps will be permitted to order supplies directly from Nat'l Headquarters, with new price lists and order forms to be printed. Both the Nat'l Patriotic Instructor and Chief of Staff Funds were authorized for the coming year.

Chief of Staff C. Leroy Stoudt raised \$247.95 this year, and after paying \$190.00 in expenses turned over \$57.95 to the general fund of the Commandery-in-Chief. Nat'l Pairiotic Instructor Albert DeHaven submitted a splendid report of the G.A.R. Memorial fund, turning over a net of \$633.65 to be credited to that fund.

A \$50.00 contribution was again approved this year to Lincoln University.

At the time of the election of officers there were 136 votes present, which were cast unanimously for the entire list of new officers.

The rank of Past Dep't Comdr. was restored to Bro. Charles C. Stull who is now affiliated with the Dep't of California.

The proposed changes to the Constitution were approved by a \(\frac{2}{3} \) vote on the following proposals:

Establishment of a Permanent Fund Creating Associate Membership

These two proposals will be submitted to Dep't Encampments for their consideration, and will not become operative until at least 10 Dep'ts vote approval of the changes.

A resolution was adopted to approve of and cooperate with the Civil War Round Table of Washington, D. C. in developing Fort Memorial Freeway by 1961. This road will encircle Washington, D. C. and it will make several Civil War Forts and positions of interest available by automobile.

By action of the Encampment, position bonds on the position of Dep't Comdr. is left to the discretion of the various Dep'ts. The Commandery-in-Chief will not insist upon these bonds where Dep'ts do not require them.

Duluth, Minn. (the home town of Comrade Woolson) was unanimously selected as the encampment city for 1954. An outstanding service in his honor is planed with full cooperation of City, State, and Federal officials.

Pledge of Allegiance changed: (next page, 1st col.)

In place of the outstretched right hand in pledging allegiance to the flag, all members out of uniform will use the standard civilian salute—that is to hold the right hand over the heart. This applies on all occasions—either in meetings or in public. By action of the Encampment, the Sons of the Confederacy will be invited to participate in the American Coalition.


Commander-in-Chief Grant has appointed P.C. in C. Davis as a committee of one to secure recordings, transcriptions, slides, etc. of Civil War men, Civil War historical sites, etc. A master file of such information will be maintained at Nat'l Headquarters where arrangements will be made for Camps and Dep'ts to secure copies for use at meetings, in schools, and various public and civic functions.

The Resolutions Committee expressed appreciation of the encampment to the following: Robert Childs and Edwin C. Ellis of the Common Council of the City of Buffalo; New York Encampment Committee; Encampment Committee of Cook Camp 223, Buffalo; Voiture 51 and 40-8 American Legion; Post 799 American Legion; Old Fort Niagara Ass'n; Sylvania Choraliers; the Hotel Lafayette; and the Buffalo newspapers.

The visit of the Auxiliary Greetings Committee including Nat'l Vice-President Mrs. Beatrice Riggs, P. N.P. Edith Nile, Mrs. Barbara Davis, wife of C in C. Davis, and a delegation from the California and the Oregon and Washington Dep'ts was timely and impressive. They presented a gift of \$200.00 to the Commandery-in-Chief from their encampment.

The Bricker Amendment was endorsed by the Encampment by a resolution which called for early action thereon.

ENCAMPMENT SIDELIGHTS





Chief Loud Voice (Clinton Rickard) is a veteran of the Spanish American War and is Comdr. of Butler Camp S.U.V C.W. in Buffalo. He is President of the Buffalo Memorial Day Ass'n and President of the Indian Defense League of North America. He has been to Washington several times relative to Indian legislation and has appeared before the United Nations.

He, along with his son, Wm. Rickard, David Hill, Chief Eagle Feathers, and Chief Howard Sky gave a demonstration of Indian dances and songs that were enthusiastically received.

General Order No. 1 Series 1953-1954

September 1, 1953

- 1. It is with a keen sense of the honor and high responsibilities of the position that I hereby assume the duties of Commander-in-Chief of the Sons of Union Veterans of the Civil War.
- 2. In order that the best interests of our Order be consistently and constantly served, I ask the continuing cooperation of the Camps and Departments in carrying out in the fullest practicable measure the purposes of the Order, as enumerated and defined in Article 2, pages 1 and 2 of our Constitution.
- 3. Camps are hereby enjoined to take active and energetic steps to fulfill in their communities, and the Departments in their States, the said mission of the Order. The Nat'l Officers and Committees will do this as regards matters on the Nat'l level, and will be ever ready to give advice and assistance within the purview of their duties; but the success of all our efforts and of the Order as a whole necessarily depends upon the activity of the Camps on their local level.
- 4. Adoption of the G.A R. Highway, Route 6, was the culmination of efforts of the Nat'l level, redounding greatly to the credit of past administrations. Its effectiveness by proper marking, paving, and maintenance of the Highway will now depend upon the sustained efforts of our Dep'ts along the route, under the general guidance and supervision of the Chairman of the Nat'l Committee.
- 5. Camp and Dep't Commanders will familiarize themselves with the resolutions adopted at the Annual Nat'l Encampment just concluded, which are pertinent to their duties and responsibilities, with a view to making them effective within their jurisdictions.
- 6. With such support from ALL members of the Order, we may confidently face the future and count upon a successful year, with the Sons of Union Veterans of the Civil War in the front line of patriotic organizations.



Maj.-Gen. U. S. Grant 3rd, U. S. A. Ret. Washington, D. C.

Elected Commander-in-Chief of the Sons of Union Veterans of the Civil War at the 72nd Nat'l Encampment, Buffalo, N. Y., August 26, 1953.

C. in C. Grant is a member of Cushing Camp 30, of Dep't of Maryland, located in Washington, D. C. He served as Dep't Comdr. of the Maryland Dep't. 1930.

He is the grandson of President U. S. Grant; was educated at Theresianium, Vienna, Cutler School of N. Y., Columbia University, U. S. Military Academy, U. S. Engineering School, and the Army War College. He married Edith Root, daughter of Hon. Elihu Root. C. in C. Grant served in Mindanao, Phillipine Islands; Cuban Pacification; Vera Cruz Expedition; and with the Pershing Expedition in Mexico. He was a member of the Supreme War Council in Versailles, France; was U. S. Assistant Commissioner for treaty with Germany on treatment of prisoners; was with the American Commission to negotiate peace in Paris in 1919.

His tour of duties included San Francisco River and Harbor Dist.; Fort DuPont, Del.; Governor's Island, N. Y.; Great Lakes Division; and Fort Leonard Wood.

Other activities include acting as Executive Officer California Debris Commission; director of Public Buildings and Public Parks of the Nat'l Capital; executive officer Arlington Memorial Bridge Commission; Nat'l Capital Park and Planning Commission; Public Buildings Commission and a member of the Zoning Commission, D. C., as well as Vice-President of George Washington University in 1946.

C. in C. Grant is Commander of the Loyal Legion of the District of Columbia; Pres. of the American Peace Society; Pres. of the American Planning and Civic Ass'n; and Pres. of the Columbia Historic Society. He has been decorated with the Distinguished Service Medal, The Legion of Merit, and also with decorations from six foreign countries.

General Whitney Replies



The 67th Nat'l Encampment was called to order by Nat'l Chief of Staff Ruth Muzzey. The Nat'l Officers entered and passed through a double line of Nat'l Aides and were introduced. They received a corsage as they approached the front of the room, then passed on to their seats. Finally the Nat'l President was escorted in and introduced. Sister Mary Mandeville sang an appropriate greeting, and then Sister Macey assumed control of the meeting. The Nat'l Officers were presented, each receiving gifts from the Nat'l President. Fifteen Past Nat'l Presidents also received gifts from the Nat'l President, following which the Nat'l President introduced each presiding Dep't President.

Following the reading of the Nat'l President's fine report, P. N. P. Mary Stapleton presented her with a check for \$200.00 from the Nat'l Organization to purchase a new television set. All other officers read their reports which were referred to proper committees.

Following the opening, the New York delegates led by P.N.P. Mayme Dwyer, Mary Stapleton and Margaret Brady presented the Nat'l President with a bouquet of roses, the leaves made of fifty \$1.00 bills from the N. Y. Dep't, and later in the Encampment, they presented Sister Macey with \$200.00 from her Dep't.

Sister Celeste Gentieu reported \$17,435.19 in the Grand Army Memorial Fund. She recommended that this be the last year of solicitation to this fund, and that a bronze statue of Comrade Woolson be placed in the rotunda of the Capital at Washington, if approved by his family, and the State of Minnesota, honoring him as the last survivor of the Civil War.

Mrs. Sarah Ehrmann, P. N. P. of the Ladies of the G. A. R. extended greetings of her organization, and Mrs. Ethel Howe, Nat'l representative of the Woman's Relief Corps represented her organization.

The Aux. concurred in action taken by the S. U. V. C. W. regarding the flag salute. In the future this will be the standard civilian salute—given by placing the right hand over the heart.

The credential committee reported 189 accredited delegates immediately prior to the election of officers.

A telegram of greeting was sent to Comrade Woolson from the encampment.

The Commander-in-Chief and a delegation from the S.U.V.C.W. were presented and the Nat'l President presented Bro. Davis with a gift from the Nat'l Organization of the Auxiliary, which was graciously accepted.

Sister Ellinore Konrad presented a check for \$250.00 to Mr. Jeacock of the Cerebral Palsy Foundation from the Organization. He was also given \$20.00 from the Club of Phyllis Dean, known as Phyllis's Spokes.

Nat'l Chief of Staff Ruth Muzzey read her report and turned over \$2,336.39 net to the organization, and Nat'l Patr. Instr. Ellinore Konrad read her financial report which netted \$1,612.00. Both reports were received with rousing applause and a rising vote of thanks.

P. N. P. Ethelyn Tucker installed the new officers with C. in C. Grant and Bro. Charles Webster present. Both Bro. Grant and the husband of our new National President extended greetings to the new officers and to the Organization.
