J. Colby Beekman presided, and the invocation was delivered by Rev. Hayward McCollough. Each organization placed wreaths, after which Department Commander of Illinois, Charles A. Brady Jr., and Commander-in-Chief Harold E. Arnold were introduced. The speaker was Maj. Gen. U. S. Grant 3rd, whose timely message was greatly appreciated. Following the singing of "The Battle Hymn of the Republic," the salute and taps, benediction was delivered by Rev. Joe Driskill.

ANNUAL ENCAMPMENT AT SPRINGFIELD

From Saturday, August 20th through Thursday, August 25th, the officers, members, delegates and friends participated in various activities of the 79th Annual Encampment of the SUVCW, along with the 74th National Encampment of the Auxiliary and the 74th National Encampment of the Ladies of the G. A. R. Splendid accommodations were found at the Hotel Abraham Lincoln and Hotel Leland. The SUVCW met in the Elks Club, while the Auxiliary met in the ballroom of the Abraham Lincoln. The Ladies of the G. A. R. met in the ballroom of the Hotel Leland. Registration was as follows: SUVCW 121, Auxiliary 186, Ladies of the G. A. R. 193. Each organization also had many non-voting members in attendance.

On Sunday morning delegates attended services at the First Methodist Church of Springfield, where seats were reserved for all three organizations. At 1 P. M. each organization attended to registration of delegates and at 3:30 P. M. the three organizations conducted a Joint Memorial Service under direction of their National Chaplains in the ballroom of the Abraham Lincoln Hotel. This was a very impressive ceremony with a special tribute being given to P. C. in C. Frank Huston by P. C. in C. Richard Locke. The entire program will be printed in the proceedings.

At 7:30 P. M. on Sunday a band concert was given by the 33rd Infantry Division Band, Illinois Army National Guard in the Centennial Auditorium, which was followed by the traditional Camp-Fire, which was featured by addresses of Mayor Lester E. Collins of Springfield; Hon. William G. Stratton, Governor of Illinois; Harlington Wood, Jr., U. S. Attorney for the Southern District of Illinois; and Charles M. Thompson, Dean Emeritus of the College of Commerce, University of Illinois.

On Monday morning a courtesy breakfast was given to National Officers and Past Commanders-in-Chief, and Past National Presidents by the Illinois Department. Business sessions were held on Monday, Tuesday, Wednesday and Thursday with the SUVCW concluding their business on Thursday morning.

On Monday evening the annual dinner of the Past Commanders-in-Chief and Past National Presidents was held in the Palm Room of the Abraham Lincoln. This was followed by a program of narrated slides. "The Lincoln Story," by Mr. and Mrs. George L. Cashman in the ballroom. This was easily a highlight of the Encampment, and was thoroughly enjoyed by all. Then, at 9:30 P. M. the Auxiliary Courtesy Hour was held under direction of the National Chief of Staff.

On Tuesday evening the annual banquet honoring the Commander-in-Chief and National President was held under direction of the Auxiliary Chief of Staff. Chief of Staff C. Leroy Stoudt did his usual outstanding job as toast-master.

On Wednesday afternoon, the entire delegation from all three organizations were guests of the Illinois Department on a bus tour which included stops at Lincoln's Tomb in Oak Ridge Cemetery, also to the grave of Major B. J. Stephenson, founder of the G. A. R. in Rose Hill Cemetery, Petersburg, and then to New Salem Village, reconstructed village where Lincoln spent his youth.

On Wednesday evening there was a Song Fest in the ballroom of the Abraham Lincoln, which was followed by exemplification of the Ritual by both the SUVCW and the Auxiliary. A team from Massachusetts performed the degree work for the Sons and initiated nine new candidates into the Illinois Department.

The Illinois Department through their various committees worked hard, and everyone agreed that it was a beautiful convention, and that they are perfect hosts.

Following a Joint Opening with the Auxiliary in the ballroom of the Abraham Lincoln, the first business session opened at 10:30 A. M. on Monday at the Elks Club. Prayer was offered by National Chaplain Spencer Leonard.

The Convention Committee chairmen (Chas. Brady, SUVCW; Mrs. Eva Blackman, Auxiliary; and Mrs. Lura B. Frye, Ladies of the G. A. R.) presented the Commander-in-Chief with a huge bouquet of flowers which graced the podium during the Encampment.

Brother Alva Reef, Indiana, presented the Order with a volume containing a listing of G.A.R. grave locations in the State of Indiana.

Gen. U. S. Grant 3rd together with a group of Loyal Legion members extended greetings of their organization. The Encampment expressed appreciation to the Loyal Legion for their cooperation at the Lincoln Tomb exercises.

THE BANNER

Greetings committees extended greetings from all of the Allied Orders. Laura I. Smith was chairman of the Auxiliary delegation, Josephine Parkhurst the Woman's Relief Corps, and a group of Past National Presidents represented the Ladies of the G.A.R. The Daughters of Union Veterans also extended greetings.

At the banquet, Natl. Pres. Beatrice Riggs presented us with a love token of \$500.00 from her organization.

National Patriotic Instructor Chester Shriver reported that his special fund totaled \$669.50 with more promised.

Indianapolis, Indiana will host the 1961 National Encampment with headquarters at the Hotel Claypool, the week of August 20th. The decision regarding the 1962 Encampment was referred to the Council of Administration, which has appointed a sub-committee to investigate.

The concluding session was held on Thursday morning, August 25th, at which time the newly elected officers were installed by P. C. in C. John H. Runkle. P. C. in C. Richard Locke presented outgoing Commander-in-Chief Arnold with his Past Commander-in-Chief's jewel.

RESOLUTIONS ADOPTED

(1) That, in view of the present international crisis, and for the continued protection of the republican form of government which our forefathers preserved for us, we hereby urge:

- A. The making of ample appropriations for the National Defense;
- B. The safe guarding of our national economy by balancing the budget and the reduction, to a minimum, of appropriations for the multitude of Socialistic proposals for Federal aid sponsored by the party platforms, and the reduction and gradual elimination of the income tax.
- C. The construction of the Memorial Fort Boulevard in our National Capital, in memory of the Veterans of the Civil War; as an effective contribution to the solution of the Capital's traffic problems, and to the observance of the Civil War Centennial.
- AND, BE IT FURTHER RESOLVED, that we are fervently opposed:
- D. To any further encroachments on our national sovereignty by the United Nations, and by Executive agreements, and any steps that lead to World Government; and
- E. To the recission of the Connally reservation as to our participation in the World Court; and
- F. To Federal Aid to the public schools, and any interference with State and local control over their schools; and
- G. To sizable Federal appropriations for Public Works, rural electrification, mental health, socialized medicine and similar steps in "Creeping Socialism" which threatens the stability of our economy; and by inducing expansion of Federal activities to encroach upon local self government and the rights reserved to the States, guaranteed by the Constitution.
- BE IT FURTHER RESOLVED, That the Sons of Union Veterans of the Civil War maintain that the loyalty oath and affidavit required by the National Defense Education Act of 1958 (Public Law 85-864) is a wise and essential provision and should be retained to strengthen and maintain the National Security of our Nation; and we petition against passage of S2929, or any other legislation that would eliminate them.
- (2) That the records and property of the Michigan Department, Grand Army of the Republic, shall be turned over to the Burton Historical Collection in Detroit for preservation and accessibility for historical research, provided only that should the Governors of the said collection ever wish to dispose of the said records and property, title will revert to the S.U.V.C.W.: and that Brother George R. Raub, Sr., be informed by the National Secretary-Treasurer of this action.
- (3) That the S.U.V.C.W. heartly support the appropriate observance of the Centennial of the Civil War in the spirit

proposed by the Civil War Centennial Commission; and offer their hearty cooperation and enjoin our Departments and Camps to afford full and active cooperation with their State Commissions and local Committees; and that we only request of the National Commission its suggestions and recommendations as to how we can help most effectively and play our part.

- (4) That we confirm our previous recommendation for the establishment of a Military and Naval Museum in the old Pension Office Building, or in a new building if obtainable, and that, in either case, it be designated as a Memorial to the Veterans of our Wars.
- (5) That as a step to this end, we favor passage of Senate Joint Resolution, sponsored by the Ladies of the Grand Army of the Republic for a National Shrine, in memory of the Grand Army of the Republic.
- (6) That we recommend to the Governors of all States the firing of a National Salute, in each State Capital, on April 15, 1961.
- (7) That Resolutions of thanks be extended to Hon. Lester E. Collins, Mayor of Springfield; Hon. William G. Stratton, Governor of Illinois; Springfield Assoc. of Commerce & Industry; Hotel Abraham Lincoln; The Elks Club; Springfield Inter-Veterans Council; Illinois National Guard; 33rd Division Infantry Band; Springfield Chapter, Sweet Adelines Inc.; Harlington Wood Jr., U. S. Attorney. Southern District of Illinois; Charles M. Thompson, Dean Emeritus of the College of Commerce, University of Illinois; Illinois Historical Society; SUVCW Encampment Committee; First Methodist Church of Springfield: Mr. & Mrs. George L. Cashman and The Choir of St. Paul's A.M.E. Church of Springfield.
- (8) "That a Committee on Centennial Military Affairs, operating under the authority of the Commandery-in-Chief and the Council of Administration, is hereby established for the following purposes:
- 1. To investigate the uniforms and operations of all units of the Sons of Veterans Reserves, now operating under the authority of the several Departments of the Order in accordance with Chap. IV of the Regulations: and to determine the need, if any, of any further standardization thereof than that now prescribed in said regulations.
- 2. To investigate all the avenues of usefulness of our Reserve units in connection with the coming Centennial observance; and, therefore, to determine and recommend any desirable augmentation of such units, and any needed changes in uniforms, operations or regulations thereof; and all means of financing the same.


That this Committee shall consist of five members, to be appointed by the Commander-in-Chief, by and with the advice and consent of the Council of Administration, from among eligible constitutional members of the Commanderyin-Chief having familiarity with the subject matter.

And that this Committee shall report, from time to time, to the Council of Administration on the results of its studies and efforts; and if between sessions of the Commandery-in-Chief, the Council of Administration is hereby authorized to take any necessary action on its recommendations. imminently required for the good of the Order."

(9) "That the Commander-in-Chief be and is hereby authorized and directed to call a special meeting of the suspended Michigan Department for the purpose of its reorganization, giving all Camps in the State (whether carried now as 'Camps at Large,' or as members of the suspended Department) a due and sufficient notice, at least 30 days in advance of such called meeting (and preferably longer), and directing said Camps to send to such meeting their proper quota of delegates chosen under existing regulations;

That such called meeting shall be presided over in person by the Commander-in-Chief, or his duly authorized and empowered representative (preferably a Past Commander-in-Chief, familiar with the case, but neutral in the controversy), who will be accompanied to such meeting by the National Counselor and the National Secretary-Treasurer of the Order; and that these representatives of the Commandery-in-Chief shall supervise the re-institution of the suspended Michigan Department and supervise the election and installation of a complete corps of Department Officers."

AUXILIARY EVENTS

The 74th Annual National Encampment of the Auxiliary convened in Springfield, Illinois the week of August 21st. Delegates from various Departments began arriving on Saturday and by Sunday morning a large number from both the Sons and Auxiliary were assembled in the lobby of the hotel ready to attend, in a body, the special Church Services held at the First Methodist Church of Springfield.

On Sunday afternoon a Joint Memorial Service was held in the Ballroom of the Hotel. The Sons of Union Veterans of the Civil War, their Auxiliary and the Ladies of the G.A.R. all participated in this tribute to their deceased members. Members of St. Paul's A.M.E. Church Choir under the direction of Jerome Singleton rendered vocal selections during the Memorial Service and immediately following the close of the program a beautiful 50 star American Flag was presented to the director of the choir for his church. This flag was presented in the name of all three Organizations.

Sunday evening a band concert was given by the 33rd Infantry Division Band of the Illinois National Guard. This concert was given in the Centennial Auditorium and preceded the Camp Fire program. The names of the prominent speakers at the Camp Fire have been listed in the Sons account of their convention.

On Monday morning the Illinois Department gave a courtesy breakfast for the National Officers and Past National Presidents which was followed almost immediately by a Joint opening of the Sons and Auxiliary. Natl. Chief of Staff Flora Bates of the Aux, and Natl, Chief of Staff C. Leroy Stoudt of the Sons received and welcomed our National President and Commander-in-Chief and they were escorted into the room through an arbor of branches of oranges-a reminder of the home state of our National President. From the front of the room the Natl. President and Commander-in-Chief received their National Officers and Past Natl. Presidents and Past Commanders-in-Chief. Following brief remarks by our presiding officers the Sons were excused so that they might begin the business of their convention

Natl. President Riggs rapped the gavel for order at 11:00 A. M. and the meeting of the convention was opened in ritualistic form. Appointments for the convention were made at this time. Committee appointments were read and sub-

stitutions made where necessary. Roll call of Natl, Officers found all present. They were presented to the convention and each received a remembrance from the Natl. Pres. 17 P.N.P.'s answered the roll call and were given gifts. Department Presidents of 1959 were recognized as were the new Dept. Presidents of 1960 and each received a token from the President. Gifts were also presented to the appointed officers for the convention.

P.N.P. Eva Blackman, Chairman of the convention committee, announced that on the Thursday preceding the convention a 50 star American Flag had been presented to the Hotel by the Department of Illinois. Mr. George Stone. Asst. Manager of the Hotel Abraham Lincoln received the flag and expressed the thanks of the hotel to the Dept. of Ill, for their beautiful gift. This flag was then raised on the roof of the hotel and was flown from the flag staff of the hotel throughout our entire convention.

The convention was then recessed to give the delegates ample time to prepare for the Governor's Tea held at the Governor's Mansion from 2:00 P. M. to 3:00 P. M. Monday afternoon. All who attended the Tea agree it was one of the highlights of the convention. They were most graciously received by the First Lady of Illinois and each left the Mansion feeling they had found a new friend.

The Monday afternoon session was called at 3:30 P. M. and the first order of business was the reading of the National President's report which was received with great applause. Other National Officers reports were read and turned over to the Committee on Officers Reports. At 4:45 P. M. the session was recessed for the day. On Monday evening the Past National Presidents and Past Commanders in Chief met for their annual dinner which was followed by meetings for these two groups.

At 8:00 P. M. the Illinois Department sponsored a program of narrated slides entitled "The Lincoln Story" a most entertaining and informative program which was most enjoyable. A courtesy hour for the National President under the direction of National Chief of Staff Flora Bates followed

and a happy time was had by all who attended. Sister Riggs received many lovely gifts from Departments as well as many friends, all presented in a most unusual manner. Members dressed as "49'ers"-Prospectors of early California-were much in evidence as were two "Pirates" who had to be watched constantly lest they make off with much of the treasure that had been placed on a table in front of the National President.

Early Tuesday morning the Department Presidents of the various Departments had breakfast with the National President and the new club was formed. The name of the club is the "Busy Bees" and each member was presented with a small pin-replica of a bee-which they were throughout the convention so all would know to which group they belonged.

The Tuesday morning business session was taken up with reports, Officers, Committee and Department, Following luncheon the first order of business was Nomination and Election of National Officers for the year 1960-1961. Following election of officers many Greetings Committees from various Patriotic Organizations were received into our meeting and extended the greetings of their various leaders. All were graciously received by our National President and our thanks was extended to them for their thoughtfulness in coming to visit with us.

Mr. Walter Wagner representing the Springfield Association of Commerce and Industry was then escorted into the meeting. Sister Elsie Evans, Department President of Illinois Department presented a beautiful 50 star flag to Mr. Wagner for his Association. This flag was presented in the name of the Illinois Department. Mr. Wagner expressed the sincere thanks of the Assoc. to the Illinois Dept. for their kindness in presenting this flag and expressed his pride in being permitted to receive the flag in the name of the Association.

Every year our Organization presents a gift in Memory of the Grand Army of the Republic. This gift is to be presented in or near the Convention City. This year our gift was five benches placed in The Abraham Lincoln Memorial Garden in Lake Springfield, Illinois. The benches were of treated oak with carved lettering which had been stained so the wording would be very prominent. Each bench had a "Lincoln Quote" on it as well as the name of our Organization as the donor. Following are the quotes used: "Let us strive to achieve and cherish a just and lasting peace among ourselves and with all Nations."-"Compromises of principle break down of their own weight."-"All American Citizens are brothers of a common country."—"If you remain true and honest you cannot be betrayed."—"My paramount object in this struggle is to save the Union."

All of these quotes were taken from either speeches made by Lincoln or letters written by him. National Patriotic Instructor Viola Bremme made the presentation which was received by Mrs. Howard T. Knight, President of the Garden Club of Illinois who are sponsors of the Lincoln Memorial Garden. In accepting these benches Mrs. Knight expressed the appreciation of all members of the Garden Club for this wonderful contribution to the Gardens. Accompanying Mrs. Knight was Mrs. T. J. Knudson a Past President of the Memorial Garden Foundation who spoke briefly on the Gardens and invited all who could do so to visit the Gardens and enjoy their restful and inspiring beauty. Mrs. Knudson pointed out that this Garden is the first Living Memorial to any one and the only one to Abraham Lincoln.

The National Presidents testimonial, presented to her by P.N.P. Margaret McKinney, was very lovely. It was a copy of the regular lavaliere of the Organization but made in gold. A copy of the Recognition pin of the Organization was in the center and directly under the copy of the recognition pin was an imprint of a gold gavel. In the center of

PENNSYLVANIA

"Gen. Armistead" again placed his hat atop his sword to lead the Confederates into the Angle and "Cushing" again died by his cannon while the 71st and 72nd Pennsylvania, the 69th Pennsylvania and other Union troops stood firm and then pushed back Pickett's men, during the re-enactment of Pickett's famed charge on the Gettyshurg Battlefield on Sunday July 3rd. More than 500 uniformed men took part in the opposing "armies" including approximately 400 from the North-South Skirmish Association, approximately 100 from the Sons of Veterans Reserve, and 50 from the National Guard.

The scene assumed a Civil War air at 12:15 P. M. when approximately 300 Union infantrymen paraded from Meade's headquarters to take their places along the Union center. The cannon crews went into position about 1:30 on both the Union center and on W. Confederate Ave. The Confederates were in place south of the Codori house by 2:15. The three companies of Sons of Veterans Reserve under command of Col. O. G. MacPherson and Major Chester Shriver were from New Oxford, Middletown, Harrisburg, Reading, Lititz and Gettysburg. Cameramen were present from CBS-TV, WMAR-TV and WGAL-TV and from a dozen newspapers.

VERMONT

On June 17, a fifty star American Flag was presented at Pleasant View Cemetery by Aux. 8 of Camp 50. Patriotic Instructor Amy Fancher made the presentation to the sexton. Mr. Elmer E. Camp. Prayer was offered by Rev. W. J. Fillier, and a poem "The Flag" was read by Elsie Page. The program was concluded with the singing of America and the burning of the old flag.
