ON THE COVER: This edition's cover photo was shot by CinC Kent Armstrong, during his November 30th visit to Milwaukee. The 60-foot tall Soldiers & Sailors monument stands at the north end of Wood National Cemetery. The memorial, crafted by the Joseph Shaver Granite & Marble Company, weighs 85 tons and is surrounded by four 24-pdr flank howitzers, 1844 model. There are four pyramids of 14 cannon balls each at the monument's four corners. The monument's dedicaton, on May 30, 1903, was attended by 1500 veterans and 2,000 civilians. Sen. John L. Mitchell addressed the crowd, saying, "The monument, which we dedicate today, built by your loving hands in memory of our heroic comrades, who slumber here, teaches us a lesson in patriotism. It stands for the noblest struggle that history records..."

General Order 16

1. Part of the obligation, taken during the initiation of a candidate for membership in this organization, is the pledge to "obey the Constitution and Regulations of this Order." This document (also known as the "C&R") provides for the governance of the Sons of Union Veterans of the Civil War (SUVCW) at the Camp, Department, and National levels of the organization. In addition to each individual's pledge, those Brothers who are elected to leadership roles are expected to uphold the C&R and enforce its provisions if necessary.

2. The Ritual of our Order is, by reference, a part of the C&R and thus enforceable. During the installation of Camp officers for instance, the Installing Officer asks a Camp Commander-elect to respond affirmatively to several questions before proceeding. The very first question asks, "Do you agree to be impartial and upright, and to obey all orders or rules and regulations originating from proper authority?" Other questions ask in part if the Camp Commander-elect will "promise to avoid disputes and quarrels" and if he will promise to see that the Camp Secretary and Treasurer reports are sent in promptly to Department Headquarters. Maintaining the harmony of the Sons of Union Veterans of the Civil War is another pledge. Furthermore, when any Camp officer takes the OATH OF OFFICE, he solemnly and sincerely promises and declares that he will faithfully adhere to the Constitution and Regulations and execute & sustain all orders coming from competent authority. Another sentence in the OATH OF OFFICE states in part, "I furthermore promise and declare that in no manner or form will I, in any degree, abuse or misuse the authority placed in me."

3. After a lengthy review of repeated C&R violations, committed willfully by a Camp Commander, I am compelled to issue this General Order of Suspension.

4. The issue stems from a Camp that was placed under suspension by a Department Commander for failure to submit all reports and per capita. Under such suspension, a Camp can ONLY meet to discuss and/or act upon the issue(s) that require(s) action in order for that Camp to come back into compliance. The Commander of the Camp that was placed under suspension asked the Commander-in-Chief to look into the matter, but rather than wait for a thorough review, the Camp Commander conducted regular business meetings on repeated occasions. The Camp Commander, himself, wrote to the National Counselor and the C-in-C, detailing how he held elections and installed himself as both Camp Commander AND Camp Secretary. The letter made it clear that these violations were willful. The Camp Commander also wrote that he would not obey orders from the Depart-

ment Commander nor take receipt of correspondence from the Department Secretary.

5. Such willful disobedience of, and disregard for the Regulations of our Order has led me to the unpleasant task of exercising summary discipline, as described in Chapter V (General Regulations), Article, VI (Discipline), Section 17. Following these guidelines, I submitted a formal Complaint with Charges and Specifications to the National Council of Administration, asking that a vote be taken to support the charges in order to authorize this officer to proceed. The vote was unanimous for the matter to move forward.

6. Therefore, effective immediately, Douglass R. Knight is hereby suspended from his status as a Brother in good standing, pending review of the charges by a hearing council to be appointed by the Senior Vice Commanderin-Chief. Additionally, Douglass R. Knight is suspended from any and all duties as an officer of the William L. S. Tabor Camp 162, Department of Massachusetts, SUVCW. Furthermore, if the hearing council rules the Charges and Specifications to be true, the hearing council may take any action allowed by the C&R. However, my recommendation is that the hearing council remove Douglass R. Knight from all elective and/or appointed offices of the Order and to prohibit him from holding any further elected and/or appointed office in the Order.

7. The election of all officers for William L. S. Tabor Camp 162, that took place on November 17, 2003 while this Camp was under suspension, is hereby ruled as null and void. Effective immediately, the last legally elected and installed Senior Vice Commander of William L. S. Tabor Camp 162, Department of Massachusetts, SUVCW is in command of the Camp and responsible for meeting with officers of the Department of Massachusetts, to facilitate this Camp returning to compliance. When this is achieved, the Department of Massachusetts can lift the suspension and oversee immediate, legal election and installation of Camp officers. If necessary, the last legally elected/installed Junior Vice Commander of this Camp is charged with the duties described above.

A Memorial Day Story By Robert L. Ward

Imagine attending a Memorial Day commemoration and unexpectedly finding the grave of your Civil War ancestor. That's what happened to a father and son, who attended the reenactment of the 1873 Decoration Day ceremony, held at the Old Amphitheater at Arlington National Cemetery on May 30, 2003. The event, sponsored by Lincoln-Cushing Camp 2, was attended by the national leaders of the Allied Orders and MOLLUS.

David H. Ward of Paoli, Pennsylvania, and Robert L. Ward of Socorro, New Mexico, father and son, members of Sgt. Jones Bradbury Camp 149, Media-West Chester, Penn., were walking on the path toward the amphitheater. They glanced to the right and just 20 yards off the path, they saw the grave monument of BG Henry C. Ward, USA, their great grand uncle.

Henry C. Ward of Worcester, Mass., enlisted in the 15th Mass. Inf. and was commissioned a 2nd lieutenant. Later, he accepted a commission as a 1st lieutenant in

Headquarters, Grand Army of the Republic, Washington, D.C. General Order No. 11 • May 5, 1868

1. The 30th day of May, 1868, is designated for the purpose of strewing with flowers or otherwise decorating the graves of comrades who died in defense of their country during the late rebellion, and whose bodies now Kepublic. lie in almost every city, village and hamlet churchyard in the land.

In this observance no form or ceremony is prescribed, but Posts and comrades will in their own way arrange such fitting service and testimonials of respect as circumstances may permit.

We are organized, comrades, as our Regulations tell us. for the purpose, among other things, "of preserving and strengthening those kind and fraternal feelings which have bound together the soldiers, sailors and marines who united to suppress the late rebellion." What can aid more to assure this result than by cherishing tenderly the memory of our heroic dead, who made their breasts a barricade between our country and its foes? Their soldier lives were the reveille of freedom to a race in chains, and their deaths the tattoo of rebellious tyranny in arms.

We should guard their graves with sacred vigilance. All that the consecrated wealth and taste of the Nation can add to their adornment and security is but a fitting tribute to the memory of her slain defenders. Let no wanton foot tread rudely on such hallowed grounds. Let pleasant paths invite the coming and going of reverent visitors and found mourners. Let no vandalism of

the 57th Massachusetts, serving until honorably discharged as captain. While in the service, he was wounded at the battles of Ball's Bluff, Antietam, Spottsylvania Courthouse, and Petersburg. He was captured at Fort Stedman and imprisoned at Libby Prison until Richmond fell to Union forces. After the war, Henry Ward accepted a commission as 2nd lieutenant in the 11th U.S. Infantry, transferring shortly afterwards to the 16th U.S. Infantry. He served in the Army for 39 years, retiring in 1905 with the rank of brigadier general, after being wounded during the Phillipine Insurrection. General Ward was a member of MOLLUS, the GAR, the Spanish American War Veterans, Associated Veterans of Mexican Wars, the Military Service Institution, and the Army & Navy Club. Manila.

Finding the grave of General Ward was a great surpirse and delight to the Wards, father and son, as they had been searching for his burial place for several years without success until last year's Decoration Day ceremony.

avarice or neglect, no ravages of time, testify to the present or to the coming generations that we have forgotten, as a people, the cost of a free and undivided

If other eyes grow dull and other hands slack, and other hearts cold in the solemn trust, ours shall keep it well as long as the light and warmth of life remain in us. Let us, then, at the time appointed, gather around their sacred remains and garland the passionless mounds above them with choicest flowers of springtime; let us raise above them the dear old flag they saved from dishonor; let us in this solemn presence renew our pledges to aid and assist those whom they have left among us, a sacred charge upon the Nation's gratitudethe soldier's and sailor's widow and orphan.

II. It is the purpose of the Commander-in-Chief to inaugurate this observance with the hope that it will be kept up from year to year while a survivor of the war remains to honor the memory of his departed comrades. He earnestly desires the public press to call attention to this Order, and lend its friendly aid in bringing it to the notice of comrades in all parts of the country in time for the simultaneous complaince therewith.

III. Department commanders will use every effort to make this Order effective.

A Long Distance Connection

While our brothers strive to honor the memory of Union soldiers, occasionally a unique circumstance occurs. Such was the case last Fall, as summarized by a letter from Mz. Sarah Ewerds, which is excerpted here.

"My grandfather was born in 1929, to Henry and Alice Ewerds, at Sullivan's Island, South Carolina...Since my grandfather was a small child, he wanted to know his father and where he was. His mother would never tell him the reason his father was not around, nor where he was or what he was doing ... Since the time he married his bride, in 1948, they have both searched on and off to find Henry Ewerds to no avail. The rest of the family joined in the search through a genealogist, national personal searches, Military Personnel Records at St. Louis, libraries, court records, Sullivan's Island records, and many other places. Even with all of this, we could only locate very little information about Henry Ewerd.

"Just prior to her death in 1988, Alice told my grandfather, in a letter, that his father was a corporal in the U.S. Army and was sent out west to Colorado

"I was working on a final paper for college and had to do some research on the internet. I was looking information on my uncle, whose name was Joseph Ewerds. When I entered the name, I found a Henry Ewerds, who was buried in Denver. Colorado, and died back in 1934...I became even more curious and excited to realize that I may have stumbled onto the information my grandfather had waited



some 74 years to know... I ordered an official death certificate and the people in Denver put me in touch with Mr Charles Sharrock. Mr. Sharrock also helped us locate in formation we had been unable to obtain prior to this, especially about his military career. When I called the cemetery...it was mentioned that the burial site was not marked with a headstone... After speaking with Mr. Sharrock and writing a letter to request a military veteran's headstone, it was done. The headstone arrived, in Denver, in September of this year and it was absolutely beautiful. Mr Sharrock took pictures of the marker and sent them to me for my grandfather. I spoke with Mr. Sharrock and told him I would like to take my grandfather to Denver to see where his father was buried. Mr. Sharrock mentioned that we could have a small memorial in Henry Ewerds honor at the time the marker was placed in the ground...

"On October 6, 2003, my grandfather, grandmother mother, uncle and I were present to see this event. We took pictures and laid a family spread of flowers in red, white and blue. Mr. Sharrock was present to meet us and we were all able to share in this life-changing event for my grandfather.

"As of today, my grandfather is a happier man, just knowing the information he desired to know for so long but never knew...I must say that our entire family has a peaceful feeling now that we know more about the man, who was responsible for our family today. We may not have ever really known Henry Ewerds, but we always wanted him to know that we cared and that my grandfather always wanted him.

"One more interesting point is that the Ewerds family is full of veterans for as small as we are or were. It started with Henry Ewerds being in the Army during WWI; his grandson Henry F, Jr. served in the U.S. Marine Corps during Vietnam; his grandson, Larry R, Jr., served in the U.S. Air Force during Vietnam; his great grandson Larry R., Jr., served in the U.S. Army during Desert Shield/Storm; and myself, his great granddaughter, Sarah E. Ewerds, served in the U.S. Navy during Desert Shield/Storm.

"I would like to take this time again to say thank you on behalf of the entire Ewerds family for all of your time, energy and effort spent on us. I am very sure Henry Ewerds would thank you too.

With the most heartfelt gratitude, Sarah and the entire Ewerds Family.

Third North Carolina Camp-at-Large Chartered

North Carolina's Daniel Ellis Camp 3, based in Asheville. held a charter presentation luncheon at a local restaurant on January 3rd. Members and their guests were honored to have Commander-in-Chief Kent Armstrong and his wife, Judy, attend. The Commander-in-Chief also serves as the commander of the "Department-at-Large," which is comprised of all of the camps-at-large, across the nation. Accepting the charter from the Commander-in-Chief were: Camp Commander Yale Mooers, Sr. Vice Commander Tom Rightmyer and Treasurer Richard Sherwin. Other charter members, who could not attend, were Duncan Ely, Penn Ely and Dallas Rightmyer.

The new Camp is looking forward to growing its membership and helping in the preservation of the many Civil War grave sites throughout the North Carolina--Tennessee mountains. Camp 3 already has a newsletter, "The Ellis Dispatch," and plans quarterly meetings at St. George's Episcopal church in Asheville.

The Camp's namesake, Daniel Ellis, was an East Tennessean, who led 10,000 or more troops from the area to Kentucky to enlist for the Union. The Confederates nicknamed him, "Old Red Fox," since he eluded capture throughout the war.

The SUVCW's presence in North Carolina began in 1995 with the establishment of the Ruger Camp 1 in Fayetteville. At the time, Rev. Thomas Rightmeyer was elected Camp Secretary and appointed Chaplain.

In 2002, Br. Rick Thomas organized General John Gib bon-1Sgt Daniel Burke Camp 2 in Charlotte and one year ago, received its charter from PCinC Grim. Last year, PCC Yale Mooers of Camp 2 was granted permission to form Camp 3 in Western North Carolina.

A joint meeting of all three Camps was held on January 24th at historic Bennet Place in Durham, followed by presentations on Judson Kilpatrick, Civil War medicine and a guided tour of the house and grounds.

New Kansas Camp

The historic city of Lawrence, Kansas, is the home of the newest Department of Kansas camp. On December 13, 2003. Set. Samuel J. Churchill Camp 4 was officially installed. In conjunction with the camp installation, seven new members were initiated into the Order.

Additionally, the camp received a transfer member and a dual member.

With over seven inches of snow having fallen in a large part of the State, several Department officers had to cancel their planned attendance at the meeting. Camp Organizer Alan L. Russ, PDC, and Department Secretary Dean K. Speaks. PDC, conducted the initiation and installation ceremonies. The following officers were elected: Camp Commander Craig A. Sundell, SVC Kent Johnson, JVC Alan L. Van Loenen, Secretary/Treasurer Alan L. Russ. PDC, and Council Members Michael Hadl, Ethan G. Van Loenen; and Robert Wandel. Darrell Giles and Roy A. Lafferty are the remaining camp members. The Camp is named for Sgt. Samuel J. Churchill, who received a Medal of Honor for his actions at Nashville, Tennessee, on December 15, 1864, while a member of 2nd Illinois Light Artillery. Churchill's first Kansas connection came in late October of 1864 when his unit camped in Kansas as they were part of the pursuit of Confederate General Sterling Price. Sgt. Churchill is one of three Civil War Medal of Honor recipients buried at Lawrence. Lawrence, Kansas, was a Kansas Territory free state" hot spot during the days of "Bleeding Kansas." In 1856, the town was attacked and burned by pro-slavery forces During the Civil War in August, 1863, Confederate guerrilla leader William Quantrill and his band of bushwhackers staged a pre-dawn raid on Lawrence, burning much of the town, again, and murdering 153 men and boys. Sgl. Churchill Camp 4 is a welcome addition to the Department of Kansas. The members have expressed great enthusiasm in becoming a part of the Sons of Union Veterans of the Civil War. We welcome our new brothers to the Department and the SUVCW.

SUVCW Returns to Georgia

Private Elias Moon Camp 2 is forming and will soon apply for its charter. The impetus for forming the new camp occurred one night last Spring, when then JVCinC Steve Michaels called Brother Eric Peterson, organizer and Past Camp Commander of Major General John Gibbon Camp 4, and Wisconsin Department JVC, to discuss the idea of forming a new camp in Georgia. Brothers Steve and Eric were acquainted through their long time association through the SUVCW.

The response was overwhelmingly positive and including the 30 national members at large there were more than 60 people who contacted Br. Peterson expressing an interest in joining the new camp. It appears that there will be 45 charter members of the new camp.

The camp held its first organizational meeting in August 2003 and has been holding meetings ever since. The corps of provisional officers is; Camp Commander Eric



On November 6, 2003 Governor Bob Taft, inducted 17 citizens into the Ohio Veterans Hall of Fame. The ceremony was held at the Riffe Center for the Government and Arts in Columbus. The Ohio Veterans Hall of Fame recognizes men and women who not only served our country, but also have remained active leaders in their communities after their military service.

One of this year's inductees was Major General Alvin Coe Voris. Gen. Voris served as commander of the 67th Ohio Volunteer Infantry during the Civil War. After the war he was a representative to the Ohio General Assembly as well as Judge of the Summit County Court of Common Pleas.

Gen. A. C. Voris Camp 67 of Akron nominated their namesake for this recognition. Camp Commander Robert Rock, Camp Secretary/Treasurer James Mastromatteo, and Past Camp Commander Paul Huff were on hand to accept the honor.

Last November 16th, Capt. John Bruck Camp 96 honored Pvt. Dewitt Clinton Orr, the last Civil War

veterans to die in Butler County, Ohio.

The ceremony was opened with an introduction by Camp Sr. Vice Commander Roger Mays, followed by a few words from Camp Commander John Clark. Benediction and prayer were given by Department of Ohio Chaplain Craig Keller. A 21gun salute was provided by the 5th Ohio Light Artillery, 24th OVI and other members of the local Civil War re-enacting community.

At age 14 and after the third try. Orr successfully enlisted in the Union Army, became a soldier in Company I, 195th Ohio Vol. Infantry, and was assigned to Camp Chase near Columbus, Ohio. The field commander assigned Orr to be a drummer boy because the men in his unit didn't have enough ammunition. "I came here to fight," Orr is quoted as saying, "not to beat a drum." The officer was so surprised at the young soldier's reply, he handed him his own weapon.

Orr marched to Charleston, West Virginia and continued to fight in the Shenandoah Valley campaign. Following the war, took part in the funeral procession of President Abraham Lincoln in Washington, D.C.

Orr died November 14, 1943, at the age of 94 and was buried at Woodside Cemetery. His funeral service was held at American Legion Post #218. which was constructed on the plot where Orr was born in 1849.





In fact, at that moment, the seller was meeting with Camp Commander Neal Breaugh, bringing the matter to a speedy, successful conclusion.

Since Br. Vouk was appointed to the Committee three years ago, the committee's focus has been on US Veteran grave markers. He got involved because he felt so strongly about marker theft. "My Camp, Anna M. Ross Camp I, Philadelphia, takes care of several veteran cemeteries and I just got tired of seeing the markers disappear, making a tough task on Memorial Day to place flags on veterans graves.
