

Twenty-Ninth Annual Lincoln Tomb Ceremony

Under cloudy skies the 29th annual ceremony to commemorate the death of Abraham Lincoln was held on Monday, April 15, at Oak Ridge Cemetery, Springfield, III. Representing the Sons of Union Veterans was Commander-in-Chief Eugene E. Russell who spoke on the topic, "Lincoln's Farewell to Springfield." Sr. Vice Commander-in-Chief William H. Upham represented the Commandery-in-Chief of the Military Order of the Loyal Legion and told those assembled how his father as a young soldier just released from a Confederate prison had met with President Lincoln in the White House. Sixty-one veterans, patriotic, hereditary, and civic organizations presented wreaths in memory of our 16th President. Music appropriate for the occasion was provided by the George Washington Middle School Band of Springfield. Elements of the 114th III. Vol. Inf. Regt. (Reactivated) under the command of Col. Robert M. Graham, a ceremony co-chairman, served as the official honor guard.

At the luncheon following the ceremony, Judge Joe Dees of Vandalia, III., spoke about the "spark of patriotism" and our need to reignite that spark as we honor the memory of the Emancipator. Among the notables present in addition to Brother Russell and Companion Upham were Jennie B. Russell, National President of the Auxiliary to Sons of Union Veterans; Helen V. Dutch, President of the Illinois Dames and representing the National Dames of the Loyal Legion; Shirley E. Wool, National President of the Ladies of the Grand Army of the Republic; Kay Marie Hoecker, National President, daughters of Union Veterans of the Civil War, 1861-1865, Inc.; and Anita Clark. representing the National President of the Women's Relief Corps.

Commander Martin P. Dutch of the Illinois Commandery of the Military Order of the Loyal Legion gave each luncheon guest a copy of a photograph of Abraham Lincoln made by Alexander Hesler of Chicago in 1860.

Among the organizations that presented wreaths were the Departments of the Sons of Union Veterans and Auxiliary from Illinois, Indiana, Ohio and Wisconsin. Commanderies of the Loyal Legion that participated were Illinois and the Central Illinois Detachment of

- 1. Official call to the 104th Annual National Encampment of the Sons of Union Veterans of the Civil War to be convened at Wilmington, Delaware with headquarters in the Raddison Hotel, 700 King St., August 11 to 15, 1985.
- 2. - 4. All members of the SVR in attendance are requested to bring their uniforms for wearing particularly at Sunday night's Campfire. The uniformed branch of our Order is more than just the showcase part of the SUVCW, it denotes a dedicated desire to give a living realistic witness to those patriotic principles that the rest of us only talk about.
- 5. Sister Jennie and I have made a genuine effort to fulfill our obligations to the Department Encampments. Sincere apologies to any missed because of travel conflicts. Other representations were to the Lincoln Memorial, Washington, DC, Lincoln Tomb in Springfield, III, and the Cathedral of the Pines Rindge, N.H. on Memorial Day.
- 6. Several awards of yellow ribbons and Certificates of Merit have been made for Brothers securing 3 or 5 new members respectively. If there are others who should be appointed as National Aides please report to me as soon as possible. All award recipients will be announced at the Encampment and names printed in the Proceedings. Congratulations to those who realize the importance of obtaining replacements due to the natural and inevitable depletion of our membership.
- 7. Elsewhere in the Banner you will find a more detailed statement on recent Banner problems, as well as comments on other communication matters.
- 8. Congratulations and best wishes to all Department and Camp Officers in furthering the principles and objects of our valued Order, and also full support from all to next year's elected and appointed National Officers.
- All Camp and Department reports should be made promptly to the respective Secretaries to facilitate complete reports for the year. National Officers

and Committee Chairmen should have reports, concise but informative, typed on 8½x11 paper and ready for presentation at the first day's business session. Any proposed resolutions or constitutional amendments should be forwarded in time for proper consideration by the appropriate National Committee. Voting delegates must present proper credentials, but any member, if not an official delegate may be seated and may attend all business and social functions.

- 10. Be sure to contribute as generously as possible to the National Funds that provide the wherewithal for the Sons' patriotic work: Senior Vice Commander-in-Chief Donald L. Roberts fund for promotional work and that of Patriotic Instructor Charles Corfman.
- 11. Appreciation to my Staff Officers, Committee Members, Department Commanders and Secretaries and all others who offered me their loyal support. Special praise to National Historian and Genealogist Jerome Orton for his commendable program of issuing certificates of recognition to first generation descendants of Civil War Veterans. Past Commander-in-Chief Richard Schlenker should be recognized for caring for Members at Large. In the absence of recorded material of recent administrations I would have been lost without the valued advice and suggestions of National Secretary-Treasurer Chester S. Shriver and many other Past Commanders-in-Chief.
- 12. To the other National Presidents of the GAR family whose paths have pleasantly coincided on many occasions: Lorraine Hebestreit Women's Relief Corps; Shirley Wool Ladies of the Grand Army of the Republic; Marie Hoecker Daughters of the Union Veterans of the Civil War; and Jennie B. Russell Auxiliary to the Sons (whose presence was more than a coincidence and provided much-needed moral support) to all may your National Conventions be successful, constructive, and pleasurable.
- 13. To all in poor health and those suffering bereavement may God's blessing be with you as we all extend our heartfelt sympathy.

THE LEGISLATIVE REPORT

Concern About the Martin Luther King, Jr. Holiday — When the 98th Congress passed legislation last fall to establish a 10th federal holiday to honor the birth of Dr. Martin Luther King, Jr., it apparently failed to look into the future. The holiday is set to fall on the third Monday in January in a range from January 15 through January 21 beginning in 1986. Every fourth year the President of the United States is inaugurated on January 20 except when the constitutional inauguration date falls on a Sunday and the public ceremony is then held on Monday, January 21.

Had the new holiday been in effect this year, a conflict would have resulted because of the inaugural events scheduled for Monday, January 21, the third Monday in the month. A conflict will occur on Monday, January 20, 1997, unless the Congress acts to adjust the observance of the Martin Luther King, Jr. holiday, perhaps by moving it to the preceding Friday in years when it would coincide with a Presidential inauguration.

A Federal Holiday for Abraham Lincoln? - It has often been asked why the memory of Abraham Lincoln has been honored on our coinage and currency but not through the enactment of a federal holiday. In this respect it is interesting to note that the House of Representatives on March 17, 1920, passed a measure that would have established the birthdate of our 16th President as a holiday in the District of Columbia, an area where the Congress exercises exclusive jurisdiction. The vote was 180 in favor and 114 opposed, and it came after lengthy debate, not on the merits of Abraham Lincoln's greatness, but on the wisdom of providing another holiday for federal employees. Although the bill passed the House, it died in a Senate committee.

National Graves Registrar

National Graves Registrar, Charles E. Sharrock is seeking the locations of all Medal of Honor winners graves. Brother Sharrock has already ordered at least five new Government issued gravestones. He has traveled hundreds of miles doing this work. Some of the gravestones that are more than eighty years old are illegible. A check with the local cemetery office is made to determine the name of the person buried there. Next the State Graves Registration of Veterans is checked. It gives the name, rank, state he served from, location of grave, enlistment and discharge date and birth and death date. After all this is checked a new gravestone or marker is ordered.

Resolutions and Amendments

Amendment

At the 103rd Annual National Encampment of the SONS OF UNION VETERANS OF THE CIVIL WAR, held August 12-15, 1984 in Akron, Ohio, an Amendment to the Constitution of our Order, Article VI -Formation and Disbandment, Section four (4) changing the time period for a Provisional Department to acquire permanent Department Status from one year - to three years, was presented with the following changes as noted.

The last sentence of Section 4 will read as follows:

"After three years a Provisional Department shall be granted permanent status by the Commander-In-Chief"

This Amendment was adopted by a unanimous vote of National Encampment In session and therefore is now in order for the proposed amendment to be presented to each Department Encampment in the spring of 1985 for rat-Ification in accordance with Article IX of the Constitution, and if favorable acted upon and ratified by at least 50% of the Departments, it will be proclaimed by the Commander-In-Chief in his General Orders to be published in the Banner preceeding the next National Encamp-

Ulysses Simpson Grant 163rd Birthday

On April 27, 1985 The New York Commandery of the Loyal Legion and the National Park Service commemorated Ulysses Grant's birthday with a ceremony from 11 a.m. to 1 p.m. at the Grant National Memorial in New York City.

In addition Congress, through a joint resolution, designated April 27, 1985 as "U.S. Grant Commemorative Day." The Riverside Church Carilloneur prepared a midday recital of Civil War Songs. All participants were invited to a reception at Riverside Church following the ceremony.

On Sunday, April 28, 1985 the General U.S. Grant Birthday Committee, Department of New York, Camps and Auxiliaries, SUVCW and Cadet Corps of New York held a ceremony at the General Grant National Memorial in commemoration of the 163rd Birthday of General Grant, followed by a dinner and reception at the Stella Dorro Restaurant, hosted by Oliver Tilden Camp 26, New York City.

Resolutions

Resolutions passed by the 1st Encampment of the Nebraska-Oklahoma Depart.

Resolution No. 1

At the FIRST (1st) Encampment of the Department of Nebraska-Oklahoma, Sons of Union Veterans of the Civil War a resolution in regards to the regulations Chapter 3 Article IV was voted to be sent to the National Encampment to be held in Wilmington, Del. in August 1985.

The said resolution is as follows:

Add to Article IV section 1 "A National Tax Officer"

Add to Article IV Section 2 following the words "Council of Administration" the words "And a National Tax Officer"

Add to Article IV Section 4 following the words (or National-Secretary Treasurer) the words "and the National Tax Officer"

Renumber the present Section 5 of Article V to Section 6 and add a new Section 5 "The National Tax officer Shall keep an accurate record of the membership of all camps and make a monthly report of the numerical strength of the order. File the annual Tax report for all camps with the IRS based on the quarterly reports of Camps.

The above change is thought necessary as there were 39 camps that had failed to file their annual report with IRS as of Feb. 1985.

Resolution No. 2

At the 1st Encampment of the Department of Nebraska-Oklahoma S.U.V.C.W. it was voted that WHEREAS the PROCEED-INGS must be current in order that an encampment of the National Organization may properly assess the action taken on recommendations made the preceeding year NOW THEREFOR It is recommended THAT:

1. Chapter III Article V Section 3 be amended by STRIKING the words "He shall keep an accurage record of the proceedings of the National Encampment

2. To Chapter V Article 1 Section 2 Add: A New subsection (H) "The Council of

Administration shall elect the Editor of the Proceedings and determine the amount to be appropriated in each yearly budget to defray the cost of publication of the Proceedings and Its mailing.

Lincoln's Birthday Observance 1985

Abraham Lincoln's 176th Birthday Anniversary dawned wet and cold as Washington, DC experienced a 1½" early morning rainfall on February 12, 1985

As ceremony time neared, the sky cleared long enough for the arriving participants to remain dry, the decision already having been made to hold the ceremony within the Memorial, where musicians, honor guards, participants and spectators were ensured relief from the elements.

At 1130 hours, the Lancaster Fencibles, SVR, commanded by SGT Carl M. Hulshart, were observed approaching from the banks of the Potomac River carrying the colors of the Commanderyin-Chief of SUVCW. They were greeted at the foot of the Lincoln Memorial steps by Commander-in-Chief, Eugene E. Russell and Auxiliary National President Jennie B. Russell and their Aides for the day, PCinC Richard and PNP Dorris Schlenker, who had all just paid their respects at the nearby Vietnam Veterans Memorial. The party then ascended the steps to take their respective places for the ceremonies.

The U.S. Navy Band played stirring music until high noon, the traditional starting time for the program, following which official government and organizational representatives rendered proper respects to the 16th President of the United States.

In addition to the wreaths of the President of the United States, the Diplomatic Corps, the Department of the Interior and the District of Columbia, tributes were rendered by 25 other hereditary, patriotic and veteran organizations. Appropriate remarks for the occasion were delivered by Deputy Secretary of Defense, William Howard Taft, IV.

Following presentation of SUVCW and Aux National wreaths by the Russells, Lincoln-Cushing Camp and Auxiliary of Washington, DC had wreaths placed by Camp Commander and Auxiliary President Conrad and Barbara Mook.

At the completion of the ceremony most of the participants met at the Rayburn House Office Building on Capitol Hill for luncheon, to reflect upon the events of the day and to enjoy the fellowship of the many other modern day patriots who came from far and wide to honor President Lincoln.

We are pleased the Sons and Auxiliary are members of the committee responsible for ensuring the continuance of this ceremony.

I sincerely hope that most of the serious problems connected with the distribution of the Banner that have plagued our Order for most of two years are being resolved. Five long overdue issues have presumably been distributed in bulk to all the Departments, for redistribution to the entire membership. A third area of communication is the providing of Department Orders and notices to Camp members in some form for their quick and easy reference. Reading of Orders at Camp meetings do not seem to give the proper exposure to important local matters.

Without proper distribution of information material at all levels, it cannot be expected that Members will show interest in the programs of our Order.
