A Camp is named in his honor in Hoboken, NJ where he raised his family after the war ended. They later all moved to California during the 1920s.

Mrs. Woerner was employed by the State of California as an Employment Representative until her retirement in 1980.

She was an active member of the First Lutheran Church of Inglewood, CA.

During the past year she was very actively involved with the Veterans of Foreign Wars Post and Auxiliary, General William S. Rosecrans 3261 in Gardena, CA and is currently serving as a trustee.

She is also an active member of the Torrance Ladies of the Elks, Auxiliary to BPOE Lodge 1948, Torrance, CA.

THE **LEGISLATIVE** REPORT

Thomas L. W. Johnson

Status of Memorial Day - Shortly after the 100th Congress convened in January 1987, Rep. Phil Crane (R-IL) introduced H.R. 108 which would have the effect of repealing the Uniform Holiday Act of 1968 and returning Washington's Birthday, Memorial Day and Columbus Day to their traditional dates on our calendar. The bill has been referred to the Subcommittee on Census and Population but no action has been taken by that panel. Of interest is the fact that the composition of that five-member subcommittee has changed so that only Rep. Robert Garcia (D-NY) remains a member and he has relinquished the chairmanship to Rep. Mervyn M. Dymally (D-CA). Other members are Rep. Gerry Sikorski (D-MN), Rep. Constance M. Morella (R-MD), and Rep. Dan Burton (R-IN). Rep. Dymally, a native of Trinidad in the West Indies, represents the southern portion of Los Angeles County in the Congress and is a former Lt. Gov. of California. He was first elected to the House of Representatives in 1980 and is in his 4th term.

Gettysburg Battlefield Site - On March 10, 1987, the House of Representatives passed and sent to the Senate H.R. 797 which would accept the donation of approximately 31 acres known as the "Taney farm" from the Gettysburg Battlefield Preservation Association for inclusion in the National Military Park The measure would also require a study and report to the Congress on the final development of the site since the boundaries of the Park have never been officially approved by Congress.

Bicentennial of the Constitution -Bills have been introduced in the House and the Senate to make September 17. 1987 a federal holiday in honor of the 200th anniversary of the Constitution. The House bill, H.R. 157, has been reported favorably by the House Post Office and Civil Service Committee but has not come up for consideration and a vote on the House floor. The Senate has taken no action on S. 699. With the Congress presently in recess until early September, there is little likelihood that this measure will become law in time to take effect on September 17. However, the recommendation of the House committee will stand as a tribute to the idea.

Commission on National Observances - Again in the present Congress, bills have been introduced to establish a national commission to advise the President on proposals for national observances and thereby relieve the Congress of that responsibility. H.R. 245 has been introduced by Rep. Claudine Schneider (R-RI), and H.R. 998 by Rep. Dave McCurdy (D-OK). In the past, measures like these have not received much attention because Representatives and Senators value the public relations involved in promoting special days or weeks during the year. Neither measure would curtail in any way the authority of Congress to consider the creation of public holidays.

Department Wisconsin: On Memorial Day, May 25, 1987, Col. E. A. von Frankenberg and the men of "Cushing's Battery" led our Department's tribute to the centennial of the Wisconsin Veterans Home located at King, WS. Known for many years as the Grand Army Home, this facility was started in 1887 by the Wisconsin Department of the GAR and years later came under the jurisdiction of the State of Wisconsin and its Department of Veterans Affairs, Centennial events are being observed throughout the year. Following the lakeside water service, Col. von Frankenberg, assisted by Col. Burton E. Kannenberg, marched the battery to a ridge in the cemetery adjacent to the Home where three Civil War vintage field pieces had been mounted. At the conclusion of the formal ceremony. the battery, under the command of 1/Lt Ronald Aronis, fired an impressive salute. After the ceremonies had concluded, spectators were invited to join the men of the battery for a demonstration of nomenclature and firing procedures conducted by Lt. Aronis. In the afternoon, Col. von Frankenberg hosted a display of Civil War artifacts from his collection which was set up in a squad tent on the grounds of the Home. Ellinore and Tom Johnson joined in the ceremonies as representatives of the Department and its Auxiliary. At the Department Encampment in

June, Col. von Frankenberg and William H. Upham each received the "Good Guy Award" presented to them on behalf of the Department by Commander Tom Johnson for outstanding service in promoting the heritage of the Civil War in the Badger state. Both men are Department officers and have given unstingily of their time and talents on behalf of our Order.

The Grand Army of the Republic Highway — Yesterday and Today

Following the initial success in getting the State of Massachusetts to designate Route 6 as the GAR Highway and in having the road completed to the West Coast, the GAR Highway committee turned its attention to convincing all of the other states through which the road passed to officially designate it as the GAR Highway and to erect markers so naming the highway.

At the 68th Annual Encampment in August 1949, the committee was able to report that legislative sanction officially designating Route 6 as the GAR Highway had been granted by all of the states through which the highway passed except Nevada. At the same time, a generally favorable report was presented regarding the willingness of states to erect SUVCW approved GAR Highway markers. It was recommended, however, that aluminum markers be substituted for iron plate markers then in use which were susceptible to rust and flaking of the printed inscription.

The efforts of the SUVCW Highway Committee in subsequent years were dedicated to the continued urging of states to publicize the route's existence as the GAR Highway, to erect and maintain the GAR Highway markers, to maintain the highway in good condition, to provide statistics on the highway in their state, and to create parks along the highway.

In retrospect the committee deserves considerable credit for its efforts. The Chairman, Brother Allen S. Holbrook, however, provided little optimism at the 73rd Annual Encampment in August 1954 when he reported: "This is a picture, Brothers, of the GAR Highway, as I have been able to get data up to the present time. It is not one of which we are entitled to a great amount of credit. after some ten or twelve years of effort. Yes, we do have a cross country Highway dedicated to our beloved sires, but Pennsylvania has continued to update Route 6 throughout the years since 1934 so there has been some re-routing and realignment.

Ohio: US Route 6 travels through nine Ohio counties invilvong four of twelve highway districts. A survey of these districts revealed that one GAR Highway sign remains in Sandusky County, one in the village of Sheffield Lake, three in the village of Chardin in Ashtabula County and one near the Pennsylvania border at the State Line Road. No markers were found in the other counties. A map published by the Geauga County engineers continues to contain references to US Route 6 as the GAR Highway. With the exception of the bypasses of Napoleon, Bowling Green, and Freemont, there have been no significant relocations of Route 6 since 1934.

Indiana: Since its designation as the GAR Highway in 1937, there have not been many major changes or re-routing of US 6 in Indiana. A bypass was constructed around Bremen to relocate US 6 and a portion in Lake County has been re-routed over I-80/I-94 and SR51 instead of Ridge Road. The Highway Department knows of no GAR Highway markers that are still in place.

who knows of it? Ask anyone in general outside of our affiliated organization what and where is the Grand Army of the Republic Highway and nine chances out of ten the answer will be, 'Never heard of it.' Now that we have it, will we be able to keep it? Only time will tell. I feel assured, however, that we will keep it only so long as we fight for it, work for it, and make of it a living, thought-stirring memorial to every one of those who answered Lincoln's call in the '60s, be he General or Private, and who preserved for us a nation united in spirit as well as in name."

In more recent years, the GAR Highway Committee and GAR Highway Officers, after the Committee effort was replaced by the GAR Highway Officer, devoted their efforts to urging state highway departments to maintain Route 6 and the GAR Highway markers in good condition, to collect data on any changes of the routing of Route 6 through the various states, and to enlist the support of SUVCW camps in states through which the Highway passed to work with state authorities to keep Route 6 in the public eye as the GAR Highway.

Status of Route 6 and the GAR Highway Markers in the States Through Which it Passes

The following summary of the current status of the GAR Highway is based upon responses from Departments of Transportation to letters sent to them by the National GAR Highway Officer: Massachusetts: Unfortunately, the Massachusetts Department of Transportation did not respond to two separate appeals by the GAR Highway Officer for information on the current status of the Highway in Massachusetts. Other information, however, shows that although the construction of Interstate I95 turned Route 6 into a bypassed highway, it remains an interesting route with many reminders of a bygone era.

Rhode Island: Route 6 is still designated as the Grand Army of the Republic Highway in Rhode Island and is so designated on the official state highway maps. The Department of Transportation knows of at least one GAR Highway marker that remains in place just over the Rhode Island line from Massachusetts. Unfortunately, it is believed that most of the other markers along the route have disappeared. With respect to changes in the routing of the Highway, it has changed at different times through Providence with new construction and traffic patterns.

Connecticut: Although no change has been made in Route 6's designation as Grand Army of the Republic Highway. considerable relocation of Route 6, approximately 50%, has taken place in Connecticut. Only a few of the markers remain and are located in the Eastern section of the state. Since instituting a strict policy about 15 years ago of erecting only essential signs based on safety, need to know considerations and funding limitations, the State has not replaced signs considered non-essential, but has with participatory funding erected and maintained signing associated with the nation's bicenten-

New York: In New York, Route 6 continues to bear the GAR Highway designation. In the town of Cortlandt, Route 6 is still on the original GAR Highway alignment. However, in Yorktown and Sommers most of the route is on new alignment. In Yorktown, Route 6 used to follow what is now East Main Street and the present Route 6N in Westchester and Putnam counties was probably "old" Route 6. Highway Department officials recall a GAR Highway marker near the intersection of Route 6N and East Main Street in Yorktown, but they cannot confirm that it is still there.

Pennsylvania: As in Rhode Island, Route 6 continues to be designated as the GAR Highway in Pennsylvania and it is so marked on the state's official

transportation map. The earlier porcelain and wood GAR Highway markers have been replaced with aluminum signing commemorating the highway.

Illinois: Route 6 still carries the name GAR Highway in Illinois. It follows essentially the same alignment across the state as it did when it was originally constructed. Grand Army of the Republic Highway signs are still located along this highway in Illinois and in 1975 new signs were erected to replace those that were missing or in need of replacement.

lowa: The GAR Highway in lowa continues to follow the route of US 6, although there have been some changes in routing and jurisdiction of the highway. At three locations, US 6 has been shifted to Interstate 80 and the old alignment is now either an unnumbered primary route or has been transferred to the jurisdiction of a county. GAR Highway markers exist at 29 locations in lowa. Twenty-three of these are still on the route which is designated as US 6, while the other 6 are on what is now designated as an unnumbered primary or county route.

Colorado: While US 6 is still designated in Colorado as Grand Army of the Republic Highway, it has undergone extensive changes through the years. US 6 has been fragmented by construction of the Interstate System and now serves local traffic only, primarily through towns bypassed by Interstate Highways 70 and 76. Unfortunately, none of the GAR Highway markers appear to remain in Colorado.

Nebraska: Although the Nebraska

Department of Roads recognized Route 6 as the GAR Memorial Highway, confirming legislation was never provided by the Nebraska Unicameral. Nevertheless, markers designating it as the GAR Highway were installed along the highway throughout the length of the state at about 15 or 20 mile intervals. There were a few extra signs left for maintenance replacement. In the course of time, because of maintenance requirements, vandalism, and theft, this extra supply was exhausted. The Department of Roads does have one of these markers preserved in their permanent historical collection. However, it appears that there are no longer any GAR Highway markers in existence on US 6 in Nebraska at this time. The alignment of US Highway 6 has changed very little throughout the years in Nebraska, except for some relocation in urbanized areas, such as Omaha and Lincoln.

Utah: For fifty years after its establishment in Utah in 1936, US Route 6 or Grand Army of the Republic Highway maintained the same alignment. In recent years, however, a portion of the highway in southeast Utah has been replaced with Interstate 70. Unfortunately, the Utah Department of Transportation reports that there are no longer any markers along US 6 designating it as the GAR Highway. Nor have the official Utah State Highway maps for the past thirty years shown US Route 6 as the GAR Highway.

Nevada: Although portions of Route 6 through Nevada have additional route numbers of Route 50 or 95, it appears to follow the path of the original Route 6 when it was designated the Grand Army of the Republic Highway. A review by the Nevada Department of Transportation of the photolog of Route 6 revealed no GAR Highway markers along the Route. While several Department staff members recall seeing such markers in the past, none have been seen in the last several years.

California: A small portion of US Route 6 remains in California. This section runs through Bishop, CA between Route 395 and the Nevada state line. The highway over the years has been absorbed into newly constructed freeways and none are referred to as the Grand Army of the Republic Highway. In Los Angeles, the Grand Army of the Republic Highway followed what is now Figueroa Street to San Pedro and then followed San Fernando Road out of the city. All of the markers and monuments are gone.

Conclusion

In view of higher highway maintenance costs and budget limitations in most states, it is unlikely that we can persuade state highway departments to undertake a greater effort in maintaining, restoring, or adding new GAR Highway markers along Route 6. It is realistic, however, to urge state Departments of Transportation to continue using the GAR Highway designation for Route 6 on its official highway maps, in tourism material, and in Department publications. Similarly, we can keep the memory of the GAR Highway alive through articles in touring magazines and publications; in newsletters and publications of city, county, and state historical societies; and in Civil War related magazines and publications.

Such an effort is likely to reach a greater audience and promote a greater awareness of the Highway than the highway markers which are seen only by those transiting the route. In this connection, it is interesting to note that a library group in Johnston, Rhode Island learned of my letter to the Rhode Island Department of Transportation and wrote to me asking if I might provide some information on the GAR Highway for the group to use in a local newsletter since the Highway passes directly through Johnston. The information was, of course, provided with the request that we receive a copy of anything publish-

THE GAR HIGHWAY IS NOT DEAD, BUT LIVES ON! Although some changes in the alignment of US Route 6 have taken place, it continues to bear the name Grand Army of the Republic Highway. The Marshall A. Hope Distinguished Author Award

The Marshall A. Hope Distinguished Author Award was established at the 101st National Encampment by Jerome L. Orton, PDC-NY, in honor of the late PDC Marshall A. Hope, a well known columnist of Oneida, NY.
