"With Firmness in the Right"

1. We all know of cases where seriously or terminally ill people are kept alive solely through life support systems. Ultimately, the question usually arises as to how long the patient must continue to suffer before the use of the life support system is discontinued. In addition to the medical questions, there are also the moral issues that arise at such times. I am afraid that we have some Camps and even Departments where there is little evidence of life. Meetings are not held, there are no elections, no activity takes place toward accomplishing the objectives of the Order, and no efforts are made to recruit new members. In these cases, the life support system is usually one dedicated, often older, member who keeps the Camp or Department alive (at least on paper) by submitting the necessary reports to National and paying the per capita dues of a few members out of his own pocket. Thus, when the member keeping the Camp or Department alive passes on or is no longer able to continue his life support role, the Camp or Department finally expires. As with the demise of family members and friends, it is always painful to see these Camps and Departments come to an end.

I am certainly not prepared to make a judgment on how long a non-functioning Camp or Department should be kept on a life support system. Rather, I would advocate making every effort to resuscitate the ailing Camp or Department. If efforts are made to cure the illness before it reached a critical stage, the decline can often be arrested or reversed. In some cases, the recruitment of one individual who is sufficiently motivated can turn things around. I have seen cases where one prime mover can

recruit a dying organization. Let's revive our ailing Camps and Departments so that the life support systems are no longer required!

2. It was especially gratifying to participate in the Remembrance Day events in Gettysburg, Pennsylvania during the weekend of November 15-17, 1991. Blessed with beautifully mild weather and an excellent attendance at all events, this was truly a weekend to remember. Following the SVR breakfast at 8:00 a.m. on Saturday, briefings were held for commanders of units participating in the parade. Stepping off precisely at 2:00 p.m., I had the honor of marching at the head of the parade with SVR Commander B/G Charles Corfman. An estimated 5,000 Union and Confederate troops paraded through Gettysburg to the Woolson monument on the National Park grounds. The wreath laying ceremony at the monument proceeded with Past Commander-in-Chief Richard C. Schlenker serving as Master of Ceremonies. The cyclorama program was well attended by an enthusiastic audience which heard from speaker Ed Bearss of the National Parks Service and of the Ken Burns Civil War series fame. The banquet in the evening was attended by approximately 150 persons. An unprecedented 800 participants danced at the Blue Gray Ball. I extend a hearty "thanks" to all those who worked hard to make the 1991 Remembrance Day a spectacular success.

3. The traditional Lincoln Death Day ceremony will be held, as usual, at the Lincoln Tomb in Springfield, IL., on Wednesday, April 15, 1992. I plan to attend and place the wreath of the National Organization, SUVCW, and I'm looking forward to seeing as many brothers and sisters of the Auxiliary who can attend this always impressive ceremony. 4. Although the THE BANNER is now being published on a regular basis, we continue to experience problems with mailing and distribution. The major reason for the delays in delivering THE BANNER has been the use of third class bulk mailing rate. We find that bags of THE BANNER often languish in Post Offices for long periods before they are ultimately delivered. For example, over 1000 of the Spring 1991 BANNERS were discovered in November, 1991. We hope to solve the problem by mailing THE BANNER by first class mail even if we must reduce the number of editions published in order to pay the increased postage costs. I personally believe that it is preferable to receive two or three editions of THE BANNER a year by first class mail than never to receive four editions sent by third class. However, there are other problems that cause delays or non-delivery of THE BANNER. If THE BANNER Editor isn't provided with an up-to-date mailing list for your Department and returns for wrong address reach the 10% level of the Department list, THE BANNERS for that Department are sent in bulk to the Department Secretary who is responsible for sending them on to the membership. There are instances where the Department Secretary can not or does not mail them on to the members. Additionally, delays in publication are experienced when those responsible for submitting material to THE BANNER Editor do not meet his deadline. The successful publication and delivery of THE BANNER is not solely up to the Editor and the Council of Administration. It requires teamwork and the cooperation of all Camps and Department officers and members.

5. Camps and Departments are urged to submit news items and photographs pertaining to their activities to THE BANNER Editor for publication. You may be engaging in some very worthwhile programs and projects, but if we don't know about them, the impression is received that you aren't doing anything. Although space limitations

may prohibit the publication of all photographs received, the Editor will, hopefully, be able to publish the articles covering your activities. Three issues of THE BANNER are planned this year.

6. I wish to express my sincere appreciation to the Lincoln-Cushing Camp, especially to Past Commander-in-Chief Richard C. Schlenker, Past National Auxiliary President Dorris Schlenker, and National Personal Aide Peter Dixon, for the beautifully organized testimonial dinner held in my honor on November 9, 1991. I also wish to thank all those who came to honor me on that occasion.

7. I was deeply saddened to learn of the death of two Past Department Commanders: Ora Niffenegger of Des Moines, IA., and James Y. Ledwith of New Haven, CT. Jimmy was a faithful attendee at the National Encampments and took pride in serving as Guide during the last several Encampments which he attended. All Charters are to be draped in their honor for one month.

8. "I hear you knocking, but you can't come in" was the title or at least the refrain of an old tune of the 1940's period. I think of this refrain when I hear about men who are interested in joining the SUVCW but are unable to do so because of a lack of response on our part. In short, they are knocking on our door and we are not answering. Recently, a number of such cases have come to my attention. There is absolutely no excuse for such inaction. If you are unable, for some reason, to assist an interested individual, at least turn the request over to a Camp, Department, or National officer who can help the prospective member.

9. In any organization there will always be opposing views among the membership regarding programs, management of finances, meeting schedules, and other matters. This is quite normal and not without its positive side. However, when these differences become so pronounced that deep seated ani-

mosities are created and the conflicts supersede all other activity of the organization, the very life of that organization is at risk. I, therefore, urge the brothers of all Camps and Departments to put forth a genuine effort to resolve such differences in a reasonable manner before serious damage is done to the Camp, Department, and National Organization.

10. Your Commander-in-Chief and other National officers welcome ideas from the membership on how we can improve our service to the organization or ideas regarding programs that the SUVCW should be conducting in furtherance of our objectives. Please do not hesitate to share your thoughts with us. If we can reasonably do so within the bounds of available manpower, finances, and other resources, we will attempt to implement worthy suggestions.

11. We wish a speedy recovery to all those brothers and sisters of the Auxiliary who are suffering from illness.

12. I urge everyone to contribute something during the coming year to the G.A.R. Memorial fund administered by the National Patriotic Instructor and to the Sr. Vice Commander-in-Chief's Fund so that we can continue the important projects made possible by these funds.

13. On the positive side, I was truly pleased to present National Ribbons and Certificates of Merit to the following brothers of the George Armstrong Custer Camp #1 of the Department of Illinois: Nicholas Kaup (18), Timothy Frake (7), Thomas Hauff (3), Harvey Hull (3), and David Bailey (3). A letter of commendation and Certificate of Merit was also presented to Brother George Nuoffer of the Department of Wisconsin for his dedicated service as the SUVCW representative on the Veterans Affairs Voluntary Service Hospital Advisory Committee at the Tomah Wisconsin Medical Center. The Department of New York is also to be commended for its fine work in publishing a book

on G.A.R. and Union monuments in New York, and support to The Grant Cottage preservation effort and other fine programs. Commendation also must be accorded the Ohio Department for the very active programs of the Department and its Camps, as well as, for the excellence of its communications with the membership. Other Departments and Camps may be engaging in outstanding activities. Please let us hear about them!

14. The 1992 National Encampment in Pittsburgh, PA, will be our first experience with the condensed schedule and weekend format. Our objective in this was to attract greater attendance at the National Encampments by (1) reducing costs by shortening the number of days required and taking advantage of hotel weekend rates, and (2) making it possible for those who cannot absent themselves from their employment during the week to attend the Encampment on a weekend. Perhaps these modifications will make very little difference in the attendance at the National Encampment and we will wish to return to the old format. However, if we are unwilling to experiment, we will never know if the changes offer improvements or not. To make this experience successful, we will need the cooperation of everyone in keeping on schedule in our business sessions and organizing our other activities in the most efficient manner possible.

15. **Memorial Day:** While other societies and organizations often play the major role in sponsoring and organizing activities on the 4th of July, Veterans Day and some of the other special days, Memorial Day is **our day**. As the successor organization to the Grand Army of the Republic, it is our responsibility to carry out General John Logan's General Order #11 to the G.A.R. by sponsoring or participating in Memorial Day ceremonies. If your Camp is not strong enough to organize and sponsor such events, at least participate in a Memorial Day event in your locality.

16. Our deepest sympathy is extended to BANNER EDITOR, James O. Lee, over the recent loss of his father. Sympathy is also extended to all those brothers and sisters of the Auxiliary who have lost loved ones recently.

17. As of this writing (February 27, 1992), I have accepted invitations to encampments of the Departments of Massachusetts (10-12 April), Maryland (25-26 April), Michigan (12-14 June), Ohio (19-21 June), and Pennsylvania (26-28 June). I regret having had to decline invitations to Iowa, New York, and California-Pacific because I had earlier accepted invitations from Departments having Encampments on the same dates. As indicated earlier, I will do my best to attend Department Encampments where my presence is required. Give me as much advance notification as possible if you would like me to attend your encampment.

The 35th Annual Remembrance Day weekend at Gettysburg was a busy one as always when representatives of The Allied Orders of the Grand Army assembled from far and wide in what has become our annual pilgrimage and reunion.

Friday evening saw a Maryland Department Banquet followed by a

Saturday activities started early with a Sons of Veterans Reserve Breakfast, then the SVR Staff meeting, a Parade Unit Commander's briefing and luncheon. The traditional parade stepped off at 2:00

p.m. arriving at the Woolson Monument in Ziegler's Grove at 2:45 p.m. More than five thousand (5,000) troops participated this year. All National and Pennsylvania State heads of the five Allied Orders were in attendance and made floral presentations at the monument in memory of our ancestors.

Many of the guest units from the parade went to various places on the battlefield which held special significance to them and held memorial services. Remembrance Day has come to be important to many other groups now which pleases us as originators of the event.

At the indoor program in the Visitor Center Auditorium our speaker-of-the-day was Edwin C. Bearss, Chief Historian of the National Park Service.

The 61st Annual Dedication Day Dinner in the early evening was heavily attended justifying the Committees decision to move to large facilities. The Blue and Gray Ball which followed was attended by more than seven hundred fifty (750) dancers.

Lincoln's Birthday 1992

Participants in the observance of the 183rd anniversary of the birth of President Abraham Lincoln, at the Lincoln Memorial in Washington, DC, were greeted by bright and breezy sunshine on a bone chilling Wednesday morning, February 12.

As the strains of music played by the Navy Band wafted across the plaza, the colors of our order, borne by the Lancaster Fencibles, SVR, could be seen snapping in the breeze. Then came the smart looking contingent of the 28th Pennsylvania Volunteer Infantry, SVR, from Philadelphia.

Representatives of all of the Allied Orders were on hand to place floral tributes at the foot of the famous Daniel Chester Finch statue of the martyred President.

The cooperative efforts of the Military District of Washington, the

National Park Service and the Lincoln Birthday National Commemorative Committee were most evident in this solemn ceremony.

Held on the steps of the Memorial, the ceremony was witnessed by a larger than usual crowd, with many busloads of school children present.

It was thrilling to hear the Gettysburg Address recited by a sixth grade student and the message from President Bush read by the Commanding General of the Military District of Washington.

Because organizations such as ours continue to lead and support ceremonies such as these in Washington and other communities across the nation, our heritage shall endure.

The Legislative Report

Study of Civil War Battle Sites— In the passage of the Arizona Wilderness Act of 1990, Congress included as an amendment the substance of S. 1770 which was designed to create a study of Civil War battle sites in the Shenandoah Valley of Virginia. The Arizona Wilderness Act, PL 101-628, approved November 28, 1990, is significant for the study of Civil War history on at least three counts.

1. It authorizes a study of Civil War Sites in the Shenandoah Valley to include an assessment of the condition and prospects for preservation.

2. It established a 13-member Civil War Sites Advisory Comm. and authorizes it to study historically important battles and sites other than those located in the Shenandoah Valley.

3. Title VI of the Act mandates a study of the Underground Railroad operations with the intent of having the National Park Service preserve and interpret key aspects of that movement.

Other legislation introduced on the subject of battlefield preservation include S. 17 and S. 80 pertaining to the Battle of Corinth, MS. S. 225 and H.R. 424 would expand the boundaries of the Fredericksburg and Spotsylvania County Battlefields National Park. H.R. 2370, would expand the size of the Stones River National Battlefield Park in Tennessee. The Senate has under consideration H.R. 990, which would authorize appropriations for land acquisition at Monocacy National Battlefield Park in Maryland.

Preservation of Historic Sites

(other than Civil War Sites)— Legislation has been introduced to increase the acreage of the Palo Alto Battlefield National Historic Site in Texas. That site commemorates the first engagement of the Mexican War and is the only location under the National Park Service that marks the era of the Mexican War. The bill, H.R. 1642, has passed the House and awaits Senate action. Bills have been introduced to study and preserve historic forts in New Mexico and in Kansas. In New Mexico, Fort Craig and Fort Stanton figured in the Battle of Glorietta fought in 1862. That engagement established federal supremacy in the New Mexico Territory and ended hopes that it would join the Confederacy.

Monday Holiday Legislation—At least two measures would restore the federal observance of Memorial Day to May 30. S. 115 and H.R. 1105 would return Memorial Day to its traditional date. The sponsor of the House measure, Rep. Phil Crane (R-IL), made the following remarks upon the introduction of his bill.

"In the battle to have the dates changed to Monday, we successfully destroyed the meaning of the holiday by equating them to business and profits. Indeed, a brief look at the Congressional Record during the 1968 debate illustrates this fact. The arguments that carried the day were those which lamented to money which industries lost in absenteeism and in closing down and startup costs resulting from the holiday.

Since 1971, when the Monday holidays first took effect, the meaning of the special days has become increasingly more obscure. An editorial in the New York Times on February 9, 1971, noted this fact and suggested that since we were honoring the dollar over the holidays by moving the dates of observance, why not do away with the names altogether and simply number the holidays!"

Commandery-in-Chief Flag

In 1953, at the 72nd National Encampment of SUVCW held in Buffalo, NY, the golden flag of the Commandery-in-Chief was presented to the organization by Runkle's 1950 Club. This was a group composed of all of the Department Commanders who served during the year in which John H. Runkle of PA, was Commander-in-Chief.

The flag has flown in many parades, ceremonials and encampments over the years, serving our order well, but it began to show the wear of tried and true service.



In 1991, at the 110th National Encampment held in Indianapolis, IN, it was voted to replace the flag.

This was accomplished through the auspices of Past Commander-in-Chief Charles W. Corfman of Ohio.

In 1992, at the annual Lincoln Birthday commemoration in Washington, DC, the changing of the colors took place. Brother Corfman presented the new flag to Commander-in-Chief Lowell V. Hammer, who in turn passed it to our official color guard, The Lancaster Fencibles who proudly carried it throughout the ceremony at Lincoln Memorial. Commander-in-Chief Hammer then presented the retired flag to Sr. Vice Commander-in-Chief Elmer F. Atkinson for safe keeping at the G.A.R. Museum in Philadelphia.




