



Past Camp Commander receives Purple Heart

Lance Corporal Ty Streeter arrived home from duty in Iraq. He was recouping from a wound he received in action.

Ty arrived in Kuwait with his unit, the 1st Marine Recon Company. 4th Platoon on February 3, 2003. On March 2nd, they crossed the Iraq border and entered Nassarea for 10 days, then started the march to Baghdad.

Enroute to Baghdad, he was involved in the P.O.W. rescue that included Pvt. Jessica Lynch. The mission involved British Royal Marines, Australian Special Forces, Navy Seals, Army Rangers and Ty's Marine Recon Unit. On disembarking his helicopter Ty received a gunshot wound to the upper leg. He didn't realize he had been shot until he was back on the copter after the successful raid. The wound was a clean one and the round was extracted from his leg. The round proved to be from an AK-47. The surgeon gave Ty the round as a 'souvenir.'

As a member of the rescue mission, Ty received the Navy Cross along with the Purple Heart for being wounded in action.

Ty is a Past Camp commander of Colegrove-Woodruff Camp 22 in Marshall, Michigan.

3. The CinC has also issued a Meritorious Service Award to honor the memory of Brother Christopher P. 5. Our organization has marked its 122nd Anniversary. Major Augustus Plummer Davis and "eight boys" organized the first Camp of the "Sons of Veterans" on Saturday, November 12, 1881. May our Order forever endure and thus "perpetuate the memory of the Grand Army of the Republic" and all of the soldiers, sailors, marines, and members of the Revenue Cutter Service who honorably served to save the Union.

6. The 47th Annual Remembrance Day was conducted on November 15, 2003 at Gettysburg, Pennsylvania. [The program is observed each year on the Saturday nearest to the nineteenth of November (the day in 1863, when President Lincoln delivered his "Gettysburg Address" during the dedication of the National Cemetery, there).] Congratulations for a job well done are extended to our Remembrance Day Committee. Kudos also go out to all of the volunteers who help host the annual Civil War Military Ball at the Eisenhower Inn, south of Gettysburg. The proceeds from last year totaled \$5.500 and a check in that amount was presented by PCinC Elmer Atkinson to Gettysburg National Military Park Superintendent John Latschar. This money will be combined with last year's donation for the restoration of Union and Confederate regimental history tablets. 7. With this year marking the 140th anniversary of the Battle of Gettysburg, as well as the dedication of the Gettysburg National Cemetery, the CinC presented a Certificate of Appreciation to Superintendent Latschar and his staff for their work to preserve and protect the battlefield and cemetery. The CinC also marked Remembrance Day by presenting a Certificate of Recognition to the leadership of the Sons of Veterans Reserve, in honor of the SVR's 100th anniversary.

8. Once more, we are very grateful to the merchants of Gettysburg who paid all fees related to the parade permit for Remembrance Day.

General Orders No. 12

I. A question has been submitted, asking if a Real Son of a Union veteran of the Civil War is expected to pay the initial Application Fee when he first becomes a Member of the SUVCW.

2. In the Regulations portion of our Constitution and Regulations (C&R), CHAPTER III - National Organization, ARTICLE VI - Finance, Section 3 - Life Member Programs, Subset (e) states in part, "First generation Sons of Union Veterans are entitled to be a Life Member without payment of any fee."

3. I have been advised that the reference of "without payment of any fee" is intended to be all-inclusive. Therefore, it is the ruling of this CinC that Real Sons are exempt from all fees. This includes the application fee, Life Member fee, and per capita (= no annual dues). However, this does not apply to the cost of items purchased through the National Quartermaster (membership badge, etc.).

This recognition is once a year to an individual or group who performs outstanding service in the memory of Union Civil War Soldiers.

War Dead, Two Real Sons

Two Real Sons from Canada Recognized

Three years ago, members of 20th Maine. Co I, a reenactment group based in New Brunswick and Nova Scotia Canada. began searching for the gravesites of American Civil War veterans, who are buried in Atlantic Canada.

To date, 75 resting places of veterans have been located and there are leads on another 25. Although a few of these menwere Americans who moved to Canada following the war, most are some of the 50,000 British North Americans who crossed the border to do their part to help preserve the Union or to tear it apart.

Most British North Americans served the Union, but there were some who fought on the side of the Confederacy. Because records are incomplete, or were never kept in the first place, we may never know how many "Canadians" enlisted, were killed in action, or even returned home.

My name is Terry Middleton and I am

President of our Maritime Civil War Living History Association. I am also an Associate Member of the National At Large Camp of the SUVCW. I had been placing requests in local newspapers, through a Genealogy column, and in Genealogy Magazines, looking for information on Civil War graves or ancestors. Several graves were found by descendants contacting me.

Graveside memorial services at these sites received TV and radio coverage. After one of these, I was contacted by a lady from Dipper Harbour who told me about Edwin Clarks' grave.

For two years I had known about Edwin T S Clark, ordinary seaman, USS Maria A Wood, being buried in Dipper Harbour, a small fishing community about 20 miles west of Saint John, New Brunswick. What I didn't know was that two of his children were still living. She told me that George Clark lived in Saint John, NB, and Arthur Clark lived in Rothesay, NB, which is where I live. I immediately contacted a niece of theirs and met with Arthur Clark, which indeed was a great honor.

It was decided that a memorial service, honoring Edwin T S Clark, and his sons, George and Arthur would be held. The Sons of Union Veterans of the Civil War were contacted and certificates and medals were pro-

vided for the two sons. A ceremony was planned for Oct 25, 2003 in Dipper Harbour.

Edwin Clark was a native of the Dipper Harbour area, and returned there after the war. He enlisted in the US Naval Service on October 14, 1861 and was discharged from the USS North Carolina on August 5, 1862.

He married late in life and had six children. His wife Lillian Sweet was 38 years younger. When he died in 1920, George and Arthur were ages 6 and 4. The young family survived on a pension they received from the US Government. They do not recall a lot about their father because they were so young. George related this memory; "One of my last memories of him is him chasing me up the hill to go to school. I remember looking back over my shoulder and seeing the top of his head, of him standing at the bottom of the hill, making sure I went," Arthur recalls being "scooped up" by his father and placed on a plank across the woodbox near the stove to stay warm while his father made breakfast.

Several days of rain gave way to a clear sunny sky on Saturday, October 25th. At 11 am, members of 20th Maine, Co. I, and a Color Party from the Royal Cana-

dian Legion met at Thomson's Burial Ground for the ceremony. Representatives of Bangor, Maine's Daniel Chaplain Camp #3, SUVCW, came to Canada to honor Edwin, George and Arthur. They were: Ryan King, Camp Commander; Eric Boothroyd, Senior Vice Commander; and Wayne Bennett, Camp Historian. Several friends and Clark family members were also present. After the memorial service, honoring the memory of Edwin T S Clark, George and Arthur were inducted and welcomed into Daniel Chaplain Camp #3, SUVCW. Camp Commander King pointed out that only about 25 living sons of Union Veterans remain in North America and we felt that it was a great privilege to be in the company of two sonsof a Union veteran of the Civil War.

Though we are Canadians, members of the Maritime Civil War Living History Association, strive to

Michigan Infantryman Remembered at Canadian Grave

Saturday, October 18, 2003 marked the first time in memory that the Department of Michigan, Sons of Union Veterans of the Civil War had gone outside the United States to perform a headstone dedication service.

Buried in a long-forgotten and overgrown cemetery in Huntsville/Novar, Ontario, Canada (about 135 miles north of Toronto), Pvt. William Strong, 9th Michigan Infantry, Co. E finally received the honor he deserved, 79 years after his death. With the help of Department of Michigan GAR Historian. Brother Jim Lyons, we were able to determine Pvt. Strong was a member of the Dwight May GAR Post 69 in Midland until 1918, serving as JVC in 1896.

Attending the ceremony were over 40 family members and area residents. Also joining us were three Canadian reenactors, two from the 116th Pennsylvania Infantry and one from the 11th Louisiana Infantry; they fired the military salute. Rev. Dawn Henderson of the All Saint's Parish provided the benediction. Assisting in the dedication ceremony was my son Colin (age 14 and Camp 1 Guard) and Tim (Department PI and Camp 1 JVC) and Kim (Champlin Corps No. 41, WRC) Kolean. One lifelong Canadian resident proudly wore his ancestor's regimental reunion souvenir pins from the 96th Illinois Infantry to the ceremony. From the time of our arrival in Huntsville right up until the ceremony, folks kept asking, "So how are you related? What side of the family are you?" They couldn't understand why some people who were not related in any way would drive over 500 miles to pay their respects...after our ceremony, they knew the answer.

properly portray the men and woman who sacrificed so much during the Civil War. We feel that it is our duty to honor the memory of the British North Americans who took part and to inform and educate the public that we too did our part to shape the United States of America and its neighbor, our home, Canada.

We will continue to search for the graves of veterans, honor them, place a GAR marker, and pass the information on to the SUVCW national graves registration project. You can check out the work that we have done on our website. You'll be able to locate the site by searching for "20th Maine Co I, Canada". Council of Administration Meeting November 16, 2003 - Gettysburg, PA

The meeting was brought to order by Commander-in-Chief Kent Armstrong at 8:03 a.m. An opening prayer was given by Past C-in-C Richard Schlenker, followed by the Pledge of Allegiance.

The Roll Call of Officers was read. Those present were Cin-C Kent Armstrong, Sr. Vice C-in-C Stephen Michaels, Jr. Vice C-in-C Donald Darby, PC-in-C Robert Grim, National Quartermaster PC-in-C Elmer Atkinson, National Secretary PC-in-C Edward Krieser and PDC Robert Petrovic. Absent were Max Newman and Ronald Gill due to their illness and David Stephen due to severe illness of his wife. PC-in-C Schlenker asked that minutes show that those absent be excused for just causes.

The C-in-C agreed and it is so noted in these minutes. Non voting Council members present included PC-in-C Charles Corfman. PC-in-C David R. Medert, PC-in-C George Powell, National Washington DC Representative PC-in-C Andrew Johnson, and National Counselor PDC James B. Pahl, Executive Director PCC Lee F. Walters, Chief of Staff Michael Bennett, and BANNER Print Service Provider John Hart were also in attendance.

The "Electronic Boardroom" votes, made since the last full Council meeting, were reviewed and approved as follows: 1. Brother Don Darby moved Max Newman, Dave Stephen and Bob Grim Seconded to approve minutes of 10 August 2003 Council of Administration meeting. Passed unanimously.

2. The minutes of the 7 August 2003 Council of Administration meeting were also approved unanimously.

3. PCinC Grim moved to approve proposal of CinC Armstrong to offer a Camp/Department the option of purchasing the Order's official ROTC Certificate or the entire Award (with medal, ribbon and certificate). There was a friendly amendment to set the price at \$5 per certificate by JVCinC Darby. The motion and friendly amendment was seconded by Council Member Petrovic. Passed unanimously. 4. National Secretary. Ed Krieser moved seconded by



JVCinC Don Darby that with the understanding that the National Defense Medal had been previously removed from the list of those qualifying for the SUVCW War Medal that the American Defense Medal also be removed from the list and that the Global War on Terrorism Expeditionary Medal be added to the list. Passed unanimously.

5. Don Darby moved, second by Bob Grim that the War Medal and Associate badge (Gold Star attached) be presented to Brother Geiger's family and that the expenses incurred for the Medal and badge be taken out of the Contingency Fund Passed unanimously.

6. Bob Petrovic moved, second by Don Darby to donate \$50.00 each to the Shriners' Children's Hospital, and the DUVCW Headquarters & Museum in Springfield, IL in the memory of Past National President Bessie L. Smith. Passed unanimously.

7. PCinC Atkinson moved, Bob Petrovic seconded to remove the C&R from the National Quartermaster's supply list. Passed unanimously.

8. Moved by Bob Grim, seconded by Bob Petrovic to pay the \$205.85 for office table and lamp to be placed in National Headquarters office. Passed unanimously.

9. Bob Grim moved, Don Darby seconded to concur with CinC Armstrong's wish to include the Gold Star with the Meritorious Service Award to Brother Ty Streeter, PCC (Lance Corporal, USMC) in recognition of his outstanding service to his country in Iraq. Passed unanimously.

Officer and Committee Reports were reviewed. Highlights include:

Sr. Vice C-in-C submitted the Program and Policy Committee Report, with proposed changes to certain Policies of the Order.

1. Policy on Unused GAR and SUVCW Graves has the addition that each Camp and Department possessing unused GAR or SUVCW cemetery plots shall forward to the National Graves Registration Officer, a description of the plots, including location.

2. Policy on Use of Badges, Emblems, Seals and Symbols were mostly grammatical, punctuation and capitalization. The Military Service medal and ROTC Award Medal was added to the list of the Order's badges.

3. Policy Statement For the Banner containing more descriptive language of who does what while remaining in compliance with the C&R took considerable time to review, discuss and approve the numerous changes. Bob Grim moved and Don Darby seconded to leave the Banner advertising rates in place. The vote was unanimous to accept.

Jr. Vice C-in-C Report - Recruitment for the Order appears to be doing well based on the number of applications received since the 2003 Ntl. Encampment, To date, the Order has received 58 applications, an average of 5.8 applications a week since mid-August. Fifteen requests for applications via regular mail were also received. "Heads-up" email is sent to all Junior Vice Commanders (that have email) telling them the date that an application is mailed to them. along with contact information for the new Brother. Department of California and Pacific JVC Tad Campbell, and Brother Linn Hoadley, NMAL Coordinator, are commended for their fast action in placing members into Camps.

Report of the National Committee on Americanization and Education - Permission requested to prepare & distribute " a simple yet informative sheet of "online resources for studying the Civil War in (whatever state)." Motion to approve made by Bob Grim, seconded by Bob Petrovic, passed unanimously.

Report of the Committee on Constitution and Regulations - The committee has been working on proposed changes to the Regulations, to reflect the direction the Order is moving and to ensure a broad base of the Brother's of the Order are represented on the Council. The committee will have specific amendments to the Regulations to present to the 123rd National Encampment, to accomplish that goal:

1) Make the National Quartermaster a nonvoting member of the CofA. This position would no longer be elected for a three year term, but be appointed by the Commander in Chief for a one year term.

2) The job description of the National Quartermaster would be revised. The new job description envisions that the current duties would be contracted out to one or more individuals or organizations. That the National Quartermaster would then be a liaison between such entity or entities and the Council of Administration.

3) Increase the number of council members from three to five. At the 123rd National Encampment, we would vote for one three year term person to replace or continue the existing position up for election this year. We would elected a new council member for a three year term and then elect a new council member for a two year term. All council members thereafter would serve three year terms. In effect, for two years we would elect two and then in the third year, only one.

4) Mandate that no two council members may be from the same Department. This would not apply to the officers of the Order (CinC, SVCinC, JVCinC, Sec, Treas), but only the council members. The committee has also considered one other matter. To properly recognize and thank our former National elected officers who have served the Order over the years (such as James Lyons, Todd Shillington, Doug Park, Gary Gibson, David Hann and David Wallace - etc), that all former National elected officers (including elected council members) be allowed to wear the gold "national"

Report of the National Counselor - In light of the report from the Committee on Constitution and Regulations, I call upon the Commander in Chief to appoint a special committee to explore the possibilities of entering into a contract with the newly formed foundation to take over the current duties of the National Quartermaster. Such contract would allow the foundation to sell these items to brothers only. with the view that there would be some excess income for the foundation to use for its various purposes. All prices would have to be agreed upon between the CofA and the foundation.

Executive Director's Report - The Annual Reporting System is functioning very well. There were initially many problems with inaccurate computation of per capita due. This was primarily because those filling out the forms did not read the instructions. After some correspondence and clarification, this has been resolved in most cases. I am regularly receiving Form 30s from the Departments. The new reporting forms are easy to use and I have no doubt that as the Department Secretaries become more accustomed to using them, they will realize a considerable reduction in the amount and complexity of their work.

Bob Grim Moved Bud Atkinson seconded to purchase a new multi function printer, copier, fax as requested by the Executive Director in amount of \$499.99 plus tax. Motion carried by all present.

Bob Grim Moved seconded by Bob Petrovic to table for the lack of information, the request of the Pennsylvania Department to get Council of Administration approval to transfer possession of Pennsylvania Department records over 7 years old to the Pennsylvania State Archives.

Don Darby moved and Bob Grim seconded to maintain the requirements for the War Medal with the exclusion of the American Defense Medal and the National Defense Medal and the inclusion of the Global War on Terrorism Expeditionary Medal. Passed by unanimous vote of those present

Ed Krieser Moved and Bob Grim second to rescind the previous Boardroom vote which changed the elements of the ROTC Award thus restoring it to only the full award of Medal, campaign ribbon and certificate. Unanimously passed.

Bob Grim moved, Don Darby seconded to allow the SUVCW Charitable Foundation to secure the services of an 'outside entity' to manufacture, advertise and market all items that the foundation is licensed to sell. Passed by unanimous vote.

Ed Krieser moved, Don Darby second to pay Rebecca Pratt the balance of her contract (\$750.00) for her work on the proceedings of the 2003 National Encampment. Passed by unanimous vote.

the project, a boulder with a bronze bas-relief plaque, placed at the exact location, where the 7th Michigan stormed across the Rappahannock in December 1862. This monument is the only one on the Fredericksburg

Battlefield to honor a Union regiment and very well may be the last monument placed on any National Battlefield.

DC Bruce Butgereit was asked by the 7th Michigan to perform the dedication ceremony for the memorial. Over 200 people attended the ceremony, listening to Butgereit speak of the reconciliatory actions of post-war Union and Confederate soldiers and how they desired to be Brothers once again.

Immediately following the service, participants began what one historian claimed was the "...most significant event in Fredericksburg history since 1901." Descendants of the 4th Michigan's Henry Seage and citizens carried 1st National Confederate flag through the streets, prior to returning it to the city. It was Henry Seage who had captured (souvenired) the flag off a building or window balcony in 1862. The flag was eventually turned over to the Michigan Historical Museum and it was just recently decided to return the flag.

Missouri

Members of the National Order, Department and St. Louis Camps attended the Memorial service for DUVCW PNP Bessie L. Smith recently. Sr. Smith was the last Nat. Pres. of the joint Encampment-Conventions of the Allied Orders in 1955. During her 98 years, she was also instrumental in establishing the SUVCW's headquarters-museum in Springfield, Ill. The Sons were represented at the service by PDC Robert Petrovic, PCC Jack G. Grothe, PCC Charles Funck, PCC Paul Leistritz and Br. Richard Kottemann.

About 100 people participated in a headstone dedication, hosted by Westport Camp 64. The new headstone was the culmination of ten years of work and honored the grave of Pvt. Robert F. McCorkendale, 2nd Colorado Cavalry, great grandfather of Br. Charles McCorkendale. During the ceremony. Br. Charles related his ancestor's military history, while Br. Jim Becker in period chaplain's garb, spoke of the significance of the 2nd Col. Cav. in the Kansas City area during the Civil War. The rifle salute was followed by "Battle Hymn of the Republic," performed on

harmonica and American Legion Post #237's playing of "Taps."

Members of the Brooks-Grant Camp, family members and history enthusiasts gathered recently in Mound Hill Cemetery to honor the memory of Gallia County's last surviving Civil War soldier, James Madison Gatewood.

Gatewood, born on July 4, 1848, in Clay Township, was the son of James Monroe and Virginia Lowery Gatewood. He enlisted in the army on February 25, 1865 at the age of 16. serving in Co. G. 195th O.V.I. After performing garrison and provost duty in Virginia, he was mustered out with the company on December 18th. Gatewood married in 1878 and raised nine children. He passed away at his home on September 18, 1943, at the age of 95.

His special marker read: "James Madison Gatewood--Here in honored glory rests the last Civil War soldier of this County. May their deeds and sacrifices be ever green in our memory."

According to Camp Commander James Oiler, who led the dedication. Gatewood's grave was never adorned with a Civil War veteran's flag holder, an oversight that Oiler said would be corrected shortly.

The Camp is planning two similar ceremonies in Meigs and Lawrence Counties.

Family members and history buffs gathered recently in Mound Hill Cemetery, Gallipolis, to honor the memory of Gallia County's last Civil War Soldier, Pvt. James Madison Gatewood.

Gatewood, born on July 4th, 1848 in Clay Township, and was the son of James Monroe and Virginia Lowerv Gatewood. He passed away at his home on Sept. 18, 1943 at the age of 95. He enlisted in Company G, 195th Ohio Volunteer Infantry on Feb. 25, 1865, at the age of 16, and was mustered out on Dec. 18th.

What are the requirements for the Military Service Medal and the War Medal?

Any Brother who has been honorably discharged from the Armed Forces of the United States (Army. Navy, Marine Corps, Air Force or Coast Guard) is eligible for the Military Service Medal. The application for the Medal (Form 8) and a copy of the Brothers DD-214 or equivalent must be submitted with the Quartermaster Order.

The Council of Administration establishes eligibility for the War Medal. In November 2002 the COA adopted a National Policy outlining the requirements for the War Medal. This Policy was amended in August 2003. That policy states "... any Brother who has served honorably in any branch of the Armed Forces of the United States which resulted in theawarding of one or more ribbons and/or medals as authorized by the Congress of the United States, the President of the United States, or the Secretary of Defense of the United States and as approved by this Order" shall be eligible for the War Medal. There are currently 36 ribbons and/or medals which the COA has approved as eligibility for the War Medal. Those medals issued since World War I are listed below. For the complete list please see the National Policy at http://suvcw.org/policies/warmedal.htm. (Note the Policy on the Website has not been updated with the amendments from August 2003.)

The medals are: World War I Victory Medal, Philippine Defense Medal, Asiatic-Pacific Campaign Medal, European-African-Middle Eastern Medal, Philippine Liberation Medal. World War II Victory Medal, Medal for Humane Action, Korean Service Medal, Armed Forces Expeditionary Medal, Viet Nam Service Medal, Southwest Asia Service Medal, Armed Forces Service Medal, Humanitarian Service Medal, NATO Medal, Republic of Vietnam Campaign Medal, Kuwait Liberation Medal from Kuwait, Kuwait Liberation Medal from Saudi Arabia, Marine Corps Expeditionary Medal, Navy Expeditionary Medal, Kosovo Campaign Medal, UN Korean Service Medal. UN Medal, and the Global Terrorism Expeditionary Medal.

To acquire the War Medal, a Brother with eligibility must complete the War Medal application (Form 5) and submit a copy of his DD-214 showing the awarding of the qualifying medal(s) or ribbon(s) along with the Quartermaster order form and payment for the medal.

Central Region Conference Well Attended



As one of Michigan's only two known sons who could claim their father fought in the Civil War, Edward campaigned long and hard to raise funds for the restoration of the monument that honored, not only the men from Kent County, but his father Egbert and uncle Buell Blakely,

Complaining that he was too young to have served in WW I and too old to serve in WW II, Edward supported veterans faithfully and proudly wore his V is for Veterans pin. Ed was a member of the Gen. John A. Logan Camp 1 and the Michigan Commandery of MOLLUS. Ed also frequently

traveled to area schools to share his life's experiences and his love of the Civil War. Never really knowing his father, he read many books and attended many reenactments in order to learn more about who his father was. Always one to have a smile and a song, Ed was a friend to all.



Artifact buyers beware


Many of our members are either avid or casual collectors of Civil War artifacts and memorabilia. When making a purchase, one needs to be extremely cautious. Now, artifacts can be the subject of not only a moral heritage violation, but of lawful prosecution as well. The final resting places of our ancestors, whether Union or Confederate, must be held sacred. The following recent article from the Greenboro News & Record was provided by Br. Rick Thomas and Br. Rob Golan (Gibbon-Burke Camp 2, Charlotte, NC) and is reprinted with permission.

Soldier's Grave was Disturbed, Church Reports

GREENSBORO -- On Sept. 22, 1864, 20-year-old Confederate Lt. S. Washington Donnell was killed in battle at Fisher's Hill in West Virginia's Shenandoah Valley, where blue uniforms outnumbered gray three-to-one. He was buried afterward in the cemetery of Buffalo Presbyterian Church, now at the corner of North Church Street and 16th Street.

For the last 139 years, Donnell's body rested peacefully there. close to the graves of other Donnells, not far from the cemetery's cedars and English boxwoods. Until this week. Sometime Thursday night or Friday morning, some-



one tried to rob Donnell's grave, digging about 4 feet into the ground in what investigators say was probably an attempt to find buttons, belt buckles or other valuable Civil War-era artifacts.

"We don't know if they found anything," said Greensboro police Detective Adrian Whitley. The would-be robbers left a mound of red earth and mud heaped on one side of the grave. Without excavating the grave completely, it's impossible to know if metal artifacts were found and taken, or if the robbers never reached the grave and gave up without finding anything. There was no sign of a coffin, clothing or human remains in the hole, but those may have decayed since 1864.

"It would be nothing left but anything brass on his (uniform)," said Herb Tucker, an elder at Buffalo Presbyterian, the church's historian and a cemetery trustee. Tucker's grandfather served in the same unit as Donnell, the 45th N.C. Regiment.

Another cemetery trustee discovered the hole around noon Friday as he was driving by the cemetery and noticed disturbed earth where there shouldn't have been any. At first, church officials thought the hole might have been dug for legitimate reasons, but Saturday morning they decided it probably wasn't and reported it to police.

Whitley said that in 25 years of police work, it was the first case of grave robbery he had seen. Buttons, buckles and other metal items on an officer's uniform have value, said Bob Zeller, a local historian and former News & Record reporter. Unless there was something very rare in the grave, it would probably only be worth a few hundred dollars, he said.

"I do know that relic hunters are pretty well known for doing scads of research, enough research so that they might have a clue as to what was in there," he said. "It's not out of the realm of possibility at all that they might have known what they were looking for."

An eBay search on Saturday for "Civil War buttons" revealed several dozen auctions, with sellers asking anywhere from a few dollars to more than \$100 per button. There are plenty of other Web sites that sell the buttons.

Whitley said he would notify investigators at police departments within 150 miles of the crime, in case they had seen similar incidents, and he said would also ask military antique dealers to be on the lookout for items that might have been taken from the grave.

"It certainly seems like a huge moral step to take for a few hundred dollars worth of relics," Zeller said. "It just seems ridiculous that somebody would be willing to do that for the return, for the relative monetary return."

By 11 a.m., Tucker was ready to shovel the dirt back into the hole. "We are greatly disturbed," he said, standing by the hole the robbers had left. "He didn't deserve that."







SUVCW Awards and Recognitions

Member Awards Established by SUVCW Regulations:

1. Meritorious Service Award: Certificate from the Commander-in-Chief to a member for exceptional service to the Order or society.

2. Meritorious Service Award: with Gold Star: Certificate and 1/2 inch Gold Star appliance worn on the ribbon of the membership badge. Presented by the Commander-in-Chief with approval of the Council of Administration. It is given to a member who has served the Order for an extended period of time in an outstanding and exemplary manner or for an extraordinary action by a member.

Member Awards Established by SUVCW National Encampments and/or Commanders-in-Chief

1. Abraham Lincoln Commander-in-Chief's Award: Presented to the most outstanding camp at the sole discretion of the Commander-in-Chief.

2. Cornelius F. Whitehouse Award: Presented to the most outstanding member of the Order at the sole discretion of the Commander-in-Chief.

3. B. F. Stephenson Award: Presented to the member who recruits the greatest number of new members during the fiscal year of the Order; and is based upon information provided with quarterly reports to the National Secretary.

4. Augustus P. Davis - Conrad Linder Award: Presented to the Department with the greatest number of new members during the fiscal year of the Order; and is based upon information provided with quarterly reports to the National Secretary.

5. U. S. Grant Cup: Presented to the Department with the greatest percentage increase in membership during the fiscal year of the Order; and is based upon information provided with quarterly reports to the National Secretary.

6. Under Forty Award: Presented to the Department with the greatest number of new members under age 40 during the fiscal year of the Order; and is based upon information provided with quarterly reports to the National Secretary.

7. Marshall Hope Award: Presented to a Department or Camp by the Commander-in-Chief for the best newsletter during his term of office.

8. National Aide: presented by the Commander-in-Chief to any member who recruits five or more members during the Commander-in-Chief's term of office. Recipients are recognized in General Orders and may wear the National Ribbon behind their respective membership badge until the awarding Commander-in-Chief leaves office.

9. Founders Award, presented to a non-member of the SUVCW or any of the allied orders by COA for outstanding service in memory of Union soldiers.
