Durgin Camp of Boscawen N.H. which escorted me at the Gettysburg parade. The wreathlaying at the Woolson statue, exercises at the Cyclorama, the Holiday Inn banquet, and the Blue and Gray Ball all gave credence to the report that next year these prestigious events are worthy of recording on national television. - Chester S. Shriver for arranging the multitudinous details connected with the appearance of those in uniform. General Ripley Robinson, commander of the Army of Northern Virginia, led the many men in Conferderate uniform, and the presence of the women in authentic costume of the period lent a beautiful touch to all the proceedings of Remembrance Day.

It is my sincere hope that this "outsider" can prove his worth in genuine concern for our military branch and that all members will support and guide me in "learning the ropes". The State House Inn will be the site of the luncheon that will immedately follow the rites at the Tomb. A shuttle bus will provide transporttion between the Tomb and the headquarters hotel.

#### THE **LEGISLATIVE** REPORT

Thomas L. W. Johnson

Independence of National Archives - Shortly after the adjournment of the 98th Congress in mid-October, President Reagan signed P.L. 98-497 which established the National Archives and Records Service as an agency independent of the General Services Administration effective April 1, 1985. Under the new law the President will appoint the Archivist subject to confirmation by the Senate. The law is designed to remove the National Archives from political pressures and give it a freer hand in collecting and preserving papers and other materials of historical importance to the Federal government.

Proposals for Memorial Day - With the retirement of Sen. Jennings Randolph of West Virginia from the U.S. Senate, supporters of a return of Memorial Day to May 30 must find a new spokesman in the 99th Congress willing to introduce legislation on this subject. In the past Senators Robert Byrd and Barry Goldwater have joined Sen. Randolph as co-sponsors of measures that would observe holidays on their historic dates. It will be up to us to let our Senators and Representatives know of our interest in this subject so that appropriate legislation can be reintroduced in the new Congress. If you contact members of your State's congressional delegation by mail, send copies of your correspondence to Senators Byrd and Goldwater to make them aware of your continuing interest.

Return of Members of Census and Population Subcommittees— Every member of Subcommittee on Census and Population of the House Committee on Post Office and Civil Service was reelected in the November 6 general election except for Rep. Katie Hall of Indiana who was denied renomination last May in her party's primary. While the membership of the new Subcommittee will not be known until February or March, it will likely include at least some members of the present panel.

## **George Meade Statue Returns**

General George Gordon Meade, the Union Commander in the Civil War Battle of Gettysburg, has returned to Washington, DC. More correctly, his statue has been returned. Removed from it's place of honor, at the foot of Capitol Hill, in 1969 to make way for the construction of a highway tunnel and reflecting pool, it has been in storage at nearby Ft. Belvoir, VA for 15 years.

The Pennsylvania Avenue Development Commission has seen fit to place it in a new, most conspicuous location at the intersection of Constitution and Pennsylvania Avenues, from which vantage point it is said the General will review all future inaugural and other parades which traverse the familiar course from Capitol to White House.

In a re-dedication ceremony held on October 3, 1984, the SUVCW and AUX. **DUVCW** and MOLLUS representatives were given places of honor by last minute invitation.

President Lincoln, in the personage of James A. Getty, SUVCW Camp No. 112, Gettysburg, PA delivered the Gettysburg Address. Floral tributes were presented by PCinC and PNP Richard and Dorris Schlenker, Washington Representatives of SUVCW and AUX: PNP Ellen Beckman for DUVCW and Frederick Drum Hunt for MOLLUS. Pertinent remarks were made by DC Mayor Marion Barry and Gwen King representing the Governor of PA, which Commonwealth gave the statue to the nation on it's original dedication date, October 19, 1927. Master of Ceremonies was Henry A. Berliner, Chairman of PA Ave. Development Committee,

New Hampshire: John W. Spaulding Camp No. 38 has an increase of five members during 1984. Nine business meetings, a family picnic and an annual Christmas party and pot luck supper were held during the year. On November 4, a pancake breakfast was held to raise money for the annual Christmas donations.
