Private Charles Lingenfelter (1841-1945) was the last living soldier of Humboldt County. He is buried in Clayton County and is listed under both counties. He served in Company D, 23rd Wisconsin Infantry Regiment. Private Lingenfelter, age 103, is buried in County Corners Cemetery in Strawberry Point.
